Village Voters Show Support For Incumbents

Village of Kewaskum constituents stated they were happy with their board of trustees as incumbents Andrew Pesch and Thomas Piwoni came out strong in Tuesday's Spring election.

Mathew A. Heiser will be the new Village President. He ran unopposed after John Kenworthy announced his non-candidacy. Heiser received 545 votes. He will now chair the Planning

Commission and serve on the Village's Economic Development Advisory Committee.

Steve Scheunemann was the lone new comer to the board. He received 310 votes. When asked how he felt about winning the race he stated he had no comment.

Andrew W. Pesch will enter his third term on the Village Board. He also is the board liaison to the planning commission. Pesch received the highest number of votes, totaling 510. Thomas J. Piwoni has served 2 years on the Village Board, and received the second highest

number of votes, 485.

Andrew Kuehl received 238 while Craig Knops received 229.

The Village Board elects will each serve a two-year term. The trustees receive an annual salary of \$600 per year plus a per diem pay per meeting of \$30 per village board meeting and \$15 per committee meeting.

Upon taking his seat as president, Heiser's trustee seat will be open. There is no word on what the board intends to do with that seat.

Auburn Voters Put Confidence in Laubenstein

Things have cooled down in the Town of Auburn following Tuesday's spring election.

After a very heated debate filled with letters to the editor in local papers and ads taken out by a group calling themselves "Concerned Citizens of Auburn" Howard Laubenstein, incumbent town chairman has emerged victorious almost doubling the amount of votes received by his opponent Joe Minz.

Laubenstein has served on the Town Board as Chairman for the last two years. Minz relinquished his supervisory seat to run for the chairmanship. Laubenstein garnered 419 votes while Minz brought in 214.

In another heated race for town supervisor, newcomer Mike Nitschke came through with 430 votes. A meat cutter by trade Nitschke will take his first shot at politics by replacing Minz.

Incumbent Merle Laatsch received 389 votes. Henry Haack who ran a fairly quiet campaign received 298, not enough for a seat at the head table.

After retiring, Camilla Butzke leaves her office to Bonnie Berg who received 368 votes for town clerk. Karen Ramthun also ran for the position, she received 297 votes.

Incumbent Shelby Sarauer will continue to sign checks for the town and pay

the bills. The current town treasurer, Sarauer received a total of 520 votes. Jeanie Gremminger who also ran for the position received 130.

Sarauer has served three terms as the Town Treasurer.

School Referendums Fail...

Goeden Back for Another Round, Maul Loses Seat on School Board

Jeanne Goeden is back for another round on the Kewaskum Board of Education. Goeden will be joining re-elected incumbents Beth Steiner and Gordie Dickman.

Lisa Maul, the other incumbent, lost by 22 votes.

Goeden, the third highest vote getter with 1,548 votes, will be filling a two year term. She stated "(Since the referendum failed) we have our work cut out for us. I hope people will come to me and talk so I can listen and help them," after finding out she won the seat.

Dickman, who is the current board president, received 1,610 votes. He stated that "I am happy with the support in my campaign, but disappointed in the lack of support for the referenda. Now we must make drastic cuts and unfortunately some additional programs will have to be cut."

Steiner was the top vote getter with 1,675. She had no comment.

The Kewaskum School Board will have to go back to the drawing board if they want improvements to the high school. All five referenda failed in most communities.

The Village of Kewaskum was the only municipality to give an okay for books and technology, but it wasn't

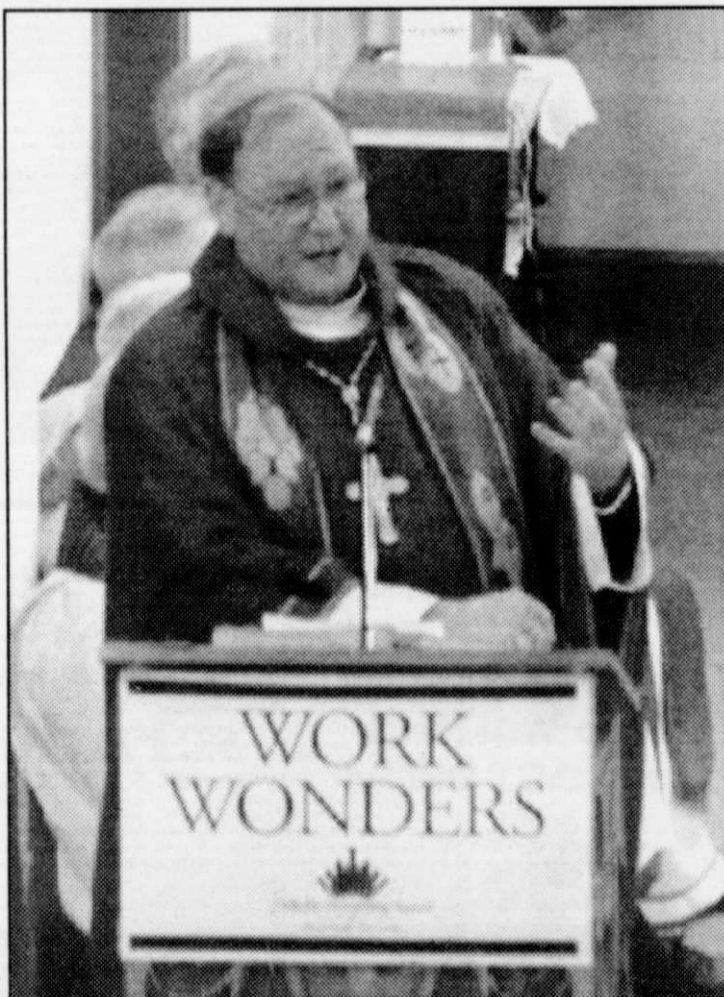
enough to overpower the 1,544 to 1,218 no's.

The first question in regards to allowing the district to exceed the revenue limit by \$400,000 for textbooks and technology failed

The second question authorizing the district to remodel and add an addition to the high school failed 1,736 to 996.

There will be weekly progress meetings for the USH 45 project held at the Community Room at the Kewaskum Village Hall every Wednesday, beginning April 2nd at 10:00 a.m. These meetings will continue as long as there is participation.

Jeanne Marchant, Project Manager, wishes to remind property owners that their mail boxes are their responsibility and not the contractors. Mail boxes in the urban reconstruct, which are all the properties from the north box culvert at the Fire House, to Kurt Schmidt's farm, will need to be moved by the week of April 7th.

Construction of the temporary road is scheduled to

begin on April 7th. Mail carriers would appreciate the move that week.

"If your mailbox is not moved, your mail will no longer be delivered. I do understand that the frost has got to be out of the ground in order for the mailboxes to be removed. Please contact your post office for placement," stated Marchant in a press release.

Marchant also stated, "I would like to take this opportunity to remind everyone of the safety hazards around a construction project. Driving at a reduced speed will make it safer for everyone concerned. Also, a highway project makes a very dangerous but attractive playground for children.

Please warn them of the dangers and please keep them clear of the construction area."

Farmington Plan Commission Recommends Moratorium

The Hot Button in rural America these days is land use.

It's not even an issue between the settlers and the newcomers, or the ranchers and the farmers and the DNR. It comes down to a question of learning from our mistakes and trying to figure out how to teach our children to feed and shelter themselves. In the terms of this Star Wars generation, do we want to make a Coruscant or a Tatooine? Most people want something in between city and desert and are willing to compromise for it.

Smart Growth is the State of Wisconsin's idea of helping us to help ourselves. By 2010 all communities should be able to report to the state a comprehensive plan of development. Several communities have made efforts toward that end.

In the Town of Trenton, a "2010" plan was developed and adopted in the year 2000. Trenton worked with the Southeastern Wisconsin Regional Planning Commission (SWRPC). All the Town was plotted and looked at as a whole, then zoning was updated. The plan was meant to be reviewed in 2010. If people in the community don't like the one and three acre plots, country estates and exclusive ag areas, the plan can be adapted to its changing needs.

The Town of Wayne took a little more drastic step 5 years ago in issuing a 3-year moratorium on land divisions while the land use plan was developed. "Most of the people went along with it," said Chairman Leander Herriges. The plan, which also was worked on with SWRPC, called for 5-acre densities. Ordinances were updated accordingly.

Retiring farmers without 401K's and profit-sharing have a right to live comfortably as much as the grocery stores have a right to find the food to sell. In an era where the state government pays farmers to let their land lie fallow to boost prices, what are the best answers?

Open space, caring for created parks, animals and taxes were all discussed. Chairman Jack Theusch pointed out that the Town of Farmington carries the second largest tax base for the Kewaskum School District. "People don't realize how much of a tax base we have here."

Ike Roell said, "If we do not have a plan in place, we will lose control of our zoning. We are not trying to keep anyone from doing their own thing on their own property. We are not here to scare people, but to regroup and get in line with a plan. We don't want to detour building, but to slow it down."

The Town of Farmington is poised to hurry up the Land Use Plan that was submitted by the Town Plan Commission a number of years ago, but not adopted. At the Plan Commission meeting on March 25, Ann Enright reported that the zoning and ordinances have been updated. "It just needs to go to the lawyer," she said. After a debate of about 45 minutes which included both residents and members of the Commission, a recommendation to the Town Board to pursue a moratorium was passed by a 3-2, 1 abstention, vote. By the time this paper is out, the Board will have heard the recommendation at the April 1 regular meeting. A report will follow.

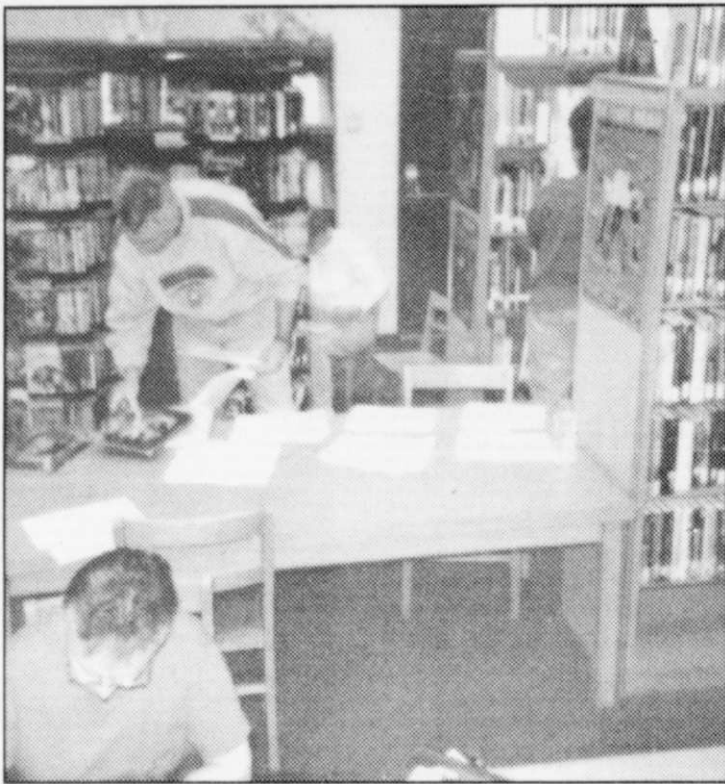

Incumbents Emerge Victorious in Town of Kewaskum Race

They say change is good. Apparently though residents in the Town of Kewaskum didn't think so. All of the town's incumbents emerged victorious in Tuesday's spring election.

Doug Kocher challenged Michael Lettow to be the town's top official. Residents

though seemed satisfied with Lettow's performance and gave him another term. Lettow's 237 votes more than doubled Kocher's 114.

In another the race for town supervisor Incumbents Bill Butzlaff received 206 votes while incumbent James Koepke received 183.

William Lehman, who had to resign himself from the race received 105 votes while newcomer Jeffrey

Shaw received 98.

Current clerk Sandy Stern will retain her office as well. Stern's votes overwhelming doubled Mary Meisser's who challenged her for the seat. Official results left Stern with 249 and Meisser with 101.

Daniel Stoffel ran unopposed for town treasurer. He received 331 votes.

Gridiron Club Anxious to Begin

While March sightings of robins usually bring to mind the imminent arrival of spring, and along with it, waning harsh winter weather, the end of basketball and other winter sports, it normally doesn't bring about thoughts of football.

Not so for members of the Kewaskum Gridiron Club's Board of Directors. Even though the 2002 youth football season ended after last October, the groundwork had already begun to be put in place planning for the 2003 season by the end of December.

This planning process typically includes monthly meetings at the local level, as well as having key board members attending the required off season league meetings on a regular basis during the winter months.

With that, the Kewaskum Gridiron Club has announced they will hold their annual spring registration for the fall 2003 football season on Saturday, April 12, 2003 at the Hon-E-Kor Golf and Country Club, 1141 Riverview Drive, Kewaskum. Registration will take place from 10 a.m. to 2 p.m. This registration includes both football players and cheerleaders.

Participation is open to youths entering the fifth through eighth grade in the fall of 2003. There are strict residency requirements, as all participants must live in the Kewaskum School District.

A parent or legal guardian must accompany any child registering. This process includes completing the necessary forms, supplying signatures by both participant and parents, and paying the participation fees. All fees must be paid and all forms must be completed before any player will be issued equipment.

This year's participation fee remains the same as in recent years at \$135 for football players, and \$35 for cheerleaders.

The Gridiron Club, a local, all volunteer organization, is dedicated to teaching the fundamentals of full contact football to our area youth, to better prepare them to play at the high school level.

Because the Club is all voluntary, including board members and coaches alike, they rely heavily on parents of participants, and interested community individuals for assistance keeping game days and other activities running smoothly. The parents of each participant are required to perform a volunteer duty on at least one home game day or other activity. There are several easy but necessary duties to choose from, ranging from concessions help to cleanup after games.

Over recent years the Gridiron Club has grown steadily from its beginnings in 1997 fielding only sixth, seventh and eighth grade teams. In 2000, the Club expanded to include a fifth grade team. Those players will be eighth graders this fall, and will be the first group to be able to compete for four full seasons, giving them valuable experience as they head to high school the following year.

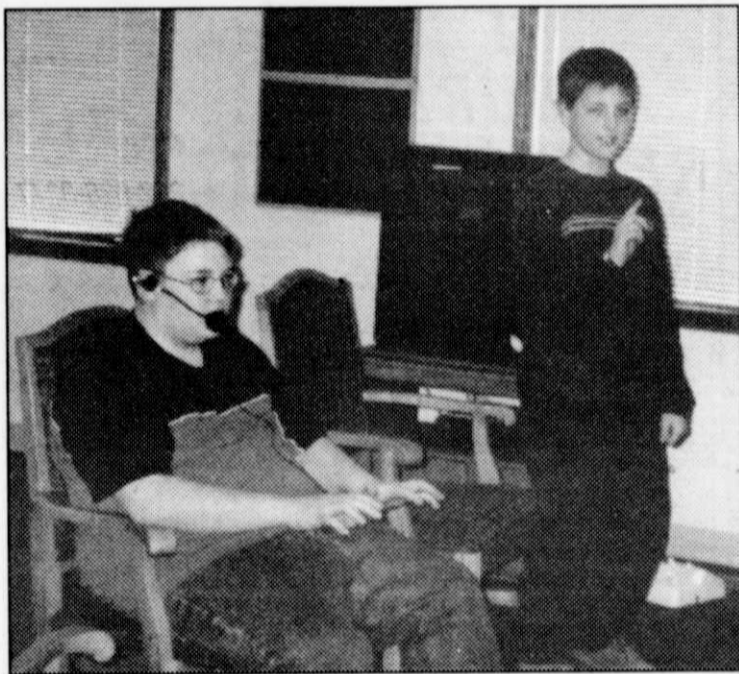

Kettle Moraine State Forest Offers Creating and Maintaining a Natural Backyard Landscape

The Evening with Nature Series at the Northern Kettle Moraine State Forest continues with the program, "Creating and Maintaining a Natural Backyard Landscape" presented by Connie Ramthun, owner of Kettle Moraine Natural Landscaping.

The program will be held on Thursday, April 10, from 7 to 8:30 p.m. at the Henry S. Reuss Ice Age Visitor Center. The Ice Age Visitor Center is located off of Highway 67, 1/2 mile west of Dundee. The program is free, but donations are always gratefully accepted.

If you traveled through southern Wisconsin prior to European settlement, you would have encountered a very different landscape than we see today. Instead of cities, suburbs and farmlands, you would have seen mostly prairies and open oak savannahs, and scattered southern hardwood forests and wetlands.

To help preserve this part of our natural heritage, many people are filling their gardens and yards with native plants. Depending on the garden/community type, people are growing such beauties as rattlesnake master, pasque flower, trillium, wild geranium, fringed gentian, big blue stem and elderberry. An added benefit to planting native plants is that they are adapted to our climate and soils, thus they

require less maintenance than other non-native species.

Connie Ramthun, through her business has been helping folks for many years establish and maintain native plant gardens, yards and restorations. She has a vast knowledge of Wisconsin's native flora and loves to share her knowledge with others. She will cover how to prepare a site, plant or seed it, and how to maintain it for years of enjoyment. Come learn how you can bring back native Wisconsin plant communities to your piece of land.

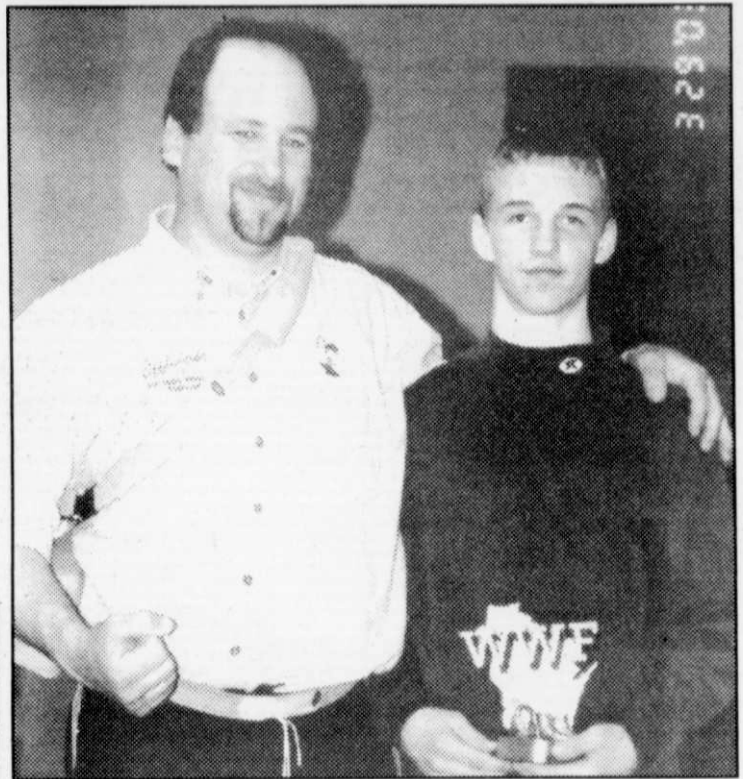

Koeflerl breaks KHS indoor shot put record

KHS Boys Take Third At Oshkosh Invitational

OSHKOSH- The Kewaskum boys track team finished third out of 34 Division 2 teams with 41 points at the 32nd annual Oshkosh High School Invitational Indoor Track Meet. The meet was held at the University of Wisconsin Oshkosh Kolf Sports Center on Friday, March 28.

The 41 points scored and the third place finish are the best finish ever for the KHS boys' team. Last year the team finished 13th and two years ago they finished fourth. Conference rival New Holstein won the Oshkosh Invitational with 57 points and runner-up Mayville scored 53 points.

Troy Koeflerl placed second in the shot put with a throw of 50' 8". This mark broke his KHS record of 50' 7" that he set earlier in the season at Slinger. The previous KHS record of 49' 8" was set by Jeff Taylor in 1989.

Seniors Mike McKee and Kurtis Cochran placed first and second in the pole vault by clearing 12' 6" and 12' 0"

respectively.

The Kewaskum 4 x 200m relay team that was shut out at the Washington County Indoor Wednesday night made a big statement Friday night at Oshkosh. The four-some of Josh Uelmen, Matt Hartmann, Adam Woebeking, and Andy Lickel finished second with a time of 1:38.56 - just 0.2 seconds out of first place and 0.2 seconds ahead of the New Holstein relay team.

Sophomore Josh Meyer finished third in the 1600m run with a near KHS indoor record time of 4:45.97 (four minutes and 45.97 seconds). Last year Meyer ran a time of 4:57.9 at Oshkosh. Josh made a determined effort to break the KHS indoor record. "I thought he was going to get the record," commented coach Jerry Gosa. Meyer missed the record by less than one second.

Hartmann also qualified for the finals in the 55m high hurdles and finished sixth in the finals with a time of 8.80 seconds. Hartmann's time of 8.66 seconds establishes a new KHS record.

Uelmen won his heat in the 55m dash with a time of 7.04 seconds, but just missed qualifying for the finals by one spot.

Junior David Wicklund finished ninth in the 400m dash when he won his heat with a time of 55.42 seconds. Wicklund dropped two seconds off his time from last year at Oshkosh. Freshman Garrett Donath broke the one minute mark in the 400m dash when he finished with a time of 57.87 seconds.

The KHS 4 x 400m relay team of Garrett Donath, Mike McKee, Alex Herriges, and Adam Woebeking ran a time of 3:54.4 and did not place in the top eight.

Meyer and Alex Herriges both sophomores, ran the 800m run and finished with times of 2:10.1 and 2:15.9 respectively.

Sophomore Zach Holm, a newcomer to track, dropped 20 seconds off his 3200m time from Wednesday night, when he recorded a time of 11:41.66 (11 minutes and 41.66 seconds).

Other Kewaskum athletes competing were the following: Mike Wagner in the 55m high hurdles with a

time of 9.13 seconds, Nate Steiner in the 55m dash with a time of 7.30 seconds, and Wicklund in the long jump with a distance of 16' 4".

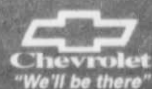
