## Schulte Resigns After Serving School Board 14 Years

Kewaskum School Board Member, John Schulte announced his resignation from the board on Monday after 14 years of service to the district.

In last week's Statesman, Schulte gave an exclusive interview to give

his side of the situation that prompted ex Kewaskum village president John Kenworthy and his wife Denise to start a recall of Schulte.

The following is taken directly from a letter to district residents that Schulte submitted to the School District:

*To the Residents of the Kewaskum School District:*

I hereby resign my position on the Kewaskum School Board effective as of today (April 28, 2003). After much weighing of the pros and cons, it is evident that in consideration of my family, and for the good of the district, it is the most prudent thing to do.

Due to the assumptions and prejudice by various peoples, and the slant the major media has put forth, I find no valid reason to continuing serving as a member of the Kewaskum School Board. I have also concluded that the whole truth isn't going to

come out in the pending trial, and it looks to me that the investigation into justice will not be served. It is because I am a man of high ethical values that I had to do what I had to do.

I appreciate the support that I have had over the last fourteen years.

The board will accept Schulte's resignation at the next board meeting on May 12. They will then discuss as to how to fill the vacancy. More details on filling the position will follow.

This Saturday Kenworthy and his wife had organized a rally to gather signatures needed for the recall effort. Kenworthy, upon learning that Schulte resigned said the recall effort will stop and applauded Schulte for resigning.

A recall effort is now in place in the Dodge County Board for Balian's wife.

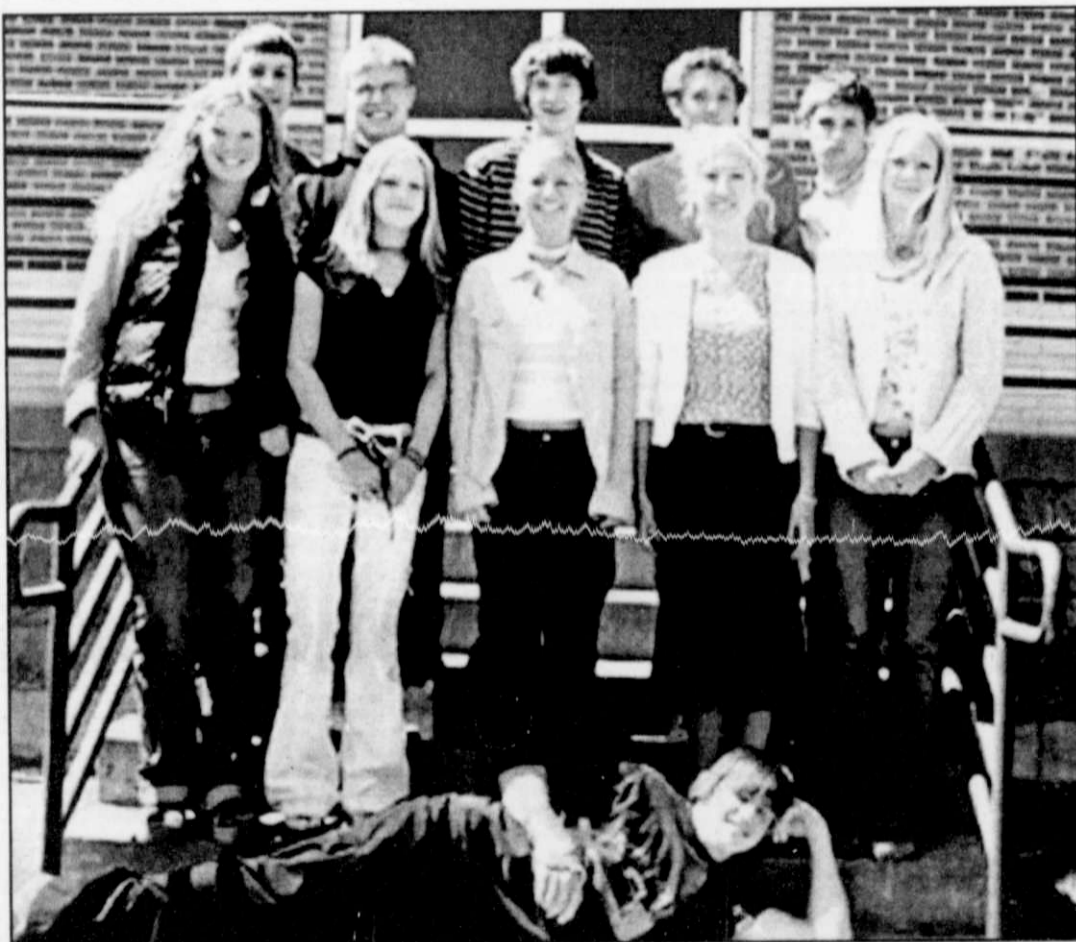

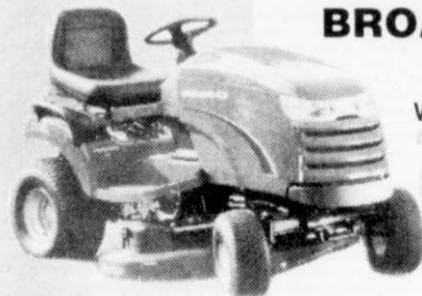

### Farmington Plan Commission

At the Town of Farmington Plan Commission on April 22, a decision on two subdivision proposals was held off. Mark Mulvaney's concept plan for Highways H and XX in Fillmore and Enoch Stiff/Badger Homes designs on Newark Drive in the southern portion of the Town were not acted upon, as the Town board is currently considering an ordinance on a zoning freeze.

On May 6, the board meets to look at drawing up a zoning moratorium in order to pass it on to the Plan Commission for review and approval, a public hearing and recommendation back to the Town Board for passage. Also at that meeting, the chairman will also make his recommendations for new appointees to the plan commission.

### Boltonville Sesquicentennial Committee

The committee met to continue planning for the celebration in the summer of 2004. Students Scott Rady and Amanda Herriges of KHS are well on their way to completing a miniature version of the village, circa 1900 with artistic license, under the guidance of Norbert Dettmann.

A float is being planned for the Fireman's Rain Days parade this coming Memorial Day weekend, as well as finalizing a visit by a Civil War era Re-enactors group to set up for the future celebration. Some time this summer, watch for a specialty calendar and souvenir buttons to be available. The group would love

some help - especially with a volunteer coordinator (done on the phone from the comfort of your own home), as well as costume makers (materials provided). Contact me for more information.

### Leonard J. Yahr County Park

Plans are rolling along for opening in 2004. The park site, located off Orchard Valley Road between CTHs H and A in Farmington will sport a boat ramp, fishing pier and beach on Erler's Lake.

The Planning and Parks Department is applying for a state grant to help offset the costs. Erler's Lake, one of three natural lakes in the township, is a glacial remnant. At thirty-seven acres and thirty-four feet deep, it is the smallest.

## Scott Chooses Grota For Reassessment

Steve Lenz, a representative from the U.S. Fish & Wildlife Service addressed the Scott Town Board at its April meeting. Recently, three Town of Scott properties were sold to this Federal agency.

Supervisor Ira Weber questioned the purpose of purchasing this land. Lenz explained that those areas are used for preserving, restoring and enhancing wildlife habitat.

The land is purchased with proceeds from the sales of Federal duck stamps and are owned by the Federal government. Wetlands are restored and maintained for the benefit of migratory birds and other wildlife. Higher grounds which he termed as uplands, are restored to native prairie grasses, or crops are planted by means of farming agreement for wildlife food plots. These areas also provide nesting habitat for wildlife.

As a means of protecting wildlife, there is a ban on all motorized equipment such as snowmobiles, all terrain vehicles or boat motors. These areas may not be used for camping or horseback riding. Dogs must be kept on a leash except during hunting during established open seasons. Blinds and tree stands are allowed but must be removed daily.

The areas are open to wildlife observation, hiking, cross-country skiing, nature study and photography.

Questioned about the loss of tax money for the town, Lenz said that three-fourths of one percent of the fair market is paid to the township in lieu of tax.

Bonnie Liepert, Don Stevens and John Devine, residents of section two requested and obtained a zoning change to A-5 for 6.385 acres and 8.77 acres of A-2 land, a total of 15 acres of A-1 land. Liepert & Stevens are purchasing 6.385 acres from Devine and adding it to their existing

8.77 acre parcel.

Mark LaFever received a conditional use permit to allow his daughter to operate a tavern and restaurant in Batavia, formerly Molly's Valley Inn.

Conditions are that all garbage and debris is to be kept in covered containers.

J.A.S.P. Adventures was given a conditional use permit to create a third apartment in an existing two apartment complex at N1454 STH 28, in Batavia with the condition that there will be off street parking only. The property was rezoned at the March meeting.

Lake Ellen Stone was granted a two year extension on its conditional use permit for operation of a gravel pit east of STH 28.

Diamond Corporation will have its sludge spreading permit renewed after proof of DNR site approval, payment of permit fees of \$1,575 for those sites and a road bond which will take care of any road damage caused by the corporation was received.

The Board of Appeals three year terms were renewed for Randy Link and Gary Held.

Newly elected supervisor Ken Willkomm was appointed to the Lakeview Community Library board.

Heberer Brothers Construction will be installing a drop box at the town hall. Price of installation is to cost no more than \$120.00.

Grota Appraisal, Germantown was selected to reassess all town properties in 2004 at a cost of \$42 per parcel. The work will be done by a walk around. Houses will not be entered. A contract will be signed next month.

A certified survey map was approved for Marshall Reysen. He will be separating the farm building and a portion of land from a larger parcel.

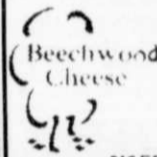

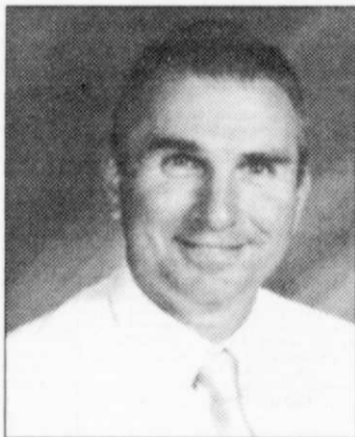

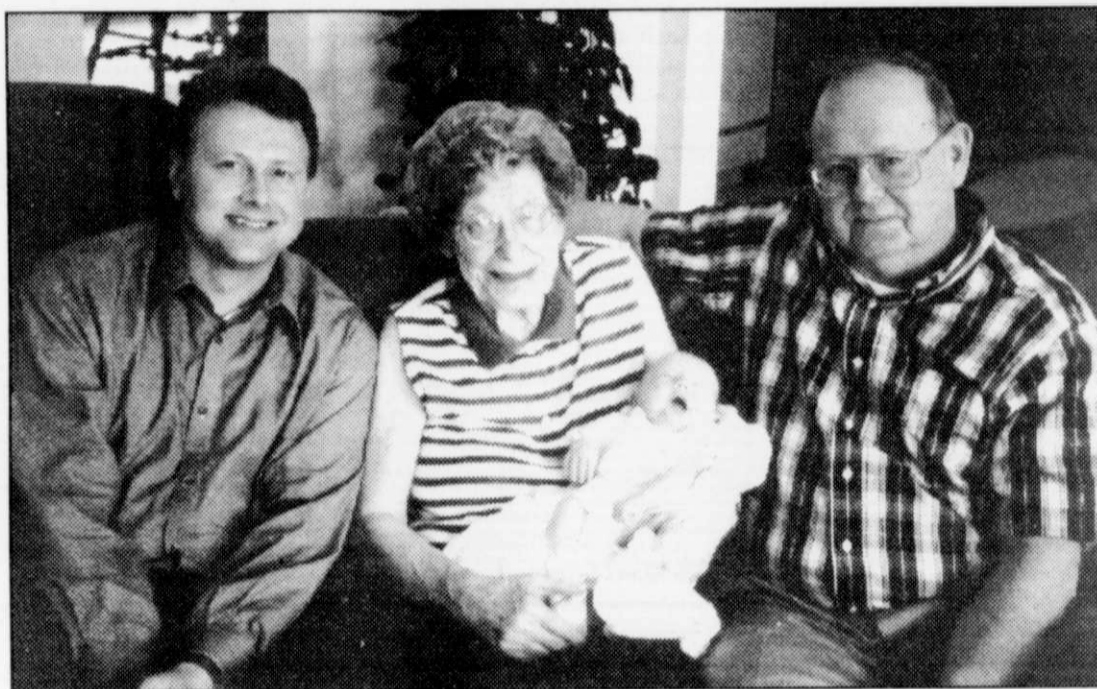

### New Farmers Needed for State's Agriculture to Prosper

MT. HOREB - Entering the farming business is a difficult task, and the implications for the future of Wisconsin agriculture are enormous. Without new farmers entering the profession, opportunities and infrastructure will continue to decline.

"Today's agriculture is capital intensive and generally requires access to expensive inputs, machinery, land and facilities. The initial capital outlay required to enter farming can be tremendous and overwhelming," says Gerald Brian, Sr. Vice President and Chief Credit Officer, GreenStone Farm Credit Services, a member of the Wisconsin Farm Credit System. "Farm Credit knows first hand it's critical to support and encourage young, beginning and small farmers, so we have special policy directing beneficial loan terms and conditions for this group."

Farm Credit takes into consideration the strengths and weaknesses of this sector, says Bryan Mullendore, Sr. Financial Services Team Leader, AgStar Financial Services, a member of the Wisconsin Farm Credit System. He says those meeting the criteria of a young, beginning or small farmer normally are subject to a lower net worth requirement and a willingness to finance a higher amount of collateral on these loans. In general, young, beginning and small farmers can apply for operating, equipment and real

estate loans with more relaxed credit standards and reduced interest rates than those offered to normal applicants. Farm Credit also works with Farm Service Agency (FSA) guaranteed loans. These loans allow more flexible terms and can provide additional assistance with interest rates.

Prior to contacting a lender, both Brian and Mullendore recommend developing a thorough business plan. Some things they recommend including are: goals and a timeline to achieve those goals; qualifications as a business manager, including strengths and weaknesses; how raw material inputs will be turned into cash and profit; specific resources needed, their cost, when those transactions will occur and the financing necessary; and, existing risks and how they will be mitigated. Once the plan is written, the feasibility of the plan from a financial perspective should be analyzed. Brian says financial statements, including historic and projected balance sheets and earnings statements, should be prepared, and Mullendore suggests looking at cash flow.

"The most important part of the plan is that it's realistic and conservative. In farming, it's only a matter of time when something won't go according to plan," says Mullendore. "If you don't leave room to maneuver when a setback occurs, you might not be able to continue farming. The more

realistic the plan, the more comfortable a lender will be and the more likely the plan will be financed."

When the plan is in place and financing has been acquired, maintaining open and honest communication and a cooperative attitude with the lender is extremely important, says Brian. Besides providing loans, both he and Mullendore point out Farm Credit offers many other services to minimize risk and assist in farm management, such as financial planning and record keeping, tax preparation and planning, crop insurance, appraisal services and life and disability insurance. Most importantly, an ag lender works with many other farmers and can provide insight on how other operations function and successfully manage their businesses, says Mullendore. However, the lender is not the "key" to business success.

"The new farm business manager is the driving force," says Brian. "If the farm doesn't generate enough profit to repay the principal, it doesn't make any difference how low the interest rate, or if the loan is approved."

The Wisconsin Farm Credit System includes four associations: AgStar Financial Services, Badgerland Farm Credit Services, FCS Financial Services and GreenStone Farm Credit Services. All are part of the Farm Credit Services



## Air Crew Comradeship

What is a comrade? The dictionary states it is a companion, friend who shares in what another is doing: fellow worker; partner; fellow soldier in arms. Comradeship is the relation of comrades; friendship; fellowship; companionship.

In the Military, comradeship varies from job to job, depending on what your assigned duties are. An air crew is a much smaller group than let's say the crew of a submariner or a battalion of soldiers. An air crew is generally six to eleven men depending on what type of aircraft we were flying in. You were hand picked along the way as you received schooling and training for a certain crew that the powers that be felt you would mesh well with. The air crews I flew with were generally 50% enlisted men and 50% officers. For example the B-29 bomber had five officers and six enlisted men aboard. The KC-97 aerial tankers had three officers and three enlisted men.

We all had attended numerous schools and had extensive flight training in our specialty. We had countless check rides by instructional air crews that measured our performance abilities. Number one, without a doubt, you had to measure up or you didn't become a member of an air crew. Even back in the 1950's, aircraft was worth millions of dollars and excuses for the loss of an aircraft was not accepted.

It is my belief that all air crew members had great respect for each other's job regardless of rank. Most of the time rank meant nothing to us as an air crew except to follow orders for a specific purpose. We each had our job to perform aboard our aircraft which we had been highly trained for. We knew our jobs and we knew them well.

There were occasions when the Officers' Club had special entertainment or dinners. Where we were off duty we generally wore civilian clothes. I always felt when not on duty a uniform was only for parades of stand-by inspections. Besides not many of us liked to wear ties. It was not unusual for our officers to invite the enlisted men of our air crew to one of these special nights at the Officers' Club. The Officers' Club was for men of rank from lieutenants to colonels. Did I feel intimidated? Yes! Normally enlisted always felt uncomfortable among a group of officers from another air crew no one made a complaint that we shouldn't be there. Most likely because the did the same thing from time to time with their own air members. Before the end of the evening we felt comfortable being there and conducted ourselves as gentlemen and officers would. I felt like it was a great honor that my officers considered

me one of them.

Many officers were married. Most enlisted men were not back in the 1950's. There were occasions when we would be invited to their homes for a meal and relaxation. Our officers did not put their rank first but their crew members recognizing the performance of our jobs was far more important because when we flew we were a team and a team performs as one for the common good of all.

In reflecting back in time to that period when I was in the USAF I believe the fact that most of the officers I flew with were recalled reservists and when released from active duty, they headed back home to civilian jobs made them more like ordinary folks. The Military life was not their career.

After we had finished our combat tour of duty during the Korean War none of us could wait to get back home on furlough. We got the opportunity to beat the normal wait for rotation to go stateside by several days if we volunteered to ferry on of our war weary bombers back to the states for a major overhaul. Of course, we volunteered even though we needed a break from flying. As the flight engineer, I had to make sure the aircraft could get us back over the Pacific Ocean and back to California. The aircraft was far from what we would have desired to fly in but there was the lure of getting home sooner if we did it.

Our first stop from Japan was Wake Island. During that refueling stop over I started to have a severe stomach ache. I thought to myself, "Wally, suck it up" so I didn't complain about it. After all we had been through together and survived, this was nothing.

After take off, our next stop was Hawaii. A few hours before landing the pain was excruciating. When we touched down in Hawaii, an ambulance met our plane late that afternoon and I was transported to the military hospital at Hicken Field, Hawaii. My appendix had ruptured. I was rushed into surgery.

When I came to and opened my eyes, the first thing I saw were 10 crew members (all of them) making sure I was going to be okay. I was deeply touched by their staying as they could have chosen to catch the next flight out and gotten home a couple of days sooner. They chose not to. Rather they hung around to see how their fellow crew member was doing. That is comradeship!

Unfourtantly, I have not seen any of them since, but, I can envision how each of them were at that time, in my mind, even now, over fifty years later.

I spent six weeks in the hospital in Hawaii. To drain the infection from my system they inserted a tube in the area where the appendix

had been. Finally they felt I could go home, but, while in flight from Hawaii to California, there was more drainage. I checked into a military hospital in San Francisco, California where I had to spend another two weeks. Finally, I could go home. Eventually I got better and the only thing I have to show for it is a scar about the size of a silver dollar that is about an inch deep.

After my furlough I had to report to Biggs Air Force Base, El Paso, Texas to the 97th Bomb Wing for air to air refueling. I passed my flight physical and was able to resume my flight duties as a flight engineer on the KC-97 aerial tankers.

Life is full of challenges and this was another one.

My aircraft commander, Lt. Schneck, flying an aerial tanker, for example, became an officer at the end of World War II and was discharged but kept in the Reserves. Uncle Sam did not want to lose all of his valuable training. After World War II there was a surplus of officers so he came back as an enlisted man and worked his way up to Sargent. He was boom operator during this period. During the Korean War he was recalled and given his officer rating back and then could resume to be a pilot again.

Lt. Schneck knew what it was like to be an enlisted man. Perhaps this is why he made no distinction between the men, enlisted or officers. We were comrades! Actually before his recall as a pilot I had more rank than Lt. Schneck when he was an enlisted man.

The co-pilot had been a used car salesman prior to being recalled to active duty.

My navigator, Capt. Sherlock was the adjutant of our squadron. He was a very busy man. He was responsible as the chief administrator for the day to day operation of our squadron. After a flight he often asked us to clean up his crew position so he could get back to the squadron to resume his adjutant duties. He took care of us by seeing that we didn't get many details such as parades, etc.

Even in survival school we worked as a team. All took turns doing the grunt work such as making or gathering wood, hunting for food, preparing some kind of shelter, etc.

I am deeply grateful that I was always very fortunate to be part of air crews that shared such strong comradeship. I had complete faith in their judgement and abilities. The air crews I served with were always ranked the highest in the USAF. To know such comradeship, more than once, are priceless experiences.

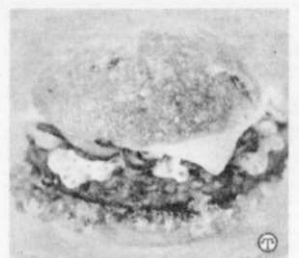

## First Turkey

Hello Friends,

What does a full-time outdoor writer do when he realizes that he will not be receiving a tag for the spring turkey hunt? A) Kick his dog; B) Drink lots of beer; C) Find someone who has a tag to hunt with.

Kicking the dog really wasn't much fun. Although I gotta admit I enjoyed the beer drinking option, in the end, what really worked out was hunting (observing) turkey with my 15-year-old neighbor, Eric Dutschek

and his father, Dave.

**Thursday, April 17  
High 41, Low 30**

Turkey paradise would best describe all of the land surrounding my house for a radius of at least 30 miles. This makes not receiving a tag even more difficult.

For today's hunt, we chose a long since harvested 50-acre soybean field. It is surrounded by oak and pine forests. Two days ago, half of the field was plowed. This added a new twist to our hunt.

Last night, Dave, Eric

and I had set up a portable blind among a stand of red pine, and we made a natural blind for Dave, since he needed to leave for work at 9 a.m. today.

There are always surprises, and this morning it was a coating of ice on everything which caused our blind to collapse. The ice, combined with low temperatures and a stiff wind, made my 41-year-old body feel every injury I have ever inflicted on it.

Eric's firearm of choice was a semi-automatic Browning 10 gauge. Our plan was that Dave would try to call in Eric's first turkey and I would take over when Dave headed to work.

It was about 8 a.m. when we spotted our first birds. They happened to be three toms feeding in the unplowed portion of the field.

We had set up in the plowed part of the field where I had watched birds all spring. By day's end, we fully realized that the local birds were hanging out only in the plowed section so they could get a good meal.

At 5 p.m., after 12 hours in the blind and watching 12 birds, we realized several things. No. 1, I stink with a call. No. 2, the birds do not seem to be attracted to each other. No. 3, I stink with a call, and No. 4, we need to relocate to the stubble section of the field.

Oh yeah, we barely heard even one gobbler after 12 full hours in the blind.

**Good Friday, April 18  
High 58, Low 40**

I had a good feeling about this morning. Long before daylight, we had our decoy spread of four hens and a jake displayed in the soybean stubble. As soon as we were in the blind and Dave was hidden next to a fallen oak, the gobblers started gobbling.

Eric and I were playing a game of "scare the other guy" with the shaker gobbler call. Dave was taking a nap. There were four jakes 500 yards away ever so slowly working their way in our direction. About 8 a.m., a tom 50 yards away in the oak forest let out his love call. That was the closest that bird came to us.

Soon after, I became very tired. I was actually jealous of Dave who was snoring profusely and becoming well rested. Deciding to take a short snooze, I laid down on the forest floor inside the blind. I was dreaming of 40-pound toms coming to my call when a monstrous explosion came from Dave's direction. It woke me from my dream.

The explosion was a gobbler and he was headed in our direction. All heck broke loose inside the blind as I got out of Eric's way. I watched as three toms rapidly worked their way toward our decoys. I saw the whole show and it was a good one.

Eric let fly with a load out of his 10 gauge and sent his first gobbler to heaven. In this excitement, Dave got up, unaware that his leg was

still asleep. He fell over the oak log he had been hiding next to.

All in all, everything about our experience was good. It was fun to spend a couple days in a blind with a young hunter. It was even better to see him shoot his first bird.

A good memory was created this week!

## Deer, Small Game Hunting Regulations Now Separate Publications

MADISON - Beginning this year, the traditional small game, deer and general hunting regulations will be published in two separate pamphlets. The small game and general hunting regulations will be provided in one pamphlet and is expected to be ready in mid-June. A second regulations pamphlet, specific to deer hunting, will be available in early August according to state wildlife managers.

Separate regulations pamphlets for bear, Canada goose, turkey, waterfowl, pheasant and trapping will continue to be published as in past years.

"The decision to publish a separate deer hunting regulations pamphlet was driven by the need to provide wildlife health experts time to analyze chronic wasting disease data that is coming in and the time needed for the Natural Resources Board and legislative approval of zone maps and regulations for the upcoming fall season," said Tom Hauge, director of wildlife management at Department of Natural Resources. "The timelines associated with approving and implementing the deer-related rules and CWD zones by the Natural Resources Board prevent this pamphlet from being available prior to August."

"The new deer hunting regulations pamphlet will provide hunters with up-to-date information and maps on deer hunting in Wisconsin, including both CWD specific rules and the standard deer hunting rules for the upcoming deer season," said Kurt Thiede, wildlife regulations and rule specialist at DNR.

"Last year there was a separate deer hunting regulations pamphlet specific to Chronic Wasting Disease. This caused some confusion to the deer hunters who, in many cases because of where they hunted, needed to carry two regulation pamphlets. We are trying to avoid that situation this year by providing one pamphlet on deer hunting which will be available in early August."

For those hunters that use the Internet, the regulations will be available a little sooner as has been the case since the department began publishing hunting regulations on the Internet. Hunters can access the regulations at [www.dnr.state.wi.us](http://www.dnr.state.wi.us).

Conservation patron license buyers will receive a fall hunting packet as usual in early July which will include the 2003 Small Game and General Hunting Regulations. This packet, however, will not include the new deer hunting regulations pamphlet. When the 2003 Wisconsin Deer Hunting Regulations pamphlet is available in early August Patron license holders will be able to pick up a copy at DNR service centers, license agent locations and on the Internet.

## KHS Boys Win First Annual Invite

The Kewaskum High School boys track team won their first annual Kewaskum Track and Field Invitational Friday night, April 25th. The Kewaskum boys tallied 115 points for the win, and Brown Deer finished second with 91.5 points in the five team invitational. Chilton finished third with 67 points, followed by New Berlin West with 59 points and Kettle Moraine Lutheran with 41.5 points.

Head coach Jerry Gosa commented after the meet, "It was nice to see the Kewaskum boys team win the invite. They had a good meet, good efforts, but they know the competition gets a lot harder Tuesday night when Kewaskum hosts the Washington County Outdoor Championships."

The Kewaskum boys won nine out of the 18 events. The Kewaskum 4 x 800m relay team of Eric Nass, Alex Herriges, Nick Bartley and Josh Meyer set the tone by winning the first running event in a season best time of 8:50.5. Meyer also picked up wins in the 1600m run and the 800m run with times of 4:52 and 2:10. Alex Herriges made it a sweep for Kewaskum in the 800m run as he finished second to Meyer with a time of 2:12.8.

Kewaskum won both hurdle races. Mike Wagner won the 110m high hurdles in a personal best time of 16.3 seconds, and Matt Hartmann won the 300m intermediate hurdles in a season best time of 42.9 seconds.

Mike McKee won the pole vault at 12', and teammate Kurtis Cochran finished third by clearing 11' 6". Kewaskum won both throwing events, with Troy Koeferl winning the shot put with a season best throw of 50' 9" and David Cibulka winning the discus with a throw of 136' 9". Koeferl also placed fourth in the discus with a throw of 118' 9".

The Kewaskum 4 x 100m relay team of Josh Uelmen, Matt Hartmann, Adam Woebeking, and Andy Lickel won with a season best time of 45.9 seconds. The same foursome struggled with a hand-off and placed second in the 4 x 200m relay with a time of 1:38.3.

Josh Uelmen finished second in the 100m dash with a time of 11.4 seconds, and freshman Ross Stockhausen also finished second in 24.2 seconds in the 200m dash. Head coach Jerry Gosa told Ross that it was all up to him after the disqualification of the other Kewaskum runner because

of the false start. "Ross ran a good race. We were very happy with his time," commented coach Randy Backhaus.

The Kewaskum 4 x 400m relay team Garrett Donath, Nass, Herriges, and Woebeking, finished second with a season best time of 3:44.

Freshman Luke Herriges finished third in the high jump by clearing 5' 4", Garrett Donath finished fourth in the 400m dash with a personal best time of 54.7 seconds, and Zach Holm finished fifth in the 3200m run with time of 11:38.

The following Kewaskum athletes almost equaled or exceeded their season best times but did not place: Nate Steiner in the 100m dash in 12.2 seconds, Zack VanWormer in the 400m dash in 57.7 seconds, and Nick Bartley in the 1600m run in 5:11. Matt Hartmann jumped 36' 9" in the triple jump, Jake Sabel recorded a leap of 16' 5.25" in the long jump, and Steiner in the 110m high hurdles had a time of 18.9 seconds.

The Kewaskum High School girls track and field team finished second at their first annual Kewaskum Track and Field Invitational, Friday night, April 25th. Chilton won nine events to capture the team title with 117 points compared to 106 for the Kewaskum girls team. Kettle Moraine Lutheran finished third with 69 points in the five team invitational. New Berlin West finished with 59 points and Brown Deer totaled 29 points.

The Kewaskum girls team managed to win only three events, but used good overall team depth to give Chilton a battle for the title.

Seniors Johnnajo Schicker and Jessi Graham both broke the previous outdoor mark of 9' 9" in the pole vault set by Graham last year during Sectional competition on her way to the State Meet. "Both girls vaulted great," exclaimed a very happy Nate Wesemen, who coaches pole vault for Kewaskum. "I'm at a loss for words." Graham placed first and Schicker placed second based on misses.

Rachel Dums and Jenna Roecker continued to make big improvement in the 300m low hurdles. Amanda Donath finished second in the 400m dash with a time of 64.6 seconds and Jessi Graham finished third in 65.1 seconds. Donath, a sophomore, has been setting the pace for the Kewaskum 400m runners this season.

Danielle DeGroot finished second in the 800m run with a time of 2:46.0 and Amy Fehlhaber finished third in the 3200m run with a personal best time of 14:59.

Breyan Donath finished third in the 200m dash with a season best time of 27.0 seconds and Amanda Magnus finished fourth in the 100m dash with a time of 13.9 seconds. Becky Herriges placed second in the long jump with a jump of 15' 3" and Magnus placed fourth with a jump of 14' 6.5".

Magnus, Graham, Herriges, and Breyan Donath teamed together to win the 4 x 200m relay with a season best time of 1:56.6 seconds. Herriges, Graham,

Breyan Donath then teamed with Roecker to win the 4 x 400m relay with a time of 4:28.

The Kewaskum 4 x 100m relay team of Jessi Butler, Katie Patterson, Magnus, and Dums finished second with a time of 56.1 seconds compared to Chilton's winning time of 55.0 seconds.

Claire Spang finished third in the shot put with a personal best put of 28' 2.5". Montana Schicker placed fourth in both the shot put and the discus with throws of 27' 4" and 75' 11" respectively. Kayla McCormack placed fourth in the high jump at 4' 6". Herriges also finished fifth in the 200m dash with a time of 29.4 seconds.

Liz Roehrig of Chilton won the high jump by clearing 5' 2" and also won the 200m dash in 26.0 seconds.

"The Kewaskum girls had a lot of very good efforts. I know that they're disappointed that they didn't win the meet, however, the most important thing is that they just keep working hard and improving," commented head coach Jerry Gosa.

Kewaskum hosts the Washington County Outdoor Championships on Tuesday, April 29th and then travel to Pewaukee on Friday, May 2nd for their annual invitational.

A Youth Turkey Hunt took place in the Kewaskum-Campbellsport area on April 12 and 13. The Gateway Gobblers Chapter of the NWTf and the Department of Natural Resources sponsored the hunt. A Youth Hunt is designed to give young hunters between the ages of 12 and 16 the opportunity to harvest their first turkey.

Youth Hunters must have completed the DNR Hunter's Safety Course and also take part in a four hour training session on turkey hunting. The youth and their mentors then met back at the New Fane Sportsman's Club to register their turkeys and exchange stories on the morning hunt. License fees are waived for the youth hunt and a turkey tag is provided to the youths.

There were 10 youth hunters selected for the hunt and five of the 10 did harvest their first turkey.

The youths selected for the hunt were first time turkey hunters who did not have a parent that turkey hunted. In some of the cases a parent went along to observe the hunt.

Everyone that took part in the hunt enjoyed it.

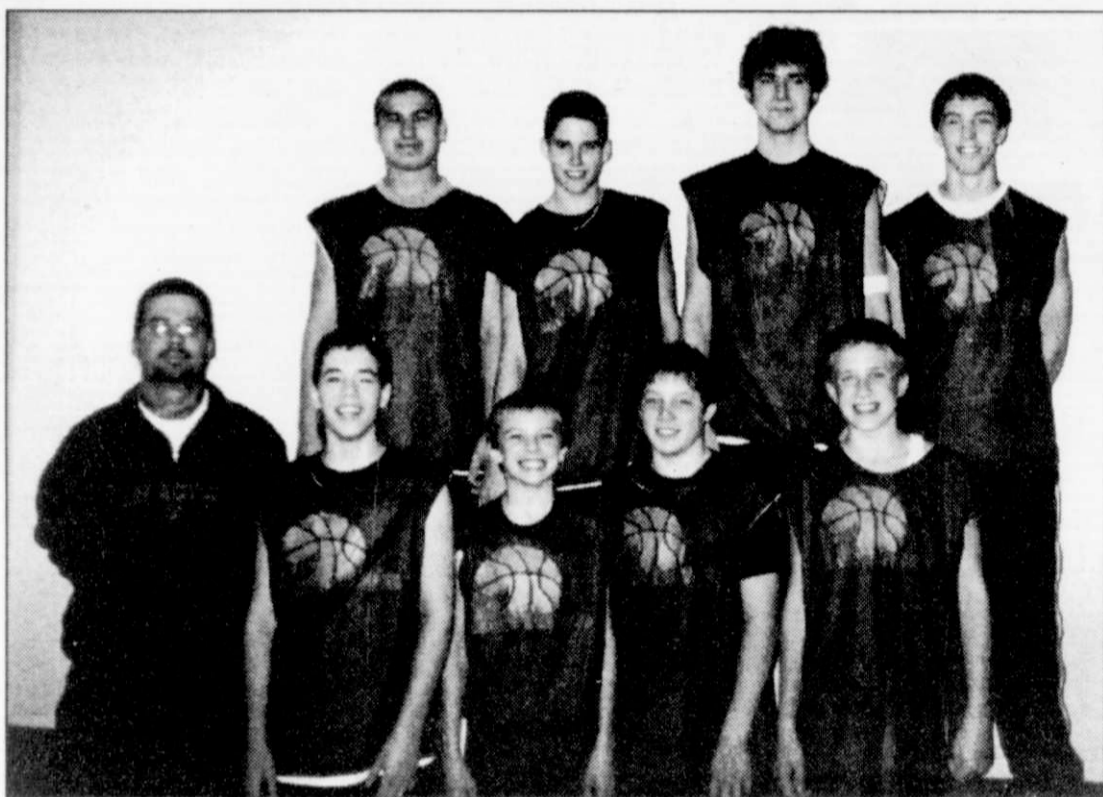

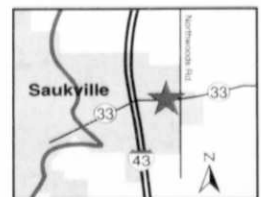

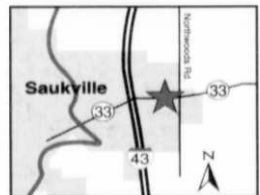
