Campbellsport firefighters responded to a fire at N2359 Triple S Road in the Town of Auburn the evening of Wednesday, May 7.

Eden Fire Department was also called to provide aid with tanker trucks. The Fond du Lac County Sheriff's Department provid-

ed traffic assistance.

The Sheriff's Department was notified of the call at 10:17 for a furnace that was on fire in the basement of the Gregory and Delores Loehr residence.

Campbellsport Fire Department determined that an oil furnace did indeed play a role in the fire. The home sustained serious fire, water and smoke damage on its interior. Firefighters were on the scene for three hours.

Board Decides How to Replace Schulte, WES Gets New Sign

Monday night's Kewaskum Board of Education meeting started off with the reorganization of the board. Gordie Dickman will remain the president, Mark Steinhardt will remain vice president, Mary Meisser will once again be the clerk and Beth Steiner will be the treasurer, replacing John Schulte who recently resigned from the board. Mary Meisser will continue to be the CESA 6 delegate and Jean Goeden was appointed the alternate. Meisser will also be the district's CESA representative

to the Annual Convention.

Lisa Maul was then given a certificate and a gift from the board to thank her for her years of service to the district. Maul lost her seat in the April 1 election to Jean Goeden, who had previously served on the board.

Kathy Robinson, the Food Services Director gave a short report on the Middle School Breakfast Program. She stated that the program seemed to be successful and they were serving approximately 17% of the student population. The district received a grant to cover portions of the program. However, had the district not received the grant, the program would have ended the

year in the negative. Robinson stated that she has already seen where she can make cuts so the program would not operate in the negative next year. KMS principal Ken Soerens stated that he has not seen a single problem pertaining to the program.

Joannie Kalina gave a report on student achievement. She stated that in the elementary and middle schools failure is not really an issue. However, there are programs that have been implemented to help the problem before it starts.

At the high school where truancy and failure is a much larger problem, Kalina

Three Apply For Village Trustee Position

Three former Village of Kewaskum trustees have written letters of intent for a vacant seat on the Village Board that was left by Matt Heiser who has stepped up to be the village's top official. Applicants include: John Borland who served a term on the board from 1994 to 1995. Borland also owns a tavern in town, John's on Main.

Andrew Kuehl who served a half of term in 1999 and is a member of the Planning Commission and Economic Development Advisory Committee has also applied. Kuehl is the opera-

tions manager at The Kewaskum Statesman.

The third to apply, Harry Roecker was on the board from 1995 to 2001. Roecker owns LR Trophy & Sportswear with his wife Lori.

The village board will review the letters at their May 19 meeting and may make a decision on who will fill the vacant seat at that meeting. If someone is chosen that person will begin his term as soon as an oath of office is signed. He will serve until April of 2004 when Heiser's term would have expired.

VB Members Face Recall

On Wednesday May 7th Greg Bernau and Scott Konzal, two village residents, filed recall papers on three Village of Kewaskum Board members. At the May 5th Village Board meeting Robert Stoltzmann, Andrew Pesch, and Thomas Piwoni voted against keeping a pot bellied pig within the village. Greg Bernau and Scott Konzal, the owners of the pig, explained, "We have vowed to hold the board of trustees responsible for their actions! They should not be spending taxpayers money to fight this ridiculous lawsuit."

Konzal and Bernau need to collect 384 signatures for each petition; residents can sign all three petitions. If the needed signatures are collected, the village would verify the names and addresses on the petition, and a special election would then be held. If the Village Trustees are recalled, Bernau and Konzal have plans to run for the Kewaskum Village Board.

At the May 5th Village Board meeting, a majority vote was needed to change the current ordinance, and allow the pot-bellied pig to stay. The Board voted 3-3, President Heiser, Kevin Scheunemann, and Steve Scheunemann voted to change the ordinance. After the vacant seat on the Village Board is filled this issue will be raised again.

is working with staff and administrators to find solutions to the problem. Kalina stated that for now they would focus on the freshman class to hopefully curb the problems early on.

The team is working on lowering the dropout and failure rates, which, with the exception of one year, both have been lower than the state averages.

The board also agreed to let the Wayne PTO move ahead with a sign for the school. The PTO has been collecting fundraiser money for two years to purchase the sign. The PTO decided that since the sign would be on school property it should be in the district's name. The board and PTO representatives agreed that the PTO would make a donation to the district to pay for the cost of the sign. The sign will be erected by Cochran Sign Co. Inc of Kewaskum. It will be a 10' x 4' double faced internally luminated monument sign. It will have three lines to accommodate letters so the school can announce things going on.

The PTO went to both the Town of Wayne Planning Commission and Town Board where they received approval. The Town Board also agreed to forego the cost of the sign permits. The cost of the sign, not including the cost of running electricity to the sign will be approximately \$8,000.

Next on the agenda was whether or not to accept Jason Piittmann as the new head football coach to replace Tim Rohlinger who resigned from the position. The board unanimously agreed to accept his application.

The board then agreed to accept the early retirement of Dennis Reha, KMS Social Studies teacher, with resig-

nation. Reha had been with the district for "36 wonderful years" as he stated.

The board also approved installing new security cameras in the high school and switching some existing ones around. John Wolfenberg stated that with the installation of the new cameras all areas of the building, except the fieldhouse, will have cameras.

The board ended the meeting with how they would fill the vacancy left by John Schulte's resignation. The board will be accepting applications from district residents interested in filling the position until 4 p.m. on Friday, May 30. See the notice on page 21 for more information.

The next meeting will be held on Monday, June 9 at 7 p.m. at the district office.

**In My Opinion: Stewardship Funding**

MADISON - State Representative Dan LeMahieu (R-Oostburg) was pleased with the Legislative Joint Finance Committee's decision to reduce the amount of bonding authority offered by the State of Wisconsin for the Stewardship Program.

LeMahieu said, "Members of the Finance needed to be commended for their vote on Stewardship funding as the committee is working toward reducing not only state spending, but also helping to put a stop to buying up large amounts of land by the State of Wisconsin."

According to the Legislative Fiscal Bureau, as of July 1, 2002, the DNR controlled a total of 1,408,730 acres of land, which represents approximately 4% of Wisconsin's total land area, while the Federal Government controls 1.8 million acres in

Wisconsin. Wisconsin's non-partisan Fiscal Bureau has stated that the DNR controls properties in 71 of the state's 72 counties ranging from less than one-tenth of an acre to more than 168,000 acres. The DNR has publicly stated their estimated goal of total state owned land to be approximately 1,825,600 acres.

Under the budget amendment passed on a 11-5 vote by the Legislative Joint Finance Committee, the Stewardship program would reduce bonding authority by \$245 million, reducing the amount of bonding authority from \$60 million to \$15 million in fiscal year 2003-2004, and from \$60 million to \$10 million in fiscal year 2004-2005. Beginning in fiscal year 2005, bonding authority will be set at \$30 million until the end of the program in 2010.

"Stewardship funding

was introduced and funding levels were increased during strong fiscal times, with the intent of acquiring land to expand recreational opportunities while protecting sensitive land areas?" LeMahieu said. "Furthermore, the Joint Finance Committee did not eliminate the Stewardship Program. Beginning again 2005, the State of Wisconsin may purchase land that is environmentally sensitive, while at the same time, yielding local land grants."

"Working with the biennial budget proposed by Governor Doyle, the Legislative Joint Finance Committee will be faced with a number of arduous decisions on state programs. As Wisconsin continues to maneuver through these tough fiscal times, I am pleased that the Finance Committee is willing to make tough choices creating a better tomorrow for Wisconsin's citizens," stated LeMahieu.

Representative Dan LeMahieu, who was elected to serve the 59th assembly district, currently serves as Vice-Chairman of the Assembly Committee on Urban and Local Affairs. In addition LeMahieu is a member of three other assembly committees.

**Kewaskum Frozen Foods Is Grand Champion**

Meat processing plants and meat markets from throughout the state this year entered 902 individual products into 33 product categories, including summer sausage, bratwurst, ham, bacon, smoked poultry and many other types of meat products.

Over 40 judges scored the

products for external appearance and eye-appeal, internal appearance, aroma and taste.

Wisconsin ranks third in the nation in total sausage production and is well known around the U.S. for

the quality of its meat products.

### Former Farmington Resident Vying for Sheriff Appointment

Now, here's a contender, Governor Doyle: Detective M. A. Joers, B.S., M.S., FBI National Academy trained in Police Management, undercover drug enforcer and drug abuse resistance instructor, patroller, former member of the State Fair Park Police Officer (now Capitol Police).

Law enforcer with twenty-five years worth of experience, twenty-two in the county; International Law Enforcement Exchange participant, community volunteer of many hours, including hunter's safety and church youth.

I'm sure glad I'm not in charge of weeding out candidates for Washington County's next sheriff. Did I forget to mention the above candidate is a woman? The widow of the former State Fair Park Police Captain?

Among the potential appointees are the acting sheriff, a state trooper and the former sheriff of Ozaukee County.

The detective has her work cut out for her. "I love Washington County," Marie Joers told me this week, before her interview with

the Governor. "We have a clean, ethical department, and I want to maintain that, to offer the best law enforcement to the people of Washington County. It's time for me to start using the skills I've trained for, particularly administration."

Marie moved her family to Farmington shortly after losing her husband, staying eleven years. "I worked second shift. Who wants to babysit those hours? My mother said they could help if I were closer, so we bought property from Jack Theusch and built the house."

In 1990, she was promoted to detective, with a more family-friendly schedule. Some of her fondest experiences involve teaching the DARE program to Farmington and Wayne Schools. She's the first to admit that when things don't go perfectly, like her first schoolroom lesson in which kids and balloons got out of hand, or the incident in which a delusional prisoner managed to overpower her and get away "clean," she finds ways to use the experiences to create better measures to handle potential problems. Marie has been commended for her handling of difficult cases of abuse, particularly of young victims. She currently speaks at groups and schools about harassment. Her affect on my own family has been wonderful. My boys don't even consider whether a woman can or should be in law enforcement. What a wonderful gift to pass down.

Marie is enthusiastically full of ideas for keeping the department running in tip-top shape, particularly with

continual policy review and the developing budgeting crunch. The amount of time left in Sheriff Theusch's term "gives a good chance to develop personality into the system." A former Officer of the Year, Detective Joers threw her hat into the ring after being encouraged by another member of the force. The appointment will run through January of 2007.

# Project Update



A view of the new lanes that are now in use. Milling of the old lanes will be complete by week's end.

The temporary lanes of traffic are now in use on the USH 45 reconstruction project.

Crews are now finishing the milling of the old lanes of traffic according to Jeanne Marchant, project engineer. Grading will begin after the milling process is complete.

Storm sewer work will then be the third step in the process of building the new lanes USH 45. That process, weather permitting should be finished up in two weeks.

Intersections at CTH H

W, Timblin and Prospect Drive will have been milled. Traffic will be limited to one lane but will always remain open until storm sewer is installed.

Work on the installation of the box culvert will start the first week in June. That project will be done in two phases, 1/2 of the culvert at a time with the east half of the box being constructed first. During the process both lanes will be open. Installing the whole box takes about 6-8 weeks weather permitting.

Seeding and the hand planting of 9,600 rootstock has begun as well.

Speeds in the village are 30 MPH and outside the village is 45 MPH.

### County to Survey Local Businesses and Residents

Through a joint effort by Washington County Planning and Washington County Economic Development, both divisions of the Washington County Planning and Parks Department, as well as several community and business representatives, a comprehensive survey regarding economic development will be conducted starting in May.

Randomly selected Washington County residents will be interviewed beginning the week of May 12th. The telephone survey will feature questions about quality of life in Washington County as well as determine views about residential and industrial growth within our community. Additional questions will ask about the residents' employment status and satisfaction with that employment status. A few additional questions address Internet usage in the home.

All businesses in Washington County should receive a mail survey beginning the week of May 19th. The purpose of the mail survey is to learn from business leaders what Washington County can do to help local businesses succeed. It is expected that the survey will

request information from participants about doing business in Washington County, future intentions and growth opportunities, workforce evaluation, notable short term change in local firms' viability, and current needs for development assistance.

Both surveys and interviews will be conducted through a partnership with UW-Oshkosh's Center for Community Partnership and UW-Milwaukee's Center for Urban Initiatives and Research. The responses received from the mid-May survey will initially be compared to the results of a similar survey conducted in late-2000 and early-2001. The survey is expected to provide Washington County with guidance for public policy decisions affecting local economic development programs. Additional surveys will be conducted of Washington County appointed and elected public officials, educational leaders and students.

### Harley Special Event Requirements

Warm weather brings out temporary food stands and this year, because of the 100th Anniversary of Harley Davidson, people have been inquiring about setting up campsites on their property. The State of Wisconsin Department of Health and Family Services (DHFS) regulate special event campgrounds and temporary food stands. Serving or selling meals to the public requires a permit and compliance with all state and local food safety regulations. Operations a campground also requires a permit and compliance with all state and local sanitation and safety regulations.

Prior to applying for a license, the operator must check with the local town, village or city about any zoning regulations or permits that apply to setting up a temporary campground or a temporary food stand. The operator must also contact the Washington County Planning and Parks Department at 262-335-4445 to be certain that the planned activity does not conflict with county code.

Once it is determined that the campground or temporary food stand is allowed by local codes, the operator must apply for a temporary campground permit or a temporary restau-

rant permit from DHFS. The Food Safety and Recreational Licensing Section of the State Department of Health can be reached by calling 608-266-2835 or by e-mailing [PlliceESS@dhfs.state.wi.us](mailto:PlliceESS@dhfs.state.wi.us).

The operator should check with his or her insurance prior to opening up a temporary campground or restaurant. If an illness or a physical injury should become associated with the campground or food stand, parties involved in the operation of the temporary campground or temporary food stand may be held liable for medical costs and damages. A copy of the campground code and the restaurant code can be obtained from DHFS. 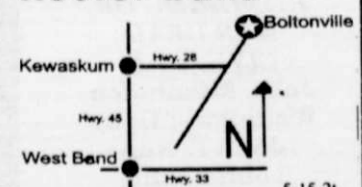

Lucas Martin to Graduate From U.S. Naval Academy

First Class Midshipman, Lucas John Martin, son of Larry and Louise Martin of Kewaskum, will graduate on May 23, 2003, from the U.S. Naval Academy in Annapolis, Maryland, where he has attended college the last four years.

Lucas is a 1995 graduate of Holy Trinity Catholic Grade School in Kewaskum and was valedictorian of the 1999 graduating class of St. Lawrence Seminary, Mt. Calvary.

On graduation day Lucas will attain the rank of Ensign, a military ranking that is earned only after rigid criteria has been achieved.

Because many of us are unfamiliar with the military and/or the Academy, and in the event that others might want to follow in Lucas's footsteps, he cordially explained the application process.

Competition to attend an academy is keen, but if you are of good moral character and have prepared yourself for a challenging, multi-dimensional four-year program and want to serve your country with distinction as a leader, you should apply.

Applying to an academy requires some time and effort. Besides reviewing your academic records, an academy admissions board will evaluate your medical and dental health, physical fitness, leadership potential and motivation. You must be recommended by teachers and nominated by at least one of the nomination sources. The academy goal is to ensure that the best qualified candidates from around the United States are selected for admission and that they have the drive and motivation to complete the

qualified scholastically, medically and physically with 1,511 offers of admission extended. The Class of 2003 began their Plebe summer with 1,232 midshipmen.

In July of 1999, Lucas started his four years of education at the Naval Academy in Annapolis, MD in exchange for five years of active duty as an officer. He started as a Fourth Class Midshipman (called "Plebe") and had a six week indoctrination period.

It was in this first year that Lucas had a great deal of transition to undergo, like not being able to speak at meals and having upper classmen spontaneously quiz you on military procedures. Much of the training at the Academy is done at Bancroft Hall, which also houses a 55,000 sq. ft. dining area called King Hall. To give you an idea of the magnitude of this place, 12,000 hot meals are prepared per day. In one hour, the kitchen can fry a ton of shrimp or broil 3000 hamburgers.

The strict military lifestyle, education, and military procedures continue to be taught throughout the four years at varying degrees, with more leadership qualities being exhibited in the later years.

Each year your class is given a new name, which designates what year you are currently in. The summers, however, are spent getting hands-on experiences. Lucas shared information about what his summers were like.

June of 2000, Lucas's first summer, was spent in Boston, New York and Newport, RI, experiencing a yard patrol boat and learning the basic introduction of seamanship and navigation.

In June of 2001, for the first half of the summer, he went to Australia and was attached to the USS Germantown DLS (Dock Landing Ship), and to various ports in Japan, which was an introduction to life aboard ship.

The second half of the summer he was introduced to aviation in Pensacola, Florida; to submarines in Kings Bay, Georgia; and, to

the Marines in Quantico, VA.

June, 2002 started in Norfolk, VA in an aviation squadron witnessing early warning aircraft and experiencing how the radar dome can detect other aircraft in the area. Lucas then had first hand experience at Cold Lake, Canada for three weeks in mock aviation flights along with several other countries. The balance of the summer was spent at the Naval Academy to utilize his leadership qualities by being the company commander for the indoctrination of approximately 150 incoming freshmen, and, spending three weeks at the London School of Economics, London as part of his major in quantitative economics, granted to him, only through the a recommendation from a professor.

One of the highlights of his four years was presenting his Capstone (like a thesis), "Analyzing the Campaign Game", at the military operations in Monterey, CA. This math paper, analyzing the use of the "Game Theory" of battle, with dynamic programming and linear models, was done jointly with professor Charles Mylander. It was also presented at the Air Force Academy in Colorado Springs, Colorado and will be published in MOPS (Military Operations Research), an academic journal, where it will be made available to the entire population.

Lucas will receive his diploma from Defense Secretary Donald Rumsfeld, graduating in the top 10% of his class of 994 graduates. After graduation he plans on a vacation in Italy.

Upon graduating, you have a choice of the branch of service and the speciality schools you want to pursue. Lucas' service area will be submarines and he will spend his first six months, when he returns in September, at nuclear power school in Charleston, SC.

Submarines are a self-contained entity powered by nuclear energy within, which helps their endurance and lets them stay deep in the ocean for long periods of time. Lucas is especially interested in this aspect of learning how to run a nuclear reactor, and, will spend additional months with hands-on training, running a simulated nuclear reactor.

He also will spend some time taking basic submarine training. After all this additional schooling, he will be stationed on a sub for three years. He is hoping to get in a larger "Boomer" nuclear sub which carries nuclear missiles, rather than a fast attack "Tomahawk" sub which hunts other subs.

Lucas feels the military is a great experience. He enjoys the traveling and serving with others. He sees the big picture of how the military impacts the world and he likes being one of the players. He is confident that the discipline and leadership qualities he has gained will prepare him for a diversified future, whether it be in the military or in the private sector.

In his four years at Annapolis, Lucas only got a chance to come home for major holidays and a few weeks during the summer.

The Martins have also been informed their daughter Lanaya, who will graduate from Brookfield Academy on June 1, has been appointed to the U.S. Naval Academy. She will be inducted into the Class of 2007 on July 1.

four-year program and to excel as officers.

All applicants must obtain a nomination from an official source during the admissions process. A nomination from an official source normally includes a U.S. representative, a U.S. senator or the Vice President of the United States.

Each congressman can only nominate ten applicants to each of the three Academies.

Of the ten selected by each congressman, one is chosen as a "principle" nominee. If you receive a principle nomination or a nomination directly from the White House, you are automatically admitted to the Academy.

Since Lucas did not receive this, he had to apply to the Academy for approval. Besides demonstrating his medical, physical and scholastic abilities, he also had to forward his high school transcripts and college boards, similar to other colleges, plus, have three letters of recommendation. Lucas was accepted, but many are not.

The Class of 2003 had 10,145 applicants, with 4,775 receiving an official nomination. 1,814 nominees

**EDUCATOR OF THE YEAR AWARD:** Michael Murphy will receive the Washington County Educator of the Year Award. The award will be presented by Dr. Wayne Schaefer, Professor of Biological Sciences at UW-WC.

Murphy is a man who has worn many hats in Wisconsin education during the past 28 years. He has served as a middle-school teacher, guidance counselor, Student Services director, Curriculum director, middle school principal and most recently grade school principal. **OUTSTANDING ALUMNUS AWARD:** Dr. David Brouillette will receive the Outstanding Alumnus Award from Dr. David Huehner, Steering Chairperson and Professor of History. Brouillette attended UW-Washington County from 1986 through 1988.

After completing his Associate Degree, he transferred to UW-Madison, majoring in pre-medicine, with an emphasis in biology and psychology. He then transferred to Palmer College of Chiropractic in Davenport, Iowa where he completed a Bachelor's Degree in general science and a Doctor of Chiropractic Degree.

Dr. Brouillette is a strong supporter of UWWC and believes that "the quality of education at UWWC was as good as, and in most cases, better than the other schools that I have attended since, especially in the area of direct professor contact and availability."

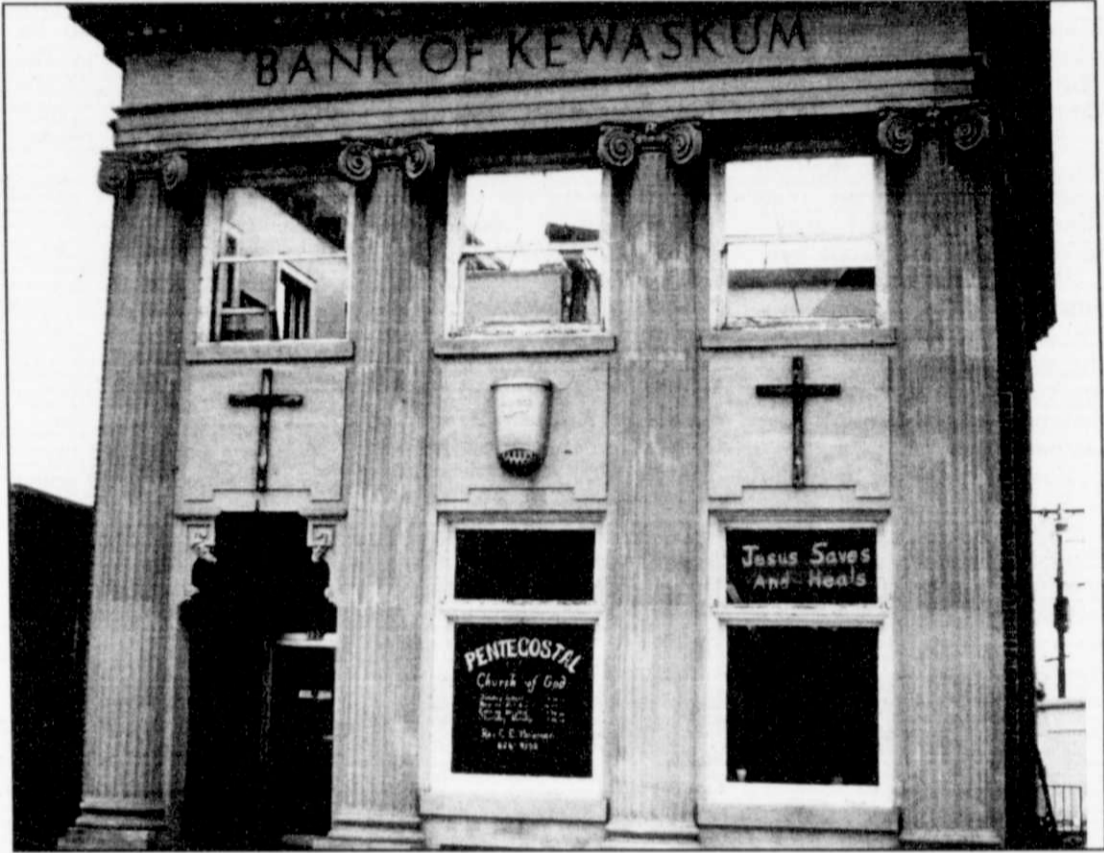

## Gypsy Moth Alert!

Now that the trees are flowering and starting to put out leaves, the gypsy moth egg hatch is right around the corner!

Gypsy moths are a non-native insect has been found along the eastern coast of Wisconsin for about 10 years, and are common in the eastern third of the state. If you live here, you or your neighbors probably have it.

Gypsy moths cause problems in many ways. First, they feed on the leaves of more than 500 species of trees and shrubs, defoliating about a million acres each year across the nation. The defoliation threatens tree health, and in some cases, killing trees. Second, defoliation can be a financial loss for property owners due to costs of treating gypsy moth infestations, removing and replacing dead trees, and by a loss in property values after trees are killed. Third, gypsy moth caterpillars can cause irritations and allergic reactions in some people. Finally, parks defoliated by gypsy moth often experience less use as visitors find the parks ugly and are 'creeped out' by abundant caterpillars, their droppings, and the nuisance they cause.

The gypsy moth has earned its reputation as an impressive defoliator for at least two reasons: its amazing reproductive capability and its unending appetite. A single adult gypsy moth female can lay up to 1000 eggs in a single egg mass. From the time that the caterpillars hatch from the eggs to the time that they complete their feeding (5-6 weeks), a single caterpillar can eat up to one square yard of foliage, the equivalent of more than 50 large oak leaves. Some trees in the southeast region of Wisconsin can have 20-50 egg masses on them. No wonder so many leaves disappear!

Gypsy moths spend approximately nine months in the egg state, from late July or August until the following May. Fortunately, gypsy moth egg masses are very recognizable. They can be up to 1 1/2 inches long and one inch wide (though smaller ones are common), and are often drop-shaped. The egg masses are hairy and look like tan or yellow felt. Egg masses can contain up to 1000 eggs, and each female deposits one egg mass. Egg masses can be found in many locations. In forests, they are found primarily on the trunk and the underside of tree branches. In residential areas, egg masses are found on almost everything - houses, gutters, firewood piles, birdbaths, lawn furniture, and vehicles. New egg masses are the only ones that will hatch this spring. New egg masses are firm while old egg masses are soft and lighter colored. Eggs typically hatch in late April or early May as

caterpillars.

Before starting to feed, some caterpillars (larvae) disperse throughout the forest in a behavior called ballooning. The larva climbs to the top of the tree on which it hatched, and dangles in the air on a silk thread. When a breeze catches the larva, the thread breaks and it is carried in the wind. Fluffy hairs and the silk thread slow the descent of the larva. Most larvae land within 150 yards of where they took off. A very small percentage of the population can be blown long distances, helping the gypsy moth colonize new areas. Once the larvae has finished ballooning, it settles down to feed. It will eat for five to six weeks depending on its sex. Females feed for an extra week to put on the fat necessary to produce eggs. About once a week the larva will grow too large for its exoskeleton and it will molt. These molts separate the larval period into five or six stages, called instars. Early in larval development, instars one through three, larvae feed during the day. Once they reach the fourth instar, however, they start to feed at night and hide under rough bark or in leaf litter during the day, possibly to avoid being eaten by birds. About 90% of the leaves consumed by a larva will be eaten in the last two instars. This is the reason it sometimes seems like trees are defoliated overnight.

When the larva is fully grown (about 1 1/2 inches for males and 2 1/2 inches for females), it starts wandering around, looking for a safe place to pupate. They look for a cranny where they will be safe from enemies like mice, birds, and parasitic wasps. Typical hiding places include between ridges or bark, under flaps of loose bark, or in cracks of outcroppings. They can also be found in crevices on the undersides of vehicles, in firewood piles, or on outdoor furniture. Once the larva has found a safe spot, it sheds its skin and its new skin hardens into a dark brown shell. The gypsy moth is immobile for most of the

pupal stage while its entire body is rearranged within the pupal shell. After a week or two, the worm-like caterpillar has been transformed into the winged adult moth which then breaks free of the pupal shell.

The gypsy moth adult male and female moths look very different from each other. Females are 1 1/2 inches long and are white with a black chevron on their forewings. Female moths can't fly and will fall to the ground if picked up. Male gypsy moths are mottled brown and gray and have large feathery antennae. They are similar in appearance to many native moths. They can be distinguished, however, by their behavior, as they fly in search of females in the late afternoon not at night.

The only function of the adult stage of the gypsy moth is to reproduce. Unlike many other moths and butterflies, the adult gypsy moth cannot feed. They have about two weeks to find a mate before they die. Once the male has found the female, they mate and the female lays all her eggs in a single-teardrop-shaped mass and covers it with buff colored hairs from her own body. A female that ate well as a larva can produce 600-1000 eggs in a mass about an inch and a half long. A female that starved in the last two weeks of larval development may only produce 50 eggs.

There are many techniques homeowners can use for the management of the gypsy moth. They include removing or destroying egg masses, using burlap or sticky bands to capture the caterpillars, and the use of insecticides. Information describing these and other techniques is available as pamphlets from a variety of sources, including those listed below.

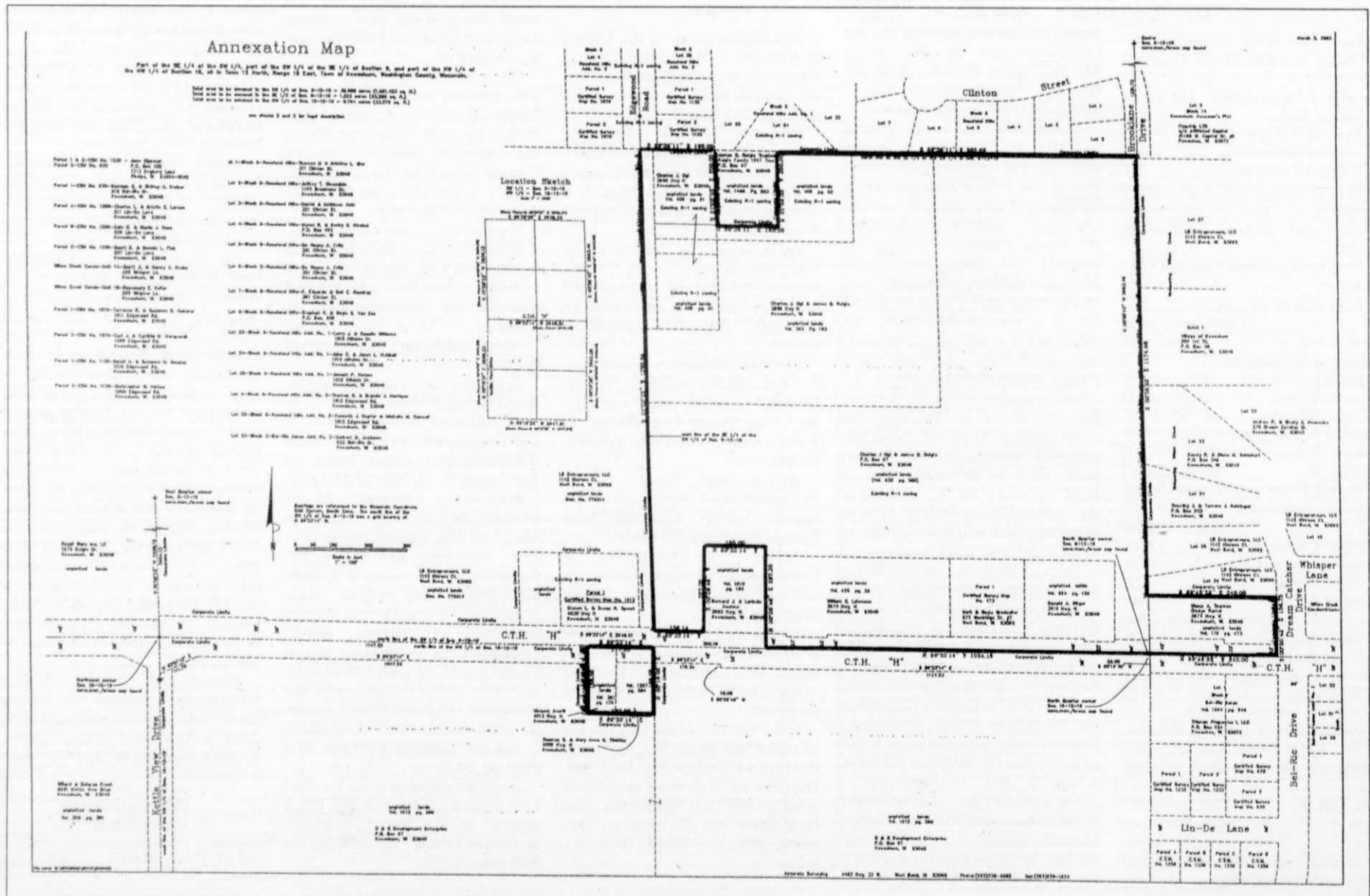

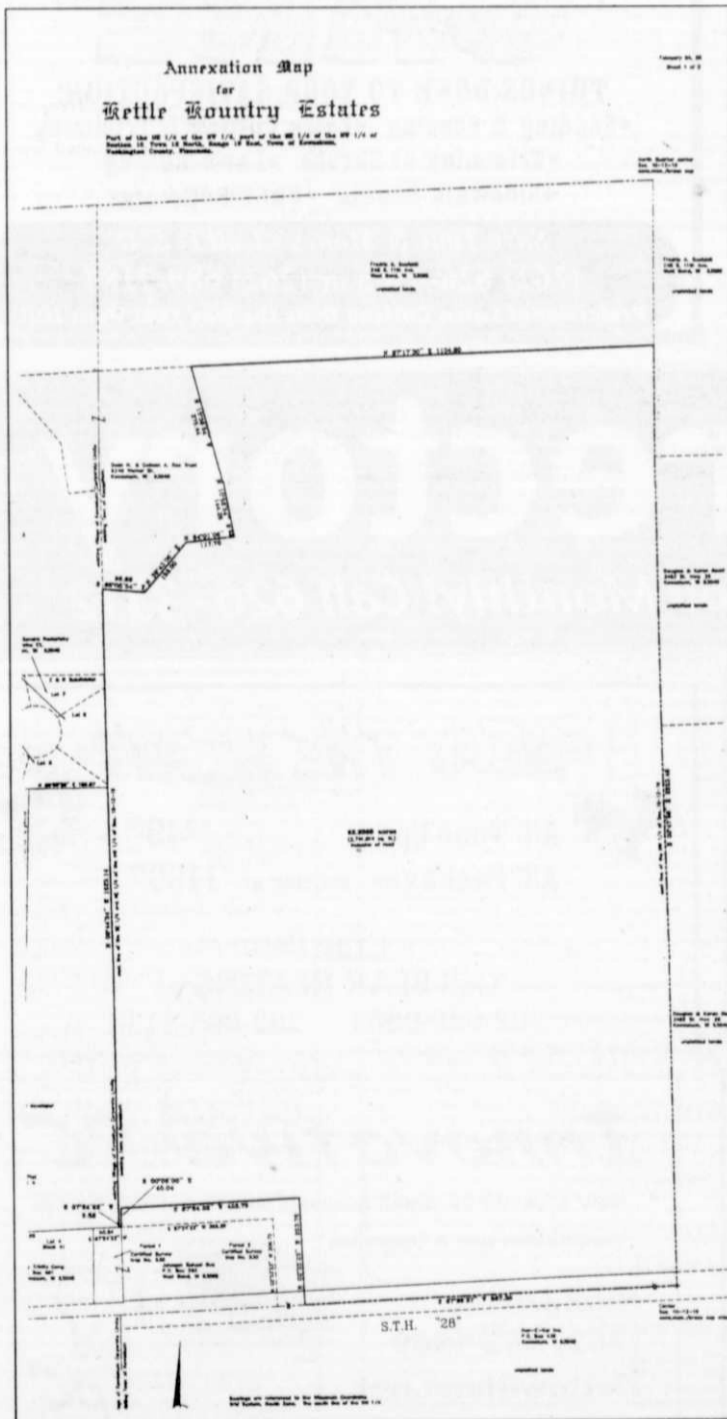

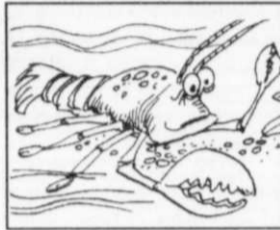
Tap dancing to the questions asked by the eight constituents present, the Congressman deferred most of his answers to that of contacting state and local representatives rather than presenting a federal perspective.

### RECYCLING TIPS

#### CORRUGATED CARDBOARD

6 of 7

**TYPE OF CORRUGATED CARDBOARD:** The cardboard that peels apart with two outside layers is corrugated. The middle section not exposed is wavy or corrugated.

**COLORS:** Some waxed and pressed cardboard may also be recycled.

**PREPARATION:** Flatten boxes and cut into 2'x2' pieces. Tie in bundles with twine or strong string. Bundles should be limited to 8" in height. Place bundles at the curb next to the dark green recycling bin or blue recycling bag. Place the bin or bag at the curb on the same day that your solid waste is to be collected. Pick up will be Wednesdays for both solid waste and recyclables. Multi-family dwellings of six or more, remember, your recycling pick up will be the 1st and 3rd Wednesday of each month.

**NOTE:** If raining on collection day, please hold cardboard until the following week.

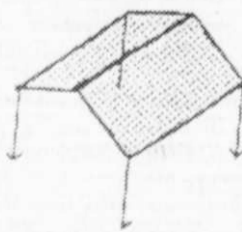

- Follow normal agricultural practices
- Be cooperative
- NOT charge any fees for hunting or access for the species enrolled
- Enroll in one of the two access plans: OPH (Open Public Hunting) or MHA (Managed Hunting Access)

To be eligible for compensation you must...

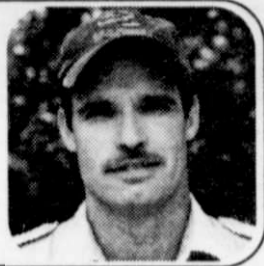
- Notify our office within 14 days of the first damage each year
- Follow the recommended abatement and all abatement points listed above
- Call each time you want an appraisal, 10 days prior to anticipated harvest date
- Comply with the permit requirements, if a shooting permit has been recommended
- Not plant crops to attract deer, geese, bear or turkey
- Maintain a hunting log, unless enrolled in OPH
- Land must have been in cultivation or approved program for at least five years.

## Baptism on the Chippewa Flowage

Hello Friends,

I had a problem that needed to be taken care of, and this past week, I did it. My 2-year-old daughter, Selina, had yet to go on a canoe camping trip. Also, my 5-month old golden retriever, Ice, needed some time alone with his master and his best friend, Selina.

So, I took this pair of pups on Sawyer County's 15,000-acre Chippewa Flowage for a three-day canoe and camping adventure.

**Friday, May 2**  
**High 69, Low 29**

Selina is in her second month of potty training, but not past the accident stage. In order to keep the training on schedule, I packed her portable potty in the canoe along with about 500 pounds of other gear.

We began our journey on the southwest corner of the Chippewa. My plan was a simple one: Find a comfortable island campsite, build camp, and spend the weekend hanging around the campfire exploring the flowage and training my pup.

Selina and I built a comfortable camp at a designated site on Cedar Swamp Island under picture perfect conditions of almost 70 degrees and sunny. Toward mid-afternoon, I decided it was time to take a bit of a tour with Selina and Ice. By this point, Selina had two accidents in the previous two hours and was now on her third set of clothes.

I had been paddling for about 10 minutes when she told me she wanted to help. Selina was wearing a life jacket and tethered to the canoe, so I figured, what the heck, and gave her a paddle. Selina is an outdoor person, a worker, who rarely gets cold. Unfortunately, she lost

her balance and fell head first into the Chippewa. She popped up like a bobber, and I immediately grabbed her rope and retrieved her.

Selina was okay until she saw her paddle floating away. That's when she started crying and pointing. I hit reverse, grabbed the paddle and headed back to camp. I stripped her down and put her in her fourth set of clothes, then built a campfire. Selina learned a valuable lesson today.

Wisconsin's inland fishing season opened today. I should be excited, but I wasn't. My priorities were on dog training, canoeing, cooking over a campfire, and dreaming about a moose hunt I had just booked for the fall.

The Chippewa Flowage is 93 percent undeveloped and reminds me of Canada. I spent much of the day fantasizing about moose being around every bend in every bay.

Today, when Selina, Ice and I went exploring, Selina never even came close to falling out of the canoe. Late this afternoon, I caught a very small walleye. By the look on Selina's face, you would have thought I had caught a world record. Ice, like all of the other golden retrievers I have owned, has perfect manners in the canoe.

I am concerned that I am not spending enough time with him. When I trained his mother almost 10 years ago, I was single and not dividing my time between a wife, four kids, 50 chickens, three steers, a cat and 55 newspapers. I have to buck up and do some serious training with this pup between now and when the leaves fall.

Something very signifi-

cant happened on this almost perfect week. Since my car accident in the middle of February, I have had problems on the left side of my head and with my left shoulder. Yesterday, when I arrived at camp, my shoulder was worse than ever. I was thinking it was definitely a long-term injury. It may be short lived, but the last two days of this adventure were relatively pain free, which helped ease my burdens.

On Sunday, we took our time breaking camp. I paddled into a 20-mile-an-hour wind for two miles. It nearly swamped us, but it was a sweet victory to meet and conquer the test. I now have a new veteran canoe camping crew!

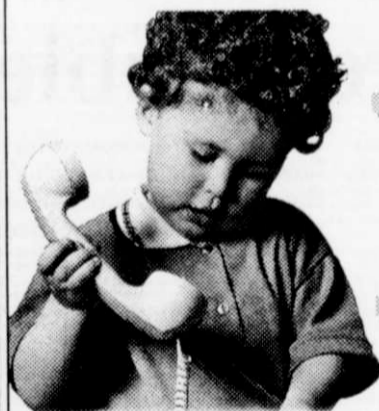

# KHS Golfers Weather the Conference Competition

After having two events washed out recently, the Eastern Wisconsin Conference boys golf coaches decided to play through the wind, water and cool temperatures on Wednesday, May 7th at Quit-Quit-Quit Country Club near Elkhart Lake.

Since Monday's event at New Holstein was rescheduled due to rain and wet course conditions, the host Plymouth Panthers and the Pro Shop Staff were determined to complete the nine hole mini-tournament as scheduled. With four league matches remaining and only ten days prior to the Conference Championships, it became paramount to finish the fourth conference event of the season to date.

Coaches paired up golfers by position and sent them off holes number one, six and ten as teams arrived at the 6,337 yard 18 hole track starting at 3:15 p.m. until approximately 4 p.m. A steady, cool rain did not deter those hearty scholastic linksters.

As most of the high school golfers were concluding their respective rounds, the varsity on the front nine and the junior varsity on the back nine, the rain finally subsided.

As individuals recorded their scores and coaches tallied their collective

totals, it became obvious that the two teams that lead the league and use Quit-Quit-Quit as their home course (Kiel & Plymouth) were separating themselves from the rest of the field but not from each other.

Therefore, Kewaskum was vying to capture third place once again as the Raiders won with a 155 total followed closely by the host Panthers at 156. The Indians did manage to secure third place overall with a team total of 171.

Leading the local linksters from Kewaskum were sophomores Josh Riebe (40) and Luke Koch (43) with senior Josh Timblin (44) and freshman Chad Pivoni (44) finishing right behind. But with Kiel and Plymouth boasting of several players in the mid to low 30's, the Indians realistically accomplished their goal of third or better in league contests.

Wednesday's results have firmly established Kewaskum in third overall with Roncalli and Campbellsport tied for fourth place in the E.W.C., three points behind the Indians.

The Indian junior varsity took third place at Quit-Quit-Quit as well with their highest team total (197) of the season, but remain comfortably in first place overall. The little Indians were paced by

Michael Schilter (47) and Adam Lehnerz (49) finishing five swings behind Manitowoc Roncalli (192) and two strokes in back of the Plymouth J.V. Panthers (195).

Heading into this week's matches, both Indian teams anticipate securing their position within the league standings and possibly overcoming some conference leaders when they compete at Hon-E-Kor on Thursday, May 15th. But the Indians had to travel to Two Rivers on May 12th and New Holstein on May 16th, before they can conclude with their conference championship 18 hole tournament back at Quit-Quit-Quit Golf Club.

Any further postponements or rainouts could result in the conference tournament to be delayed to next week to allow the teams to complete their scheduled mini-tour events prior to conducting a meaningful conference championship.

The season wraps up with the W.I.A.A. Regionals at Camelot on May 27th and the W.I.A.A. Sectionals to be conducted at Hon-E-Kor on Tuesday, June 3rd. The playoff series concludes at the W.I.A.A. State Tournament at University Ridge near Middleton on June 9th and 10th.

# Slow Down In Work Zones - Fines Are Double

Orange and black are prevalent fall colors often associated with Halloween. But in warm weather months, these colors signify a different season - road construction. As the bright orange barrels and signs with black lettering begin to appear on interstate and other highways, drivers should remember that work zones are very congested spaces with heavy equipment and workers just a few feet from traffic.

"Because of many unpredictable hazards and obstacles due to construction, speeding in work zones is irresponsible, dangerous and expensive," says Captain David Pichette of the Wisconsin State Patrol District Three Headquarters in Fond du Lac. "Work zones frequently have narrow lanes and uneven pavement, in addition to workers and equipment near the lanes of traffic. Driving through a work zone can be challenging under the best of circum-

stances, but your reaction time and margin for error are reduced significantly if you speed."

Rear-end collisions are the most frequent type of crash in a work zone. These crashes are caused primarily by inattentive driving, following too closely, and driving too fast. In the past five years, work zone crashes averaged about 2,000 per year in Wisconsin with an average of 11 fatalities annually. Most of those killed in work zone crashes are motorists.

To reduce crashes and protect workers, fines for traffic violations in work zones are double the usual amounts when workers are present.

"The minimum fine for speeding in a highway work zone, with court costs and other associated penalties, is \$175.40. In a freeway work-zone, the minimum goes up to \$225. You also could have between three and six demerit points added to your

driving record, depending on how fast you're traveling at the time," Captain Pichette says. "State Patrol officers are specifically assigned to many work zones, making sure your speed is safely reduced as you pass through. Speed limits in work zones will be strictly enforced."

## Graham Breaks Pole Vault Records KHS Girls Take Third At Vanderpan Invite

**SHEBOYGAN FALLS** - The Kewaskum High School girls track team finished third with 108 points Friday night at the 33rd annual Vanderpan Invitational. Host Sheboygan Falls won their invitational by amassing an impressive 146.5 points compared to runner-up Oostburg's 128.5 points. Team depth was a huge factor in determining the outcome of the meet. Both Kewaskum and Sheboygan Falls each won five events. Oostburg didn't win an event, however, they picked-up seven second place finishes and five third place finishes to capture the runner-up spot.

Howards Grove finished fourth just one point behind Kewaskum followed by Sheboygan North and Plymouth tied with 65, Elkhart Lake with 46 and Southern Door with 29.

Jessi Graham set a new KHS record and new meet record in the pole vault by

clearing 10 feet. Tanya Weber of Sheboygan Falls placed second at 9 feet. Katie Patterson, replacing injured teammate JohnnaJo Schicker, placed fourth based on misses with a personal best 8' 6". The KHS record was jointly held by Graham and Schicker at 9' 9" set earlier this season. The previous meet record was 9 feet set by Weber set in 2002.

Amanda Donath continued her impressive season by winning the 400m dash with a personal best time of 1:00.9 - just 0.5 seconds off the school record.

Amanda Donath and Jessi Graham teamed with Becky Herriges and Breyan Donath to win the 4 x 200m relay with a season's best time of 1:50.9. Breyan Donath held off Oostburg's fourth runner in a heated battle to anchor the Kewaskum foursome to victory. Oostburg was timed in 1:51.1.

Jenna Roecker was up to the challenge as she won the

100m high hurdles with a season best time of 16.6 seconds. Roecker and Weber of Sheboygan Falls both had seed times of 16.8 seconds coming into the meet, but Roecker improved her time to win and Weber struggled to a third place finish.

The Kewaskum 4 x 400m relay team of Jenna Roecker, Jessi Graham, Becky Herriges and Amanda Donath continued their improvement by dropping five seconds to win with a season best time of 4:14.2. Oostburg and Sheboygan Falls finished 2-3 with times of 4:20.8 and 4:25.9.

Kewaskum only picked up two second places. Rachel Dums finished second in the low hurdles with a time of 50.3 seconds and Amanda Magnus placed second in the long jump with a distance of 14' 10". Graham also placed fourth in the 400m dash with a time of 66 seconds.

Jessi Butler continued to improve in the 100m dash finishing fourth in finals.

The 4 x 800m relay team of Tami Dorzok, Rachel Shea, Jenny Bischoff and Nicole Stern finished fourth with a season best time of 11:26.1.

Roecker also finished fifth in the 300m low hurdles with time of 51.0 seconds and seventh in the triple jump with a distance of 28' 7.5". Herriges placed fifth in the long jump with a distance of 14' 4.5".

### Meyer Ties KHS Record In 800M Run KHS Boys Track Team Takes Third at Vanderpan

SHEBOYGAN FALLS - Plymouth won the 33rd annual Vanderpan Invitational Friday, May 9th, by amassing an impressive 156 points. Plymouth demonstrated that they are a power in the Eastern Wisconsin Conference and that they are ready to challenge New Holstein for the EWC title. Oostburg won four events and finished second with 130 points. The Kewaskum High School boys track team had their highest finish in over twelve years as they finished third with 104 points. Sheboygan Falls finished fourth with 100 points followed by Southern Door 84, Howards Grove 69 and Elkhart Lake 48. Kewaskum finished sixth last year.

Kewaskum and Plymouth each won three

events. But Plymouth picked up six second place finishes compared to just three for Kewaskum.

Kewaskum School record when he finished second in the 800m run with a time of 2:02.0. Ryan Wachter of Plymouth won with a time of 2:00.8. The KHS record also held by Chris Donath set in 1989.

The Kewaskum 4 x 100m relay team of Matt Hartmann, Andy Lickel, Adam Woebeking, and Josh Uelmen finished second with a season best time of 45.1 seconds. Sheboygan Falls won the 4 x 100m relay with a meet record time of 44.8 seconds.

Mike McKee and Kurtis Cochran placed 2-3 in the pole vault by each clearing 12' 6". Jacob Kruger of Plymouth set the meet record with a winning height of 13' 10".

The 4 x 200m relay team of Uelmen, Hartmann, Woebeking and Lickel finished third with a season best time of 1:35.4. The 4 x 800m relay team of Eric Nass, Nick Bartley, Zack VanWormer and Alex Herriges also picked up a third place finish for Kewaskum with a time of 9:00.4.

The Kewaskum 4 x 400m relay team provided a lot of excitement at the end of the meet by edging host Sheboygan Falls for third place. Garrett Donath, David Wicklund and Adam Woebeking teamed up with Josh Meyer for a season best time of 3:36. Meyer ran an impressive 51.9 second anchor leg for Kewaskum.

Hartmann, competing for the first time in the long jump, placed fourth with a jump of 18' 5". Hartmann also finished fifth in the 300m intermediate hurdles

with a time of 43.5 seconds.

Donath and Wicklund finished fifth and sixth in the 400m dash both with personal best times of 54.0 seconds and 54.3 seconds respectively. Uelmen officially ended up sixth in the 100m dash after an apparent fourth place finish with a time of 11.5 seconds.

Alex Herriges continues to improve in the 800m dash finishing with a personal best time of 2:08.8.
