One of the original founders of Kewaskum's now famous family fall festival, Kettle Kountry Kolors, has stepped up to the plate to take over the annual festival that was dropped earlier this year by the Kewaskum Area Chamber of Commerce.

A newly formed group calling themselves Friends of Kewaskum was formed to promote the Kewaskum area. Lana Harbeck Kuehl, Editor/ Publisher of the Kewaskum Statesman Newspaper, started the idea for the group. She, along with a group of community minded individuals announced earlier this month that they will continue the tradition started 13 years ago. Harbeck-Kuehl will chair the festival with the help of many committee chairpeople.

Though this year's festival will be smaller, her committee promises it will continue to dazzle to all that attend. Now if only the group can get Mother Nature to chair the weather committee things should be set.

The new board member will sit on the board until next April and then be up for election.

Kewaskum Qualifies Eight For State Track Meet

The Kewaskum High School girls' track team qualified seven girls; three in individual events and one relay at the WIAA Sectional Track Meet held here on Thursday, May 29. Kiel won the sectional by scoring 79 points, followed by Milwaukee Lutheran 59, Chilton 55, and Kewaskum 54. Over thirty schools participated in the meet. The top three finishes in each individual event and relay qualified for the state track meet at UW-LaCrosse June 6-7th.

Jessi Graham won the pole vault and set a school record by clearing 11'. Graham had just established 10' 3" as the school record just two days earlier at the regional meet. Teammate Johnnajo Schicker cleared 9' 6" to place second for Kewaskum. "I'm so proud of both girls. They have had an amazing season," commented KHS pole vaulting coach Nate Wesemen.

Amanda Donath continued her impressive season finishing second in the 400m dash with a school record time of 59.7 seconds.

The previous school record of 60.4 seconds was set by Ginger Wiesner in 1992. "She was in about fifth place with about 200 meters to go when she started to catch people. She is so strong that she powered herself physically and mentally past three runners down the stretch to finish second and qualify for state. Her goal all season had been to break the KHS 400m dash record and she did right here on her home track," reported head coach Jerry Gosa.

Rachel Dums continued to make impressive improvement in the 300m low hurdles. Dums finished second in the 300m low hurdles with a personal best time of 47.7 seconds.

The Kewaskum 4x1600m relay team of Jenna Roecker, Graham, Becky Herriges and Amanda Donath finished second with a season best time of 4:08.8. This is the third year in a row that the Kewaskum girls' team qualified the 4x400m relay team for the state track meet.

Graham ran the second leg of the relay and put the relay team into third place, while Donath anchored the unit to a second place finish by running a sub 60 second



400m for the second time that evening.

Troy Koerferl finished

third in the shot put and qualified for state with a throw of 50' 8.25". Koefler was the only boy to qualify for the state meet. David Cibulka placed fifth in the discus with a throw of 144' 5".

Grafton won the boys sectional title by scoring 114.5 followed by Milwaukee Lutheran 63, Mayville 43, Dominican 40 and Brown Deer 38. Kewaskum finished 15th with 18 points.

Josh Uelmen finished 10th in the 100m dash and Mike Wagner also finished 10th in the 100m high hurdles and both did not qualify for finals.

The Kewaskum 4x 200m relay team of Josh Uelmen, Andy Lickel, Adam Woebbeking and Matt Hartmann finished sixth with a season best time of 1:33.6. The same foursome who ran a season best time of 44.9 seconds on Tuesday at the regional track meet struggled with a hand off and finished 11th with a time of 45.7 seconds. "They were very disappointed. They know

that they could have done better but it just didn't work out tonight," reported coach Jerry Gosa.

Hartmann also finished sixth in the 300m hurdles with a season best time of 41.8 seconds and just missed finals in the long jump when he finished ninth with a jump of 19' 4".

Josh Meyer finished seventh in the 1600m run with a time of 4:41.6 - off his season best time of 4:35.3. David Wicklund finished 13th in the 200m dash with a time of 24.0 seconds.

The Kewaskum girls' 4x 200m relay team of Amanda Donath, Jessi Graham, Becky Herriges, and Breyan Donath just missed qualifying for state by finishing fourth in a season best time of 1:50.0. A poor baton exchange caused an addition of time.

The Kewaskum girls' 4 x 100m relay team also didn't fair well as they too experienced a bad

exchange of the baton causing a 10th place finish. The team of Jessie Butler, Katie Patterson, Amanda Magnus and Rachel Dums, all sophomores, had a season best time of 53.0 seconds and will have time next year to work on their baton exchanges.

Jenna Roecker finished fifth in the 300m hurdles in 48.6 seconds and sixth in the 100m high hurdles with a time of 16.6 seconds.

Becky Herriges finished ninth in the long jump at 15' 2.75" and Breyan Donath finished 11th in the 200m dash with a time of 27.3 seconds. Kayla McCormack finished 13th in the high jump at 4'6".

I'll get my living room back - my living room that will grow a little more dusty each week. I'll miss their laughter, their games. But I know that they will take with them the most precious memories. They will take along the habit of prayer, and of finding people to care about and be with wherever they go.

Yeah, it's worth giving up my comfort once a week. When's the first college

break?

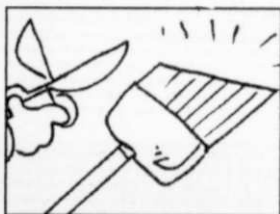
need YOU to help make the club an asset to the community. This year, we had six new members join them in their social meetings and two fundraisers.

Town of Farmington Plan Commission Holding

"We have to stop the bus!" has been Supervisor Ike Roell's rallying cry since last March.

The bus is stuck. On calls of "sabotage" by the ones responsible to finalize the six-year effort to get the Town zoning ordinances up to date, to "irresponsible" throwing out years of hard work, about forty residents heard the discussion on May 27. The Town Board passed a vote to look into the issue of a zoning moratorium, which passed the ball back into the Plan Commission hands.

"A moratorium would be a good thing right now, because different kinds of people are coming in - professional people, developers," said John Guttman. "We need to get our town on the level they are. Being a member of the Fillmore Fire Department, in looking at (three new subdivisions), it's going to be a strain. We're all volunteers." When a community member commented that they could add on new members as well as building, Guttman replied that the station is currently landlocked. "There is no room to add on."

Roell stated that that "we need to get a whole picture of what's going on in this township. No one is throwing any plans out, or saying that the moratorium will last for two years. This whole thing is like looking into a muddy stream. Maybe we'll have a better handle on the development that's coming."

"I'll say it right out," said Joe Enright, newly elected chairman. "I'm not in favor of the moratorium. It's our own lawyers that are holding us up. We would more than love to have that plan here so we can get this worked out. We have a lot of smart people here." He called a tow truck of sorts when he directed the town clerk contact Attorney Harvey and get the zoning ordinance back.

Concerns about the growing tax burden for the residentially zoned lands, and keeping Farmington "great" were addressed by the commissioners. Enright called for a stop to any action on development by the Plan Commission until they get the zoning ordinance. In a passed recommendation to the Town Board, the Plan will read and review the ordinances before recommending them for acceptance to the Board. "We

can't vote on what we don't know."

None of this phased developer Mark Mulvanny who even that afternoon continued to review his plan to develop the Rex farm property on Highway H and XX with county officials. "Rampant" rumors had him planning for 90 houses (he's only proposing 80) and on lots "no less than 1.25 acres, exceeding what is currently on your books." Since the county would not allow egress onto H, according to a plan commissioner, heading "into your community, which looks like a downtown," he's changed access to County XX. He's including professional engineering, landscaping and berms with trees. Mulvanny also stated that he wanted to work with the fire department. "I'll build onsite underground storage tanks on my property," he offered.

"All this is not going to happen in one-two months," said Roell after the meeting. "We've got to move this along. There are so many options as to density, how many buildings to plan for, ag zoning and looking into other town plans. There are a lot of packages available."

Bolton Drive to be Closed

County Trunk Highway DD or Bolton Drive will be closed to all traffic from STH 144 northerly to Scenic Drive in Boltonville for two weeks beginning June 16, 2003. Washington County Highway forces will be replacing the bridge over Stony Creek.

Since the existing bridge will be removed there will be no traffic through the construction area. Access to abutting properties will be maintained via Bolton Drive from either north or south of the project site. No detour route will be posted. Additionally, this project is dependent on the weather so actual start and completion dates could vary.

The new bridge will be a pre-cast concrete arch sitting on a cast-in-place footings. The Washington County Highway Committee selected this type of structure for several reasons. By having the concrete sections pre-cast off site the length of time the roadway will be closed to traffic is dramatically shortened. Additionally the arch type structure will

allow construction to occur with limited disruption to the bed and banks of Stony Creek.

Once the new structure is in place the roadway will be reopened to traffic with temporary pavement in the area of the bridge. Highway department employees will then do selective tree removal and ditch cleaning within the right of way of both sections of CTH DD - Bolton Drive and Pine Lane.

Later this construction season, the existing pavement on both sections of CTH DD - Bolton Drive and Pine Lane - will then be pulverized and repaved. Payne and Dolan will do the pavement project under contract with the Washington County Highway Commission.

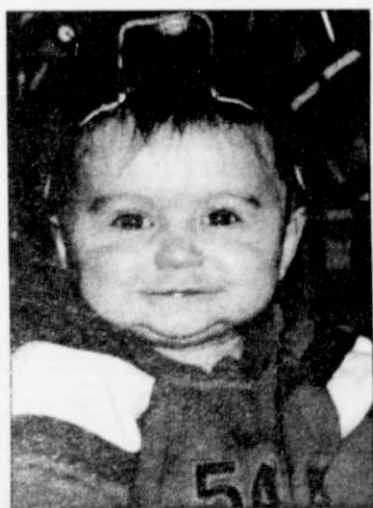

Beechwood Fire Dept. Celebrates 90 Years of Service to Community

In 1905 Beechwood, Wisconsin had a population of 125 people. The town consisted of two churches, a school, a doctor's office, two general stores, two blacksmith shops, a wagon shop, a creamery, cheese factory, two halls, a saloon, a dozen homes and storage buildings. It had no fire protection.

After a disastrous fire in early June 1913, two Beechwood residents solicited the community for funds to organize a fire department. By the middle of June they had contacted 105 donors, and collected \$790. That money was used to buy a horse drawn, hand operat-

ed water pumper. The pumper will be in this year's Beechwood parade.

A news account of January 17, 1914 tells that several members of the fire department hauled stones for the foundation of their 18' x 30' firehouse, which was built in the spring. The logs and all labor were donated.

The first department picnic was held on August 13, 1915. It produced \$339.43 for the treasury. Several more picnics and events were held, and by 1921 the department was able to buy a 1917 Jeffrey motor car they rebuilt into a fire truck. Horses were borrowed from

nearby barns, or even from buggies along the street whenever there was a fire emergency.

In the 1930's the fire department bought a 1938 Ford truck, and built it into a fire truck. It was used until 1967. The department now had a 500-gallon pumper, hoses and chemical tanks. During these years even whey tank drivers would respond to a fire and contribute loads of whey to fight a fire.

In the 1940's the department bought land, and began clearing it for a park so that picnics could be held there. An area was leveled to lay a wooden dance floor.

Admission charge was 42¢ and 8¢ tax.

In 1947 the department joined the Eastern Wisconsin Firemen's Association, covering Sheboygan, Calumet, Manitowoc and Ozaukee counties. Membership has continued to the present time.

In the 1950's Beechwood joined the Badger Firemen's Association covering Fond du Lac, Washington and Dodge counties. The association provided information and professional training for the firefighters.

In 1954 the department bought a 1949 Studebaker truck with a 1250-gallon water tank, a 500-gallon pumper, and a thousand feet of 2 1/2 hose.

In the 1960's the first (1963) parade was held, 50 years after the department was organized. In 1966 first aid, oxygen and resuscitator equipment was added to the department reflecting the addition of emergency care to its fire fighting responsibilities.

In 1967 the department bought an F-750 Ford truck from Adell Motors. This truck had a 750-gallon per minute volume pumper and high pressure pump capable of operating fog hoses.

House numbers and central call systems to Sheboygan were set up in 1968.

In the 1970's a siren system was placed in the Beechwood Rest Home for the town.

In 1975 the Beechwood Auxiliary was organized. At that time 25 women were assembled. In the beginning they raised funds for the department through dances,

raffles, bingo, picnic, games, and the sale of food and a cookbook they had published. The Auxiliary provided holiday entertainment for the young children in the community.

In 1976 there was a terrible ice storm that left the community without power for days. The fire department provided a warm community center in the fire hall. Heat, water and donated food prepared by the Auxiliary members were available.

In 1978 it was recommended to spend \$10,000 to purchase radios and pagers. This was the beginning of a rapid communication system without dependence on someone to sound the siren button.

In the 1980's major purchases were 10 turnout sets, but the largest expenditure was to ask the Town of Scott board for a loan for the construction of a new firehouse. In 1986 an 84' x 84' steel building was erected on the East Side of the Firemen's Park. This building had five bays. In 1990 a meeting room was added to the firehouse. In 2000 the firehouse saw an addition of two truck bays.

In 1998 the department purchased a tanker truck (#15) and the Town of Scott and the Department in 2000 purchased a tanker truck (#16) and in 2002 an equipment van (#17).

The department has also purchased 10 air packs, and 35 sets of turn out gear with funds raised from both fundraisers and its annual Firemen's picnic.

The department now has 34 active members, and 26 honorary members. There have only been seven acting (dedicated) Chiefs in the 90 years of the department. In the early years there was little formality or keeping of records. Art Koch or A.C. Hoffman may have been the first chief. From 1930 until his death in 1950, Arthur Staeger was chief. From 1950-1972, Art Fritz, from 1972-1977 Vernon Staeger, from 1977-1992 Roger Vetter and from 1992 to the present the chief has been Mark Muench. The department continues to hold several fund raising events each year. The funds raised at these events continue to go towards purchasing department gear and appa-

Notices are also sent to the Kewaskum Statesman, official newspaper for the Village, WBKV radio and the West Bend News.

The Kewaskum Water Utility routinely monitors for constituents in your drinking water according to Federal and State laws. The following tables show the results of our monitoring for the period of January 1st to December 31st, 2002.

Health Information

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife. Inorganic contaminants such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming. Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses. Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems. Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which shall provide the same protection for public health.

The Village Board of the Village of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council room of the Municipal Building, 204 First Street.

President Mathew A. Heiser presided. All other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and the Pledge of Allegiance.

On a motion by Trustee Kevin Scheunemann, seconded by Trustee Thomas Piwoni and unanimously carried by voice vote, the minutes of the April 21, 2003 were approved as printed.

President Mathew Heiser, called the public hearing on the request to change the zoning for the subdivision Woodland Creek for Jim Wessing for the property adjacent to 1701 Fond du Lac Avenue (located southwest of the intersection of STH "28" and USH "45") of the Village of Kewaskum, Wisconsin, (V4-0003-00Z), from AG-1 Exclusive Agricultural District and C-1 Conservancy District to R-1 Single Family Residence District, R-3 Two Family Residence District, R-4 Multiple Family Residence District and C-1 Conservancy District. Mr. Jim Wessing explained the proposed development and reviewed the layout with the Board and others in attendance. Trustee Andy Pesch indicated the Plan Commission reviewed the request and sent it forward with a favorable recommendation. Several questions were asked in reference to future or potential water problems. It was noted that steps are being taken to prevent problems by having the developer's engineers as well as the Village's Engineers review the plans to prevent any such actions. Discussion was held on the proposed county trunk highway construction on the west side of the property. Mr. Wessing indicated they would be working with the Village to create a natural area adjacent to the already developed Knights Avenue Park. Roll call vote was 6 "Aye" 0 "Nay" 0 "Absent."

Action was taken on Ordinance No. 2003-07 An Ordinance to Amend the Zoning of the Village as heard at public hearing for Mr. Wessing (Woodland Creek Subdivision) as attached hereto:

Discussion was held on the Ordinance No. 2003-11 An Ordinance to Amend Chapter 10 Animals at the requests of Trustee Kevin Scheunemann, Trustee Steve Scheunemann, as well as Gregory Bernau and Scott Konzal of 1434 Parkview Drive. The proposed amended ordinance would allow for the keeping of miniature potbelly pigs, clarify definitions and address the wild animal issue. Trustee Kevin Scheunemann asked the Administrator to explain the proposed changes. Scott Konzal spoke

In Memory Day- American Heros Honored At Vietnam Veteran Memorial

Ever since 1993, Founder and President of the Vietnam Memorial Fund Jan Scruggs has made it a mission to recognize veterans who have passed away as a result of "their service, but who do not meet the Department of Defense requirements for inscription on The Wall."

Since the Memorial was built, a little known roll has been kept - one that few knew existed. This separate "wall" of names was begun and added to as the death toll mounted - now on friendly soil. Veterans who were exposed to toxic agents, terrible wounds that did not take their lives immediately, and post traumatic stress, passed away after their tours of duty. These veterans did not die of wounds suffered in combat zones, and will not be inscribed on The Wall with the 58,229 others.

A separate ceremony held on the third Monday of April at 10:00 a.m. honors these veterans. Begun as a grass roots movement, it is held at the site of the Memorial and eventually became publicized by the Memorial Fund. The Memorial Fund collects applications through the

end of February each year. Family members and friends who would like their loved ones remembered send a copy of the death certificate and military records showing service in Vietnam with an application. Applications can be obtained through phone request: 202-393-0090, or through the Memorial Fund website. "It's impossible to say to what degree wartime service should be blamed in deaths years later. If a family makes a reasonable case, the name is accepted," said Holly Rotondi, applicant reviewer.

"The annual ceremony brings together families and friends who have sustained similar tragedies, allowing them to share stories and to start the process of healing," said Scruggs. During the ceremony, family members read aloud their loved one's names in chronological order by date of death. Following the ceremony, participants lay tributes at the black granite panels that correspond to the honoree's dates of service in Vietnam so that these veterans come to rest with the comrades with whom they served.

At this spring's ceremony held on April 21, Truman Ray Johnson, late husband

of Irene M. Johnson, formerly of Kewaskum, was honored. The Johnsons lived in Holder, Florida. Seventeen veterans from Wisconsin were also named in the ceremony, the largest to date, contributing nearly 400 honorees to the In Memory rolls. Over 1,000 veterans have been added since 1993. Speakers were Lt. Gen. John S. Caldwell, Jr., David F. Addestone, Founder of National Veterans Legal Services and Earl Hockaday, brother of a former honoree. Congress has authorized the American Monuments Commissions to erect a commemorative gray granite plaque at the site of The Three Servicemen statute with the inscription, "In memory of the men and women who served in the Vietnam War and later died as a result of their service. We honor and remember their sacrifice."

Separate legislation is currently underway in the House and Senate to authorize the building of a Visitor Center at the Wall site. The 10,000 square-foot center would serve as an educational area featuring photographs and items left at the wall.

Serving in Vietnam "was one of the most important things in my life," said local

Vietnam Veteran Ike Roell. "The light is a different color." He finds honoring those who died as a direct result of their combat service as a good thing. "The guys on the wall were the ones popped off. Life is a different window" for those of us who served. "No one can take that experience away."

Because of their service, free people worldwide owe a debt. The least we can do is respect their memory. For more information, visit www.vvmf.org, the Vietnam Veteran's Memorial Fund website.

On Friday, May 16th all eight Eastern Wisconsin Conference Schools participated in a rain makeup match at Badger Creek 18 Hole Golf Course near New Holstein. The original May 9th date proved to be unplayable, therefore the league members reconvened on the following Friday. The conditions were much drier but unfortunately it was very cool and windy on the 6,392 yard, par 72 layout. The varsity competed on the back nine with the junior varsity playing on the front nine, both par 36.

The Kewaskum Indians held a five to six point lead over Campbellsport and Manitowoc Roncalli for third place overall as Plymouth and Kiel are separating themselves from

the rest of the league's linksters.

The Indians however, lost ground by finishing fourth behind the Roncalli Jets as well as the top two conference teams Plymouth and Kiel. Pacing the boys varsity was junior Brandon Gitter with a 41 and senior Josh Timblin with a 43. K.H.S. added five strokes to their team scoring average to date to total a 175 to Roncalli's 171, Kiel's 159 and Plymouth's 157. Campbellsport dropped to eighth place by virtue of their 184 team score, which was higher than Kiel's junior varsity total.

The JV Indians finished third but still maintain their overall lead in the conference standings. The little Indians were led by sophomore Luke Koch's 45, fresh-
