V. Board Lock Up Borrowing Power

The Kewaskum Village Board approved a \$3 million borrowing plan at a special meeting held Tuesday, June 24 in anticipation of the planned and proposed capital projects already engineered and others in the process of being engineered. At that meeting village administrator, Daniel Schmidt, informed the board he thought this was the right avenue to take with the possible tax caps being imposed by the lawmakers in Madison. With the anticipated projects on the table, joint commitments made the states action will only add additional cost and time delays.

The budget bill that the Legislature approved late in June would prevent counties, cities, villages and towns from increasing property tax levies for three years, except to accommodate growth from new construction.

If it becomes law, the plan would mean that communities would not be able to borrow money to pay for large expenditures for capital improvements.

That law could put the village in a financial bind. Without borrowing funds now to pay for plans with

Washington County to do work on the sanitary sewer on Riverview Drive from Main Street to the county line on CTH S the project might not be completed. The project also would give that stretch of road a complete facelift.

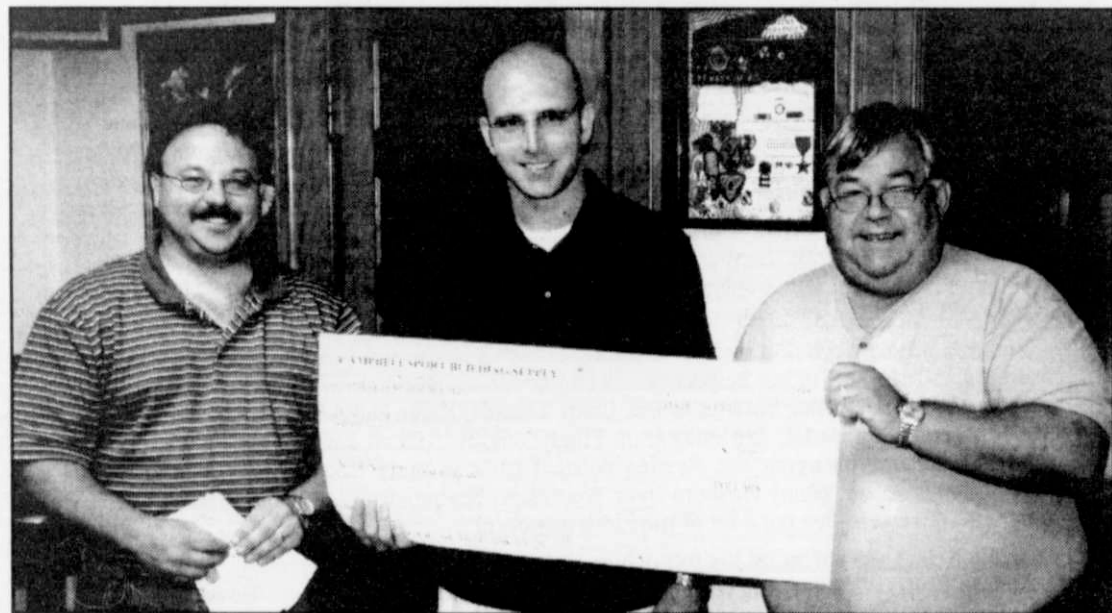

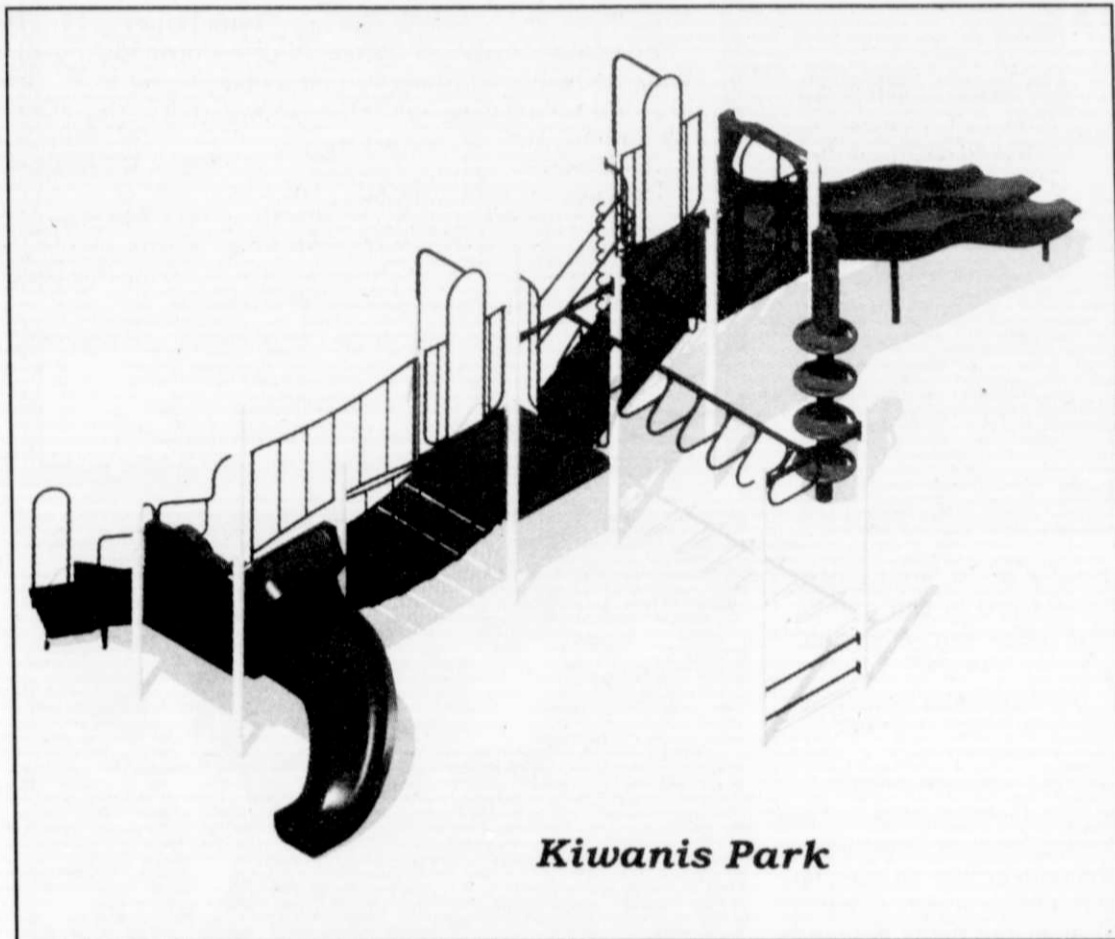

Junior Women Planning Fundraising Event in August to Benefit Playground Equipment

Members of the Kewaskum Junior Women's Club are busy planning their largest fundraising activity to date. Their event, The Jungle Gym Jamboree will be August 2nd in Kewaskum's Kiwanis Park.

According to the group's leader, Karen Heberer, "We started planning and organizing in January of this year and have received an overwhelming response from the community." Those words coming right after receiving a \$5,000 check from the New Fane Sportsman's Club. Also donating so far have been The Kewaskum Kiwanis Club- \$3,000; Kewaskum Area Chamber of Commerce- \$500; and The Kewaskum Woman's Club- \$100. St. Francis Bank and West Bend Savings have both donated \$225 for the band. The Junior's have also donated \$5000 in addition to spearheading the event.

Heberer states the club has a goal of raising \$20,000 and completing the project in three phases. Phase I is the largest addition to the park worth \$13,000. Additional equipment will be added as they continue their efforts.

The event planned for August 2nd will begin at 11 am and wind down 12 hours later. Family activities are planned from 11 - 5. A locally favorite band, Relative will perform from 7 - 11 p.m. Food, drinks, popcorn, and cotton candy will be served

all day.

Activities for the day include a Basketball Shoot from 1:00 - 2:00 p.m., a Tug-O-War from 4:00 - 6:00 p.m. with sign up at 3:30 p.m., a Cake Walk from 11:00 - 3:00, an Obstacle Course from 11:00 - 6:00, a 50/50 Raffle from 3:00 - 7:00, Face Painting from 11:00 - 5:00, and a Silent Auction from 11:00 - 7:00. There will be a small fee for all activities.

Heberer states her club is hoping organizations, families, and businesses will participate in the Tug-O-War contest. There are age categories for some of the activities and prizes will be given for most of the contests.

The Junior Women are working with Burke Company in Fond du Lac. The new apparatus will replace the current wooden structure, which was donated by the Kewaskum Junior Women's Club in 1987. That structure will be relocated to Wildlife Park on the north side of the village.

The Historical Society invites members and friends to tour the historic Boltonville Mill on Saturday, July 12, starting at 11:00 a.m. Tom's Country Mill, LLC, is one of the few county businesses still operating as it was originally intended out of its same building. The business is open from 8:00 a.m. to 4:30 p.m. on Mondays, Tuesdays, Thursdays and Fridays; Saturday mornings and by appointment on Wednesdays. Tom became its owner and proprietor June 1, 2000.

Tom carries pet foods - veterinarian formulated dog food, bird food and Delco products, as well as custom mixes for horses, calves, sheep and goats. To meet the growing unusual small farm animal needs around the community, he also sells llama, emu, ostrich and alpaca feed. Call the mill at 692-2800. ESCAPE SUMMERTIME WOES

Summertime is finally here and with it come hazards. Third-year medical student at Lake Erie College of Osteopathic Medicine in Erie, Pennsylvania, and

hometown Kewaskum native, Rachel Chambers, recently talked about things to watch out for. She is presently in a clerkship in Family Practice at the Jackson clinic, and reports that they are seeing lots of viral colds. The main care in prevention is, of course, staying away from people who are sick, and frequent and thorough hand-washing. "The medical community is split on the controversy of bacteria-killing versus regular soaps," she said.

Another thing to pay attention to is the Lyme-disease carrying nearly microscopic deer ticks. Anyone who goes out in the woods to use our trails and farmers walking the fence rows and through maturing crops are at risk. Rachel says to pay attention if you notice any welts with a clear center. Symptoms of Lyme's Disease vary greatly.

Use an insect repellent with DEET to avoid mosquito bites and possible West Nile virus, and apply sunblock at least twenty minutes before you go outside, so that it begins to take affect early to avoid sunburn. Reapply frequently, especially if swimming.

A pet peeve of Rachel's is injuries that could easily have been prevented by use of bike helmets. "Always, always, wear helmets when biking, and helmet, elbow, knee and wrist pads when

roller blading or using a scooter."

Finally, "Get out and enjoy the summertime weather. This is a good time to get walking and exercising for good heart health." Rachel goes next to Grand Rapids, Michigan, for a clerkship in critical care pediatrics.

FARM PROGRESS

Alan Linnebur, Farm Management Educator, says that things are going well locally. Initially we were dry, and still are a little bit, but the crops are progressing. The first hay is off and growing again. He said he thought it was a little behind because of the cool spring, but it produced reasonably well. Corn is good. We spoke a bit about agriculture being an industry in today's world, one that requires education and dedication. The profitability in farming is so slim. "You have to be good to survive," he said.

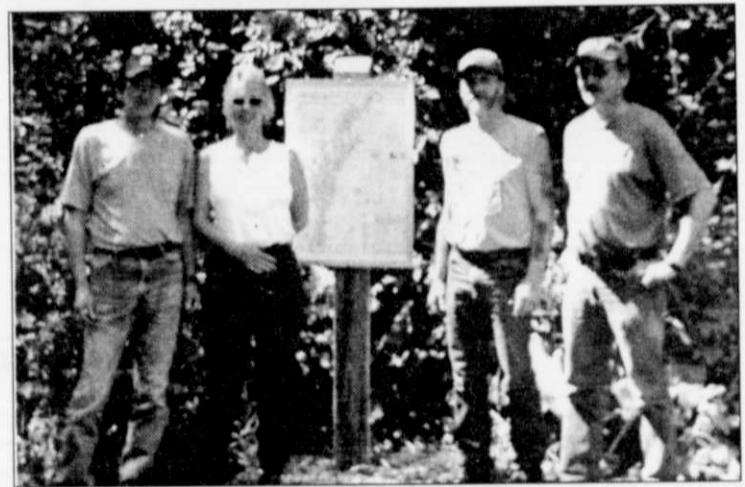

News From The Capitol

Senate Promotes Economic Growth

Last week the Legislature passed a taxpayers' budget that included no tax increases, a freeze in state spending and a local property tax freeze. This week, the Senate passed legislation that will create jobs in the state of Wisconsin and upgrade our infrastructure for the future. We are sending a signal that Wisconsin is open for business.

Currently, corporate income and franchise taxes are calculated using a formula that factors in sales, property and payroll. This is commonly referred to as the "jobs tax." This formula discourages multi-state companies

from locating property and jobs in Wisconsin. Companies choose not to expand and create jobs in Wisconsin because they will be penalized with higher taxes than if they were to locate in another state. Senate Bill 197 phases out the property and payroll factors and uses only the sales factor in calculating corporate and franchise taxes.

Improving Wisconsin's transmission capability and upgrading our production capacity is important to improving the state's economy. To succeed in revitalizing our manufacturing economy and in drawing new,

high-tech businesses to the state, a key factor will be our ability to ensure an adequate and reliable supply of energy to meet the rising demands of a modern, growing economy. Senate Bill 180 provides financial incentive to local municipalities that allow public utilities to locate there.

Eliminating the jobs tax and creating an incentive for communities to allow the electric generation to power Wisconsin's economic recovery will make Wisconsin more competitive and appealing to companies that are planning to expand or locate. This is only the beginning of Wisconsin's economic recovery. We will be working throughout the summer and fall to keep the momentum going. We will keep our commitment to do what it takes to encourage economic growth in our state.

One Millionth Document Recorded in Washington County

WEST BEND - The Washington County Register of Deeds' Office officially recorded its one millionth document on Thursday, June 26th celebrating with a small gathering (and chocolate) for the record-setting event. The document, a mortgage, was recorded into the county records 167 years after the first document containing a Washington County legal description was received.

Washington County's first known recording, hand-written in a large bound book, was a deed from Joshua Hathaway Jr. to T. H. Hubbard of the City of Utica, the State of New York. The land included 5 different parcels and was sold for \$1,500. The purchase was made through the Green Bay Land Office and was put into the public records August 3, 1836.

It took 150 years to record the first half-million and only seventeen more years to record the second half-million. "This shows that people love to live in Washington County, and with the low interest rates, continue to buy or refinance their current mortgage," said Washington County Register of Deeds Sharon Martin. According to Martin, the Register of Deeds office implemented a computer document management system in 1992 that allows staff to record and process documents more quickly and efficiently. The system was upgraded in 1998 and modified in 2003 to be

one of only two Wisconsin Counties that accept electronic recordings.

"The newer computer system keeps Washington County in the high-tech times by working more efficiently. The volume of documents recorded in the Register of Deeds' office has increased revenue and has allowed other county offices to improve programs and services for residents without overburdening taxpayers", Martin said.

The Register of Deeds' office broke their single day record Tuesday, May 20, 2003 when they recorded 476 documents with a total of 2,538 pages. "The last record-breaking day we had was November 25, 2002 when we recorded 484 documents but only had 2,364 pages in a single day. The large volume of pages can no longer be carried in one stack, and often takes two to three wire bins to carry", said Martin.

Martin added, "Our office

handles land-related documents as well as vital statistical records such as birth, death and marriage records." The Register of Deeds' Office records, archives and returns documents submitted for recording. The office processes an average of 250 documents daily. Most of these involve real estate transfers of people who have purchased a home or vacant land or those who have refinanced loans on property they already own.

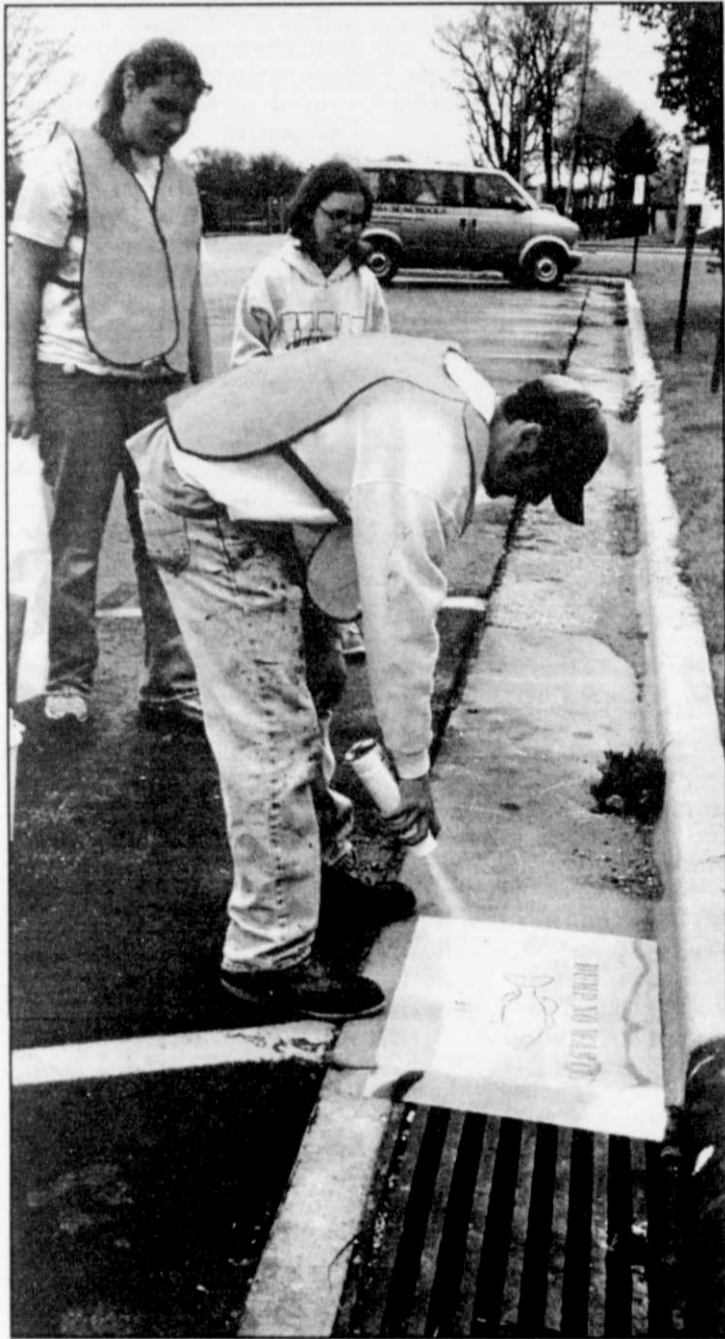

(Help Our Planet Earth), with consent from the Kewaskum Village Board stenciled an important message next to storm drains in the central area of the village of Kewaskum. The KHS students of H.O.P.E. Club involved in helping that day were Jenny Harter, Val Rieden, Andy Lickel, Julie Blasky, Jessi Graham and Alexa Nelson. The message these students helped relay reads, "DUMP NO WASTE - DRAINS TO RIVER."

In connection with Washington County Land and Conservation Department and supported by its education coordinator, Sue Millen, H.O.P.E. Club is hoping to raise awareness of helping keep our valuable waterways as pollution free as possible. The storm drains along Kewaskum streets eventually lead to town streams and the Milwaukee River that flows through the village. The river is an attraction for fisherpersons, canoers, and strollers enjoying a peaceful

view through River Hill Park. And it is, of course, home to numerous plant and animal species. Waterways are an incredibly valuable resource, and it is very simple for people to help keep that resource safe.

According to a flyer put out by the W.C.L.C.D., here are some simple steps people living along the streets of Kewaskum can take to help keep our streams and rivers pollution free:

- * Do not use storm drains for disposing of motor oil, antifreeze, pesticides, paints, solvents, or other materials.

- * Clean up leaves or grass clippings that accumulate on your driveway, sidewalk or in the street.

- * Sweep! (do not wash) fertilizer and soil off driveways and walkways.

- * Minimize your use of salt on sidewalks and driveways during the winter.

- * Dispose of pet wastes by flushing them down the toilet or by burial.

- * Redirect down spouts from your rain gutters away from paved areas to vegetated areas.

- * Wash your car on the

lawn - not the driveway.

The W.C.L.C.D. flyer further notes, "Rain or melting snow wash soil, litter, pet waste, fertilizers, leaves and grass clippings off the [yard and] pavement and into your storm sewer [drains]. When the storm sewer empties into lakes and streams, these materials become pollutants that may kill fish, close beaches and increase weed and algae growth."

If each person decides he/she is just one person and cannot do much damage by not handling waste products conscientiously, that's thousands of people of Kewaskum contributing to the deliberate deterioration of its waterways. If each person takes on the non-strenuous, simple task of disposing of wastes properly/safely, that's thousands of people caring to keep waterways in safe condition for Kewaskum's todays and tomorrows.

It is H.O.P.E. Club's intention to stencil the "DUMP NO WASTE" message around more storm drains in Kewaskum next fall. Other endeavors of H.O.P.E. Club include such events as litter clean-up, tree planting, energy conservation awareness, hiking, camping, and horseback riding among other activities that are environmentally peaceful.

As for the storm drain stenciling project, H.O.P.E. Club members would like to impress, once more, please dump no waste in storm drains; to not do so is a pure benefit to you and your neighbor and your future generations.

Historically Speaking

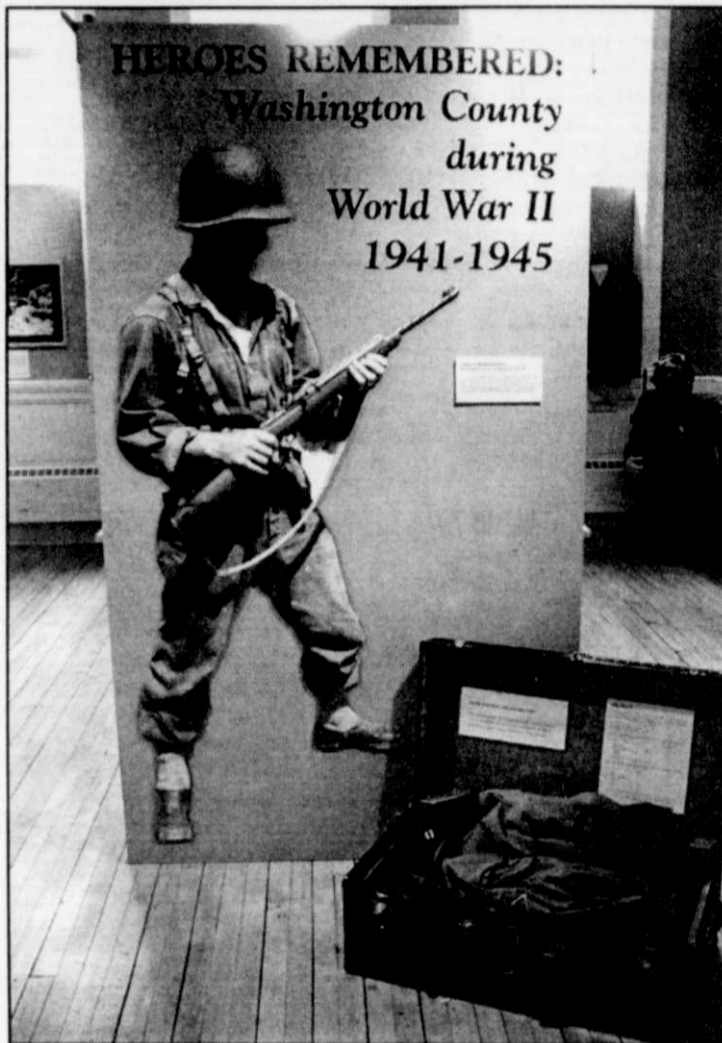

A view of the World War Two Exhibit features photo of late PFC Wallace Francis of Kewaskum.

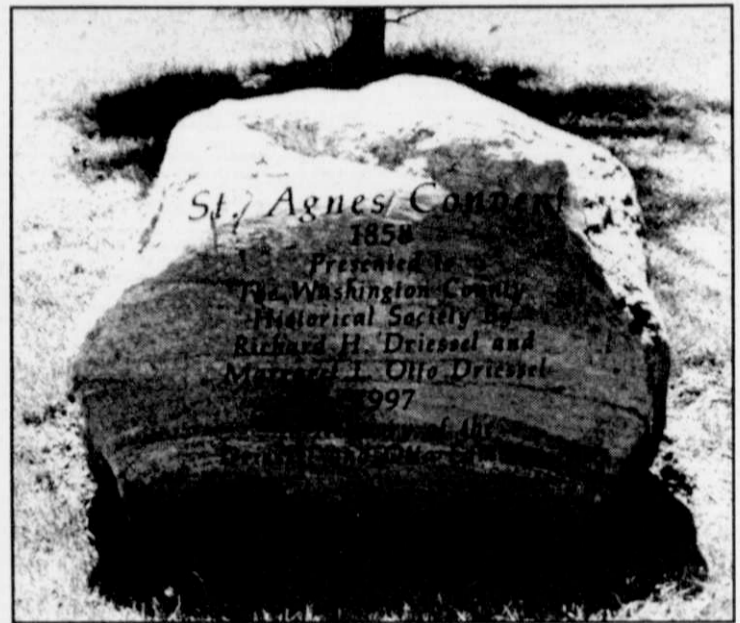

The Plan Commission of the Village of Kewaskum, Washington County, Wisconsin met in the Council Room of the Municipal Building, 204 First Street.

The meeting was opened with a Moment of Silence and pledge of Allegiance.

Chairman Mathew Heiser called the meeting to order. Members present were Andy Pesch, Frank Beesten, Richard Schmidt, Leann Butschlick and Theodore Meilahn. Member Andrew Kuehl asked be excused. A quorum was present. Mr. Rick Kania from SEWRPC was not in attendance to discuss the proposed Zoning Ordinances.

On a motion by Andy Pesch, seconded by Frank Beesten and carried by the majority voice vote the Plan Commission approved the minutes as amended for April 29, 2003.

Discussion was held on the request to rezone 967 Fond du Lac Avenue from R-2 Single Family Residence District to B-2 General Retail and Service District for the placement of an office for Trinity Construction, tax key no. V4-0191-005. It was noted minor remodeling would be completed within the existing building and to expand the parking area outside the building to allow for handicap access. On a motion by Richard Schmidt, seconded by Andy Pesch and carried by voice vote, the Plan Commission sent a favorable recommendation on the rezoning to the Village Board for public hearing.

The Plan Commission reviewed the preliminary plat for Kettle Kountry Estates proposed development acknowledging the plat is in accordance with what is being discussed and proposed. No action was taken.

Review of the final plat for Woodland Creek took place, noting that the only phase being platted is the first phase. On a motion by Theodore Meilahn, seconded by Frank Beesten and unanimously carried by voice vote, the Commission sent the final plat forward. The Village Attorney and Engineer would be reviewing it in conjunction with the preparation of the Developer's Agreement.

On a motion by Richard Schmidt, seconded by Theodore Meilahn and unanimously carried by voice vote, the Commission recommended to the Village Board to accept outlots 1 & 2 in lieu of the \$200.00 open space fee for the 23 lots in phase one. When the building permits are applied for R-3 and R-4 lots, an additional charge of \$200.00 per unit will be assessed for open space charge, less the original open space fee collected.

Review of a proposed PUD for the 5 acre parcel on the North side of CTH "H" was discussed. The existing driveway was to be relocated because additional driveway accesses will not be approved by Washington County. On a motion by Andy Pesch, seconded by Frank Beesten and unanimously carried by voice vote, the Commission acted to send the PUD plat to the Village board as presented with a few notes.

1) The PUD is to have up to a maximum of 11 living units as proposed.

2) The PUD is to have up to a maximum of 6 building pads.

3) The private drive will be an undedicated roadway with sidewalk placed adjacent to CTH "H".

4) The utilities (water and sewer) will lay within a 30-foot easement in conjunction with the 24-foot roadway.

5) The water and sewer mains need to be extended to the east and west lot lines.

Review of the final plat for Homestead Hollow took place with

concerns over the platting of lot 13, which is noted to be in the wetland. It was noted the engineers have not reviewed said plan nor has DNR permitting been received. Clarification on this particular point should be addressed prior to approval on sending it forward. No action was taken, but it was noted the Board could technically act prior to the Commission if the point was cleared and documentation received.

On a motion by Richard Schmidt, seconded by Theodore Meilahn and carried by the majority roll call vote, the Commission adjourned the meeting. Roll call vote was 6 "Aye" 0 "Nay" 1 "Absent".

The Park and Recreation Committee Chairperson Steve Scheunemann inquired about the fall zone materials for the proposed new playground apparatus for the KKCP. Director of Public Works Jerry Gilles reviewed price quotes for various fall zone materials and related information. It was noted the Jr. Women's Club would like to proceed with having the equipment installed in July prior to the Fun Day, August 2, 2003. It was further noted the company the equipment was coming from would not install the apparatus without a

proper fall zone. To install a poured rubber mat, an estimated 1,300 square feet, would cost \$16,920.00; wood chips would cost an estimated \$4,000.00; rubber chips/pellets would cost an estimate \$5,600.00.

Relocating the existing playground apparatus to Wildlife Drive Neighborhood Park was discussed and what the cost would be for similar fall zones. Respectfully the rubber mat would be estimated at \$9,000.00, the wood chips at \$2,400.00. After a considerable amount of discussion and debate, on a motion by Trustee Kevin Scheunemann, seconded by trustee Steve Scheunemann and unanimously carried by voice vote, the Board approved the installation of the rubber mat fall zone within the KKCP at the cost of \$16,920.00 and the installation of the wood chip fall zone within the Wildlife Drive Neighborhood Park at an estimated \$2,400.00 and that the money for said work would be moved from the Open Space Fund.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee Harry Roecker and unanimously carried by voice vote, the Board waived the fee for use of the ball diamonds, etc. for the Jeff Sabish Memorial Softball Tournament.

Also the impact fee process was briefly discussed but the next action to proceed will be taken after the village knows what will be happening to the State budget deficit.

Mr. Ed Roehrborn was present to complain that the Police Department isn't doing enough as to writing citations on noise ordinance violations. The Police Chief took exception to his comments and indicated he would report back to the Board.

Ten area teams participated in the first round of the tournament series on the 6,300 yard, 18 hole, par 70 layout on a sunny, warm, calm and dry day. Only the top three teams and the three lowest scoring individuals (not on those teams) qualified for the Kewaskum Sectional, the second round of the WIAA play-offs.

The 18 hole medal play qualifying tournament began with tee times from 9:30 to 11:30 a.m. After the first nine the Indians found themselves just four strokes behind the top three teams in the field. Therefore, Kewaskum needed to better the competition by five swings on the back nine to advance. Unfortunately, four teams improved upon their front nine team totals while the Indians added one (from 169 to 170). The end result was that Kewaskum finished fifth behind the champion Kiel Raiders (310), runnerup Waupun (320), third place Mayville (328) and the Lomira Lions (338) nipped the Indians by one.

While the Kewaskum varsity team ended their collective season, senior Josh Timblin extended his high school career by virtue of posting a 79 to qualify for the

Sectionals hosted by KHS at Hon-E-Kor Golf and Country Club in early June. Josh recorded a 40 on the inside nine at Camelot and then came back with a solid 39 on the outside nine to finish third individually out of 50 regional competitors.

Nine teams and nine additional individual qualifiers, including Timblin, participated in the 2003 WIAA Division Two Sectional Golf Tournament at Hon-E-Kor on Tuesday, June 3rd. Even though he may have come up short of his state goals, Josh represented KHS and the whole Eastern Wisconsin Conference well. Yet, according to a very proud KHS head coach, Glenn Eichstedt, "One of the best ways to conclude your athletic season, school year or scholastic career, is with a chance to advance to the state finals."

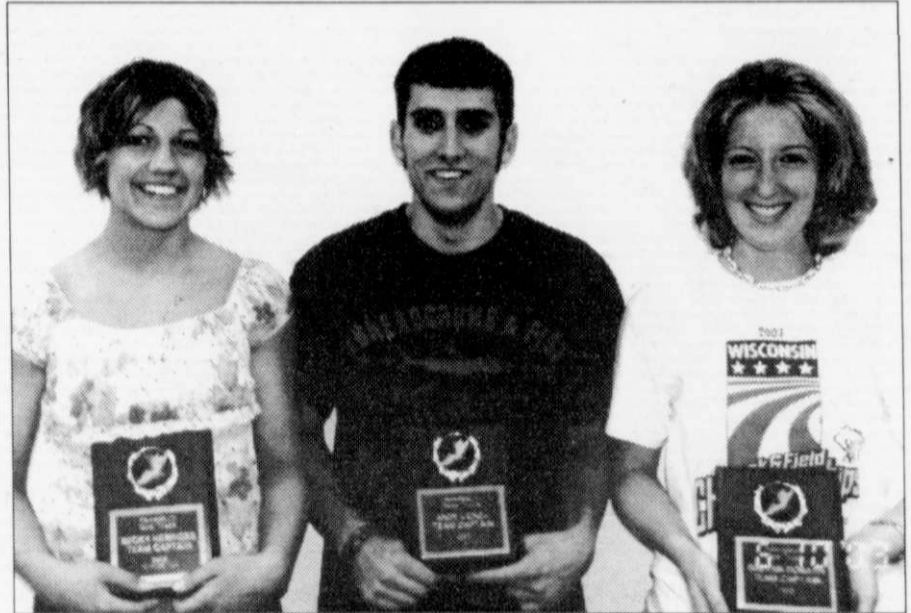

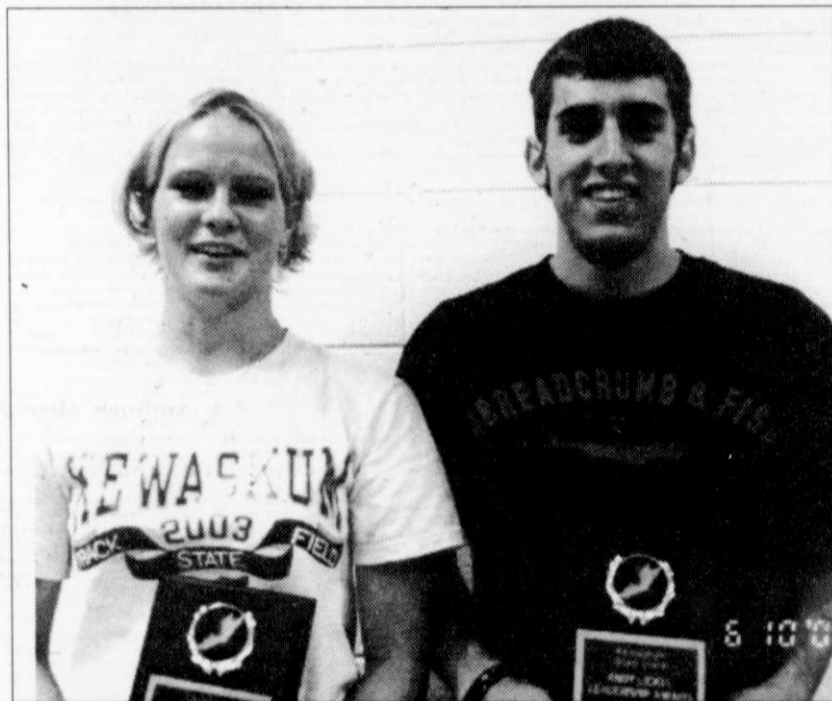

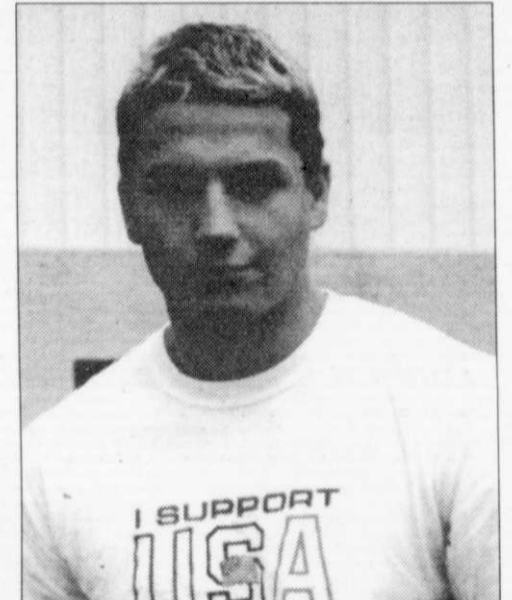

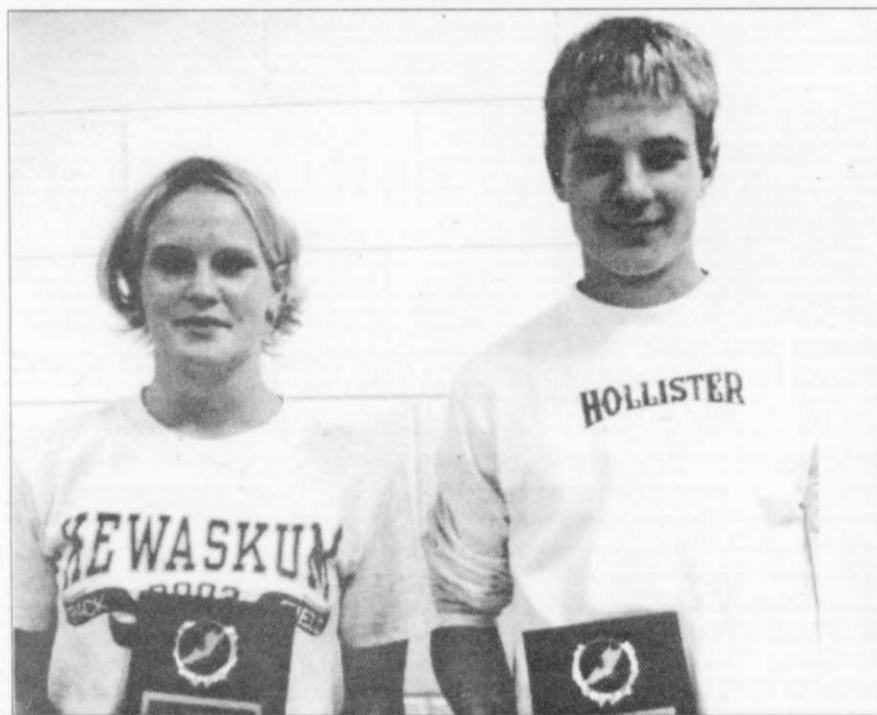

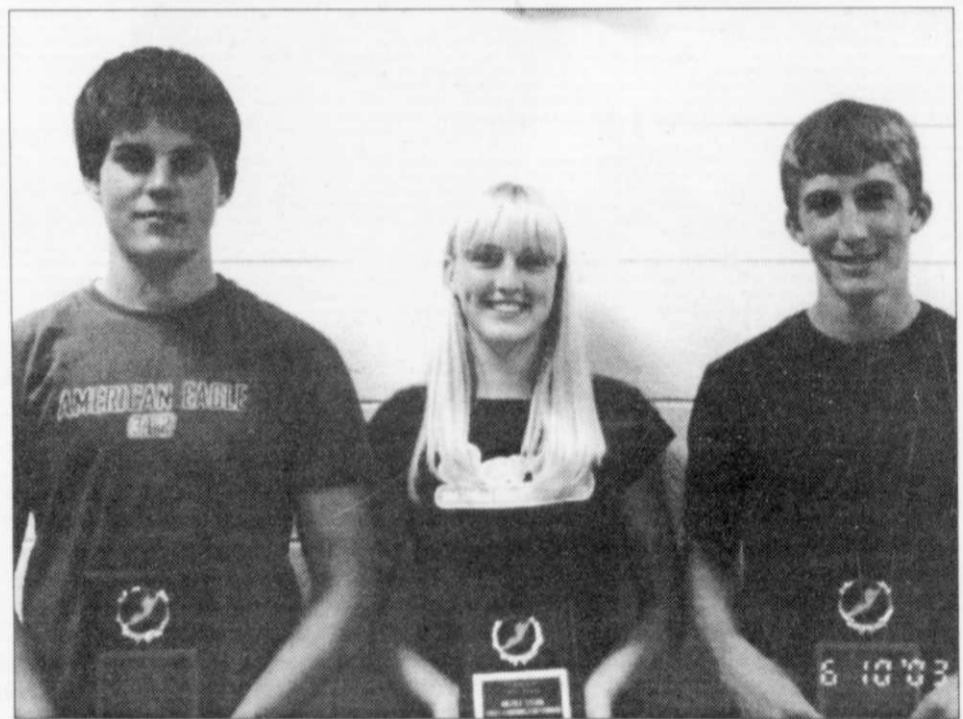
