Beechwood Crash Leaves Kewaskum Teen Dead, Auburn Crash Sends Three to Hospital

The Kewaskum community is mourning the loss of an 18 year old man from New Fane who was fatally injured in a one vehicle

accident that occurred on CTH S, two tenths of a mile east of Maple Tree Road in the Town of Scott on Friday, July 4 at 2:26 a.m.

The teen, Benjamin Westerman, a passenger in a vehicle driven by William J. Schroeder, 22, of

Campbellsport was ejected. Schroeder was transported to St. Joseph's Community Hospital in West Bend but was later transferred to Froedtert with life threatening injuries. Schroeder was listed in critical, but stable condition at Froedtert Memorial Hospital in Milwaukee Tuesday afternoon.

The Sheboygan County Sheriff's Department is still investigating how the crash occurred. How the crash happened is being looked at closer by the department's Crash Reconstruction Unit.

Random Lake Jaws and EMS, Beechwood Fire Department and Batavia First Responders assisted at the scene.

Kewaskum EMS responded to two crashes over the holiday weekend. The first, on Saturday, on STH 144, south of CTH HH in the Town of Farmington for a one vehicle roll-over in which a Kewaskum teen girl was injured.

That crash unfolded as the 16-year-old girl was traveling southbound on STH 144 and

struck the ditch. Upon trying to regain control of the vehicle she overcompensated. She entered a field west of the road. The vehicle overturned three times according to a report from the Washington County Sheriff's Department.

The teen was transported to St. Joseph's Community Hospital in West Bend by Kewaskum EMS.

Following that crash, Sunday, July 6, at 11:15 a.m. Kewaskum EMS assisted Campbellsport Fire Department and EMS with a two vehicle accident on CTH G south of STH 67 in the Town of Osceola.

That crash occurred when a large SUV pulling a 26 foot travel trailer struck a car that crossed the centerline on CTH G and entered the northbound lane of travel.

The car was driven by Jonathon L. Juech, 18, of Campbellsport. He was transported from the scene to Froedtert Memorial Hospital in Milwaukee by Flight For Life Helicopter. He was allegedly not wearing his seatbelt according to a report from the Fond du Lac County

Sheriff's Department.

The driver of the SUV, Luke J. Uitenbrock, 46, of Kaukauna and another 33 year old passenger were transported to St. Agnes Hospital in Fond du Lac for non-life threatening injuries.

The SUV also had five children passengers, ages 1-7 who were uninjured. All the occupants of the SUV were wearing seatbelts according to that same report.

Juech was listed in serious condition Tuesday afternoon at Froedtert Memorial Hospital.

Hello friends,

It's me Kyle Darmody, recent graduate of Kewaskum High School and sports journalist at the Kewaskum Statesman, I am writing to you today to tell you of a once

in a lifetime trip I will be going on this month.

Some of you may know that I have been selected by International Sports Specialists Inc. to represent the state of Wisconsin, in the Down Under Hoops Classic VII, being held on the Gold Coast of Australia, July 25 through the 27. The Down Under Hoops Classic is a basketball tournament; each state will have a handful of representatives playing for their team. I will be one of those representatives playing for the Wisconsin State team. Due to the lack of other representatives here, Wisconsin, Texas, and Colorado will be combining to form one team.

Each team carries about seven players so everyone gets a lot of playing time. Each team will play in a minimum of four games, but may have the opportunity to play in more depending on how

many games they win.

My 13-day trip to Australia includes 4 days and 3 nights in Sydney, Australia, and 7 days and 7 nights on the Gold Coast of Australia. FARMINGTON HISTORICAL SOCIETY NEWS

The Farmington Historical Society, Inc. invites the public for a tour of one of Washington County's oldest businesses still in operation. FIRST 100 DAYS FOR SUPERVISOR

People often measure a politician's record against his first one hundred days in office. Brian Bausch's hundredth day as a Washington County Supervisor, District 11, was June 25. Bausch was unanimously recommended by Board the after the death of Daniel Rodenkirch last winter.

Bausch retired from the Washington County Sheriff's Department to avoid any possible conflict of interest. "I turned in all my equipment, my badge and my gun," he declared. He still works for the AODA and is a warden for the DNR, a state agency. In fact, Bausch credits his work at the DNR making him more knowledgeable in his Board of Adjustments appointment.

"I find that very interesting," he said. They take into consideration wet lands, setbacks and other permits denied by the county for building proposals. "We actually go on site and

observe the landowner's complaint. The ultimate guideline is state law ordinances. If we feel that the landowner is justified, we can reverse the denial."

Bausch was also appointed to the Economic Development Advisory Committee. Part of the committee involves hearing issues from municipalities. "We get a picture of what's going on. Mostly, there's a lot of urban growth and business loss, voting down school referendums. We try to monitor and balance agriculture and industry. What about hearing from town governments? "Hmm, good question. I'll bring that up," he said. Agriculture is dwindling. "Something that surprised me was the farmers who originally didn't want to turn their farms into subdivisions, yet when they get close to retirement, (their land) is their retirement account. Then they sell."

The biggest issue with the County Board is the hospital. "I had an awful lot to learn, as the Board has been dealing with this for several years already. It's quite a battle." An unofficial random sample of Bausch's constituents here in District 11 do not want to see the hospital move, he said. "The way I see it, the issue should be debated. If you're going to vote on something, it should be debated."

Affecting District 11 is the Leonard Yahr county park proposal for the Town of Farmington. Some people feel that the county has too many parks, and some feel we need more. A DNR grant

has been applied for to help pay for the development costs. "This is a difficult time, putting money into a park when we don't know the impact of the budget cuts for our county," Bausch said. The grant is for \$50,000 toward a \$450,000 budget. There would be five or six parking spaces and a carry-in boat/canoe place. Picnic area, restrooms and paved roads are in the plans. "It will take several years to develop," he said.

As far as his original goal of giving back to the community? "I've done a good job of making myself available. Generally, everyone I run into has some real strong opinions. I enjoy this job because it's new and challenging. It's caused me to do a lot of reading and study. It's come at a good time for me, because I have extra time right now."

KHS Pranksters Charged

New Washington County Sheriff Settling In



Washington County Sheriff Brian Rahn

When Brian Rahn saw the governor's press release that there was a vacancy for the Washington County Sheriff's position (due to the death of Jack Theusch), he immediately checked the internet to see the prerequisites of the position. Knowing that anyone in the whole state or even out of state (after establishing residency) can apply for the job, Brian submitted his application quickly to the proper personnel indicated on the Internet.

The "application" is only the first step if you wish to obtain the position, as the Governor's legal staff then screens each application. They narrow the pool down to approximately three applicants, depending on the amount of people that apply for the position.

The finalists are then each interviewed privately by the Governor, who only does this to fill vacancies during incomplete terms, as normally Sheriffs are elected. The Governor examines such things as job expertise, community involvement, education, training, knowledge of the position, and leadership qualities.

Obviously, Brian was the "leader of the pack" in all these qualifications as on June 12, 2003, he was appointed by Governor Jim Doyle to complete the Washington County Sheriff's term until 2007.

Brian's qualifications for the position are impressive and he is willing to share his background with his constituents, not only so the populous will know some of the steps that qualify a sheriff, but also for any youth that may want to pursue this type of occupation.

After graduation from high school in 1983, Brian entered the Marine Corp, serving one

year in active duty and then being placed in the reserves until 1987. From 1984-1987 he worked in construction until he was hired by the Dept. of Correction.

He started his approximately four-year job at the prison as a correction officer and worked his way up to supervisor, which entailed overseeing the housing unit and being on the investigative bureau within the prison, which examines such things as officer misconduct, etc.

In 1990 he served a year as a Jackson County Trooper in the Tomah district. In 1991 he served in Washington and then Dodge counties, with the Wisconsin State Patrol, which are headquartered at the Fond du Lac District Office. This office covers 12 districts, including the counties of Dodge, Washington, Ozaukee, and Brown.

Later in 1991 he was promoted to supervisor, where his primary responsibility was to oversee the day to day operations in the district and to make decisions for this group of seven to twelve men. He also made major decisions for the twelve counties as the "duty supervisor" on his particular staff.

In 1998 he was promoted to Sergeant and he then had to manage the entire third district out of the Fond du Lac office, handling any problems that would occur with his staff of patrol people as well as handling major incidents. One horrific, unforgettable such incident was the fatal multi-vehicle accident that occurred on I-43 when he was one of the state patrol supervisors in the top chain of command making the decisions. These decisions encompassed the fire department press, traffic controllers, ambulances, plus helping supervise the many aspects of accident reconstruction.

Brian remembers the incident, as do we all, with a

heavy heart, but, he learned a great deal of valuable experience in this tragedy as far as the importance of having a chain of command, prioritizing, and working swiftly and tirelessly with many other departments and people for a common goal. Brian has pretty much tied up his duties with the Wisconsin State Patrol now and is getting into the full swing of his new office.

Brian is particularly honored to be a part of Washington County because of the professionals he has to work with, the existing programs, and the potential for great opportunity. Some of the existing programs include a drug unit who recently helped the Federal Government with a 350 lb. marijuana seizure, a detective bureau, a D.A.R.E. program, a swat unit, security at the courthouse, and the newly formed dive team for rescuing and identifying.

The opportunities that he would like to see progress is to start and/or assist in setting up various programs. One program would be on child safety where children's car seats would be analyzed for safety and child finger printing would be done.

Another program that Brian strongly advocates is involvement in the community through a citizen's police academy. There are many topics to cover in this area and it could be done over a series of weeks, with each week covering a specific aspect.

Some of these would be learning what the Sheriff's department does, overview of the Sheriff's job, touring the jail, seeing the communication center and how they handle 911 calls; riding in a patrol car, and concluding with a question/answer period. Anyone could attend these sessions and it would familiarize citizens with the Sheriff's department and their duties to make him or her better aware of the fact that they are the "good guys".

Brian would also like to see some involvement with youth groups, teaching them employee safety issues for various businesses, how to lock up a business at night, and how to safely walk to your car at night. He would like the Sheriff's Dept. to be the leader in this type of training classes.

A refresher program of prioritizing would also be very beneficial for his officers (or anyone) to learn the proper sequence in disastrous situations, with life threatening emergencies or injuries being first, injury accidents being second and accidents in traffic being third.

This is the natural prece-

dence, but in a state of chaos, one might not react accordingly unless they are programmed to do specific acts in these situations. This is just a sampling of programs that Brian would like to see take place in the future.

Brian married his wife, Rebecca, in 1996, and they now have two boys, Spencer, 5, and Cody, 3. They live in Hartford and Rebecca is employed as a dispatcher for the Washington County Sheriff's Department. In Hartford Brian was an Alderman for the office position. Brian's hobbies include fishing, hunting, and an interest in sports, especially soccer, baseball and hockey. He tries to attend as many Milwaukee Admirals' games as his schedule will allow. Since both he and his wife are busy, they devote most of their spare time to spending quality time with their boys.

Brian explained his duties as Sheriff are more involved than most people would surmise. On a daily routine basis, he not only oversees his staff of leaders, but also exchanges ideas and problems with them to keep a smooth running operation. These leaders are a Captain who is in charge of the patrol officers, a Sergeant who heads the communication center, a Captain for the jail administration, and an Office Manager for the front office. Obviously, the military chain of command is used in department heads as well as the approximately 180 other people under his jurisdiction.

Brian also will attend several fire department meetings throughout the cities of Washington County as in many situations the two departments work closely together and it is important that everyone know the chain of command process in disaster situations. It is also helpful to air any suggestion or problems at these meetings. It is imperative to Brian to also keep abreast of "Hazmat", the hazardous materials department that West Bend now has in operation. He will also be doing

public speaking and attending meetings, especially in the next few months, to get to know the people of Washington County.

Likewise, he would like to see the people under him get to know the people of Washington County better by perhaps pulling their squad over and talking with people whether it be in the city or on the farm.

Brian feels if his department builds relations with people that they will no longer feel uncomfortable talking to patrolmen who too many people realize are "great people" only when they are involved in an accident or run out of gas!

Brian had previously known some of the people in his department and he is very proud to be a part of such a top-notch department, and he will definitely seek re-election in 2006. He is thrilled to be a part of such a unique county, with its metropolitan southern end and it's northern rural end, and he feels he is getting the best of both worlds.

Brian declares himself a "people" person and seems to have a genuine concern for them, caring enough to recognize good deeds and a job well done. He realizes he has tough shoes to fill from his predecessor (who he highly respects), but he feels they are "different" shoes of different times. Everyone brings in a different management style for a different time in life.







Letter to the Editor:

After reading numerous articles about the senior boys who attempted to cut down the large tree in front of the Kewaskum High School, I feel the need to express my thoughts and opinions.

It appears to me that the community and the media are missing important elements of this situation, i.e., are there aspects of this incident that haven't been reported or discussed? Are the boys remorseful for the actions that occurred? What have they done, since May 23 to rectify their wrong doing? Why did they make such a choice? Was it only a "senior prank with drinking involved"?

After talking to the parent of one of the boys who was involved in this incident, I feel that the boys are truly remorseful and ashamed of their behavior. Judging by their actions following the incident, I also believe that if these boys could take back the events of that evening, they would in an instant. They have busied themselves with community service and are paying restitution in a timely fashion. Their families have also cooperated fully with the authorities and are equally remorseful and saddened by the event.

One night of inappropriate drinking and poor decision making has left scars with these boys and their families forever, so in turn, I ask, do we as a community (parents, schools, religious organizations, service providers, etc.) do all that we can do in order to prevent underage drinking and promote a healthy family environment? When organiza-

tions such as the Council on Drug and Alcohol Abuse comes knocking on our doors, or offers skill building and education, do we welcome the opportunity to learn and embrace them as partners, or do we make them jump through hoops in order to provide services for our kids? Do we just "not have the time"?

Historically, senior pranks have occurred in Kewaskum and in many other communities and probably will in the future. Young people have made poor choices and have suffered the consequences and future generations will do the same. Some families will never experience this type of situation, but numerous will. As parents, as professionals and as a community, let's evaluate our role modeling and work harder to provide programs, services and outreach to our young adults in an attempt to curb underage drinking. Let's use this experience as a learning tool and put some positive energy into reaching out to parents and teenagers.

It's a tough job to be a parent today!



FISHING REPORT

Who takes care of fingerling bass? Do you believe they go to day care after they are born? As they get older is there a grade school and then high school for them? Is there a bass college? Do you get a degree when you graduate and what is it in? Can you go on to get your Masters? Is this the school which teaches how to keep your big mouth shut when my lure goes by? The teachers must be the oldest and biggest bass. They are the ones to get to know. Is this what people mean when it is said bass are schooling? What happens if you fail? Are you kept back a year? Do you take the class over?

How come I'm not asked to go? Is it only for bass? Looking for a great teacher? Who else but me? Need help with your up bringing? Guess who'd jump at that job. Couldn't I tell you whose lures to strike at and who's not to? It certainly would be nice to tell you where the best places are to stay, hide, and eat. Wouldn't I be helpful? Would coming out of retirement to be a teacher or student be a thought? Dumb question! Stay tuned to see if Bert and Bertha have the answers? (Just writing the word Bertha sends a tingling down my spine).

Long Lake: The week started slow with only a few small bass in the 15 to 16" range. The Bagley BB3 is still working and also the copper colored spinner bait. There were some big bass in the pads and sloop. They were hitting a Moss Boss 3 to 4 times on one cast. Just look for the heaviest cover and that's where they hideout! The bass were hooked and I could see how big they were but they got off. The next day in the same area one hit a Snag Proof Tournament Frog in charreusse and the same thing happened.

Tuesday night fishing started at 9:00 p.m. and ended at 12 midnight. Six bass hit spinner baits with the biggest being 17" and the rest 15"-16". The rock bass were still hitting blades with abandonment. These guys are the clowns of fish. They are so funny looking and they hit at anything.

Wednesday morning the

lure of getting those bass in the pads and sloop got me up at 5:00 am. With 5 hours of sleep, I headed for the entrance of the north channel and was greeted with a big surprise. Two bass hit almost 5 minutes apart. Both were caught on a Snag Proof Frog, my new favorite lure. One was 18" weighing 3 lbs. 3 ozs. The other was 20" weighing 3 lbs. 13 ozs. Also Tittle Lake produced some action with some 22" to 25" northers plus a 30" plus northern that hit a BB3, but managed to get off.

Wednesday night the boat traffic on Long Lake was too much for me, so it was off to my "favorite lake in the world". The Big A. (Aurburn Lake) and she disappointed me again, only two bass both 16". One on a spinner bait and one on a Snag Proof frog. Ok, so I can't catch fish on the Big A. My confidence of catching fish in this lake is wearing thin, but I'll go back and keep trying. It just a matter of time before this lake will produce some big fish. There is a love-hate relationship with her. Hopefully there is a time when the right bait will work and my nightmares will go away.

To bring up my self esteem on Thursday, Wolf Lake seemed the likely place. Getting back to my old self, the lake produced some quarter pounders and one 15" bass plus one 12" walleye. They were caught on a deep diving white crankbait or my favorite bait, Bagley's BB3 in the gold shiner color. Oh by the way, the guy who forgot to put his car in park at the Wolf Lake launch, HE doesn't do that anymore! HE learned his lesson.

Hope you saw my float in the Campbellsport parade. My arms were tired from throwing Bertha in the air, but my family and I had a great time. Just a side note - I was totally in charge of the operation and making of the float. Everything was checked and double checked. Extra duck tape, tie raps, fishing line, blue paint, paper, magic markers etc. All was going well until my son asked "Where's the candy?" Oh-oh! I forgot the candy! So if you saw a woman running to Piggly Wiggly and out of breath that was my wife getting the candy. Never will I hear the end of that one.

Thank you dear! The moral of the story is not to have this man in charge of a float. He'll always screw up something. How can I always be wrong?

With the Campbellsport Parade and Long Lake Boat parade over it's was time to go bass fishing. The experiment was to see if bass can be caught with fireworks exploding. Bass must like fireworks because 5 of them hit spinner baits Saturday night with the two biggest being 18 and 18".

The others were in the 15" range. Also caught a couple clowns with the longest being 10". These fish were caught between 9:00 pm and 11:30 pm. If the copper colored spinner bait gets lost there will be a tear in my eye. Guess they also like to celebrate America's birthday by eating. Another question for Bert and Bertha. (Again a tingling feeling goes down my spine just saying Bertha).

It is 10:45 Sunday night and

what a way to finish the week. A 27" walleye hit that copper colored spinner bait. Wow my first walleye this year and what a big one. Not bad for only fishing 2 hours and even after a storm.

Quite a week for me and I should not complain. The night bite is on so if you get a chance stay out late and check it out. The quality of bass is up but the quantity isn't. Whining it's one of my better traits.


