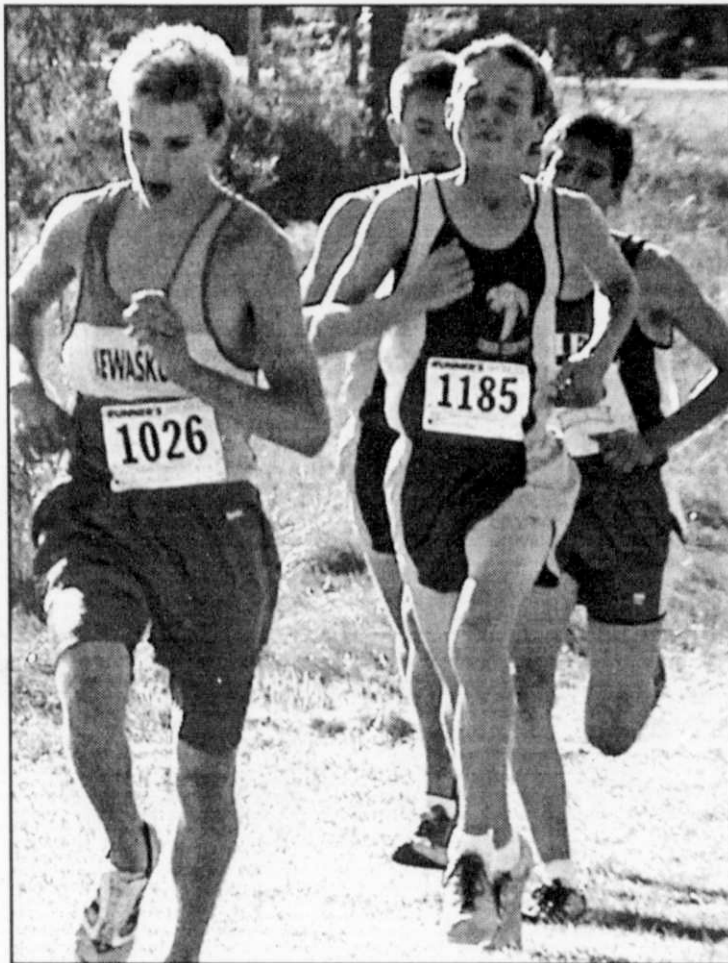

C-Sport Woman Remains Hospitalized After Crash

The Fond du Lac County Sheriff’s Department, along with the Campbellsport Rescue Squad and Fire Department and the Campbellsport Police responded to a head-on, two-vehicle crash on Saturday, November 1, 2003 at 2:42 a.m. in the Town of Auburn. The crash occurred on CTH DD 120 feet north off Lovers Lane.

Patrice Seefeldt, 38, Campbellsport was taken by Flight for Life Helicopter to Froedtert Memorial Hospital in Wauwatosa for life threatening injuries she received. Her condition was not avail-

able at press time.

The crash occurred when James Cesarec, 27, Kewaskum allegedly crossed the centerline while traveling his truck southbound and struck Seefeldt’s car head-on while she was traveling northbound.

Cesarec was taken to St. Agnes Hospital in Fond du Lac. He was later treated and released.

The Wisconsin State Patrol continues to investigate the crash.



Town of Barton Teen Killed in Weekend Crash

Washington County suffered its 15th traffic fatality of 2003 as a result of a one car accident on Saturday, November 1, at 8:55 a.m. on Schuster Drive in Barton.

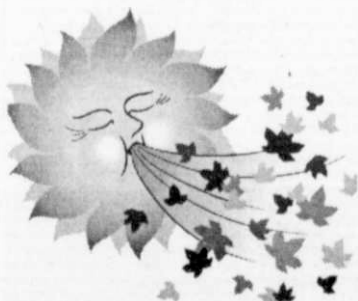
Nineteen year old Brian A. Brester of Barton was eastbound on Schuster Drive when he crossed left of the center line into on-coming traffic. He swerved to miss the traffic, lost control of his vehicle and entered the ditchline where his vehicle struck a tree. The vehicle then caught fire.

A volunteer fireman from the Kohlsville Fire Department responded to the scene and pulled the man from the burning vehicle, however the

man was pronounced dead at the scene by the Washington County Medical Examiner.

Excessive speed is believed to be a factor in the accident.

The Kohlsville First Responders and Fire Department and the West Bend Fire Department and Rescue responded to the scene.

Suspects in Fatal Hit-and-Run Crash Fail to Appear for Hearing

Three West Bend women, who were to appear in Fond du Lac County Circuit Court on charges of hit-and-run involving death and harboring/aiding a felon failed to appear at a preliminary hearing Thursday, October 30.

The driver of the car, Esperanza Cruz-Torres, 32, faces six years in prison for hit-and-run resulting in death on October 22. Angelica Martinez-Jimenez, 19, and Patricia Mendoza-Perez, 24, were also charged with being party to the hit-and-run resulting in death crime and face six years in prison on that charge. The two passengers both face an additional three years for harboring/aiding a felon.

The charges stem from a fatal car versus motorcycle

crash that occurred on CTH S in the town of Auburn on October 18. The women, with Cruz-Torres as the driver, left the accident scene where Michael Neuenfeld, 34, of Kewaskum was fatally injured.

After the crash the three women fled the area and stayed out of state until Fond du Lac County Sheriff's deputies made contact with them and advised them to return. They were then charged.

At their initial appearance Circuit Court Judge Peter L. Grimm set cash bail for the three. Cruz-Torres was set at

\$5,000, and \$2,500 each was set for Martinez-Jimenez and Mendoza-Perez. All three then posted bail.

At Thursday's hearing, Judge Grimm issued arrest warrants for all three women, who failed to appear in court.

Charges have also been filed for Cruz-Torres for operating without a valid license. This was her first offense.

All three women are to appear December 2 in Fond du Lac County Circuit Court again for a bail/bond forfeiture hearing.

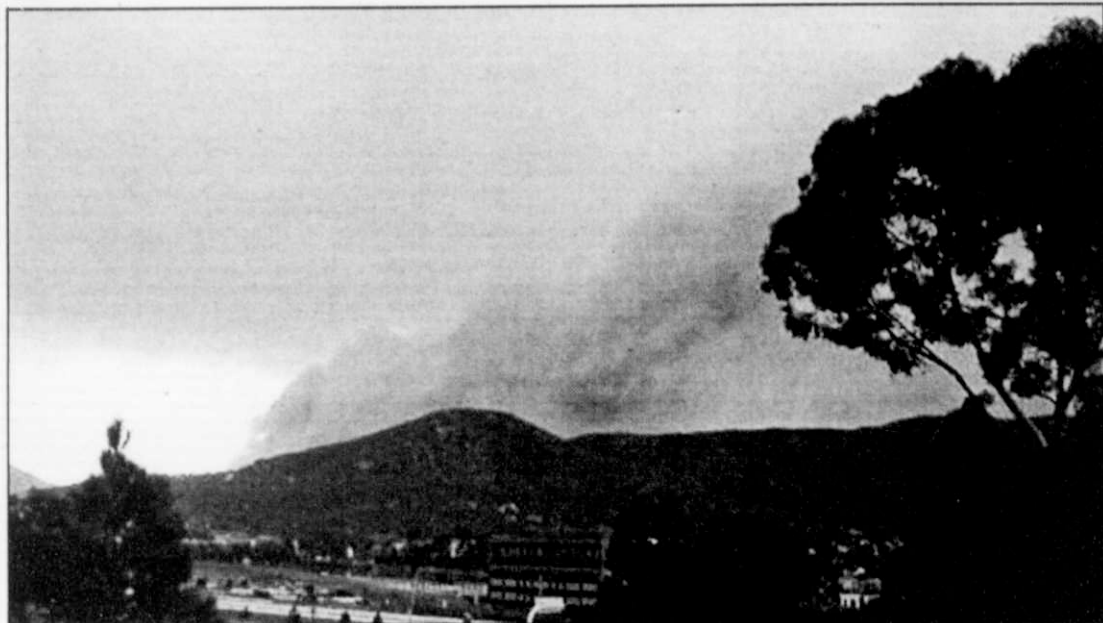

Former Kewaskum Grads Share California Wild Fire Experience



The above photo was taken from then end of Downs and Novotny's parking lot in San Diego. The highway you see on the bottom is Hwy 15 (about four miles north of where the fire crossed over) The smoke is coming from the city of Poway which borders San Diego. This was taken on Sunday morning, Oct. 27. On Sunday night, when the sun went down, the two could see a very strong red/orange glow coming from behind the mountain shown. The area that was hit the hardest (Scripps Ranch) is about two miles south of this smoke.

Two years ago when Mackenzie Downs moved to San Diego from Wisconsin having to evacuate her home was not something she ever thought she would have to do. Her worst fear was maybe a small earthquake and even then she hoped for the best.

A wildfire that was a little less than five miles from the home she shares with her significant other, Rick Novotny, (another former area native) was not something either person thought they would ever deal with.

"Our first thought was panic. When we heard that the fire had jumped Interstate 15, we starting packing," stated Downs in an interview.

According to the 1998 Kewaskum High School graduate The Santa Ana winds are very strong and unpredictable, and they were carrying the embers miles from the main fire.

Downs and Novotny shared their experiences in dealing with the worst disaster in California's history.

"Sunday was the worst day because nobody knew which way the fire was going to burn. We packed up all of our important papers, pictures, clothes and all of our dog's food and toys," Downs stated

Roadblocks were in the vicinity of the fire, which as of now has moved east into the mountains. Looting, as with any disaster has been a problem. According to Downs police had arrested one person for looting and are investigating a few other reports.

"The police have done an

amazing job of patrolling and checking id's," she stated.

"I have a few co-workers where the fire had come as close as their back yard. I have heard other stories of family members and close friends losing everything. Another co-worker of mine had to evacuate three times because the fires kept starting up in his community. It has been a very stressful time here for everyone, and not knowing whether or not their homes have been lost is the absolute worst feeling," said Downs.

On Monday, October 29 both took the day off and Downs only worked a half-day on Tuesday. They both say they have had to stay indoors as much as possible.

According to the two, the air quality has been horrible. Tuesday, October 30, was their worst day.

"It felt like you were looking through yellow tinted sunglasses and when you stepped outside, breathing was extremely difficult. All of our windows have to remain closed and Rick has had to be extra careful with his asthma. Everybody has been complaining of headaches, sore throats, and you hear coughing and sneezing constantly," she concluded.

Fortunately for the two and many in their area it's getting better. The air is still very much polluted, but is beginning to feel like normal.

"I have heard that the Cedar fire was caused by a lost hunter sending up a rescue flare and the Paradise fire is suspected to be arson...these are not confirmed." If it happens to be true that somebody set this fire on purpose, I will be furious. To live here and see

first hand the devastation that this fire has caused is inconceivable and if the fire was indeed arson, the person who is to blame should go to prison for life."

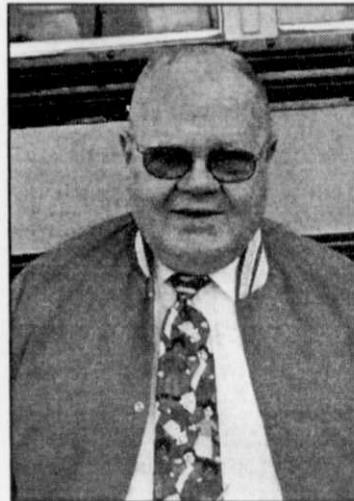

The Story of Taps

The 24-note melancholy bugle call known as "taps" is thought to be a revision of a French bugle signal, called "tattoo," that notified soldiers to cease an evening's drinking and return to their garrisons. It was sounded an hour before the final bugle call to end the day by extinguishing fires and lights. The last five measures of the tattoo resemble taps.

The word "taps" is an alteration of the obsolete word "taptoo," derived from the Dutch "taptoe." Taptoe was the command - "Tap toe!" - to shut ("toe to") the "tap" of a keg.

The revision that gave us present-day taps was made during America's Civil War by Union Gen. Daniel Adams Butterfield, heading a brigade camped at Harrison Landing, Va., near Richmond. Up to that time, the U.S. Army's infantry call to end the day was the French final call, "L'Extinction des feux." Gen. Butterfield decided the "lights out" music was too formal to signal the day's end. One day in July 1862 he recalled the tattoo music and hummed a version of it to an aide, who wrote it down in music. Butterfield then asked the brigade bugler, Oliver W. Norton, to play the notes and, after listening, lengthened and shortened them while keeping his original melody.

He ordered Norton to play this new call at the end of each day thereafter, instead of the regulation call. The music was heard and appreciated by other brigades, who asked for copies and adopted this bugle call. It was even adopted by Confederate buglers.

This music was made the official Army bugle call after the war, but not given the name "taps" until 1874.

The first time taps was played at a military funeral may also have been in Virginia soon after Butterfield composed it. Union Capt. John Tidball, head of an artillery battery, ordered it played for the burial of a cannoner killed in action. Not wanting to reveal the battery's position in the woods to the enemy nearby, Tidball substituted taps for the traditional three rifle volleys fired over the grave. Taps was played at the funeral of Confederate Gen. Stonewall Jackson 10 months after it was composed. Army infantry regulations by 1891 required taps to be played at military funeral ceremonies.

Taps now is played by the military at burial and memorial services, to accompany the lowering of the flag and to signal the "lights out" command at day's end.

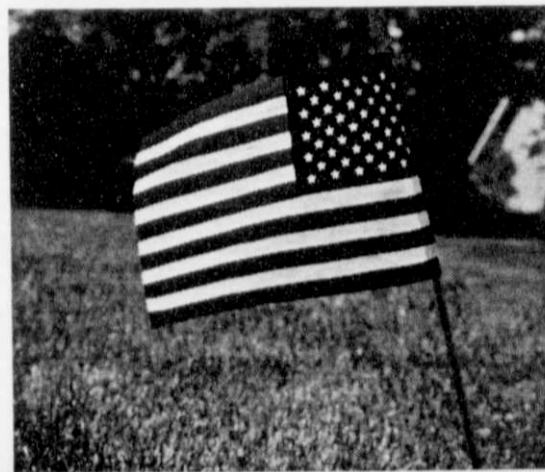

Assembly Bill 592 Advances

A bill authored by Representative Daniel LeMahieu (R-Oostburg) that will help garner additional federal funds for Sheboygan County's nursing home and other county homes across the state is one step closer to becoming law as it passed through the Joint Finance Committee unanimously recently.

AB592, which Representative LeMahieu co-authored with Senator Joseph Leibham, (R-Sheboygan) ensures that county nursing homes would be able to generate additional federal dollars and that these federal monies will be paid out to county nursing homes by lifting a \$37 million cap currently in state statutes.

"Recent state and federal funding cuts have put county nursing homes in real danger of closing their doors forever," said Mark D. O'Connell, WCA Executive Director. "Representative LeMahieu should be commended for initiating legislations that will directly help the neediest individuals that county homes serve, while at the same time protecting the property taxpayers of Wisconsin."

In the state budget passed earlier this year, county nursing homes received a

\$40 million reduction in funding. Because of these cuts, county nursing homes around the state have been struggling to keep their doors open or have been facing significant increases in the property tax to stay operational.

"AB 592 can reduce the impact of the cuts from the state budget and save the taxpayers across this state millions of dollars," said O'Connell. "We are grateful to Representative LeMahieu for his leadership and look forward to continuing the fight with him to advance this worthwhile legislation."

Later this year, Rock, Sheboygan and Walworth Counties will participate in the federal government's Intergovernmental Transfer Program (IGT), which brings federal dollars back to states that operate county homes.

With the \$37 million cap lifted, as called for in AB 592, these three counties will be given incentives to generate federal dollars for county homes in the state. According to WCA Legislative Director Craig Thompson, if the cap is not lifted, millions of federal dollars will be left on the table that Wisconsin will not be able to get for its county homes.

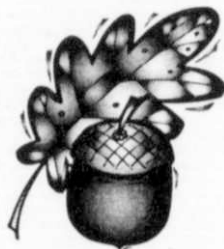



Fishing Report

(It came to my attention that some people don't like to read the first part of my Fishing Report. So for all those people go to paragraph B). The other day the vacuum cleaner needed a new motor installed and for some dumb reason I put it in. Vacuum cleaners, they drive me nuts. They are the noisiest things in the world. They rate higher at irritating me than chalk scratching on a chalkboard, kids screaming in my ear or a noisy barking dog. They are like having a race car in my living room. It's a plan to get me out of the house when my wife uses one. It does not take a vacuum cleaner to get me out of the house to go fishing but this woman does it when I can't go fishing. They are more powerful than me. I'm forced to move out of their way when they come by me. The Fishing Report can't be written on the computer while this commotion is going on. Ear plugs don't work. I have nightmares that one is running over and attacking me. She knows just when to use it and how irritating it is to me. Like when we have to go some place and fishing is

out of the question that day or when we are having company over and I'm trapped in the house. I checked out Oreck's web sight to see if they sold a muffler for their machines. It seems they don't sell one for these dirt suckers. If I lived alone someone would have to come and sweep for me or it would stay dirty all the time. If God wanted to irritate me He sure picked a device to do it with. To destroy one of these contraptions would be like catching a huge bass in my book. I'd be ecstatic. But as my wife says she needs one to pick up after me.

(B) The Big A: Monday, Thursday, Friday and Saturday: With the water temps down to 50 degree I have finally started to use live bait. The weather was so damp and rainy Tuesday and Wednesday I never did get out. The first day the northern were inhaling the chubs. The biggest one was 30" and others were undersized. One 14" bass took off into the reeds with my chub. It took a second or two to set the hook before realizing what happened. Wednesday the

northern were just hitting the bait and then releasing it.

Out from the reeds in the weed bed, on the south end of the small lake, is where most of the fish hit. The center of the weed bed did not produce anything. Only the east and west side of the bed produced fish. Using a slip bobber and rigging it at 6 to 8 feet worked the best. Sometimes the bobber would not even go down, you just had to check once in awhile to see if the chub was in the weeds or hit by a northern or bass. The chubs were about 4" long and after losing some fish I started using a treble hook stinger. After that the only hit was from a 14" bass which came off the weed bed on the northwest part of the small lake. Not bad for two days of fishing. At least the fish are where they are supposed to be.

Friday was another day fishing the same spots. The shiner was hardly in the water one minute when a 24" northern hit it. Another fish hit my chub on my other rod soon after I put it in the water. The hook was set too quick and I lost it. My next fish came on a black and red spinner bait. An almost 14" bass nailed it. That was all for the

day. The other weeds beds in the small lake produced nothing as well as the weed bed near the launch.

Saturday the action was slow. The chubs didn't attract any fish. One 24" northern did hit, in the small lake, a black and red spinner bait with hammer nickel blades. Another small northern hit a Rapala Husky Jerk, the silver and black pattern. Staying out in 9 feet of water and casting into the shallows I fished to the left of the white pier that sticks out into the lake where I lost one fish on the husky jerk. These fish came out of the southwest weed beds in the north lake.

A "tip of the hat" to the couple from Sheboygan who I talked with at the launch. After asking if I was Mr. Fisherman they said they were in the presence of a celebrity and enjoyed my Fishing Reports. Oh what a swelled head I had that day.

It kind of amazes me that there are very few people fishing. The weather on some of the days I fished had been great and the opportunity to catch big fish was there. Never put your boat away until you have to shovel the snow off it.

O.k., this week let me tell you what line I use. Mostly Trilene XL. is on my reels. My surface bait reels have 17 lb. test to get the big ones out of the slop. One crank bait reel is wound with 14 lb. for cast-

ing lures like Bagley's bb3 and one has 17 lb. for lures like Bagley's db3's. Sometimes 14 lb. is o.k. for casting the db3's. A couple of my reels for casting lighter baits have 12 lb. test. The 14 lb Berkley Fire-line smoke colored is used for throwing spinner baits. I'm not real happy with this line because it shreds but it is still strong even after that. My plastic worm and tube fishing reels have 12 lb test Stren. I've got some Berkley braided line on one reel and it seems to be ok but it seems too visible in the water. The new fluorocarbons are supposed to be good. My son uses it and likes it. The Berkley Power Pro is great stuff from what I heard but is expensive. My Musky reels have 25 lb Sten and the other has 17 lb Trilene XL. One will have braided eventually. Next week reels.

My contact says the Eagle River Chain is producing some nice walleyes. The walleyes are in the holes and are hitting fathead minnows on jigs. The larger lakes have also been turning out some nice fish. The walleyes have been where there is hard bottom. Check the shallow water at night with big minnows. Musky action has been great on the Chain using large suckers and slow moving crank baits. Email me for info.

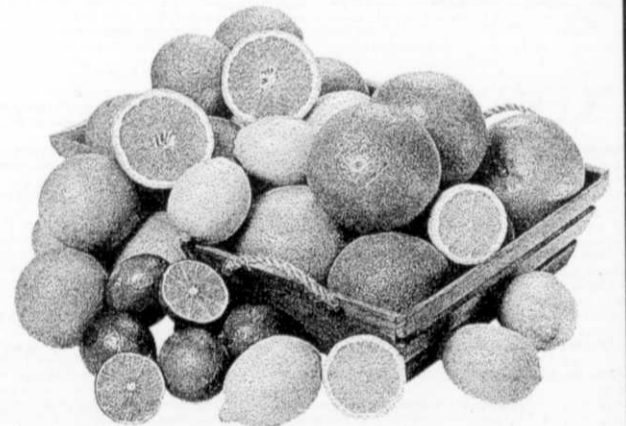
