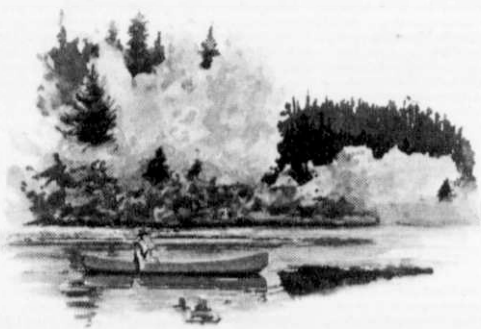

Benefit Being Planned

Kutschenreuter Recovering From Near Fatal Crash

It's the call every parent dreads receiving when their teenage son or daughter is away from home. It usually comes after the parent/s have fallen asleep and the call momentarily stops your heart.

Kim (Weare) Kauth received that call early in the morning Saturday, October 25 while she was at work saying her daughter, Chrystal Kutschenreuter, 15, was the victim of a near fatal one-car crash.

Kutschenreuter was the passenger in a vehicle driven by Luke Wagner, 18. Reports alleged that Wagner lost control of his vehicle that night and was also severely injured. Both were taken via Flight for Life Helicopter from St. Joseph's Community Hospital in West Bend to Froedtert Hospital in Wauwatosa. Chrystal has remained there since the night she almost lost her life. Luke was discharged a few days after the crash.

As a result of the crash, Chrystal's most serious injury was brain trauma. Along with the severe trauma, was a blood clot in the front lobe of her brain. She will require months of therapy, but doctors are hopeful with her age, she will make an almost full recovery. Other injuries included a compound fracture to her left arm, a lacerated spleen, fractured clavicle and scapula, broken ribs, bruised

lungs and her sixth and seventh vertebra in her neck were fractured and twisted. During her first week at Froedtert, she was unresponsive to anyone and needed breathing assistance.

As of late, her family is starting to see gradual improvements. She is starting to speak once again and walking has been an onerous task but is slowly coming back. Chrystal is slowly turning back into a normal 15-year-old girl so to speak. With this transformation, doctors have told Chrystal and her family that she may now be released to a brain rehab center. The accepting facilities are located within Froedtert and at St. Agnes Hospital in Fond du Lac.

Chrystal's family took a tour last week of the St. Agnes facility and found it to their liking and deemed it best for Chrystal's recovery. Part of this recovery is getting Chrystal back to the everyday activities that she took part in prior to the crash, activities like seeing friends and family and doing normal chores for herself. Chrystal's family feels the move to Fond du Lac would progress her recovery because being close to family, friends and school would be essential to her recovery. Currently the only people who are allowed to see Chrystal at Froedtert are Kim, her stepfather Tim, sister Tabitha and biological father, Brett.

Kim stated she received word from St. Agnes Hospital this past Sunday that Chrystal was accepted into the rehab center and a room is waiting for her. The only thing delaying the move into the rehab center right now is Brett's refusal to allow treatment, which her mother feels is in Chrystal's best interests.

"This whole ordeal of Chrystal's rehabilitation has been very stressful and emotionally draining on our family," stated Kim.

Because Chrystal is 15, and her mother and father have joint custody, it needs to be a joint, unanimous decision where she receives her rehab

care. If a decision is not made soon, Chrystal could lose her room at St. Agnes, which would deter her recovery. The end result could be at the discretion of a circuit court judge, who could delay the move even more so by making the two sides go into mediation.

"My biological father has had no contact with Chrystal and I for the past three years, in my opinion he should not have the right to determine where my sister goes next. She needs to be close to home and in my opinion that is what he is trying to prevent. Chrystal and I have a very special bond and I only want what's best for her," stated Tabitha.

In the meantime, Tabitha and other members of Chrystal's family have begun fundraising efforts to defer medical and rehabilitation costs. A fund has been set up at St. Francis Bank in Kewaskum in Chrystal's name. Donations can be mailed to the bank in care of **Chrystal Kutschenreuter Benefit Fund**, P.O. Box 68, Kewaskum WI 53040-0068. They can also be dropped off at the Kewaskum branch. Tabitha has also made donation boxes that can be found at many Kewaskum businesses.

Kim and Tabitha have both taken a leave of absence from their jobs at BRIDGES of Wisconsin located in West Bend. Their co-workers are planning a benefit for the family on January 24th at the Amerahn Ballroom in Kewaskum. Specifics are being ironed out and *The Statesman* will follow up with more information as it becomes available to the paper. Bridges of Wisconsin provides services and resources for individuals with physical, mental or cognitive disabilities.

"The support we received from people inside, and outside the community with phone calls, prayers, cards and visits has been overwhelming and greatly appreciated," added Chrystal's grandpa, Neal Weare.

Drivers in the Village of Kewaskum can soon breathe a sigh of relief as traffic is moved on the newly reconstructed four lanes of USH 45.

According to D.O.T. Project Engineer, Jeanne Marchant, all work is completed in the village. The newly constructed box culvert at the fire station is completed and the roadway has a fresh coat of asphalt all the way south to the new four lanes.

Motorists are now able to use all four lanes and TWLTL [two way left turn lane] from CTH H West to Sandy Ridge Road, at the village limits. Once the switch is complete crews will remove the temporary markings on the Southbound lanes and retire for the winter.

Marchant stated that paving will cease for this year and hopes paving outside the village will be complete by May of 2004. She further stated that snowmobile enthusi-

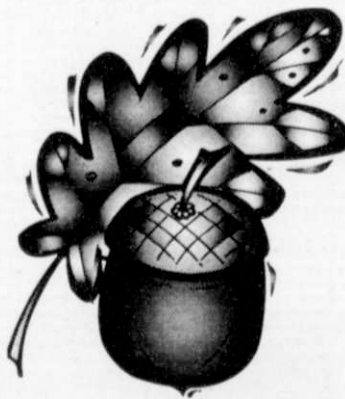

Missing Your Bike?

Kewaskum Police Chief Richard Knoebel would like to inform all Kewaskum residents about the abundance of bikes that have been found in the Village of Kewaskum recently by his police officers. So many of them in fact, they had to be moved to a larger storage area, as they did not fit in the police department garage.

These aren't just old bikes either according to Knoebel. "A lot of these bikes are almost like new," he said. Knoebel added that if a resident is missing a bike he/she should make an appointment at the police department to describe the missing bike. An appointment can be made by calling the department at 262-626-2323. The bike will

be given back to its rightful owner after the bike is registered.

According to a village ordinance all bikes are supposed to be registered. Registering the bike in the village costs only \$5, a lot less expensive than buying a new bike or walking. This enables the police department to keep record of whom a bike belongs to.

If the bike is registered, the police officer that finds it checks the registered bike's license and returns the bike to its owner. If the bike is not registered, the bike sits in a storage garage awaiting its owner or after a period time, the bike is auctioned for pennies on the dollar to area residents.

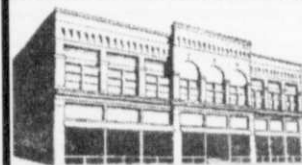

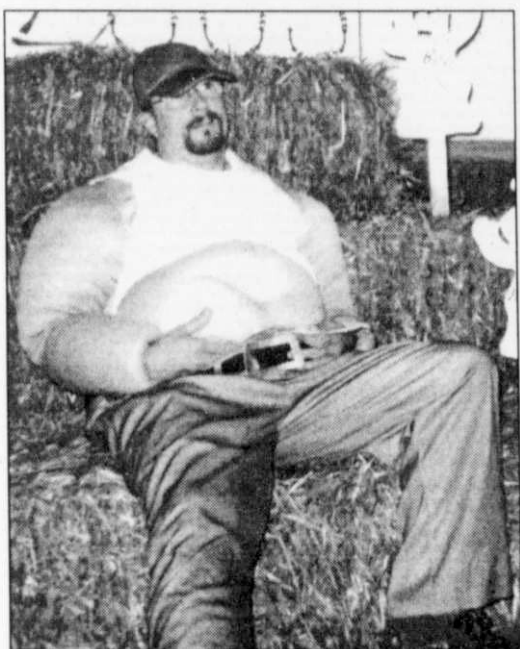

New Potawatomi Prairie Subdivision Promotes Heritage



Shown above is a view from Kettle View Drive of the progress in the Potawatomi Prairie subdivision. Work has been progressing at a steady pace. Two structures have already been erected and crews are working at infrastructure.

The Potawatomi Indian oral tradition tells of three brothers, Ojibwe, the oldest son was the Faith Keeper; Odawa, the middle brother handled trade; and Bode-wadomi, the youngest, kept the sacred fires lit.

When the three brothers left the Eastern seaboard and migrated back to the Great Lakes area, they may not have had distinct tribal identities, but within time they evolved into three nations. These three closely aligned nations of the Ojibwe, Ottawa, and Potawatomi formed an ancient confederacy called "Ne shna bek". Within the Ne shna bek, they inter married and gained strength in their alliance.

Today, the Potawatomi still refer to themselves as the "Keepers of the Fire".

It was this heritage that led to the name of the new subdivision Potawatomi Prairie. The emerging tribes from the three brothers are also carried out in the streets of Potawatomi Subdivision with names of Ojibwe Path, Odawa Circle, and Bode-wadomi Circle. Another street, Ne Shna bek Trail, portrays the three-tribe alliance.

No Indian heritage in this area would be complete without the chief who resided in Kewaskum, so there is also a "Chief Kewaskum Place" in the subdivision. Potawatomi Prairie subdivision is truly a memorable way to honor the first inhabitants of this land.

THREE DIFFERENT BUILDING STYLES MAKES NEW POTAWATOMI PRAIRIE SUBDIVISION UNIQUE

Potawatomi Prairie Condos will consist of three different types of living units, side-by-side condo duplexes, four-family unit condos, and single-family homes. The three types of units will be in different areas of the subdivision.

The first category of the new Potawatomi Prairie "reservation" will be the side-by-side duplexes built in two phases, with two units to

each of the 16 buildings. Electrician John Kuehl, Builder Charles (Ed) Edmonds, and Builder/Developer, Gary Gavin formed a "pow-wow" called "Trio Condo L.L.C.", and they will be handling this segment of the project.

The 1600 sq. ft. units will start at \$160,000. It will be a turnkey operation with everything done for you in exchange for "wam pum" of \$75-\$100 per month in maintenance fees. Buyers will be able to pick out flooring, counter tops and other basics to customize their particular "tee-pee". If additional individual things are wanted or needed, the buyer must make their wishes known early and the group would be happy to work with the buyer.

Local tradesmen, who have been in the business for many years, will be working on these buildings. They are currently moving dirt, building roads, and installing sewer and water as part of Phase I, which started in October. The anticipated move-in date for the five buildings (10 units) in phase one, is March 2004. Phase two is slated for 2005, if not sooner.

Another section of Potawatomi Prairie will be 26 four-family units with Gary Gavin being the "chief" developer/builder. The first of these units was started in October and will be offered through Kewaskum Prairie Gardens L.L.C.

These condos will cover 1400-sq. ft. and will include two bedrooms, two baths, a two car attached garage, and a large balcony or patio. Twenty-three insulation is being used as a fire barrier between the buildings and for soundproofing (so the beat of the "native drums" will not be heard). Buyers will have the option of picking out some of the basics for their unit within parameters.

Each building will be somewhat different and landscaping will be provided. The units will start at \$145,000 with maintenance being done through the \$75-\$100 "Wam Pum" condo association fees. One unit is planned to be built this year,

five units next year, and then five units per year thereafter.

These luxury four-family condominiums will offer exclusive living in a park setting with 45 acres of nature behind them. Nature trails, reminiscent of early native Indian trails, will be prevalent, and will be accessible to village residents, making it an asset to Kewaskum. Street lights, curb and gutter, and picnic areas with grills are just a few particulars that will be done to enhance the subdivision, while making it a more friendly place for all "natives" to enjoy.

The third portion of the subdivision will be composed of 60 single-family lots in various sizes, also being offered in two phases. The introductory lot prices will run from \$46,000 to \$52,900, and can be obtained through Kewaskum Prairie Gardens L.L.C.

Although it would be more convenient to have your home done by builder Gary Gavin, who is well known in the area for quality construction, it can be done with your builder from another "tribe". However, the developer, prior to construction, must approve all plans with no pre-fabs allowed. The inside of the home is pretty much what a buyer wants to do; however, the outside of the home will be subject to the covenant. This covenant will be strictly enforced to keep the standards of exclusive living high throughout this subdivision which denotes our heritage.

The covenant requires a six-pitch roof minimum, a concrete driveway, and at least two trees of one and one-half inches in diameter, just to name a few items. 25% of the house front must be something different than siding and no houses in the block can be the same.

Easements will vary from a full walk out to a half-exposed basement, according to the lay of the land, lending further variety. To assure the covenant is upheld, all home plans and colors must be submitted and approved by the developer before building, as well as a landscape

design for each house.

The developer will be planting two trees in front of every lot. Potawatomi Prairie has a rolling terrain with a 45 ft. drop from the west side of the property to the east side.

The subdivision is bounded by CTH H on the North, Kettle View Dr. on the West, trees and farm land on the South, and 45 acres of nature on the East. To get the best views and prices, it's the "early bird" who gets in before construction who will get the choice buildings and lots.

Potawatomi Prairie will be different than any other subdivision with its upscale tasteful plan resulting from compliance with the covenant and the many enhancements the developer is adding.

For example, there will be boulevards with planters and a three-fourths acre pond just for the beautification of the place. An 84 ft. easement with planters will be constructed at the grand entrance, which, besides being beautiful, could be assimilated as the gateway to a "fort".

All of these numerous special touches to this community, plus the natural surroundings, will truly comprise a feeling of pride in all "tribesmen" who will be able to live in this prestigious "clan".

GAVIN A DEVELOPER WITH PRIDE IN HIS COMMUNITY

Gary Gavin is no stranger to the Kewaskum area where he is known for his many quality land development and construction projects since he started in 1983. In 1993 he developed his first big project called "Sunset Estates", composed of 54 lots. In 1995, 26 condos were built at "Park Place" a condominium community in Sunset Estates.

Forty-five lots were developed in 1996-97 in "Whispering Willows", and 94 lots in "Old Glory Heights" in 1999-2000. These two projects were done in conjunction with Joel Fehlhaber.

Across the road from his current, new super subdivision "Potawatomi Prairie, is another new smaller project that Gary started in September of 2003, called "Crown Royal". This project on the former Bill Lehman property will consist of five side-by-side duplexes. The ten units in "Crown Royal" will start at \$165,000 (plus condo fees), and the house that is currently on the property will be rented out or sold.

Outside of Kewaskum he developed the 25 lots called "Krystal Heights" in Farmington with five lots left ranging from \$45,000 to \$52,000. In

the town of Wayne on the former Harold Proeber farm, Gary is currently developing "Essence of Time", a 25 lot subdivision with two and one-half to ten acre lots.

Gary has lived in Kewaskum all of his life and is proud of it. He and his wife, Linda, have three children, Stacy, Heather and Krystal. Gary thinks Kewaskum is a great place to live where there are 57 acres of parks, good community groups, and an ideal area for raising children. He enjoys being in the heart of the Kettle Moraine, yet just 45 minutes to an airport.

Gary compliments the Village of Kewaskum as well as Village Administrator Dan Schmidt and Department of Public Works Director Jerry Gilles for doing a good job, and he enjoys working with them. Gary feels the new four lanes coming into town will impact the community with some influx of new people who will be looking for housing. However, Gary's main concern is to develop land for the local people who want to stay in Kewaskum and need housing.

Gary has a true "gift of imagination" to have the foresight to see how land can be turned into a subdivision, and does what it takes to get the job done. He is a major contributor to the growth of Kewaskum through his insight for developing land and providing all types and prices of homes for people.

Rep. LeMahieu's First Piece of Legislation Garners Historic Bipartisan Support

A bill authored by Representative Daniel LeMahieu (R-Oostburg) on behalf of the Wisconsin Counties Association (WCA) that could potentially keep county nursing home doors open passed both houses of the legislature yesterday with uncommon bipartisan support.

AB 592 passed unanimously and ensures that county nursing homes would be able to generate additional federal dollars and that these federal monies will be paid out to county nursing homes by lifting a \$37 million cap currently in state statutes.

"The Intergovernmental Transfer Program (IGT) has been a controversial issue over the years, yet through the leadership of Representative LeMahieu, every representative - both Democrat and Republican, voted in favor of this important bill yesterday," said Craig M. Thompson, WCA Legislative Director. "That is truly an accomplishment."

AB 592 was initially shepherded through the Assembly by Representative LeMahieu,

where he was able to garner a 99-0 vote. It was then sent on to the Senate, where co-author Senator Leibham secured a 32-0 vote.

In the state budget passed earlier this year, county nursing homes received a \$40 million reduction in funding. Because of these cuts, county nursing homes around the state have been fighting to keep their doors open or have been facing significant increases in the property tax to stay operational.

"As a former county board chairman, Representative LeMahieu did not forget his roots. He picked his first piece of legislation to be about protecting counties and the property taxpayers," said WCA Executive Director Mark D. O'Connell. "I wish we could have 99 Representative LeMahieus in the Assembly."

Later this year, Rock, Sheboygan and Walworth Counties will participate in the federal government's Intergovernmental Transfer Program (IGT), which brings federal dollars back to states that operate county homes.

President Mathew A. Heiser presided. Trustee Thomas Piwoni asked to be excused and was absent; all other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and the Pledge of Allegiance.

They also asked if the Board would have funds to provide the fall zone if necessary. The Board indicated they had no problem with additional play equipment, but wanted them to bring in a sketch of the proposed location and exact pieces of equipment to determine the fall zone criteria and then to take the matter to the Park & Recreation Committee. The Board also told them little if any money could be made available to assist them.

Fire Chief Mark Groeschel was absent.

Director of Public Works Jerry Gilles reviewed the following:

1. The Board was informed some storm sewer cleaning has taken place and of the poor condition of the storm sewer and catch basin in the middle of the First Street block.

2. It was reported that a storm sewer drainage way within Sunset Estates was cleaned with the assistance of Washington County.

3. Leaf collection has begun, but if anyone knows of any party wanting leaves, to contact the Village.

On a motion by Trustee Kevin Scheunemann, seconded by Trustee Steve Scheunemann and carried by the majority voice vote, the Board approved the issuance of the Operator's Licenses for 2003/2004 upon proper payment of fees and documentation for the following:

The Police Department had no objection to the issuance of said licenses.

Administrator Daniel S. Schmidt reviewed the following with the Board:

1) League and Taxpayer bulletins.

2) Review building permit report for period ending September 2003.

3) Reviewed a proposal to have Washington County Highway Department lower the speed limit from Kettle View Drive east on CTH "H" to at least 45 mph. On a motion by Trustee Andy Pesch, seconded by Trustee Harry Roecker and unanimously carried by voice vote the Board directed the Administrator to

send such a reduction of speed request to the Washington County Highway Commissioner and Highway Committee.

4) Review correspondence.

A. Review request to remove sewer charges from a water and sewer bill because the customer indicates all or at least the larger percentage of water was deposited on the lawn. The Board reviewed the PSC (Es criteria for not charging for sewer. Schedule Mg-1 is to be used for the quarterly fixed charge to be charged per meter and then the water to be billed off the same schedule. The request to have an individual meter would need to be placed per Schedule Am-1 indicating a \$6.50 meter rental charge as well as a \$30.00 installation charge. This would mean that a total cost of \$56.00 additional would need to be placed on the bill versus sewer charges. This would indicate that to break even it would take 18,300 gallons going thru said extra meter.

On a motion by Trustee Robert Stoltzmann, seconded by Trustee Andy Pesch, and unanimously carried by voice vote the request was denied and that a letter be sent to the customer.

Public Works Chairperson, Trustee Andy Pesch informed the Board that a general discussion was held regarding the proposed budget for 2004. No action was taken.

Board Representative for the Plan Commission, Trustee Andy Pesch, announced a scheduled Commission meeting for October 28, 2003 at 7:00 p.m. might not take place.

Board Representative of the Library Board, President Mathew Heiser, reported that there was a meeting Monday, October 13, 2003 at 6:30 p.m. The details of that meeting were unknown.

Board Representative on the Mid-Moraine Municipal Association Legislative Committee met and the topic was again health insurance. It was noted the new proposed plan is not progressing as fast as they thought it would.

On a motion by Trustee Kevin Scheunemann, seconded by Trustee Steve Scheunemann and unanimously carried by voice vote the Board authorized the narrowing of the private roadway within the PUD for HH Duties as long as adequate parking is made available. If the police were to enforce no parking in the tapered 65, area, a request for such enforcement and proper signage would need to be posted.

Discussion was held on the street snow plowing agreement with the Town of Kewaskum. On a motion by Trustee Kevin Scheunemann, seconded by Trustee Robert Stoltzmann and unanimously carried by voice vote the Board authorized the signing and sending of the letter in which the Village agrees to plow snow from the Village limits to the USH "45" intersection in turn for the Town plowing the easterly 1/2 of Kettle View Drive just south of CTH "H". The Board acknowledged the six driveways and very little snow storage space, indicating the village is not responsible for any snow being deposited into any driveway or yard.

Administrator Daniel Schmidt reported on the Wisconsin Department of Transportation Report for 2003. It was indicated .4 mile of streets were added to the village street system totaling 13.14 miles. Action on Resolution No. 2003-26 A Resolution Authorizing The Submission Of The Wisconsin Department Of Transportation report for 2003 as attached hereto:

Administrator Daniel Schmidt reviewed the Park & Recreation Proposed Budget indicating not many items have been left in because of the need to address the cracks within the tennis courts and that that cost is estimated to be \$60,712. An overall budget summary was then reviewed and options as to a direction to accomplish a balanced or

flush budget was determined by consensus. The total levy for 2003 budget was \$1,134,415. The growth experience this year was at 3.31 percent adjusting the levy to \$1,171,964. The total proposed budget revenue for the 2004 budget is \$882,605 and the expenditures are \$1,984,634. The library had requested \$91,422 and debt service is at \$95,088 giving us a total expenditure of \$2,171,144 or the need for \$1,288,539 in levy or \$116,575 more than the \$1,171,964 that would maintain a flush or flat budget. It was indicated that if the Village Board transfers \$77,192 or 1/2 of the hydrant rental to the water utility as suggested by the Governor and Legislature, removing \$7,364 from the Park outlay account, setting a maximum for Library support for 2004 at \$89,632, moving \$20,000 from Open Space and \$10,229 from the Restricted Fund, a balanced/flush or flat budget can be achieved.

This would mean the equalized tax rate for 2003 of \$6.57 would remain for 2004 and that the General Budget would be \$1,977,290 or down by \$25,913 or down by 1.3%. Discussion was held on a few of the noted items followed with a consensus of the Board to have the staff prepare for the public hearing and remaining budget process using this philosophy.

Discussion was also held on drafting a letter to be sent to the School District regarding the use of the southwest and other diamonds at the Kewaskum Kiwanis Community Park and the School Liaison Officer.

The proposed meeting dates for the balance of 2003 were reviewed. On a motion by Trustee Kevin Scheunemann, seconded by Trustee Harry Roecker and unanimously carried by voice vote, the Board left the November 3, 2003 meeting date as is with November 17, 2003 meeting date changed to the Public Hearing date with a start time of 7:00 p.m. and establishing of one meeting date in December, that being the 15th. The changing of the Plan Commission dates will be scheduled as needed to take care of business.

Motion by Trustee Kevin Scheunemann, seconded by Trustee Harry Roecker and carried by the majority roll call vote, to adjourn. Roll call vote was 6 "Aye" 0 "Nay" 1 "Absent".

Hunters Register More Than 38,800 Deer During Early Zone T/CWD Hunt

MADISON — A preliminary count of deer registered in the Oct. 30-Nov. 2 Zone T gun deer hunt showed Wisconsin hunters bagging 38,803 deer in mixed weather conditions across the state. Oct. 30 also marked the start of the extended gun hunting season in the chronic wasting disease (CWD) intensive harvest zone, and the registration totals include some antlered deer that were shot in the CWD zone. A total of 47 Zone T deer management units and 15 CWD units were part of this past weekend's hunt.

Bill VanderZouwen, chief of the DNR Wildlife and Landscape Section cautioned that it is difficult to compare Zone T harvest numbers to previous years. The number of deer management units included under the Zone T framework changes from year to year, as it is based on reducing herd size in units that surveys show are over population goals. This is unlike the November hunt when all units statewide participate every year.

"There were 41 deer management units designated as Zone T in 2002," VanderZouwen said. "This year it was 47 units. With the changing number and distribution of Zone T units from year to year, then preliminary results don't really tell us much.

Final registration numbers for the 2002 October Zone T hunt was 28,144. Hunters registered another 8,084 in the four-day December 2002 Zone T season.

"Hunters produced an average harvest of 625 deer per Zone T unit in October 2002 and about 860 per unit this past weekend," VanderZouwen said. "This looks like a big gain but it's important to remember that deer units do have different sizes, habitat types and total deer populations so direct comparisons are difficult."

Hunters in the southern region experienced good conditions Thursday, Friday and Saturday but also awoke to a cold rain Sunday morning. Late Saturday registration was brisk between sunset and station closing at Barneveld where four registration lines were busy with three and four vehicles at a time in each line. Many vehicles brought in three and four deer at a time.

"I saw and spoke to many hunters who took to the woods this weekend," said DNR Secretary Scott Hassett, who worked at the Black Earth registration station on Saturday and the Barneveld registration station Sunday. "While it was great recreation for the hunters I talked to, most also were aware that their efforts were helping manage the deer herd in the state, and we truly thank them for those efforts."

Rutting activity was evident in most areas of the state with hunters reporting good deer movement and excellent deer condition in many areas. The focus of the four-day hunt was antlerless deer but many landowners in the

CWD disease eradication zone who applied for a landowner permit and were issued two free buck tags with the permit used the opportunity to fill their buck tags. Many others earned the right to shoot a buck by first shooting an antlerless deer. In the DNR South Central Region, which primarily includes the CWD zone units, 71 percent of the deer registered were antlerless deer.

Biologists were collecting deer heads for CWD testing at registration stations across the CWD management area west of Madison and in selected other areas around the state. In the CWD intensive harvest zone gun hunting will continue through Jan. 3. All other areas of the state will return to archery hunting until the nine-day November gun hunt opens on Nov. 22.

Dry late summer conditions made for good access in wetland areas that would normally be difficult to hunt, said Bob Michelson, regional wildlife biologist from Eau Claire. In other areas, most of the corn has been harvested, reducing escape cover and improving chances of success. While hunting conditions in general were favorable for the four days, rain on Sunday kept hunters out of the woods in some places.

Northern region hunters experienced somewhat different conditions according to regional wildlife biologist, Mike Zeckmeister.

"There were 18 northern deer management units in the Zone T hunt this year," said Zeckmeister. "The weather was overcast all four days and it was rainy on Thursday and Friday but little or no rain fell Saturday and Sunday. Temperatures were in the mid 40s. Overall, there were good hunting conditions for late October to early November."

State hunter safety education coordinator, Tim Lawhern, reported a single nonfatal self-inflicted gunshot injury occurred on Nov. 2 in connection with the Zone T hunt. The hunter, a 14-year old, apparently fell asleep but awakened as his rifle slipped between his knees. The hunter grabbed at the firearm causing it to discharge, hitting his foot.

"As we track the conditions and circumstances under which hunting accidents occur we find that one-third to one-half of all hunting accidents are self-inflicted," said Lawhern. "Following firearm safety precautions at all times, such as making sure the firearm safety is on at all times except when ready to shoot, can help reduce the number of self-caused injuries."

The Zone T hunt coincided on Nov. 1 with the statewide Youth Deer Hunt. On this day, youth aged 12 through 15 could hunt antlerless deer with a firearm in any non-Zone T and Zone T deer management unit. This special season, especially in non Zone T units, gives youths a

quality hunting experience during a time when there is less hunter pressure than during the regular gun-hunting season, Lawhern said. Youth must be accompanied by an adult 18-years or older and provides an opportunity for mentoring and bonding.

A second Zone T hunt will be held Dec. 11 through 14. That hunt is only held in deer management units located south of Highway 8. Hunters may also use their Zone T tags to shoot antlerless deer in Zone T units during any other hunting season, including the archery, or regular gun season, which runs Nov. 22-30, or the muzzleloader season.

"Zone T hunts are an invaluable tool in helping to lessen the impact caused by high deer populations, said VanderZouwen. "I would guess that nearly every driver in the state has hit or knows another driver that has hit a deer. Farmers lose thousands of dollars worth of crops to browsing deer and homeowners have found entire ornamental plantings mowed down by hungry deer.

"This Zone T hunt made a significant contribution to controlling the deer herd, but we still have a long way to go in most units if we are to drop the Zone T hunts or avoid earn-a-buck regulations in 2004."

LETTER TO THE EDITOR

TO THE EDITOR:

Saturday, November 8, 2003 was a beautiful day for pheasant hunting. Tylere and Bryan Daggett, along with Tylere's dog, Jasmine, and Bryan's dog, Goldie, were looking forward to an afternoon of hunting.

As I prepared to pull off the highway to let the boys and their dogs out, I leaned over and patted Jasmine on her head and said, "Have a good hunt, girl." Bryan released Goldie from the back of the truck. Both boys held onto their dogs as cars passed by. Their plan was to start in this short fence line and then work their way back to my son's farm.

Bryan and Tylere are cousins who both play high school football and have been friends since they were little. Both boys love the outdoors and being together with their dogs hunting.

This Saturday afternoon started out with the usual excited anticipation for a good hunt. Before it barely began, tragedy struck. Tylere's dog, Jasmine, got caught in a choke hold (Conibear) type of trap. The boys heard her yipping and rushed to her side, at first thinking she had picked a fight with a racoon, only to be struck with absolute horror to find her caught in this device.

They frantically tried to free Jasmine from the massive choking device, but they did not know how to get the trap off and used all their strength to help Jasmine. Tylere told Jasmine to lie quiet so they could get at the choking device. She obeyed the command, but they were unable to stop the choking because the device was securely pressuring against her throat and the top of her neck, and she then slowly passed away. It was a slow, agonizing, brutal death that the boys had to witness and will never forget.

Jasmine's death has brought unbearable sadness to the whole family. She was a constant companion to Denise, Tylere's mother. Jasmine would sit in the front seat of the van waiting for Denise to return from shopping. The girls, Rachel and Leah, loved her too. She stayed in the house and was a good watch dog as well as a companion, and yet she remained true to her love of the hunt. When Tylere, her master, mentioned hunting, her little tail would wag and she couldn't wait to head for the fields alongside him.

The suffering Jasmine endured before death came was horrific, so when we were told these traps are considered

more humane than other devices, it is a false statement. There is supposed to be a tool which the trapper has to release the victim he has trapped, but, in Jasmine's case it was not available. What if it had been one of the boys? Could it have meant an amputation of a limb because of restricted blood flow? Since the trap had been placed by a large bale of straw or hay, with the trap hidden in tall grass, it was a disaster waiting to happen.

When I think of traps set for animals, I usually think of them being placed along river banks in low-lying areas. I could never have imagined one where Jasmine met death.

Here you have two boys that had done all the right things. They both had gone through the gun safety course. They were enjoying the great outdoors with their hunting dogs. So, how does something this tragic happen on a bright, sunny afternoon when pheasant hunting? For one, a trap should never have been placed in that location. Hunters have to know their target and beyond. Doesn't the same rule apply for a trapper? Shouldn't he be using the same rationale when placing traps to avoid this needless tragedy?

For safety's sake, I would recommend all land owners to ask the person/persons requesting to hunt on their land, if he/they are hunting or trapping, and if this person is trapping, where the traps are being placed. Why isn't the area posted to warn other hunters of the potential danger? Trapping is no form of hunting and is made for lazy hunters. I can see no joy in trapping and to me it is inhumane.

When you go hunting you know your target, and it is killed as quickly as possible, but in this conibear trap, the animal suffers a miserable and painful death. The trap makes no distinction between domesticated and wild animals. With this trap a pet cat roaming the fields hunting mice, or your pet dog, can fall prey to this trap.

It is inhumane to subject any animal to such torture and eventual death. The use of these traps is controversial so notify your legislator to ban this trap.
