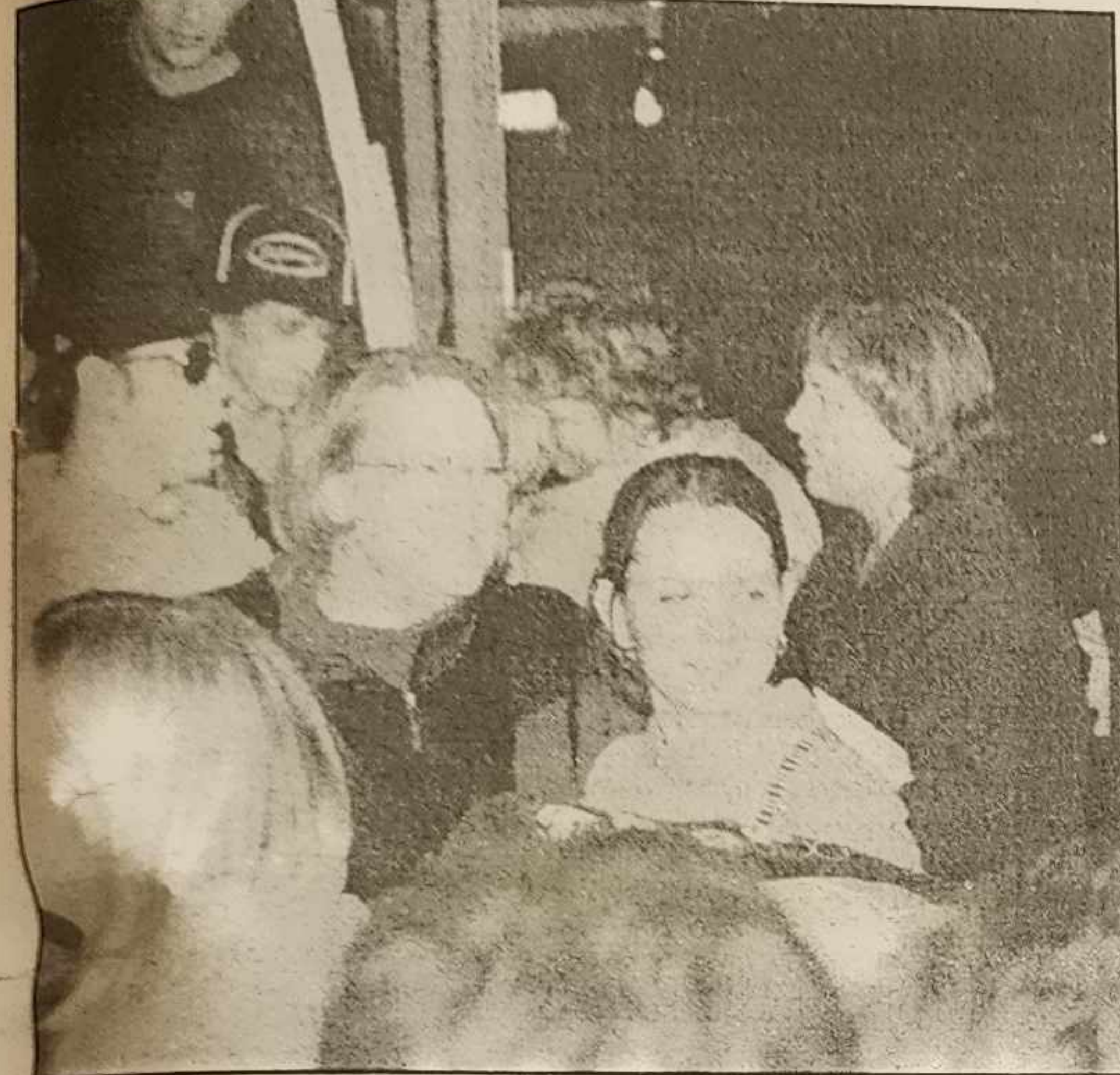

Chaperone, Band Director Still in Indy Hospitals KHS Band/Choir Students Injured After Bus Crash in Indy

The parents of 103 Kewaskum High School band and choir students were elated to see two Trailways Buses of Indianapolis Monday night around 11:15 p.m. The buses returned students and chaperones from a weekend trip to Florida where they participated in a concert.

Dry eyes of parents and siblings were in the minority as many of the parents and students walked off the busses with crutches and bandages covering bruises and cuts they received when two of the Kobussen chartered buses they were riding in collided on northbound Indiana Interstate 65 through downtown Indianapolis around 12:30 p.m. Monday, police there said.

The group had traveled 17 hours when the crash occurred. Many of the students were sleeping, playing cards or watching TV.

School officials learned of

the crash when a student on the bus misdialed and called the high school when attempting to call a parent. School officials here immediately went into crisis mode.

Indiana State Police said the first crash occurred shortly after 12:15 p.m. when a 1996 Kenworth, driven by Salvador Santillan, 38 of Harvey, Illinois, entered the north split ramp to I-65 at too fast a speed that caused his flatbed trailer and tractor to rollover.

As a result of this crash the cargo of coiled steel rolls broke free from the flatbed and the semi and tractor came to rest blocking the ramp to northbound I-65.

The operator of the lead Kobussen bus driven by Dan Kunstman, 54 of Neenah, WI slowed abruptly to avoid traffic that had moved in front of him. At this time the second

bus driven by Lloyd Schuessler, 65 struck the rear of the front bus. The front bus was then pushed into the side of a Mack dump truck. None of the drivers were injured in this crash.

The buses, bound for Wisconsin, were carrying students and chaperones who had participated in a band and choir festival in Orlando, Florida over the weekend. The students came back to Wisconsin with one trophy but the joy that trophy brought was taken out of the limelight as the collision unfolded.

The front of one bus was smashed, and the back of the other also sustained some damage. Neither driver involved in the bus crash was injured.

Thirty-eight people from the buses were taken to area

hospitals, mostly with minor injuries. Most of the injured were released shortly after being treated.

The uninjured students huddled on the inside shoulder of the road as they awaited another bus to take them to the Indianapolis Red Cross Shelter where they remained until around 4:30 p.m. when they boarded the new buses to being the last leg of their journey home where anxious families awaited their safe arrival at 11:15 p.m..

KHS principal Christine Horbas stated Tuesday that band director Keith Reynolds was admitted to Methodist Hospital where reconstruction

Harlow Joins Statesman Staff

"We didn't have many girls in the neighborhood, so it was either stay in the house or join

in the boys' games. I chose the latter," she said, adding she never regretted the move.

Spending her summers at Random Lake gave Harlow the opportunity to do a lot of fishing, an activity she still enjoys, and she is still pretty competitive when it comes to golf.

Harlow is eager to meet with all the high school coaches to see what kind of talent they have on their spring teams. "I know track has come a long way since Jerry Gosa took over as the coach," Harlow said, expecting both the boys' and the girls' teams will have some good individual talent.

Harlow also indicated she's glad fast-pitch was added as a girls' sport over a decade ago because there are so many girls in the area that love the sport.

Harlow hopes to offer features on KHS athletes who have taken their talents to the college level, and she will write about activities at Hon-E-Kor Country Club as well as report on the Kewaskum Athletics home talent baseball team.

"We are very excited to have this addition to our staff, Judy is a veteran of sport journalism. I know she will be a huge asset to all of our publications," stated Andrew Kuehl, Statesman Managing Editor.

St. Joseph's Convent Looking for Financial Assistance for Defibrillator

After instructing employees on CPR of St. Joseph's Convent located along the Milwaukee River in Campbellsport, Tina Rawlins, a 19 year veteran of the campus saw the need to introduce an A.E.D. machine more commonly referred to as a Public Access Defibrillator.

Rawlins is quick to point out that the defibrillator is not for the sisters of the Convent but for the 180 employees of the campus. She also sees the need for the visitors of the convent.

"We have a variety of classes held here at the convent, there are a lot of people coming through the doors each day, anything can happen to anyone of these visitors and we want to be prepared," stated Rawlins.

Rawlins along with the Convent's Employee Safety Committee did their homework on the purchase of this life-saving tool. Once the \$3,600 is raised, the machine they plan on purchasing will be compatible with machines used and recommended by the Campbellsport Police and Fire Departments.

Rawlins continued, "We did this in the unlikely event that there would not be a qualified person on staff to handle the situation; any member of law enforcement or emergency medical service could step in with the same knowledge of the equipment."

Many of Campbellsport's civic organizations have

stepped up to the plate to assist with financing this project. Over \$1,300 has been raised.

Most recently this newspaper has agreed to give a portion of each new subscription purchased in the month of April.

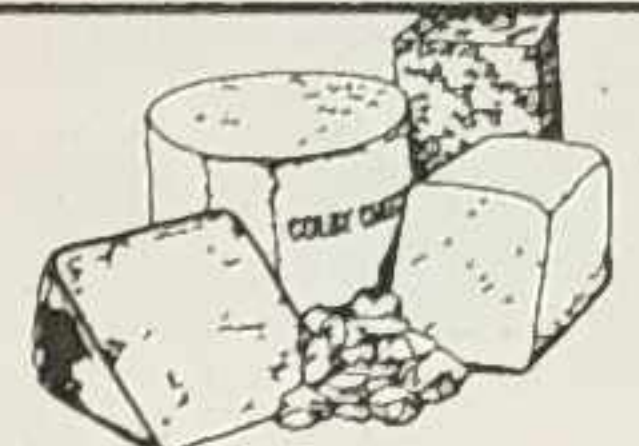

tion on his ankle took place and bone chips from his knee were extracted. His release is pending.

Horbas also indicated that a chaperone, Sandy Zimdars was slated to be released Thursday or Friday from Wishard Hospital. She had a rod placed in her ankle.

A handful of students involved in the crash attended classes Tuesday. Horbas indicated that it was not a requirement for the students. Wednesday was the first day the entire student body will be required to be in attendance. Counselors will be available if needed.

Kyle Lickel, 17, who was riding in the first bus and escaped injury, said the trip to Florida plus the wreck will make the trip very memo-

orable. And he didn't think his classmates would view Indianapolis too harshly.

"The Red Cross was just great. Absolutely. They fed us, made us feel comfortable, and got us teddy bears," Kyle Lickel said. "And the weather was great. It was beautiful down there (in Indianapolis). A great place to stop."

Statesman Correspondent Shares her Experience

Rockin' in Orlando, Shakin' in Indy

"Welcome to Indianapolis," the Red Cross worker told our crowd. "We love to have people visit us, but not this way," she said. On our way home from a wonderful and successful music festival competition and theme park visits in Orlando, Florida, we literally ran into a little problem in Indianapolis. Late in the morning, a semi roll-over caused a massive back up on I-65. Our bus could not stop quickly enough to avoid hitting a vehicle in front of us. The second bus behind us could not compensate for the sudden halt and rear-ended us.

We were impressed by the immediate reaction of the first responders, fire department and Indianapolis Red Cross to come to our aid, followed on the spot by the media. We hoped to get word to our families before you could see the frightening-looking damage caused by the crash. The students were fantastic and cooperative, helping and comforting each other and sharing their phones. Of the 103 KHS people and two bus drivers, less than a third

needed to visit the hospital for their injuries, two of which, both adults, were considered serious

enough to need possible corrective surgery and an overnight stay. The rest were treated and released to the Red Cross facility. Resulting injuries included one student receiving fourteen staples to close a head wound, concussion, glass cuts, a torn ACL, broken teeth and an impressive collection of bumps and bruises. And we thought the Disney characters were colorful - wait until you see some of the blues and greens students and chaperones alike brought back. We are all grateful to Polly Bertelsen, our trip nurse. She went into immediate triage mode and was a huge help at the accident scene. Indianapolis Red Cross went out of its way to make us comfortable and feed us, even replacing lost shoes and providing emotional support. Two other busses were provided to take

Hon-E-Kor Opens for Season

The familiar sound of "fore" could be heard echoing around Hon-E-Kor Country Club last Friday, the opening day of the 2004 golf season.

The members were happy to see the course open early, and owner/greenskeeper Jim "Jonesy" Korth was grateful Mother Nature was kind to the greens and tees over the winter, making the early start possible.

Amerling, John Hoerchner and John Dreher, will be working on a new trap on the right side of No. 9 Blue.

"It's going to be a target-type green," he said, and once it is finished, golfers will be forced to hit a straight approach shot or they will find sand.

Korth said a year ago the membership total hit close to 300, and with 250 already signed up for the year, it looks like the 2004 total will be in the same area.

In that current total are 14 remaining charter members, including Bill Butts, Bill Geidel, Janice Honeck, LaVern Hron, Harold "Buddy" Perkins, Norb Rohlinger, Joyce Simons, Clayton Stautz, John Tessar, Ginny Warner, Cy Wietor and Al Zehren.

"The last husband and wife team is George and Corliss Fassbinder," Korth said.

Jane Korth serves as club manager. In that capacity, she books golf outings, special events and oversees the restaurant.

Joe Harlow returns as club pro for the 34th year. The pro shop offers a full line of clubs, clothing, golf balls and golf accessories.

Harlow will again run a Player of the Year competition. "This includes three tournaments during the summer, and the Club Championship," he said, indicating points are received for finishes in the respective events.

"There will be one tournament in June, one in July and one in August," Harlow said, noting these events are hand-

icapped, while the competition in the Club Championship is based on handicaps.

Joe Volesky of West Bend is the defending Player of the Year. "He won (the Player title) in 2002 and 2003," Harlow said.

School Referendum Important Issue on Tuesday's Ballot

Kewaskum School District Administrators, staff members and school board members have been out promoting the district's referendum that will appear on this Tuesday's ballot.

The most important thing to remember when voting is that the money must be used for designated items listed in the referendum question on the ballot. Concerns have been voiced that this money could be used for salaries and benefits. This is not true. Legally, the district CAN NOT use the money for items other than what is specified.

The question which will appear on the ballot will read exactly as follows:

**RESOLUTION
AUTHORIZING THE
SCHOOL DISTRICT
BUDGET TO EXCEED REVENUE LIMIT BY \$778,000 PER YEAR FOR FIVE YEARS FOR NON-RECURRING PURPOSES**

BE IT RESOLVED by the School Board of the School District of Kewaskum, Washington, Fond du Lac and Sheboygan Counties, Wisconsin that the revenues included in the School District Budget be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$778,000 a year for five years beginning in the 2004-2005 school year and ending with the 2008-2009 school year, for non-recurring purposes consisting of acquiring textbooks and supplemental instructional materials; maintenance, repair and improvement projects at various school district buildings and sites; acquiring maintenance equipment and vehicles; and acquiring audio/visual equipment, computer hardware and software including related training costs.

The referendum breaks down to \$778,000 per year, expiring in the 2009-2010 school year.

TEXTBOOKS

The school district's budget for textbooks and supplemental instruction materials will be increased by \$180,000 per year for five years, for a total of \$900,000.

The need for textbooks comes from the fact that the district is currently four years behind on their replacement cycle for textbooks. The cycle was developed and designed to replace all textbooks dur-

ing a six-year period. If the district continues their present course, it will take 15 years to complete one cycle!

Budget constraints have forced the district to cut the funding for textbooks by 40% over the last four years. Typically, the adoption of new textbooks for one core subject will cost approximately \$145,000.

MAINTENANCE

The budget for maintenance projects, maintenance equipment and vehicles will be increased by \$321,000 per year for five years for a total of \$1,605,000.

The previous referendum that was passed in 1997 allowed the district to renovate and expand Farmington and Wayne Elementary Schools and to build a new Kewaskum Elementary School, but neglected the middle and high schools. The newly remodeled/renovated schools are in excellent shape, but over the course of five years will need some maintenance work such as roofing and asphalt repairs.

However, the middle and high school buildings will need a SUBSTANTIAL amount of maintenance work and building improvements over the next five years in order for these buildings to function adequately. In addition, some school district vehicles and maintenance equipment will need to be replaced.

Another major project is the removal of the floor tiles at the high school that contains asbestos and replacing it with new non-asbestos tiles. Other projects include sidewalk repairs, replacement of toilets and toilet partitions, window and door replacements, and tuckpointing. The plan also calls for the replacement of three vehicles and some maintenance equipment.

TECHNOLOGY

In this day and age, computers are essential. The use of technology such as digital cameras and LCD projectors in the classroom has become

a greater part of our student's everyday educational programs.

For the last four years, the district has relied on funding from the TEACH block grant from the state to pay for the acquisition of computers. The state eliminated the grant for the 2003-2004 school year and the loss leaves a major gap, approximately \$65,000 annually, in the district's ability to purchase computers and other technology.

Funding for technology is needed to: improve access to updated classroom technology; improve network security for staff and students; provide funding to replace computers on a regular cycle; provide software and hardware equity in all buildings and provide \$25,000 per year for technology training for staff.

The estimated increase in the tax rate resulting from approval of this referendum is 88¢ per \$1,000 of property value.

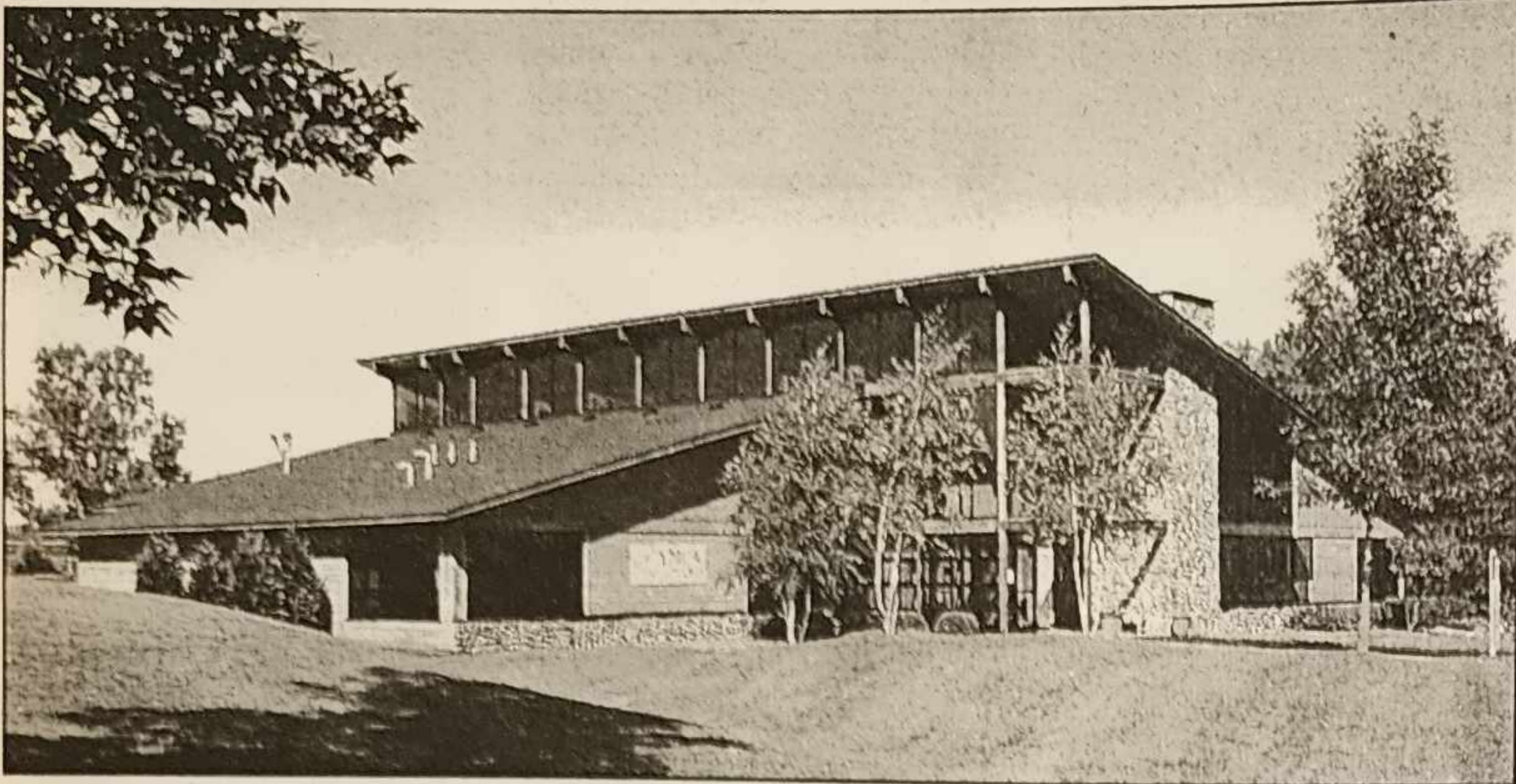

Community Invited to YMCA Camp Matawa Open House

The thoroughly modern Camp Matawa, at N885 Youth Camp Rd., in Campbellsport, is truly a "diamond in the rough" of the Northern Kettle Moraine Forest. Specifically, the camp has over 130 acres of pine and oak forests and is located adjacent to the 29,000 acres of state owned public land.

Camp Matawa is inviting the public to attend their upcoming Open House and Brat Fry Sunday, April 4 from 1:00 p.m. - 4:00 p.m. Bring the family to camp to enjoy the beautiful surroundings, tour the facility and meet the staff. Fun activities will be available at no charge; try the climbing wall, basketball, volleyball and more.

The DNR (Department of Natural Resources) started Camp Matawa in 1973 when they built a dining hall along with four comfortable "dorm" cabins. Each cabin is carpeted and heated, sleeps up to 29 people, and has bathroom and shower facilities inside. Each side of the cabin accommodates twelve people with a separate leader room in the back that sleeps five.

The dining hall, now called the Taylor Family Dining Hall, can seat large groups with meals being served either buffet or family style. The downstairs of the hall provides a great space for recreational and educational opportunities.

In 1996, the Metropolitan Milwaukee YMCA took over with a thirty year lease for the property which remained DNR owned by the state. In 1997, the YMCA built a beautiful spacious lodge, named after Jack Blank, for his Milwaukee YMCA involvements, especially with camping programs. The lodge houses the staff offices, has a large meeting room, an indoor climbing wall, showers, restrooms, and the Maple Sugar Suite, which includes sleeping for eight with a small kitchen.

Also in 1997, a large pool with a slide and devices for the handicapped was added by the YMCA. The pool goes from two and one-half feet to five and one-half feet deep. In that same year, they proceeded to build a fifty foot Alpine Climbing Tower.

One of the proudest additions to the camp in 1997 was the construction of the Mary Panzer Equestrian Center. The center stables twenty-eight horses, leased for the summer and returned in the winter. The Branch Manager for Camp Matawa, Jennifer Feltz, who has been with the YMCA since 1997, said that four, fully accessible, new "lodge" cabins were also completed by the YMCA in 2002.

The new cabins have vaulted ceilings, hardwood floors and comfortable furniture. Each lodge cabin is heated, has a common sitting area with a refrigerator and microwave, and a screened in porch. The lodge cabins have two separate living spaces with bathroom and shower

facilities and sleep fourteen people per side (total of twenty-eight), with leader facilities.

Putting a dollar value on all these projects, the Metropolitan Milwaukee YMCA has made one and a half million dollars of additions and improvements to Camp Matawa since their takeover in 1996.

Now that you know what exists on the campground, the next question is to find out about their programs to see if it is something suited to your child.

YMCA Camp Matawa is very proud of their camping agenda. Each program and activity area is designed to not only be fun and exciting, but also provides opportunities for learning new skills, personal growth, and enhancing self esteem. In addition, YMCA camping gains assets for kids in building relationships, making positive choices, and living in a supportive environment outside the family.

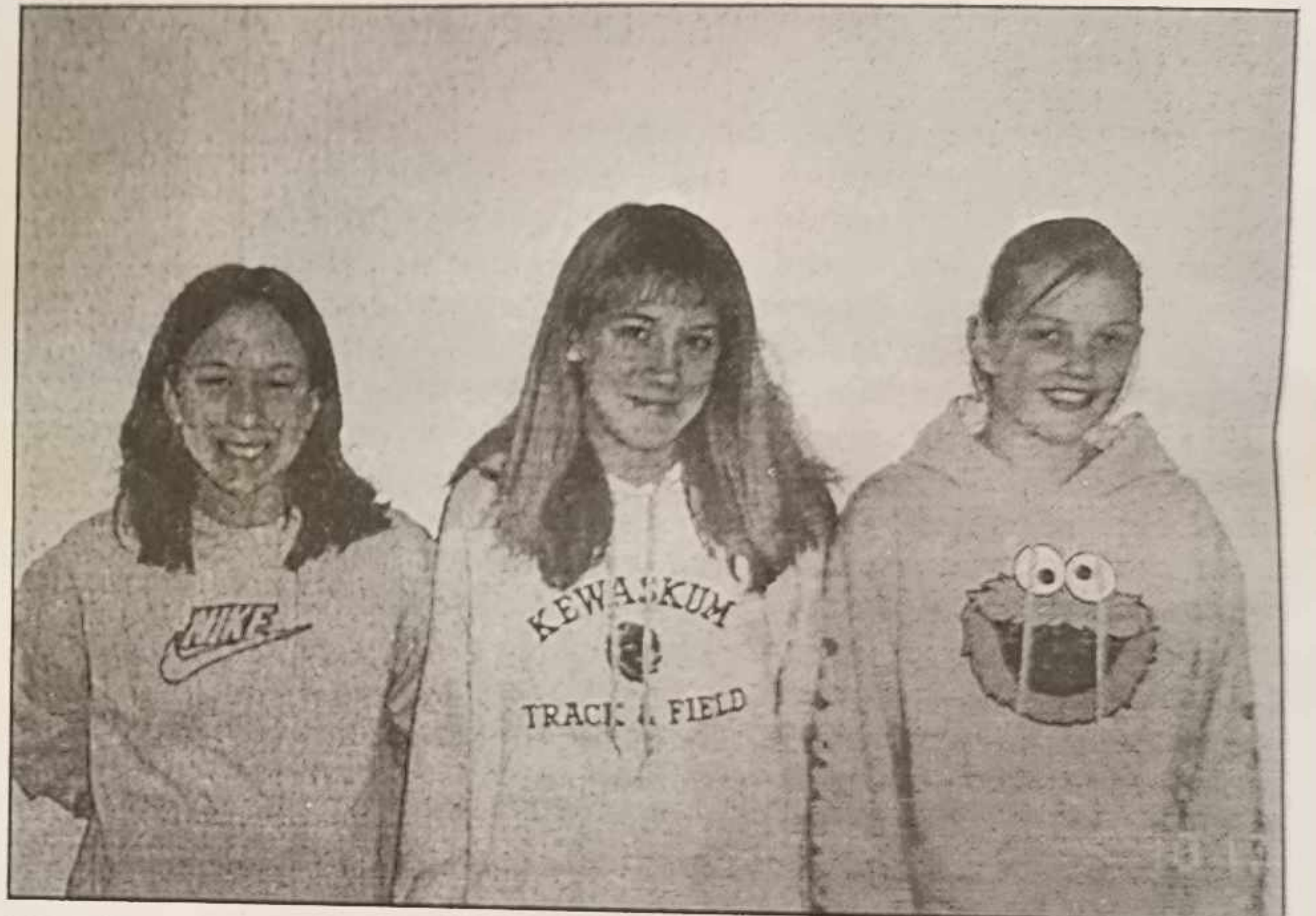

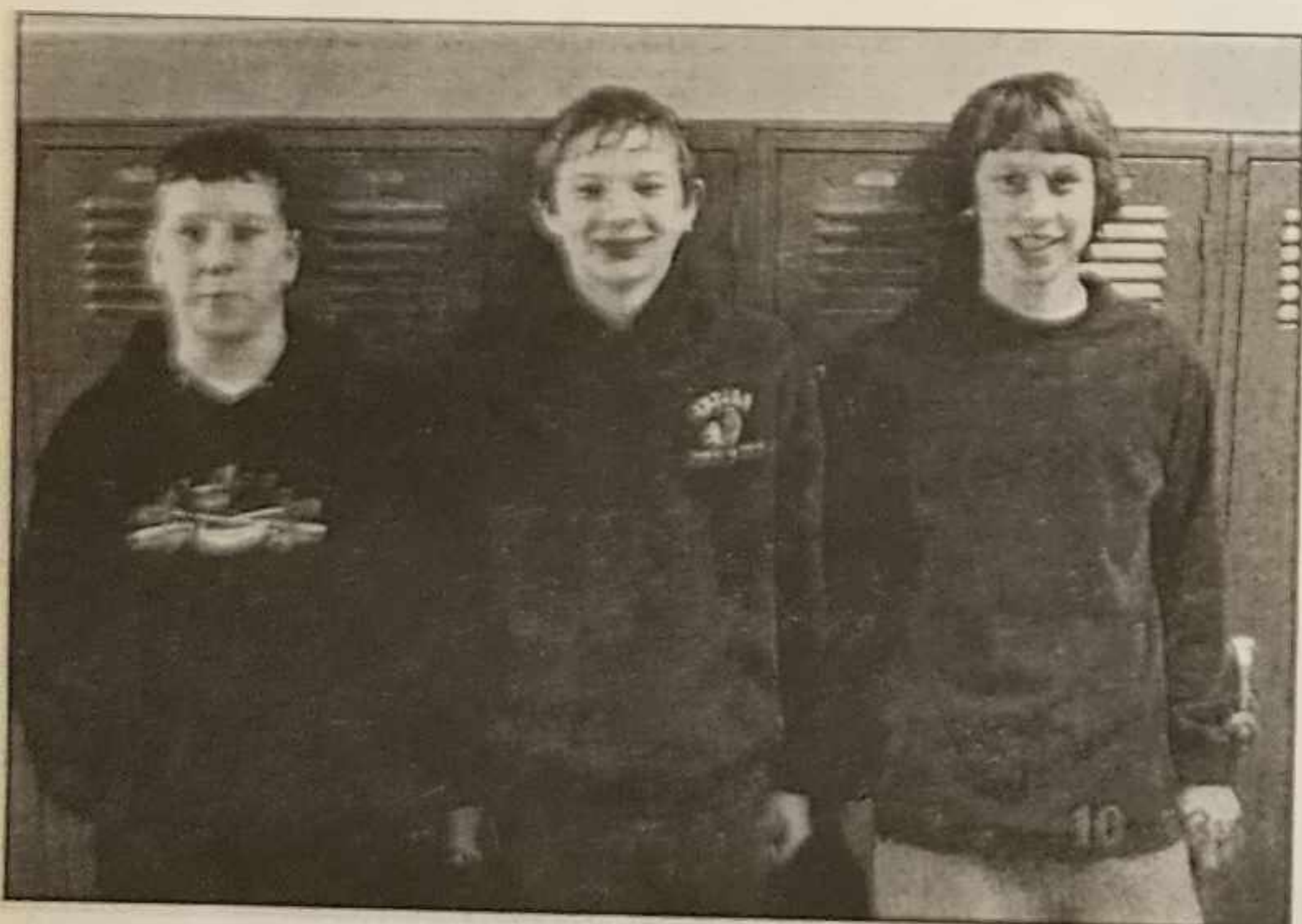

tions begin. It is a showcase of all that camping is about. It's an exciting time for making new friends, trying new activities and learning new skills. Cabins of similar age and gender, form a village, having its own special activities and traditions. Experienced and caring counselors, excellent facilities, extensive program offerings, healthy meals and "Camp Matawa Tradition" await each camper.

Adventure activities, mountain biking, arts and crafts, nature study, archery and other special programs are just some of the activities that campers can choose from. As a cabin group, campers and counselors will enjoy hikes, games, sports, and evening activities as well. There are six summer sessions of adventure camp and it is offered in both one and two week programs.

Adventure camp is divided into three age groups: ages seven-nine are in the Pioneer Village, ages 10-12 make up the Frontier Village, and ages 12-14 comprise the Trekker Village. Along with participating in traditional camping activities, Pioneer campers will enjoy their own special campfire with s'mores on the open fire, swim lessons and they may sign up for the thirty-foot indoor climbing wall.

There are many activity options to choose from such as mountain biking, hiking, canoeing, archery, and other sports, making this program ideal for the adventurous.

The Trekker Village is the culmination of all that Camp Matawa has to offer. Campers in this village can sign up for the activities that they love the most. Along with traditional camp activities, Trekkers can climb the fifty-foot alpine tower, go off-site to the Wisconsin state New Fane Bike Trail, spend days canoeing at nearby Mauthe Lake and will even spend one night venturing deep into the forest for a one night stay in tents. Events include a special night of Trekker Village activities, theme meals and campfires.

It is evident that Adventure camp has an abundance of activities making it easy to choose things to do. The daily schedule has structured offerings, but each camper can choose four individual pro-

grams that they enjoy the most.

For those horse lovers, age ten and up, they offer equestrian camp and equestrian adventures sessions. Once comfortable on horseback, these campers can take their horses on over thirty miles of riding trails in the spacious Kettle Moraine State Forest ice age trails. Western or English riding instruction is offered as well as general horsemanship, sound riding skills, horse care, feeding, anatomy and treatment of minor injuries. Equestrian campers also participate in other regular camp programs.

For the more advanced older campers, they offer Teen Extreme Camp for ages 13-15, a Leaders-In-Training Program for ages 14-15, and a Counselor-In-Training Program for ages 16-17. These specialty camps include beginner and advanced mountain bike, rope challenge, gone fishing, and adventures in independent living.

Independence First, an organization serving kids and adults with disabilities, will provide assistants and aides to make the "adventures in independent living" camp experience successful.

Camp is a special place, especially for kids, because they can be themselves and not have to act a certain way like being subjected to the peer pressure their friends put on them at school. It is a vacation away from their normal activities where they meet different kids from various lifestyles; developing new skills physically and mentally, broadening their circle in life. In fact, at the closing ceremonies on Thursday evening at summer camp where they reflect on the week they had together, some kids shed a tear or two when they have to say goodbye to their new-found friends.

Two outstanding natural features of this camp is that they are connected with many Ice age trails and have the Milwaukee River accessibility. Because of its prime location, a person can walk the ice age trails from Camp Matawa to Mauthe Lake in approximately forty minutes. Or, one can canoe from the Milwaukee River at the camp directly to Mauthe Lake.

ed on the basis of good character and their ability to relate well to children. References and past work experiences are thoroughly checked prior to hiring. Program staff members are college students or graduates, who are dedicated, experienced responsible, enthusiastic, positive and fun!

They help carry out the mission of the YMCA, which is to put Christian principles into practice through programs that build a healthy spirit, mind, and body for all. All staff are trained in CPR and Basic First Aid and specialists have certifications and training specific to their area of expertise. Staff also participate in an intensive week-long training that highlights character development and challenges them to accept and demonstrate the YMCA philosophy, which instills values of caring, respect, responsibility and honesty.

To further the commitment to camper safety, a registered nurse or health officer is always on site and readily available in the camp health center. A doctor is on call twenty-four hours a day and hospital facilities are nearby. In addition, Ricky Wright, who holds a degree in recreation, is senior program director at the camp, and lives on the property with his wife, so there is always a staff member on the premises.

Jennifer Feltz is another staff "plus" as she holds a degree in therapeutic recreation, which allows her to work with people with disabilities. She promotes healthy leisure lifestyles through recreation.

The next question most people have is the affordability of the camp. You do not have to be a member of the YMCA to go to camp, but the YMCA member fee is slightly less than the community participant fee.

Adventure camp for the community participant is \$535 for 2004, but only \$999 for a two week session, for an example. Specialized camps run a little higher.

However, at YMCA Camp Matawa, they believe that EVERY child should have the chance to experience camp. Thus, the YMCA's scholarship program supported through contributions to the "Strong Kids Campaign" provides scholarships for those in need, within their resources.

A scholarship application must be completed and the YMCA works with the families to make it all happen. From ten percent to seventy percent of the cost can be paid, depending on income.

A great deal of their financial assistance comes from the "Strong Kids Campaign," which provides program and membership support for anyone who desires to be a part of the YMCA family.

Through donations from individuals and corporations, the "Strong Kids Campaign" financed \$28,000 of the total of \$65,000 that was given away so kids could go to

camp last year. The remaining funds of \$16,000 came from the United Way, and, the \$21,000 from the Milwaukee YMCA. These generous donations from so many caring people have put alot of smiles on kids faces, and if you want to help to make sure it continues, just call any YMCA, Camp Matawa at 262-626-2149, or the United Way.

Summer camp is not the only program at Camp Matawa, as year-round opportunities can be enjoyed thorough their various other

programs offered in 2004. On April 11-14, a Spring Break Camp will be in session to coincide with Milwaukee Public Schools spring break. On May 21-23, a Mother/Daughter Equestrian weekend is being held. Family Camp falls over Labor Day weekend, September 3-6. Halloween Camp corresponds with the Wisconsin teachers convention school break on October 27-29. A winter camp is offered December 10-12 to end the scheduled sessions.

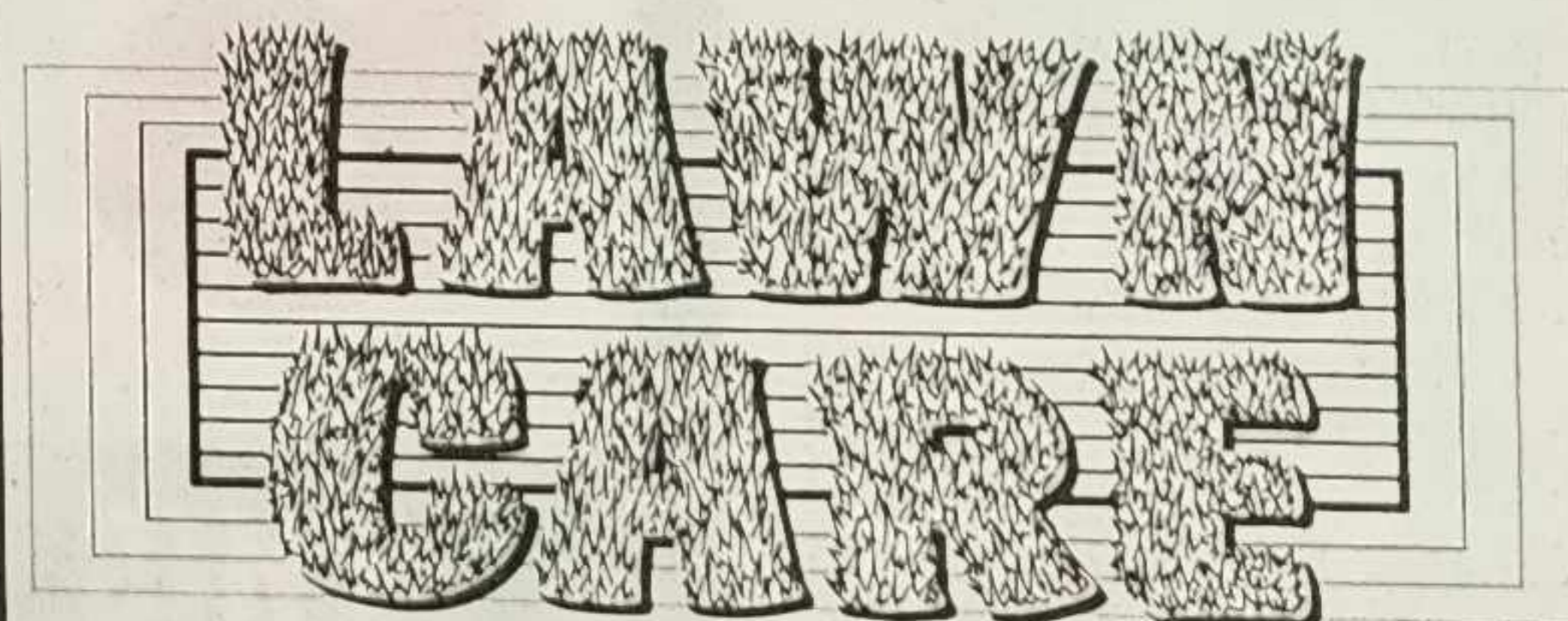

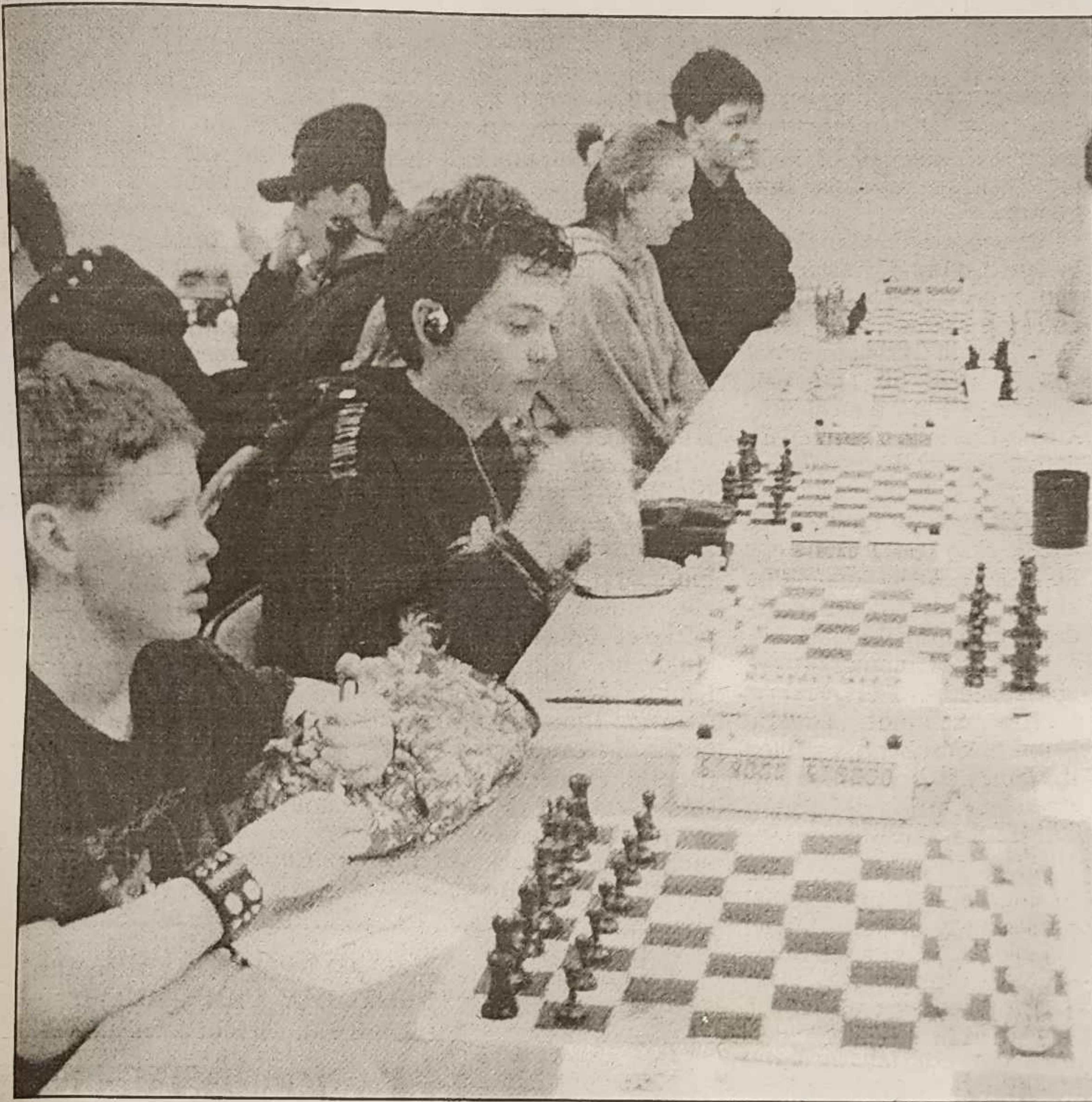



Dear resident:

I am writing to ask for your support in my election for County Board Supervisor on Election Day, April 6. I have been serving the Village of Kewaskum and the rural Kewaskum area on the County Board for the past 20 years, and it would be my privilege to continue to serve you for another term.

Letter to the Editor:

As the Superintendent of Schools for the Kewaskum School District, I rarely respond to Letters to the Editor, but I must make an exception. Last week a letter appeared supporting a candidate for School Board. I can't take a stand on the election process or candidates, but information Ms. Buschman cited in the letter are misleading so I felt compelled to address them as a representative of the school district. In her letter she stated that, "years ago we had maintenance as a part of the budget. We also had a textbook budget on a five-year cycle...we had a maintenance budget..we had a textbook budget and we had a BALANCED BUDGET." The writer seems to imply that the district currently does not have a maintenance budget, does not have a textbook budget, and doesn't have a balanced budget. Nothing could be further from the truth.

By law, every school district is required to present a balanced budget at their Annual Meeting. We do this, and have done this every year, no matter who is serving on the School Board. The district does have a maintenance budget. It also has a textbook budget, and as stated, does have balanced budget. To imply otherwise is misleading to the very public that reads these letters.

The reality is that the revenue limits imposed on school districts since 1993 have had a negative impact on the Kewaskum school budget. There may still be people in the community that are not aware that every year the school district's revenues are capped by the state and are the only governmental entity that has its revenues capped. For clarification purposes, our district does budget for maintenance and textbooks, albeit not enough to meet the district's budget projections. Why is this? Due to the revenue limits, we are unable to budget sufficient amounts to purchase all textbooks or to cover identified maintenance projects. To balance the budget, other costs such as transportation, utilities, health care benefits/salaries and open enrollment, must be allocated in the budget thereby reducing the amounts budgeted in other areas.

I sincerely do not believe that Ms. Buschman meant to imply this at all. I believe she was trying to make a point in support of a school board candidate. Regardless, I felt I needed to clarify these points for the voters. The School Board has been very diligent and has been forced to make some very difficult budgetary decisions over the past 3-4 years. Having worked closely with them over this period, I believe they need to be complimented for their efforts, not criticized.

As everyone should be aware of, there is an important school district referendum question on the April 6 ballot. This funding is important for several reasons. Each year we suffer a revenue loss due to open enrollment, which means resident students choosing to attend schools other than Kewaskum. Many of these open enrollment losses are due to other surrounding districts' schools with better resources, (Textbooks and Technology) sports, extracurricular's, and modernized buildings.

Our school district is important to our community and every property owner, whether they have kids in school or not. The viability and a thriving school district, affects the rate of how your most expensive investment, (your real estate) will appreciate in value. In the long term, someday these properties will be sold and when we realize a 50 to 100% return on an investment rather than a 20 to 30% capital gain. The extra \$150 or \$200 per year (cost of the proposed referendum) would look like money wisely invested. It's also wisely invested because it's directly invested in the future of our next generation and future business leaders.

I know that all tax increases are an annual burden. With taxes imposed on all cit-

Particularly in the area of technology education I was afraid we were attempting to provide instruction in every conceivable facet of instruction. I have come to believe that there is much more in improving what we are doing now. Access to computers is far less than it needs to be. The programs run on the computers need to be updated in order to remain relevant. I also wanted to know for what the money earmarked for maintenance was going to be used. There is a long list of items, some of which have a payback through increased efficiency such as lighting and heating. Others are things that in the normal course of things will need attention. The third area covered by the referendum is textbook replacement. A five to seven year replacement cycle is normal. We currently have textbooks that are 10-12 years old. That just isn't good enough for our children.

The second question I had was how did we get to this point. I believe the answer is that every year there is strong, vocal pressure to keep taxes down and for good reason. The result however is that each year certain areas of the budget need to be cut or at least maintain previous spending level. Maintenance, technology education and textbook replacement are likely candidates as the thought is, we can make do another year. If this referendum is not passed, it will not be long before we are asking how we got to the point that the quality of our schools (both in terms of the physical plant and the instruction provided) got to the point that we find unacceptable. Now is the time to step in to maintain the quality education in our schools.

Dear Editor:

I want to comment on an earlier letter that addressed the upcoming referendum. In the last 9 years the School District has had a revenue/expenditure deficit in 3 of them. In the 9 years prior to that, the School District had a deficit in 5 of those years. Back in 1993-94, the State imposed revenue limits on school districts making it harder to match revenues with expenditures. However, the School District has been able to avoid deficits in more years after, than prior to, the limits.

In the area of textbooks, the district has an annual budget of approximately \$60,000. Prices of books have been increasing while the annual budget has remained constant. This situation causes an ever-increasing gap between available funds and expenses and further extends the overall textbook rotation from a preferred 5-7 year cycle

to a 12-15 year cycle. A portion of the 40% textbook cuts have come in the area of workbooks that need to be purchased every year. This annual burden on the textbook budget has been lessened through teachers using alternative ways to teach the material. The school district has always had and still has a textbook budget.

A maintenance budget of approximately \$100,000 per year is available to address projects throughout the district. The cost to replace the boiler at the high school is roughly \$172,000. This is well above the annual budgeted amount for the entire district. In order to complete this with current funds, money would need to be taken from other areas. So there is an even greater cost than just the money needed to make-up the difference. The current boiler is operating at approximately 60% efficiency. 100% efficiency is not feasible, but if 80%-90% can be reached a minimum annual savings of \$10-12,000 will result. The annual budget to heat the high school is approximately \$50-60,000.

My point is that the boiler situation and other big-ticket items (asbestos flooring) need to be addressed now. By prolonging these projects, we are looking at future higher replacement costs and annual wasting of dollars due to inefficiency. The district always had and still has a maintenance budget. It's just that costs are increasing at a greater rate than monies available.

Be it the public or private sector, it is virtually impossible to please everyone involved when it comes to making fiscal/financial decisions. The Functional Analysis the district purchased not only identified possible cuts, it also identified possible revenue sources. It also identified that a majority of areas in the district are operating fiscally sound. The Functional Analysis was a one-time cost. I have a bigger problem with other items. Such as a boiler that is so inefficient that money is lost every year.

We can go back and forth forever on whether or not we should support this referendum. Possible cuts can be proposed in a variety of areas, but are the long-term implications being considered when these cuts are being suggested?

The bottom line is that these needs and costs will not go away and cannot be supported within current revenue limits. The longer we put this off the more disservice we are doing our #1 priority: "Our Children".

Letter to the Editor:

On Tuesday, April 6th, you will be voting on who you want to represent you on the Kewaskum School Board for the next three years. I, Neal Weare, feel that I can fill that

position for you. In addition you are being asked to approve a referendum that will allow the school district to EXCEED the revenue caps by \$778,000 per year for the next five years. You should also know that the extra \$778,000 per year will be in ADDITION to whatever increase comes with the general operating budget for the 2004-2005 school year, which you the voters will approve at the annual school district meeting in July.

I would like to address some concerns that are in the referendum. 1) I feel that maintenance should be contained in our operation budget as a SEPARATE budget. When I was on the board, we placed into our budget, a maintenance budget SEPARATE from the general fund to be used ONLY for maintenance. The amount we placed into the fund was \$250,000. This fund should have grown each year in proportion to the increase in the overall budget. At an annual school district meeting I asked where the maintenance budget was. I was told that we didn't have a separate maintenance budget and that it all came out of the general fund. Now I am told that we spend between \$80,000 and \$100,000 on our maintenance. Where did that money go? I am told that it went for utilities while others have said it went for salaries and fringe benefits for district employees. At the time the money was placed in the fund, we also developed an ongoing, prioritized, five-year maintenance program that was updated yearly.

2) While I was on the board, along with two current board members Jeanne Goeden and Mary Meisser, we started a 5-6 year rotation of books district wide. What happened to that program and its funding? Salaries and fringe benefits or utilities? The year after I left the board the district spent for the school year 97-98 a total of \$108,836.45 on textbooks. For this school year 03-04 the district allocated \$66,723 and has only spent \$32,727.19 and the school year is almost over. Please keep in mind that the board back then was also working under the revenue caps that were put in place in 1993.

In the Functional Analysis report the district just spent \$35,000 for, it has identified budget reductions of between \$945,000 and \$1.1 million that the board could use to address budget shortfalls in the district. To date the board has not taken any action to implement any of these options.

I feel that my past experience of 12 years as a past Kewaskum School Board member will help me to address these issues, as well as any others that will come up.

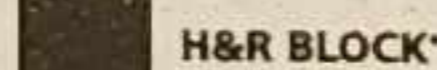

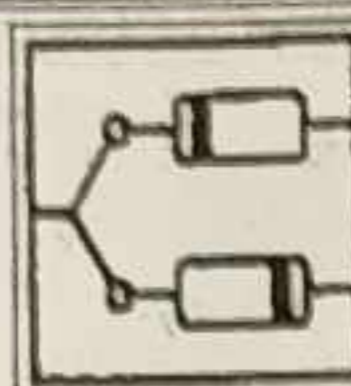

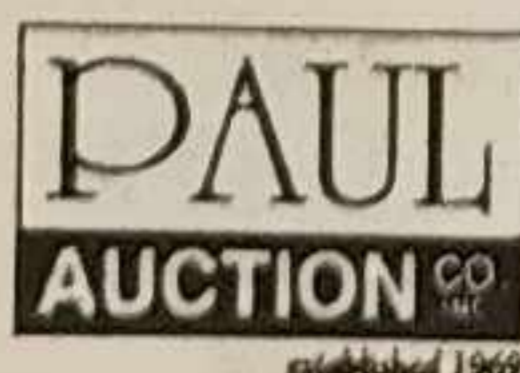

The Plan Commission of the Village of Kewaskum, Washington County, Wisconsin met in the Council Room of the Municipal Building, 204 First Street.

The meeting was opened with a Moment of Silence and pledge of Allegiance.

Chairman Mathew Heiser called the meeting to order. Members present were Andy Pesch, Richard Schmidt, Andrew Kuehl, Theodore Meilahn, Leeann Butschlick, and Frank Beesten. A quorum was present. Ms. Janelle Philippi and Mr. Ron Weis working for Mr. Thomas Timblin, Mr. James Wessing, Mr. Brian Moser, Mr. Frank Voge, Mr. Kevin Scheunemann and Mr. Gary Gavin were present on the various items for the Plan Commission to review.

On a motion by Leeann Butschlick, seconded by Frank Beesten and carried by the majority voice vote the Plan Commission approved the minutes as printed for January 27, 2004.

The Commission was informed that FEMA has not gotten back to the Village regarding the signing of the proposed amendments to the Zoning Ordinance and that the Public hearing won't be scheduled until we know that it is on the way.

The Certified Survey Maps for Mr. Thomas Timblin dividing the 23 acres into four parcels was reviewed. One parcel pertained to the land lying east of Pleasantwood Drive. It was noted the village engineers did not have a problem with moving it forward, but indicated there were some technical items to be corrected. Mr. Weis indicated he was aware of the creek name not being on the map. On a motion by Theodore Meilahn, seconded by Andy Pesch and unanimously carried by voice vote the Commission recommend the approval of the CSM and sent it to the Village Board with a favorable recommendation. Andrew Kuehl abstained from voting.

The Commission reviewed the second CSM for Mr. Thomas Timblin regarding the land west of the creek and west of Pleasantwood Drive on the northern parcel. This second CSM has three parcels and the area west of Pleasantwood and east of the creek was noted as non-buildable per deed restrictions and/or in the developer's agreement. It was noted the village engineers did not have a problem with moving it forward, but indicated there were some technical items to be corrected. Mr. Weis indicated Mr. Timblin would be phasing the construction of the units, but that the road dedication for the entire project is on the CSM's and that the street and infrastructure improvements will all be accomplished at the same time and dedicated at the same time. On a motion by Richard Schmidt, seconded by Andy Pesch and unanimously carried by voice vote the Commission recommend the approval of the CSM and sent it to the Village Board with a favorable recommendation. Andrew Kuehl abstained.

Review and discussion was held on the proposed Preliminary Plat for Woodland Creek Addition 1 for Mr. James Wessing took place. It was pointed out that Edgewood Road would be connecting to STH "28" several hundred feet west of initially planned as per the DOT approval. The number of lots is one less than in the original plan and the number of duplex lots would be one less. It has yet to be determined if a Zoning amendment is required because of the road adjustment. It was also noted that this work is proposed to be completed this year, not in 2005 as originally planned. Edgewood Road

The Plan Commission also reviewed a CSM for the first phase of Woodland Creek regarding the dividing into two lots the larger one on the south side of Evergreen Terrace that would have had a storm water pond constructed if the stormceptors would not have been used. This CSM is the same as the Land Use Plan. On a motion by Andy Pesch, seconded by Theodore Meilahn and unanimously carried by voice vote the Commission recommend the approval of the CSM and sent it to the Village Board with a favorable recommendation.

The Plan Commission reviewed Petition For Annexation for Solid Rock LLC regarding 32,892 square feet to the north and east of the bus garage on STH "28" as previously discussed with Kettle Kountry Estate Development. It was noted this is a direct annexation not involving any residents or dwellings. The Plan Commission did not see a need to hold a public hearing on this annexa-

tion because of it being straightforward. On a motion by Theodore Meilahn, seconded by Andrew Kuehl and unanimously carried by voice vote the Commission sent the Petition for Direct Annexation to the Village Board with a favorable recommendation.

The Plan Commission reviewed the request of the developers of Kettle Kountry Estate to dedicate a small parcel of land and playground equipment installed and landscaped adjacent to the lift station parcel in lieu of payment of open space money. On a motion by Frank Beesten, seconded by Leeann Butschlick and unanimously carried by voice vote, the Commission recommended the installation of said neighborhood park in lieu of open space funds and indicated the placement of this into the developer's agreement.

On a motion by Frank Beesten seconded by Andrew Kuehl and carried by the majority roll call vote, the Commission adjourned the meeting. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent".

(a) Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth or machine and cast his or her vote, except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

(b) (i) If paper ballots or lever machines are used, then on the referendum election question, the elector shall make a cross (X) in the square at the right of or depress the button or lever next to the answer which he or she intends to give.

(ii) If a punch card voting system is used, then on the referendum election question, the elector shall make a punch or a hole at the right of "yes" if in favor of the question, or the elector shall make a punch or a hole at the right of "no" if opposed to the question.

(iii) If a marksense voting system is used, then on the referendum election question, the elector shall make a mark in the space at the right of "yes" if in favor of the question, or the elector shall make a mark in the space at the right of "no" if opposed to the question.

(c) The vote should not be cast in any other manner. If the elector spoils a ballot, he or she shall return it to an election official who shall issue another in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth or machine. Unofficial ballots or a memorandum to assist the elector in marking or punching his or her ballot may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

(d) (i) After an official paper ballot is marked, it shall be folded so the inside marks do not show but so the printed endorsements and inspectors' initials on the outside do show. After casting his or her vote, the elector shall leave the voting machine or booth and, where paper ballots are distributed to the electors, deposit his or her folded ballot in the ballot box or deliver it to an inspector for deposit in the box, and shall leave the polling place promptly.

(ii) If a punch card voting system is used, then after an official ballot is punched, it shall be inserted in the envelope provided so the punches do not show. After casting his or her vote, the elector shall leave the booth, deposit the envelope containing his or her ballot in the ballot box, or deliver the envelope to an inspector for deposit, and shall leave the polling place promptly.

(iii) If a marksense voting system is used, then after an official ballot is marked, it shall be inserted in the envelope provided so the marks do not show. After casting his or her vote, the elector shall leave the booth, insert the ballot in the voting device, discard the envelope, and shall leave the polling place promptly.

(e) An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty in reading, writing or understanding English, or that due to disability is unable to cast his or her vote. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.

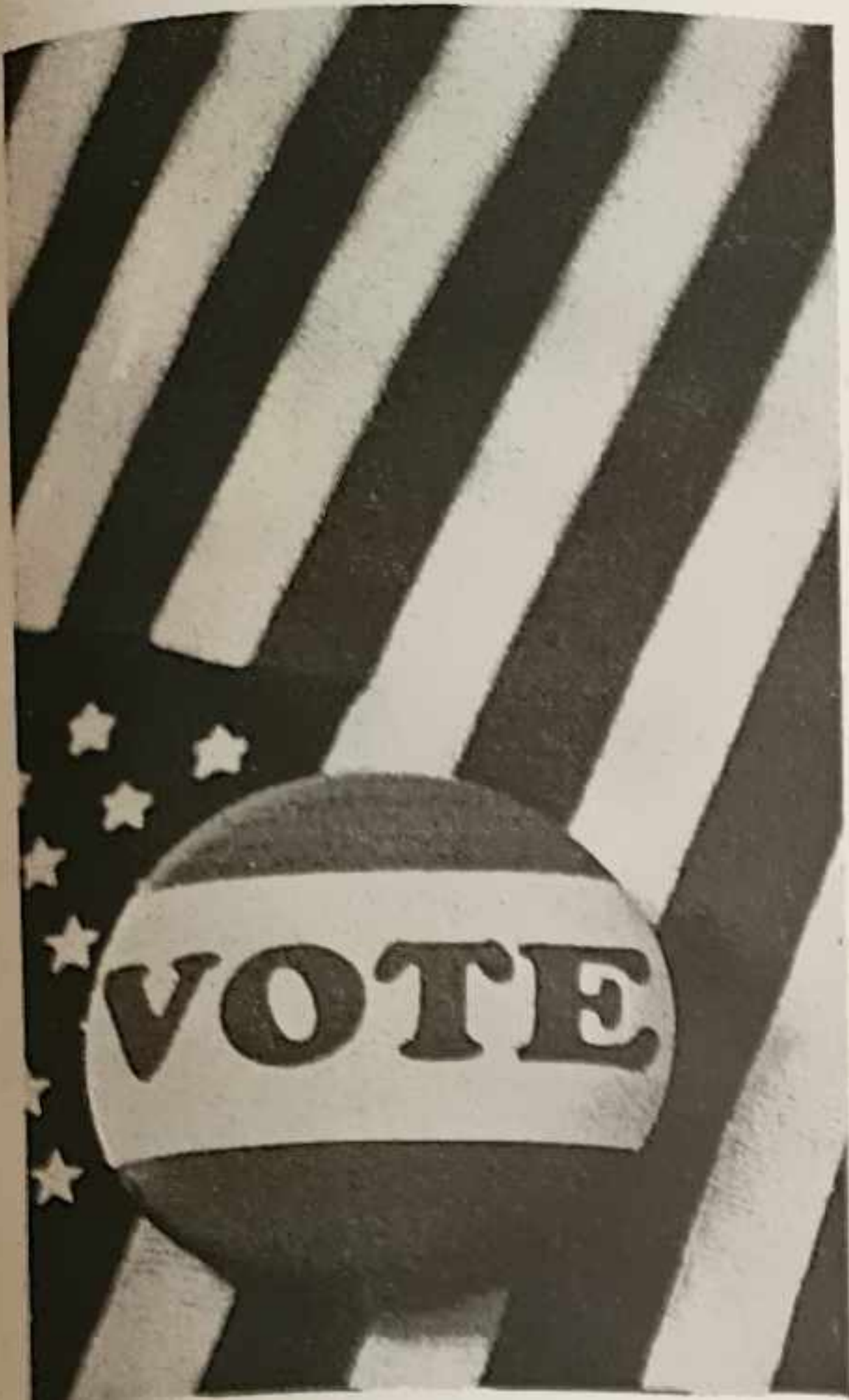

Three School Records Set At Oshkosh Invitational

Competing in two meets in the same week isn't the easiest of tasks, but the boys on the Kewaskum High track team responded in grand style March 26th, setting three school records in the annual Oshkosh Invitational held in Kolf Fieldhouse on the UW-Oshkosh campus.

The Indians, who had finished fifth in Tuesday's Washington County Indoor Meet on Tuesday, scored 17 points in the division for smaller schools, finishing in 11 place out of the 25 schools.

"We did very well," KHS Coach Jerry Gosa said Sunday, reporting the first record came in the triple jump where sophomore Eric Nass jumped 38 feet, 2 inches (38-2). The distance was good for 11th place.

A second new mark came in the 800-meter run, and again it was a sophomore putting his name in the school's record book. Nick Bartley trimmed a full 10 seconds off the time he posted Tuesday, covering the distance in 2 minutes, 8.27 seconds (2:08.27). This beat the old mark of 2:08.40, which had been held by Jeff Dirmeier since 1993.

"Nick benefited from being in the fast heat, and he really

responded by running a great time this early in the season," Gosa said.

Bartley contributed two points from his 7th place.

The other record, and the most impressive, was provided by the quartet of Garrett Donath, Josh Meyer, Zack VanWormer and Nass in the 400 relay. They combined for a time of 3:38.66, bettering the mark of 3:41.47 set in 2002 by Matt Hartmann, Andy Lickel, David Wicklund and Chris Canter.

Gosa deserves credit for motivating these runners. By design, he showed them the record board before leaving for the meet. "I told them they each needed to run splits of 55 seconds to break the record," the veteran coach said. "It felt great to finish second (in the event) ahead of

both Two Rivers and New Holstein, two traditional powers of our Eastern Wisconsin Conference."

Two Rivers wound up capturing the title with 66 points, two more than Grafton (64). Rounding out the top five were Mayville, Howards Grove and Ripon with 37, 35 and 34.5 points, respectively. Gosa reported distance ace Josh Meyer was second all week but managed to place seventh in the 1,600 with a 4:53 clocking.

Other good efforts included: Luke Herriges' sixth in the high jump (5-8), Adam Schlosser's seventh in the high jump (5-6), the tie for eighth in the pole vault by Scott Rhoads (10-6) and the ninth and 11th respectively by Donath (55.33) and VanWormer (55.65) in the 400.

KHS Teams Take Fifth At County Outdoor Meet

In what could be considered the first major meet of the year, the Kewaskum High girls' track team scored 49 points to finish fifth out of eight teams in the March 23rd Washington County Indoor Track and Field meet held in West Bend, while the Indian boys came up with 37 points, which also put them in the fifth spot.

Cousins Amanda and Garrett Donath turned excellent performances for the Indians. Amanda Donath notched the only win for KHS, running the 400-yard dash in a time of one minute, seven and five-tenths seconds (1:07.5), which was well over a second ahead of her nearest rival.

"She led the whole way ... wasn't even pushed," stated veteran KHS Coach Jerry Gosa, beaming about the effort of his sophomore standout, who broke the school record and qualified for the WIAA Division 2 State Meet in that event a year ago.

Later Donath added a third place in the 213 dash (28.5 +) and in the concluding event of the evening, she helped the 10-lap relay finish third with a time of 4:16.5.

"Amanda anchored," Gosa said, reporting the other three girls in the relay were Paige Thelen, Whitney Pfeiffer and Rachel Dums.

"We're going to have some good competition for those spots," Gosa said, figuring this quartet has the potential to score major points for his team all season.

In addition to Donath, Gosa had praise for Dums, who chipped in with a third place in the 50-yard low hurdles, covering the distance in 8.54 seconds, which was just .01 of a second out of the second spot.

"Rachel isn't really a 50-yard hurdler," Gosa said, explaining her strength is really the 300-meter hurdles, an event she went to state in last spring.

Gosa went on, "There's a girl by the name of Sam Droese. She went 4-8 (four feet, eight inches) in the high jump," an effort that added six points to the Indians' total. Other points came from the following: Katie Patterson's tie for third place in the pole vault (7-6), a fourth by Amanda Magnus in the long jump (14-8), Kayla McCormack's fifth in the high jump (4-6 based on misses), and a third place by the six-lap relay (2:22.5), which was aided by disqualifications to two of the teams.

West Bend West, led by its outstanding middle distance runner Megan Duwell, won the title with 103 points, while Slinger, behind three first places and five second, wound up as the runner-up

with 93.5 points.

KHS Boys Struggle To Place

The talented Garrett Donath had a big day for the Indians, coming in with a second and a sixth, and he also helped the 10-lap relay to a solid effort, which netted the foursome a fourth place.

Donath was clocked 58.2 in the open 400. West Bend West's Nate Pieper was the class of the event with his time of 55.7. Donath also cleared 11-6 in the pole vault for the sixth.

"I would say Garrett ran well. Actually our other 400 runner, Zack Van Wormer did, too. They show a lot of potential," Gosa said, reporting Van Wormer took a spill during the race but scrambled to his feet and still came in with a respectable time. "That showed a lot of poise."

"Luke Herriges went 5-8 (third place) in the high jump. That equals his personal best from last year," Gosa went on. "He looks very good."

The highlight of the night, according to Gosa, was the third place in the 20-lap relay. "In my 12 years here, we've never placed in the 20-lap relay," he said, reporting Eric Nass, Matt Parrent, Justis Clayton and Bob Gibson changed that by finishing third in a combined time of 8:30.6.

What makes their feat so remarkable is the fact Nass is a sophomore, while Parrent, Clayton and Gibson are all freshmen.

Distance ace Josh Meyer had a good outing, contributing eight points to the team total with his fourths in the mile run (5:01.3) and the 880 (2:16.4).

Adam Schlosser chipped in with a fifth in the high jump after clearing 5-6.

When the meet concluded,

the Germantown boys went home thinking they finished second with 101.5 points, behind Slinger's 107. A recount made after the meet showed otherwise, however, because of an omission in the scoring. Germantown received an additional 16 points to defeat the Owls, 117.5 to 107. West Bend East wound up third at 97.5, ahead of West Bend West, 62; Kewaskum, 37; Kettle Moraine Lutheran 21, Hartford, 19.5; and Living Word Lutheran, 2.5.

Kewaskum's next meet is the State Indoor Track Meet on Saturday, April 10th in Madison.
