Father Mark Jones was given a new assignment in June of last year. That new assignment took him to St. Lucy parish in Racine. Ironically, the new pastor for Holy Trinity and St. Michael comes from about a 45-minute drive from Fr. Mark's new parish home.

Father Edwin Kornath is currently serving in Waterford at St. Thomas Aquinas Parish. That faith community serves around 1,350 families.

Being the former pastor at St. Matthew Parish in Campbellsport, Fr. Ed is pleased to return to the Kettle Moraine area. He served in Campbellsport for four years and left in 1999 for Waterford.

"I'm looking forward to working with the people at both parishes," stated Fr. Ed in a phone interview Tuesday after-

noon. He seemed very excited about working with the students and faculty at Holy Trinity School.

Fr. Ed was ordained for the Archdiocese of Milwaukee in 1984.

Father Russel Stommel, who has been temporary parish administrator at Holy Trinity stated Tuesday, he did not know where he was being reassigned to. He said the process has started and when he knows he would let the parishioners know.

Fr. Russ stated he will miss the many people he became friends with while at Holy Trinity since Fr. Mark's departure. He said a lot of hard work has been done on the collaboration of Holy Trinity and St. Michael parishes and he admired the hard work and dedication by both parishes.

His favorite memory of Holy Trinity will be his interaction with the highly qualified staff and the children at Holy Trinity School.

Father Robert Artmann, current pastor at St. Michael, will be retiring in January of 2006. He will serve as Associate Pastor for St. Michael.

More information on the collaboration between the two parishes and Fr. Ed will be published when he arrives.

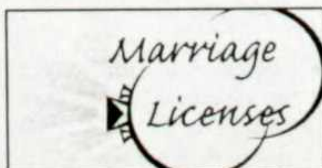

## T. Barton to replace Woodford Bridge



Officials in the Town of Barton met Tuesday evening, May 10 to discuss the replacement of the Woodford Bridge. Town clerk Aggie Prunner stated the township has had the County Highway Department look at the bridge and it was determined that through a state grant offered to the county the two would pick up a portion of the cost of the replacement. This would leave Barton to pay around 20 percent of the total cost of the project. Prunner stated they would begin budgeting for this and the replacement could happen in 2007 or 2008. Town chairman, Dick Bertram stated that he was unsure if the town would receive the grant. The town wants to remove the bridge and replace it with a 15 foot culvert.

## School board to borrow \$400,000 for boilers

The Kewaskum Board of Education met Monday night, May 9 and approved borrowing up to \$400,000 to replace boilers at KHS and retrofit boilers at KMS.

The district will borrow the money from the State Loan Trust Loan Program at a rate of 4.25 percent.

Business Manager, Paul Reichert told the board "Although \$400,000 has been reserved by the state trust fund, the district will only be obligated to repay the amount of funds that are actually drawn." He estimated the project will cost approximately \$350,000.

Two boilers from the 1950's will be replaced with three new hot water boilers and new piping will be installed. Some sections of the existing pipe will be abandoned and some sections will be removed. New hot water unit ventilators will be installed in five rooms on the north side of the high school. In addition, new heating units will be in-

stalled in the library.

Demolition and removal of the existing boilers will start May 16 and will be completed by May 31.

Installation of the new boilers will take place June 13. It is hoped to be complete by September 16.

Two boilers at KMS will be retrofit to operate in a fully modulating capacity, enabling them to operate in a low fire or high fire mode. New variable speed pumps will be installed to regulate the flow of water through the boilers. New piping will be installed in the boiler room to accommodate the new pumps. This is scheduled to begin June 13 and completed by August 19.

Asbestos in the KHS boiler room, piping and floor tile will be removed by Environet Inc of Wisconsin.

New flooring in the KHS boiler room will be completed by Handeland.

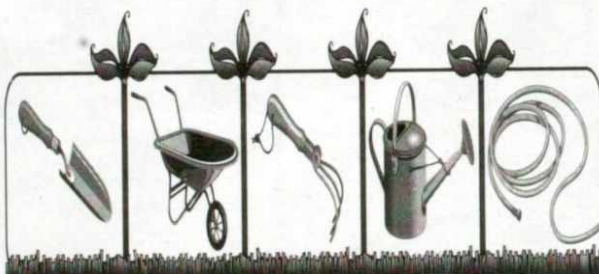

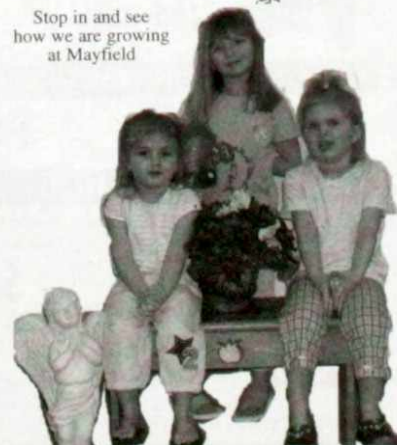

## County - Briefs -

### New principal at Silverbrook

Silverbrook Middle School in West Bend has a new principal. Jean Broadwater will take over for Cindy Guell, who will begin her new job as district assessment coordinator. The change, for both jobs, should take place July 1st.

Broadwater has been the assistant principal at Silverbrook for the last two years. She was selected for the principal's job from a pool of 36 applicants. The school board is scheduled to formally approve Broadwater's contract at their May 23rd meeting.

The district is still in the midst of filling three other administrative positions. Interviews are being conducted for the administrator of pupil services, assistant superintendent of curriculum and instruction and administrator of technology. All the positions should be filled by the end of the month.

### Sensenbrenner proposes 'Watchdog'

Congressman Jim Sensenbrenner wants to create a Government Watchdog for the Federal Judiciary. The proposal comes on the heels of a federal judge's decision in the Terri Shiavo case. The brain damaged Florida woman died after the federal courts refused to order the reinsertion of her feeding tube. Sensenbrenner has been quoted as saying "Congress can monitor how the courts are set up, but it's another thing to tell them how they must author opinions." He says a watchdog would not affect Congress's independence.

### Port Police job

There are now 12 people in line to become the next Police Chief in Port Washington. Sixty-four people initially applied for the job. The Police and Fire Commission narrowed the field this week. The Commission hopes to name a new chief by early June.

The Chief's job opened after Ed Rudolph retired at the end of last year. Rudolph stepped "out" amid scandal, as he was ticketed \$181 for tossing an empty beer can out of his squad. The city says their investigation and legal fees in that case cost over \$19,000. Rudolph's severance package is worth nearly \$80,000.

### Crossing Guard cookbooks

Crossing Guards in West Bend have more cookbooks for sale. They're available for \$5 at the Police Station at Main and Vine. Proceeds from the sale benefit the Sunshine Club, which is an organization that helps local charities. This is the second printing for the 80 page book. About 100 are available.

A 53 year-old West Bend man had a charging conference Monday for a fire he allegedly set at Meadowbrook Manor in West Bend. The fire at 475 Meadowbrook Drive began around 4 p.m. Sunday. The building had to be evacuated and firefighters were on the scene for several hours. Two tenants were transported for injuries. The Red Cross is helping those displaced by the fires.

### FdL woman is National Guard soldier of the year

A 20-year-old woman from Fond du Lac has been

named the Wisconsin National Guard Soldier of the Year. Spc. Traci Smet is a member of the 57th Artillery Brigade. Smet is currently a sophomore at UW-Oshkosh. She's majoring in athletic training. Smet now advances to the regional competition at Camp Riley, Minnesota.

### WB HS band moving to state title

A standing ovation was given to some West Bend High School music students Monday as they advanced in a statewide music competition. The band is called "Elements of Style." It's comprised of students from West Bend East and West High Schools, along with Kewaskum High School. The local group won the Milwaukee Regional in a competition created by the Wisconsin Foundation for School Music. The band will compete again in July in Madison. If they win, the grand prize is a recording session and gig next year at Summerfest.

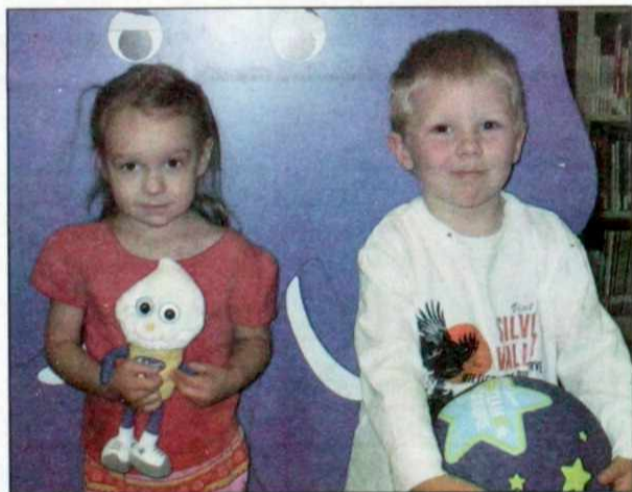

The Village Board of Kewaskum, Washington County, Wisconsin, met in Regular Session in the Council Room of the Municipal Building, 204 First Street.

President Mathew A. Heiser presided. Trustee Harry Roecker asked to be excused and was absent; all other Trustee Members were present. A quorum was present.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion by Trustee Kevin Scheunemann, seconded by Trustee Thomas Piwoni and unanimously carried by voice vote the Board approved the minutes of the April 4, 2005 Village Board meetings as printed.

Mr. Ryan Hill, 549 Washington Court, asked the board to consider reducing the number of days the noon siren is blown. The Police Chief Richard Knoebel indicated that a telephone survey of other communities was done and the majority of communities only activate the noon siren once or twice per week. The Chief advised the Board that if they wish to adjust the siren schedule to only activate once per week, he would suggest blowing it on Saturday at noon and then have what is known as a growl and or silent test. On a motion by Trustee Kevin Scheunemann, seconded by Trustee Andy Pesch and unanimously carried by voice vote the Board adjusted the blowing of the noon siren to just once per week on Saturdays at noon.

Mr. John Knepel of the accounting firm of Virchow, Krause & Company, LLP was present to review and answer questions on the latest audit prepared for the Village of Kewaskum for the year ending December 31, 2004. Mr. Knepel explained the entire audit process and financial statements regarding the General and Utility Funds portion of the audit and associated financial statements. The audit revealed the Village to be in a healthy position.

A variety of questions were asked of Mr. Knepel that he answered. Mr. Knepel thanked the staff for their assistance and good records. He further shared with the Board that the Village of Kewaskum should be pleased to have the Administrator and Deputy Clerk for they do an excellent job on maintaining good records and control over spending, etc.

President Mathew Heiser, along with the entire Board, also thanked the entire Village staff for a job well done and thanked the auditors as well.

On a motion by Trustee Kevin Scheunemann, seconded by Trustee Thomas Piwoni and unanimously carried by the majority roll call vote the Board suspended the rules to take up IX. New Business items A. and B. Roll call vote was 5 "Aye" 0 "Nay" 1 "Absent".

On a motion by Trustee Kevin Scheunemann, seconded by Trustee Thomas Piwoni and unanimously carried by voice vote the Board accepted the audit report as prepared and presented for the year ending December 31, 2004.

Discussion was held on a proposal to provide assistance with the preparation of Water and Sewer rate adjustments. ## NOTICE OF SMOKE TESTING PROGRAM

By order of the Department of Natural Resources, the Village of Kewaskum is commencing a comprehensive study of the sanitary sewer to identify and eliminate sources of clear water that may be entering into and overloading the sanitary sewer system. Clear water entering into the sanitary sewer system is not unique to the Village of Kewaskum. The study is being required as a condition of the WPDES permit issued by the Department of Natural Resources.

An early step in the study is testing to determine where clear water is entering the sanitary sewer system during heavy rains. The test that will be used is a "smoke test". The "smoke testing" program will be conducted on sanitary sewers throughout the Village. **During the next few months, "smoke testing" will be occurring in your neighborhood.** You do not have to be home during the testing period.

The "smoke testing" process has been endorsed by the Environmental Protection Agency and has been safely used by sewer service contractors and municipalities for more than 25 years. The "smoke" is not a true smoke. It is a mist containing a large percentage of atmospheric moisture that is highly visible at low concentrations. The mist is seeded by zinc chloride and other products such as free carbon. It will not stain, and will disappear rapidly without leaving a residual odor.

During the testing, "smoke" will be blown through the sanitary sewers from a manhole in the street. The "smoke" will then fill the sewer pipes and appear from any roof drains, catch basins, or house vent stacks connected to the sewer system. "Smoke" may also appear from cracks in the pavement above the sewer, from lawns, or around buildings that have foundation drains connected to the sewer.

It is possible that "smoke" may also appear in basements through unused floor drains, disconnected or

faulty plumbing fixtures, or any direct opening to the building sewer lateral. **To reduce the likelihood of "smoke" entering your home or business, pour a bucket of water down all floor drains, sinks or other plumbing fixtures.** Pay particular attention to unused or abandoned plumbing fixtures, or open plumbing resulting from remodeling projects. The water will fill the plumbing trap and prevent the entry of the "smoke".

If "smoke" should appear in your building during the testing, open a window or door to dissipate the mist, and leave the area for the brief time it takes for the air to clear. Overexposure to the "smoke" can cause minimal irritation of the throat, or pose difficulties for persons with severe breathing problems such as emphysema. Such incidents rarely occur and can be alleviated by moving the affected person or persons into the fresh air. If you have any concerns about situations that could be affected by the "smoke testing", please call Jerry Gilles, Director of Public Works, at 262-626-4310 or Steve Zaleski with Ruckert/Mielke at 262-953-1090.

The smoke testing will be performed by the consulting engineering firm Ruckert & Mielke Inc. Crewmembers will have identification badges and will be driving a vehicle with Ruckert & Mielke signage.

In general the crews will be working from 8:00 a.m. to 5:00 p.m., Monday through Friday. The Village will know on a day-to-day basis where the crews are testing. The day before a specific street is to be tested, signs will be placed in the terrace area of the street, indicating that the testing will be done the next day. A notice will also be placed on your doorknob reiterating some of the information in this notice. Signs and notices will be placed on Friday for testing to be done on Mondays.

After losing four Eastern Wisconsin Conference matches by scores of 4-3, the Kewaskum High tennis team was due to win a close match and pulled through in grand style in its competition against host Sheboygan Falls last Thursday.

"It's about time," KHS coach Dan Ross said about the 4-3 win, which came over the defending EWC champions.

The Indians swept all three doubles matches and got help from Dan Parker at No. 4 singles.

At No. 1 doubles, Abe Foerster and Josh Bryant improved

to 7-1 with a solid 7-5, 6-4 effort over Justin Thimmig and Jake Arpke.

The real pivotal match came at No. 2 doubles where seniors John Carpenter and David Figge had to come from one-set down to claim the victory.

"It was an excellent comeback by our No. 2 doubles," Ross said, praising the efforts of Carpenter and Figge for winning the next two sets, 7-5 and 6-4.

A pair of golf teams from Washington County, including Kewaskum, did very well in the annual BrownPort Invitational held last Friday at the Hawthorn Hills Golf Course near Waubesa.

Germantown, the winner of the Washington County Tournament, added another title to its 2005 resume, with a 406 total in the five-player, all-count format used in the event.

Following Brookfield East (410) and Cedarburg (412), like Germantown, Division 1 teams, came Kewaskum, with a fine 413. The Indians were led by junior Jason Jahnke, who started out with a 41, then improved by three shots with a 38 for a 79. Jahnke, who put a lot of time into his game last summer, wound up tied with three other players for the seventh spot, and going back on the card, he ended up 10th, two places from taking home a medal.

The medalist for the day was Andy Jagow of Port Washington with a 39-35—75.

Luke Koch was very consistent with his 41-40—81 for KHS, and Chad Piwoni was a shot back at 82. Senior Josh Riebe carded an 84 on a pair of 42s, and sophomore Casey Scheel came in at 87.

There were no comments by KHS coach Glenn Eichstedt on the match.

The Indians had an off day at Green Lake on Wednesday, with one team finishing 14th and the other 15th in Lawsonia Tournament competition that included 20, 2-man teams from 10 schools.

Riebe (86) and Koch (89) combined for a 175, while Piwoni (88) and Adam Lehnerz (90) teamed up for a 178.

"We finished in the top 20 of all three divisions, but not as well as we expected," Eichstedt said.

Brenden Fenske (80) and Dan Schenk (85) of Baraboo claimed the medal with their

165 total.

\* In Monday's match at The Bull near Sheboygan Falls, Plymouth and Kewaskum ran 1-2 again, although the scores reflected the toughness of the golf course and the fierce weather conditions the players faced.

The Panthers stretched their win streak in Eastern Wisconsin Conference matches to four by posting a 179 from its top four players. Kewaskum was four shots back at 183, which was quite an improvement over last year's effort at the same course.

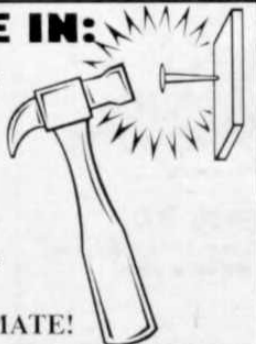

## Indians unable to take either win in doubleheader

In the nightcap, more errors opened the door for the Raiders to score six runs in the third inning, then Kewaskum's only run was scored in the top of the fourth when Tiffany Hedlund sent a ball to deep right-center field and churned all the way to third base on the hit and scored on an error by the right fielder.

"She (Hedlund) just crushed the ball," Gosse said. "She's been slumping until now."

"I was happy with the way the girls played these games but frustrated we keeping doing the same stuff (mistakes) over and over."

"The Indians' woes continued on Thursday when they traveled to New Holstein and suffered through a 13-0 defeat in a game shortened to four and a half innings because of the 10-run "mercy rule."

April Lettow pitched and took the loss. "I give her so much credit. She was a true warrior,"

Gosse said, reporting he had to keep her in to rest Breese.

Lettow struggled, giving up 15 walks, while striking out four and giving up just three hits.

"The defense didn't help much either," Gosse went on about the errors by the Indians.

Kelli Freund of New Holstein no-hit the Indians early in the season but not this time. "We actually hit this girl hard last night," Gosse said, reporting Breese had one of the three hits, with Hedlund and Amy Holm coming up with the others.

"Holm is starting to come out of her slump," Gosse said, adding, Breese "has really improved 100 percent as a hitter. She's confident."

With the three losses, the Indians fell to 1-9 in the EWC and 1-15 overall.

## Track athletes keep lowering times, improving in field events

With the Eastern Wisconsin Conference Meet coming up next week (May 17th at Kiel), Kewaskum High track coach Jerry Gosa is starting to determine what events to put his athletes in so the team and individuals will have the best chances for success.

Some are already set in stone, but after seeing what Eric Nass did in the long jump last week during a quadrangular meet, Gosa is probably rethinking where to put the talented senior.

The KHS boys finished third in Tuesday's meet, with 123.33 points, behind New Holstein (213.50) and Plymouth (146.17). Campbellsport was last with 39.

Nass flew 21 feet, 3 inches (21-3) to win the long jump. "That was Eric's first long jump since his sophomore year," Gosa said, and when asked how close that was to the school record, he answered "about five inches."

Currently the record is held by Chris Canter, who jumped 21-81/2 during the 2001 season.

Another highlight for the boys was the 4x400 relay, which won easily. "The boys won with another 3:28. That's a nice sign," Gosa said about his quartet of Garrett Donath, Nick Bartley, Zach VanWormer and Nass.

Their 3:28 at the Washington County meet put them fifth in the May 5th state track honor roll, which includes efforts from all three divisions.

Donath added a win in the pole vault (12-6), second in the 200-meter dash (24.01) and third in the open 100 (11.93).

Nass and Bartley went 1-2 in the 400 for 10 KHS points. Their times were a 51.42 and 54.16, respectively.

Another 1-2 came in the high jump with Adam Schlosser and Luke Herriges both clearing 6-0. This time, Schlosser got the nod on fewer misses.

After sitting out several weeks because of an athletic

code violation, junior Scott Rhoads returned to action and turned in several solid efforts. He took second in the pole vault (11-6), second in the 300 hurdles (44.40) and second in the 110 high hurdles (17.22).

The KHS girls won their end of the competition, scoring 137 points. Plymouth was next at 122.5, followed by New Holstein, 104 and Campbellsport, 70.50.

Amanda Donath won four events, including her specialty the 400, going under one minute again with a 59.74. "She's been very consistent," Gosa said, reporting Donath also came out first in the 200 (27.68), first in the long jump (16-0) and helped the 4x200 (Lindsay Keller, Katie Patterson and Jessi Butler, 1:56.65).

Sam Droese stole some of Donath's thunder, however, with her win in the high jump at 5-2. "She had a real good night," Gosa said. "Anytime you go five feet, it's good. Not a lot of people go five feet" and she was two inches higher than that benchmark.

Other KHS firsts included: Kelly Uelmen, 100, 13.93; 100 hurdles, Liz Potter, 18.29; 300 hurdles, Potter, 53.82; 4x100 relay (Butler, Patterson, Keller, Uelmen), 52.96; Patterson, pole vault, 9-0; and discus, Catherine Stoffel, 91-07.

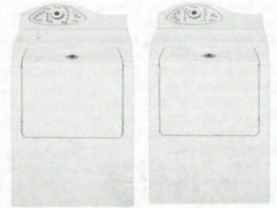
