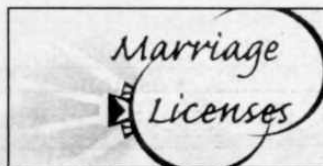

Thull farm beating victim now dead, DA says homicide charges now pending

Washington County Sheriff's Department Captain, Dale Schmidt, has confirmed that Roman Sanchez, 35, of Kewaskum was pronounced deceased at Froedtert Hospital on Friday, December 16 at 5:50pm. Sanchez became the victim of a beating at the William Thull farm on Monday, December 12, along with his brother, Rosando Sanchez, 26, also of Kewaskum.

Roman Sanchez was conveyed to Froedtert Hospital by Flight for Life Helicopter shortly after arriving at St. Joseph's Hospital. He underwent surgery there but was ultimately kept alive by a life-support machine until family could be reached in a remote area of Mexico to give permission to remove the life sustaining devices.

An autopsy on Roman Sanchez was conducted on Saturday morning revealing that he died from blunt force trauma to the head. Schmidt

stated that Rosando Sanchez was released from St. Joseph's Hospital in the Town of Polk.

Anselmo Gonzalez-Castillo, 34, of Kewaskum was initially charged with two counts of first-degree reckless injury on Wednesday, December 14. Assistant Washington County District Attorney Mark Bensen stated he planned on filing homicide charges Wednesday, December 21. This will leave Gonzalez-Castillo with one count of first-degree reckless injury and the new modified homicide charge.

Illinois man arrested for residential burglaries in Washington, FDL Counties

In the next few days, Washington and Fond du Lac County Sheriff's Departments expect to request burglary charges on a 54 year old Winnebago County, IL man for a string of residential burglaries that occurred December 7.

On December 13, Detectives from the Washington County and Fond du Lac County Sheriff's Departments served a search warrant at a Town of Beloit, WI residence. Items taken in burglaries from Washington and Fond du Lac County were located in that residence.

Detectives then located the 54-year-old suspect where he was staying in South Beloit, IL and questioned him in regards to the burglaries. He admitted involvement in the burglaries, and there is some evidence to corroborate that confession.

The man became a suspect when a Winnebago County, IL Sheriff's Detective discovered the man had pawned several rings at a pawnshop in Winnebago County, IL. One of the rings was traced to a burglary in Fond du Lac County. Washington County Sheriff's Dept.

Detectives are continuing to investigate these five burglaries as the possibility of additional suspects exists, and not all stolen items have been recovered.

The Rock County, WI Sheriff's Dept. and the South Beloit, IL Police Dept. also assisted in the investigation.

It is not believed that the

Illinois man is involved in the commercial burglaries that occurred on December 7th and 9th in Washington County. The Department continues to investigate those, and several other residential burglaries.

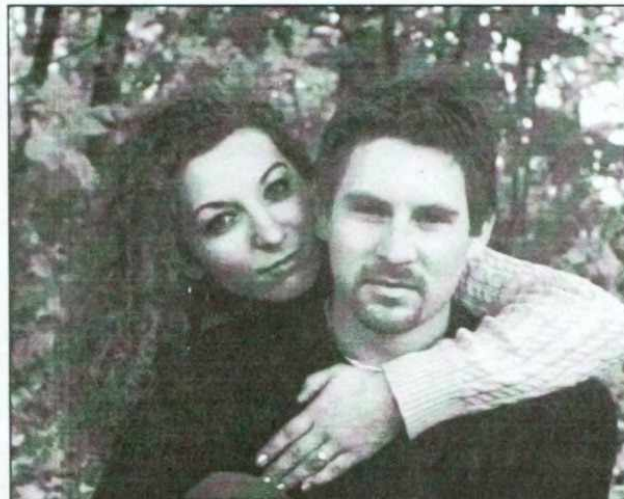

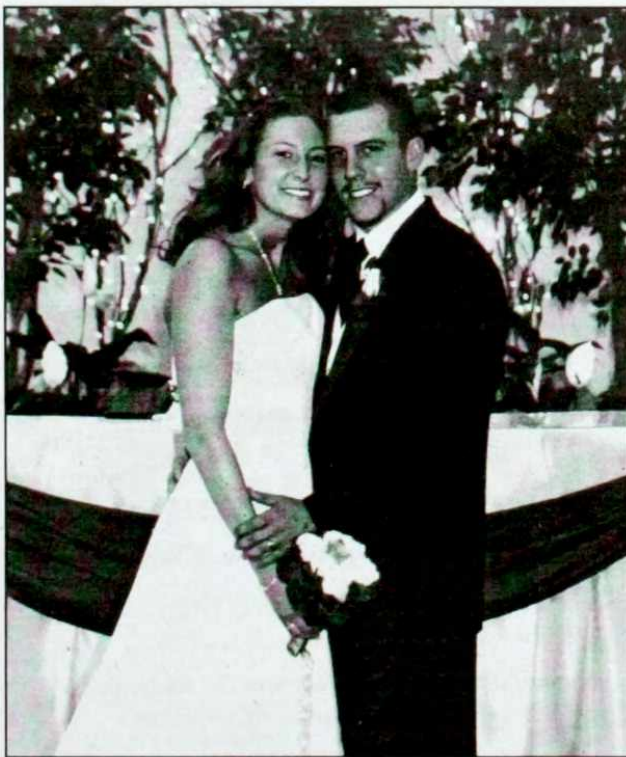

Cassini Mission to Saturn

The Evening with Nature Series at the Kettle Moraine State Forest-Northern Unit continues with "Cassini Mission to Saturn." The program will be held on Thursday, January 12, from 7:00 p.m. to 8:30 p.m. at the Henry S. Reuss Ice Age Visitor Center. The Ice Age Visitor Center is located off of Hwy 67 half mile west of Dundee. The program is free, but donations are always gratefully accepted.

With its stunning rings and dozens of moons, Saturn is a very intriguing planet. It has a stormy atmosphere with winds clocked at about 1,118 mph near the equator. These super-fast winds, combined with heat rising from the planet's interior, create the yellow and gold bands visible in the atmosphere. Saturn's extensive and complex rings are made up of billions of particles of ice and rock ranging in size from grains of sand to as big as houses. Then there are the planet's 34 moons. The largest moon is Titan which is larger than the planets Pluto and Mercury and has its own atmosphere. Some moons are

"shepherd moons" that herd the orbiting particles into the distinct rings while others create twisting and wave patterns within the rings.

Before the Cassini spacecraft, there were three previous spacecraft sent to Saturn: Pioneer II, Voyager 1 and its twin Voyager 2, but Cassini was the first to explore ring system of Saturn and its moons from orbit. It came into orbit on June 30, 2004 and immediately began sending back amazing images and data. The European Space Agency's Huygens Probe dove into the moon Titan's thick atmosphere in January 2005. The sophisticated equipment on both spacecraft are providing scientists with vital data and the best views ever of this mysterious planet.

Join Kevin Koski as he takes you on a journey through space to the ringed planet of Saturn. He will share a short video and then lead a discussion about the Cassini mission. After the inside presentation, he will set up a telescope outside for some great winter night sky view-

ing (weather permitting). This program is best for adults and youth over ten years old.

CAMPBELLSPORT- Forget the customary red ribbon and scissors. Monday afternoon's First Cut ceremony was to cut the first stud to be used in building the new Campbellsport Building Supply's Custom Cabinetry store.

Joel was 10 years old when he was paid \$1 per hour for cleaning and stocking nails. After college, he joined the family business and has been part of its growth.

"It (the business) is much bigger than we envisioned. The community has been very good to us. The customers have been very good to us. It's only because of the customers that we are here today," he said.

CBS likes to say their business is building, and that is true in more ways than one as seen by their growth to three locations and nearly 50 full-time employees in fewer than 20 years. As to the future, it's "Whatever our customers want. We need to grow to survive. We help our employees and customers to grow and expand also."

Back in 1985, when Albert asked the contractors what they wanted, one was hours that worked with their schedules. 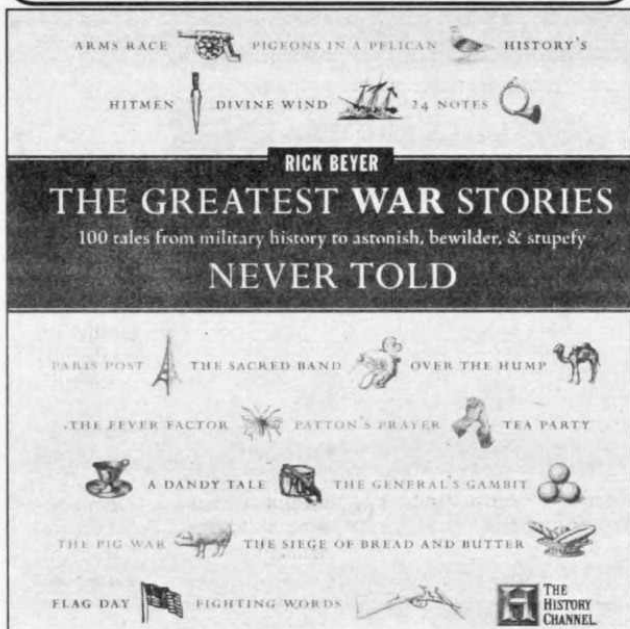

Remember high school history class?

Some people excelled in it. Others consider high school History class as a portion of their lives best... well, best left to history. All those dates. All those battles. All those kings and despots and commanders that you had to try to remember. Ugh. Why couldn't history be fun?

It is, when you read "The Greatest War Stories Never Told" by Rick Beyer. Pick up this book, and you'll see that history is exciting, interesting, and enjoyable.

Remember Davy Crockett? Sure, he was the guy with the coonskin cap who fought valiantly at the Alamo, right?

Wrong, according to Mexican soldiers. They claim that at the end of the battle, Crockett and six others were discovered quite alive, having retreated to a back room. Crockett reportedly tried to talk his way out of the situation, but General Santa Anna ordered the prisoners executed on the spot.

Speaking of Santa Anna, the General lived in New York City for awhile after The Battle of the Alamo. Ever the revolutionary, he devised a money-making scheme to use chicle as a cheap rubber substitute. The idea didn't work for tires or balloons, but it worked really well for chewing gum.

Almost everybody knows about the "don't ask, don't tell" policy of the U.S. military, but did you know that one ancient Spartan military force consisted entirely of 300 gay soldiers? They were called The Sacred Band, and for more than 30 years, they remained undefeated. You'll find out why in this book.

You'll also learn about the U.S. Government's failed attempt to use camels in the quest to settle the Old West; the second career of a military failure; a prayer that General

Patton ordered his soldiers to repeat; a Nazi supporter who stood up to the Japanese Army; a woman who stood up to the House of Representatives; a huge hoax that fooled Hitler; and a whole lot more.

I really like books like these. "The Greatest War Stories Never Told" is easy to pick up and put down. You don't have to try to remember a long, detailed plot line. You don't even have to read every page if you don't want to. And if you've got five minutes, you've got time to learn something fun-to-know because each chapter is exactly two quick pages long.

Author Rick Beyer says that these stories are found everywhere - in textbooks, online, and in old papers or library books. He says it's easy to find stories like these, but verifying them can take some effort. As you're reading this book, you'll be glad that he did the research because these stories wouldn't be half as much fun if you couldn't believe them.

Whether you're a history buff who couldn't wait for class to start, or a history buffoon who couldn't wait for class to end, you're going to find something fascinating when you read "The Greatest War Stories Never Told". Pick it up and enjoy.

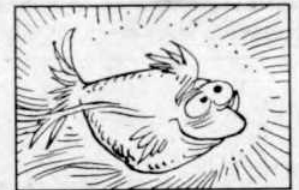

Considering the level of competition at the meet and the fact Nick Bartley was unable to wrestle, Kewaskum High did very well to finish seventh out of 23 teams in last Saturday's Marty Loy Classic held in Fond du Lac.

The Indians, paced by Jacob Turowski's second place and thirds from defending state champion Scott Rhoads and Eric Ogi, wound up with 123 points.

As expected, Luxemburg-Casco, a Division 2 powerhouse, claimed the team championship with a whopping 344 points. No one even came close to the Spartans. Pulaski finished second with 200.5, while Appleton North was third at 149, and it would have taken both of those team's points to overtake the champions.

Medford placed fourth with 130.5, and rounding out the top five was Denmark with 128.

Had Bartley been able to wrestle, Kewaskum would have had a good shot at a top-five finish, but there are more big meets on the horizon, so it is best to have him rest the knee until it is stronger.

"Bartley is doing some therapy on his knee yet. It is a

little sore, and he needs a little more time," KHS Coach Dennis Aupperle said Monday morning.

The other Indians did their best in his absence and performed well in many cases.

Turowski won several matches to earn a berth in the 189-pound finals where he lost to David Casper of Westby 10-3. This was Turowski's first defeat of the season, and it came against a quality wrestler.

"He had a returning state champ in the finals and wrestled a good match. It was closer than the score showed," Aupperle said. "The kid he beat to get there is also ranked, so now he knows where he stands. He is right in there with those guys."

Rhoads also suffered his first loss of 2005-06, and Aupperle said, "Scott had a good kid in the semis that really kept control the whole time. It could have gone either way."

In the battle for third place at 152, Rhoads won by forfeit over Darren Reiland of Appleton North.

Ogi was solid in his 12-8 victory over Andrew Carlson of Medford in the third-place match.

"Eric took a long shot in overtime with the Pulaski kid (Will Anderson) and didn't get it," Aupperle said. "The kid who won it, (Zac) Cibula of Luxem-

burg, is a sophomore and returning state champ."

"Dan (Shileny) wrestled well all day, really bounced back from Thursday (a loss to a Kiel wrestler)," the coach went on about Shileny's fifth place. Shileny decisioned Brandon Schreiber of Menomonie 7-5 to take the fifth.

"Jon (Olla) had a good tournament. he lost a real exciting match to the No. 2 ranked kid from Lux-Casco in the second round. He battled right down to the end," Aupperle beamed.

Olla placed sixth at 171, losing his last match 3-1.

And what about the young freshman P.J. Krueger, who is competing at 215 pounds, which normally is a weight class manned by upperclassmen at most schools?

Krueger placed seventh, topping Shane Harvey of Pulaski 6-4 in the match to determine seventh and eighth places.

"P.J. wrestled well again. Placing as a freshman was outstanding," Aupperle said. "He was in every match. He is right there with some pretty tough kids."

Overall, Aupperle was pleased. "The competition at this tournament is excellent," he said. "A lot of weights have state place winners as well as state champions."

Kewaskum was at a triple dual meet in Waupun Tuesday. The annual On the Waters Classic at UW-Oshkosh will be held Thursday and Friday, Dec. 29-30.
