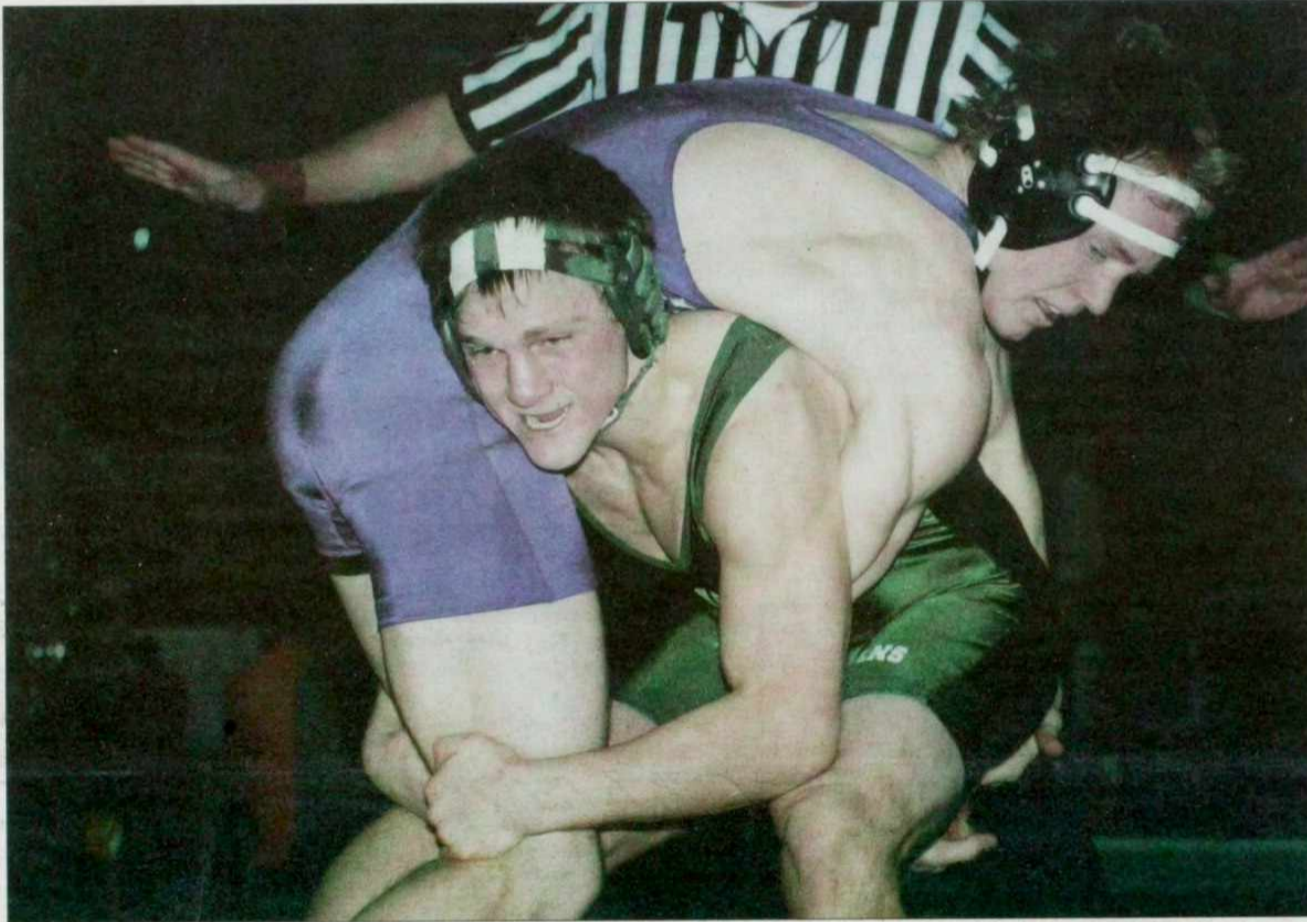

Reindl Farm to be home development

KEWASKUM- The Village of Kewaskum's Plan Commission heard plans for yet another residential development Tuesday evening. Mike Rosen presented the commissioners with a concept plan of 103 upscale single-family homes and 36 duplex condominium units.

Tom Timblin, of Cherokee Lakes was first on the agenda and presented a concept plan reflecting changes from his original plan of a 76 unit multi-family building. Timblin stated that he would now rather continue building the two-unit ranch condominiums currently being built. This will add 25 ranch style units. The development will take place on the west side of the newly constructed bridge on Caleb Drive.

Timblin stated the new plans call for considerably less density than what was originally planned. No zoning changes are needed because the property has already been zoned multi family.

Timblin stated five of the eight units built have already been sold. "We've had a pretty successful floor plan, and we would like to stick to that," he remarked about the proposed change. Building will continue to occur as units are sold. While he would like to have the land developed within a year, he stated it would be more like two to three years.

Mike Rosen is a partner in the development of Kettle Creek Preserve on 120 acres of the former Reindl Farm on Kettle View Drive. Rosen stated the concept plan is laid out to take advantage of an existing wooded area.

The development is touted as a conservancy development. Rosen stated the lot sizes are planned to be between 13 and 16,000 square feet.

Rosen added he would like to begin improvements late this summer, however the land needs to be annexed to the village from the Town of Kewaskum. A motion to send the plan to the Village Board for a favorable recommendation was taken. This is a very attractive development," stated Village President Matt Heiser.

Engineers say TID on target, developments continue

Village Board joins West Bend in asking for sales tax revenue

KEWASKUM- Just after receiving a glowing update on their Tax Incremental District (TID) The Kewaskum Village Board decided to follow neighbor West Bend in asking Washington County for a piece of sales tax revenue pie.

The Village of Kewaskum's board of trustees heard good news about the TID from Christie Cramer of Ruekert & Mielke, the village's engineering firm. Ruekert and Mielke were technical consultants regarding the TID. Cramer stated she thought that because projected interest costs were lower than anticipated, the entire cost of the project has decreased.

Bottom line she says, the village is in good shape for

paying the TID off. "The village is still looking at a 14 year TID," she stated. Under state law a TID has 27 years before it needs to be paid for.

Kewaskum residents have been skeptical about the project since the Village Lakes Center development has been in limbo. Developer Gary Gavin has stated that he has a number of other large firms very interested in developing the parcel along Highway 45. Gavin's residential development at Badger Road and Prospect Drive that is also part of the TID, continues to make progress.

Work continues on the storm sewer installation at the parcel along Badger Road. Department of public works Director, Jerry Gilles, stated the contractor continues to finish up water and sewer installation.

He noted that water and sewer has been installed for Kettle Moraine Town and Country Purina Feed Store, so they can open as planned. Once that is finished, the actual street construction for the frontage road can start.

Kettle Moraine Town and Country feed store hopes to open April 1. The TID frontage road will start March 15.

"Weather is certainly a wild card at this time of year. My best guess at this time, is probably street construction in April," stated Gilles.

The convenience store that will sell Citgo gasoline and be joined by a McDonald's and car wash is slated to break ground in the next month. James Thull of Farmington is developing that property.

Schmidt stated that Ruekert & Mielke would give

the Village Board an annual update on the progress of the TID.

West Bend Mayor Doug Bade asked the village board to join his city in passing a resolution to ask Washington County to share the sales tax revenue they are going to be receiving in the future. The Town of West Bend also passed a similar resolution.

The City of West Bend passed their resolution on Monday, January 23. It passed 7-0. Kristine Deiss, who is the county's clerk of courts, ab-

stained. Bade has proposed the idea to a number of municipalities in Washington County.

In 2004, the county received, \$8,310,373.30 in revenue from sales tax. On February 14, the County Board voted to extend the sales tax for five more years, through 2011. The vote was 18-9.

Kewaskum unanimously approved a resolution Monday, February 20. The Town of West Bend has also joined in the asking process.

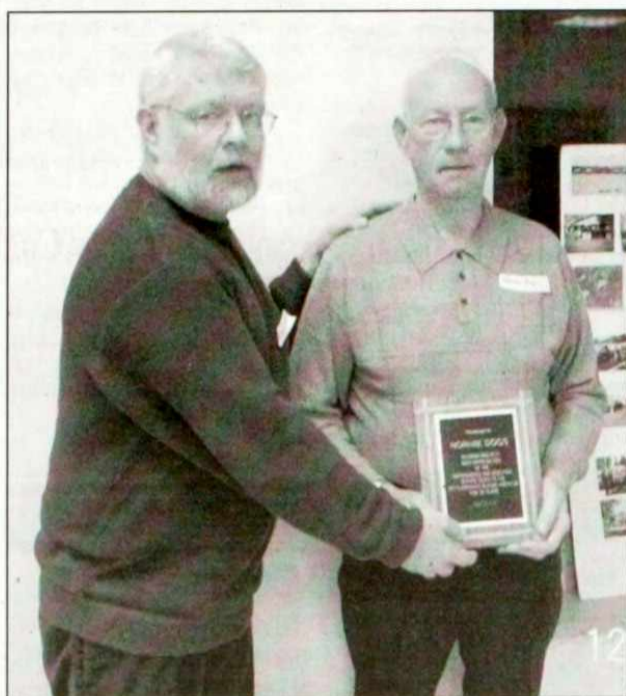

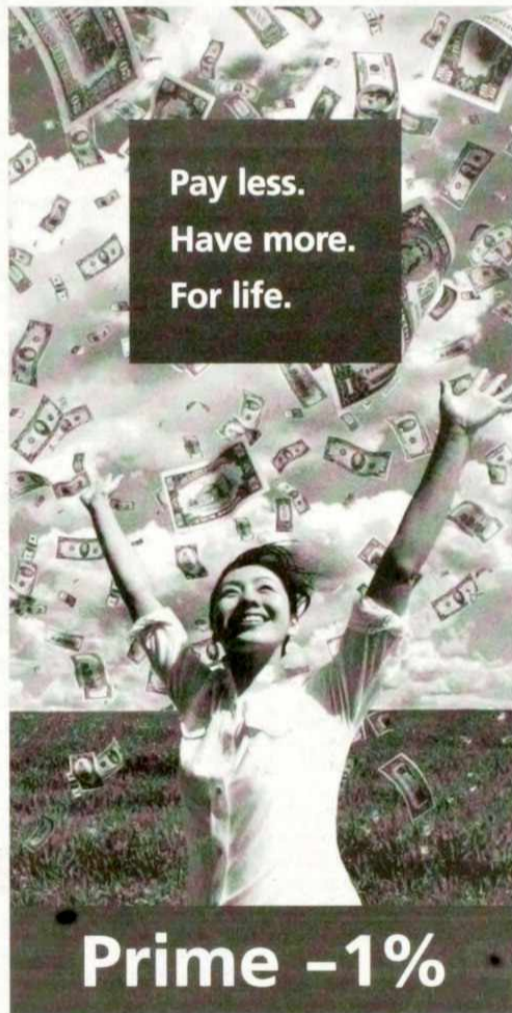

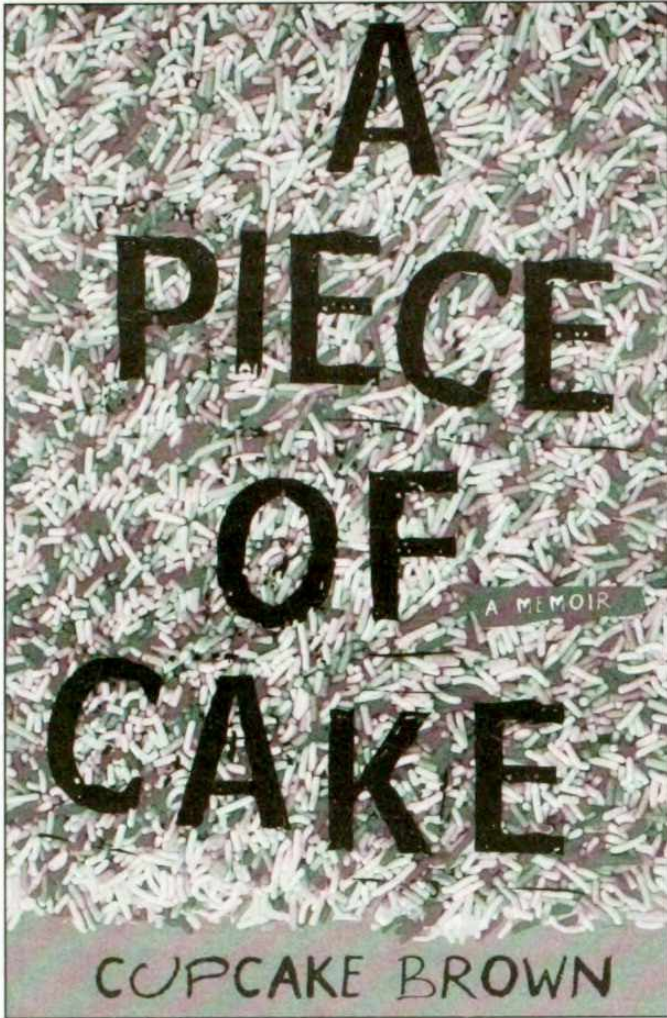


The Bookworm Sez

A Piece of Cake

By Cupcake Brown
Crown \$24.95 464 pages



Over the course of many months, Brown repeatedly ran and was always returned to the same foster home, even though physical abuse was obvious. Each time away, she discovered more ways to get high and survive on the streets. Finally, when she was fourteen, she was taken in by a relative who was also rearing four orphaned boys, the eldest of whom introduced Brown to Gangsta life.

Shot at age fourteen, emancipated at sixteen, and constantly drunk or high (or both) by the time she was twenty years old, Brown told herself that she wasn't really a junkie. She didn't need drugs, she liked them. She didn't have to drink every day, she just did. Besides, she held a job, and junkies didn't have jobs.

And then she hit bottom; or, as a policeman predicted, she went below bottom. The rest of her story - the kindness of friends and strangers, the support of people who believed in her and made her believe in herself - is a story you positively can't miss.

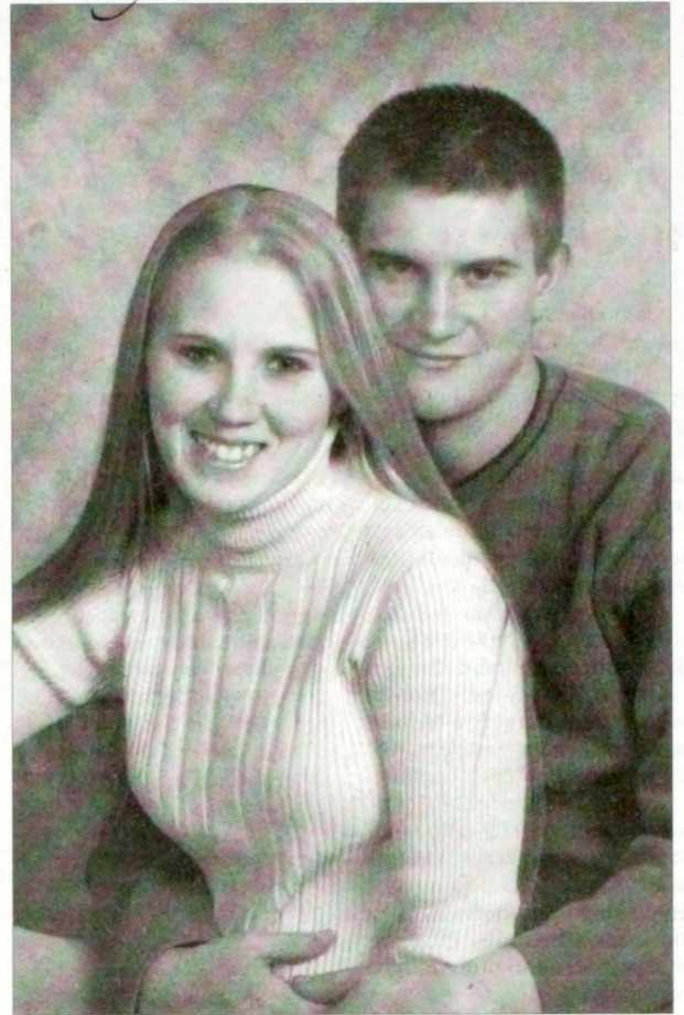
Every now and then, I get a book that I carry around with me everywhere because I can't stop reading it for any reason. This is one of those books.

I loved that each part of Brown's life is told almost in a different voice, which brings home the innocence of childhood, the despair of abuse, the violence of gang life, and the haze of constant highs. Brown's story will make you gasp. It will make you laugh, believe it or not. And it will make you want to tote this book everywhere you go.

If you're looking for something that gives you hope and makes you smile, slice into "A Piece of Cake". This book is not some half-baked memoir.

When Cupcake Brown was eleven years old, she awoke one morning to the sound of her mother's clock radio. Wandering into her mother's room, she wondered why Mama was still sleeping.

But Mama wasn't asleep. She had choked to death during a seizure.

Within days, Cupcake learned that the man she called Daddy wasn't her birth father. California law then stated that custody of minor children be given to blood relatives, so

Cupcake and her brother were handed over to a man they had never seen before. Just as quickly, the man dropped the children off at a foster home.

Within the first few minutes of arriving at the home, Brown says that she was punched. Beatings, verbal abuse, poor nutrition, and nasty pranks became daily occurrences, but Brown didn't buckle. But when she was raped by her foster mother's nephew, she decided to run away.

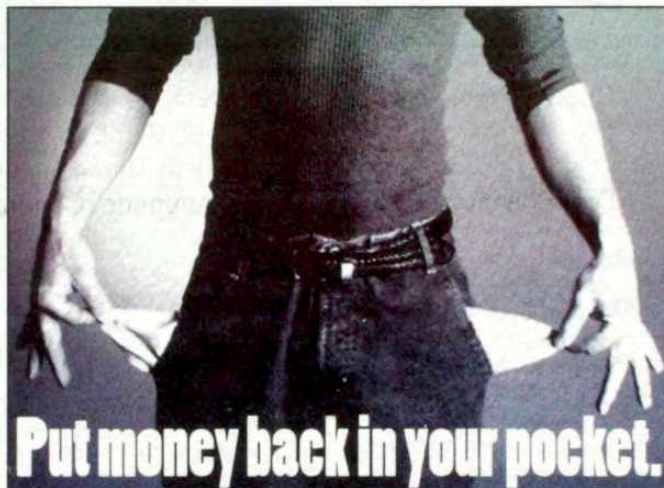

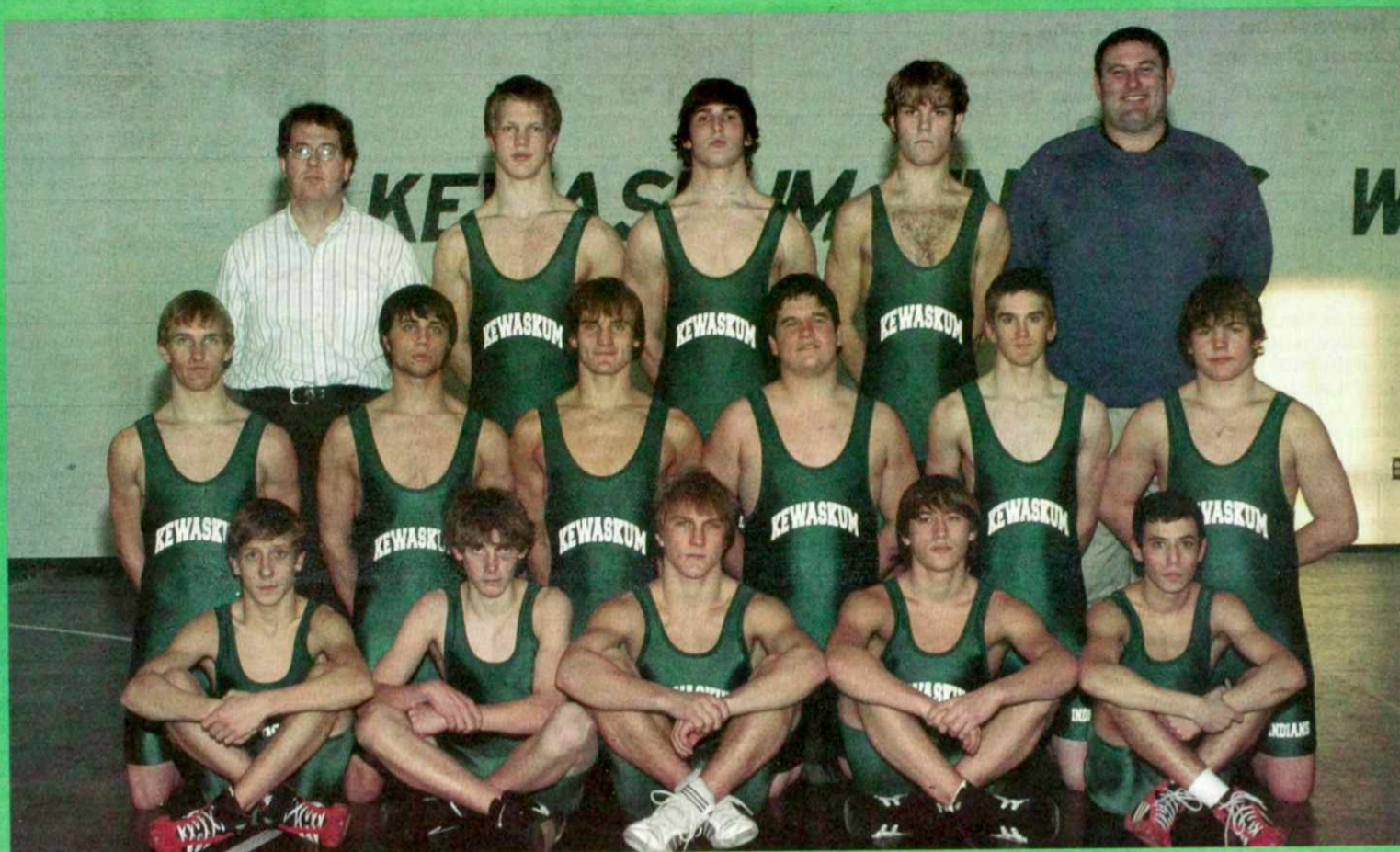

Gehl Company reports record annual sales and income

WEST BEND- Gehl Company (NASDAQ NM: GEHL), recently reported net income of \$.62 million or \$.50 per share for the fourth quarter of 2005. This compares with net income of \$.29 million or \$.29 per share for the final quarter of 2004. The 2005 fourth quarter was positively impacted by \$.12 per share a result of reversing, in full, a \$1.5 million after-tax warranty charge the company had recorded in its second quarter of 2005. Fourth quarter 2005 revenues were a record \$108.7 million compared with \$93.9 million in the same period a year earlier.

Annual revenues were \$478.2 million in 2005, also a record level, compared with \$361.6 million in 2004. Construction segment net sales increased 42% to \$344.0 million for 2005, reflecting continued strength in the north American construction markets and share gains in European markets. Agricultural segment net sales increased 13% to \$134.2 million in 2005. Compact equipment sales within the Agricultural segment increased 28% in 2005, while agricultural implement shipments declined 16% from the prior year. Compact equipment sales within the Agricultural segment grew to 70% of segment sales in 2005 versus 62% in 2004.

For the full year 2005, the Company's net income totaled a record \$21.8 million or \$1.97 per share. Comparable results were \$13.4 million or \$1.47 per share in 2004.

Key factors driving the increase in net income in 2005 included higher shipment volume, cost containment and effective pricing actions. These items were partially offset by

higher net interest expenses, due to higher average debt balances and higher interest rates in 2005 versus 2004, and higher expenses related to the sale of retail finance contracts.

"Our team performed extremely well in 2005," said William D. Gehl, Chairman and chief Executive Officer. "They are successfully executing our compact equipment focused strategy, and it is reflected in our 2005 financial performance. We tightly managed our costs, introduced innovative new products, expanded our telescopic handler manufacturing capacity, invested in state-of-the-art manufacturing technologies and improved our capital structure."

2006 Full Year Outlook

The company's markets for compact equipment continued to show strong demand throughout the fourth quarter of 2005. Orders in the fourth quarter increased over 100% compared to the prior year, driven largely by the company's introduction of its new E-Series skid loader line and the continuing strength of rental industry demand for telescopic handlers. Backlog at December 31, 2005, or \$186.3 million, increased over 180% from year-end 2004.

Based on 2006 forecasted

market growth for compact equipment in North America, as well as the company's recent order rate, backlog position and production capacity, the company expects 2006 net sales to be in the range of \$510 million to \$520 million, an increase of between 7 and 9% over 2005 levels. Operating margins are expected to continue to improve as the result of initiatives to tightly manage costs and improve efficiencies throughout the organization.

Provided general economic conditions continue to be favorable, input prices remain stable, and the availability of product from the company's suppliers is sufficient to meet demand, the company expects to earn in the range of \$2.13 to \$2.18 per share in 2006. Expected earning per share include an estimated \$.06 per share of compensation expense related to the company's adoption, in the first quarter of 2006, of Statement of Financial Accounting Standards No. 123R, which requires companies to recognize compensation expense for all stock-based awards.

All earnings per share information included in this release is on a fully diluted basis.

ORDINANCE NO. 2006-02
AN ORDINANCE
CREATING STORM WATER
UTILITY DISTRICT No. 1
VILLAGE OF KEWASKUM,
WASHINGTON COUNTY,
WISCONSIN

The Village Board of the Village of Kewaskum, Wisconsin, do ordain as follows:

SECTION 01 CREATION AND PURPOSE

The Village of Kewaskum Utility District No. 1 (Utility) was created pursuant to Section 66.0827 of the Wisconsin Statutes and is hereinafter referred to as the "Utility District". The Utility District was created for the purpose of providing facilities for the drainage and control of storm and surface waters so as to insure that the health, property, safety and welfare of the District and its inhabitants are safeguarded and protected. The District includes all of the territory shown on Exhibit 1 and described in Exhibit 2, which are incorporated herein by reference. The Village, through the Utility District may acquire, construct, lease, own, operate, maintain, extend, replace, clean, dredge, repair, conduct, manage and finance such facilities as are deemed by the Village to be reasonably necessary for a system of storm and surface water management within the Utility District.

SECTION 02 DEFINITIONS

The meaning of terms used in this subchapter shall be as follows:

1) *Administrative Costs.* The cost of general management and oversight of the Utility District, development plan and erosion control plan review, and compliance with the requirements of Wisconsin Administrative Code Chapter NR 216, including, but not limited to, the following
(a) Wages, salaries and employee's related expenses together with fringe benefits and premiums paid on such wages and salaries for the State Worker's Compensation Coverage.
(b) Utility billing and accounting expenses.
(c) Office supplies.
(d) Permit fees.
(e) Consultant and legal fees.

2) *Board.* The Village Board of the Village of Kewaskum.
3) *Capital Cost.* The cost of acquiring, purchasing, leasing, planning, designing, constructing, extending and improving all or any part of the Storm Water Sewerage System that benefits properties within the Utility District and any principal, interest or premiums on any indebtedness incurred for these purposes.

4) *Debt Retirement.* All annual principal and interest requirements and obligations of the Village that relate to storm water sewerage system improvements that benefit properties within the District.
5) *Equivalent Impervious Area.* The amount of impervious area on a lot or property plus the amount of pervious area times a factor of 0.10.
6) *Equivalent Runoff Unit (ERU).* The amount of equivalent impervious area on a typical single-family residential lot within the District.

7) *Operation and Maintenance Costs (O&M).* All direct and indirect costs, excluding debt service and other capital costs, necessary to ensure adequate drainage and control of storm and surface waters on a continuing basis and assure optimal long term function of storm water sewerage system facilities. O&M costs for the Utility District shall include expenses incurred by the Village of Kewaskum for activities that benefit properties within the District. O&M cost may include expenses for, but not limited to, the following purposes:

(a) Wages and salaries and employees' related expenses for operating and maintenance of the Storm Water Sewerage System, and

supervisory personnel, together with fringe benefits and premiums paid on such wages and salaries for the State Worker's Compensation coverage.
(b) Electrical
(c) Fuel and other operating supplies.
(d) Repairs to and maintenance of the equipment associated therewith.
(e) Premiums for hazard insurance.
(f) Premiums for insurance providing coverage against liability for the injury to persons and/or property.
(g) Rents and leasing costs.
(h) Operation, licensing and maintenance costs for trucks and heavy equipment.
(i) Consultant and legal fees.
(j) Replacement costs.

8) *Pervious Area or Pervious Surface.* Any permeable surface that allows water to pass through.
9) *Replacement Fund.* Expenditures for obtaining and installing equipment, accessories and appurtenances which are necessary during the useful life of the storm water sewerage system to maintain the capacity and performance for which such system was designed and constructed.
10) *Service Charge.* A charge levied on users to recover the component of total operation, maintenance and capital costs of the sewerage system that relates to storm and surface water runoff generated by users of the system. The Storm Water Service charge shall consist of a charge in terms of dollars per Equivalent Runoff Unit.

11) *Storm Sewer.* A sewer that carries storm and surface drainage but excludes domestic wastewater and industrial wastes.
12) *Storm Water Management Program.* Any activities undertaken by the Village of Kewaskum for the collection, transportation, storage, treatment, and disposal of storm and surface water and for the reduction or elimination of pollutants in storm and surface water, including, but not limited to administration, operation and maintenance of the Storm Water Sewerage System, constructing storm water sewerage facilities, and complying with the requirements of Wisconsin Administrative Code NR 216.
13) *Storm Water Sewerage System.* Any plant, facilities or equipment owned or leased by the Village for the collection, transportation, storage, treatment, and disposal of storm water and surface water, including but not limited to storm sewers, stormceptors, retention/detention basins and storm water drainageways.
14) *Storm Water Charges.* Charges to properties in the Utility District to recover the administrative, operating, maintenance and capital costs relating to storm water management facilities benefiting properties in the District. Storm Water Utility Charges may include service charges or any other special fees and charges that may be required to provide for an equitable sharing of Utility District costs by properties in the District.
15) *Utility District (District).* The Utility District No. 1 of the Village of Kewaskum.
16) *Village.* The Village of Kewaskum.

SECTION 03 APPLICATION
The application of this subchapter, its rules, regulations and rates shall apply to all individuals, firms, corporations and institutions owning property within the Utility District.

SECTION 04 MANAGEMENT
(1) The operation, management and control of the Storm Water Management Program of the Utility District is vested in the Village Board. The Village Clerk/Treasurer shall keep all records of the Utility District in the Town Hall or other officially designated place.
(2) The Village Board shall establish a Utility District Fund, which shall be used for collection of revenues and payment of expenses relating to the Utility District. A separate accounting shall be maintained for the Utility District Fund by the Village Treasurer.

(2) The Village Board shall cause an annual audit of the books of the Utility District to be made and shall make the books and records relating to the Utility District available for inspection during regular business hours.
(3) The Village may utilize the full authority provided in §66.0821, Wis. Stats, with respect to financing methods, service charges, and other matters therein dealt with and shall have all legal authority permitted for municipal utilities to impose reasonable charges for services.
(4) Storm Water Utility charges imposed on properties in the Utility District shall provide for a proportionate distribution of administration, operation, maintenance, capital and replacement costs among user classes.

SECTION 05 STORM WATER CHARGES

(1) *Purpose.* There is hereby established a uniform system of Storm Water charges that shall apply to each and every lot or property within the Utility District. It shall be the policy to establish storm water charges in such amount in order to pay the following costs relating to the Utility District: 1) operation and maintenance (O & M); 2) administrative; 3) contributions to a replacement and capital improvement fund; and 4) debt service, including debt retirement, debt service reserves and coverage requirements. The Board may establish and modify storm water utility charges as necessary so as to assure that the charges generate adequate revenues to pay the costs of the storm water management program and that costs are allocated fairly and proportionately to all properties in the Utility District.
(2) *Rates Set by Resolution.* All storm water service charge rates shall be established from time to time by resolution of the Village Board and set forth in a Storm Water Service Charge Rate Table.
(3) *Determination of Charges.* (a) The Storm Water Charges shall consist of a service charge. The Village may establish special fees, charges or credits as deemed necessary to assure uniform and proportionate allocation of costs to all users.
(b) *Service Charge.* Each lot or property that is within the Utility District shall be subject to a storm water service charge. This charge shall recover operation, maintenance and capital costs of the Utility District. The charge to each property shall be based upon an assignment to the property of a number of Equivalent Runoff Units (ERU). The service charge for each property shall be equal to the product of the service charge rate in terms of dollars per ERU, and the assigned number of ERUs for the property.
(c) *Determination of ERUs.* For purposes of imposing service charges, all properties within the District shall be classified into the following three customer classifications: 1) Single-Family Residential; 2) Multi-Family Residential; 3) Nonresidential; and 4) Vacant. The number of ERUs for each customer class shall be assigned as follows:
1. *Single-Family Residential:* All single-family residential properties shall be assigned 1.00 ERU per dwelling unit.
2. *Multi-Family Residential:* All multi-family residential properties shall be assigned 0.50 ERU per dwelling unit.
3. *Nonresidential:* The Village shall determine the Impervious Area and Pervious Area of each nonresidential property based on the best available information, including, but not limited to data supplied by the

Village Assessor or Building Inspector, aerial photography, the property owner, tenant or developer, or actual on-site measurements. The total Pervious Area of the property shall be multiplied by 0.10 and added to the Impervious Area of the property to determine the Equivalent Impervious Area. The Equivalent Impervious Area shall be divided by the number of square feet per ERU as established by the Village Board and set forth in a Storm Water Service Charge Rate Table to assign to the property. The number of ERUs per property shall be rounded to the nearest 0.50 ERUs.
4. *Vacant Land:* All vacant properties shall be assigned 1.00 ERU per acre.
(d) *New Construction.* The construction of new buildings will result in an increase in the number of ERUs for a property. For all properties subject to the service charge, the Village shall recalculate the ERUs upon completion of new construction.
(4) *Method of Payment of Charges.* (a) *Stormwater Service Charges.* Storm water service charges shall be billed on quarterly basis and shall be payable to the Village Clerk/Treasurer. Statements for such charges shall become due and payable within 20 days after the end of each period. A penalty of 1.5% per month shall be added to all bills not paid by the date fixed for final payment.
(b) *Billing.* The property owner is held responsible for all storm water charges on premises that he or she owns. All storm water bills and notices of any nature relative to the storm water management service will be addressed to the owner and/or occupant and delivered to the addressee by bulk mail.
(c) *Failure to Receive Bill, No Penalty Exemption.* Every reasonable care will be exercised in the proper delivery of storm water bills. Failure to receive a storm water bill, however, shall not relieve any person of the responsibility for payment of storm water charges within the prescribed period nor exempt any person from any penalty imposed for delinquency in the payment thereof.
(d) *Delinquent Accounts.* 1. *Authority.* The Village Board of the Village of Kewaskum adopts §66.0821(4)(d), Wis. Stats., by reference.
2. *Procedure.* a. The Utility Director shall inform the Village Treasurer before October 15 of each year of all lots or properties for which storm water charges are still owed for service supplied in the year preceding October 1.
b. On October 15 in each year, notice shall be given by the Village Treasurer to the owner or occupant of all lots or properties of real estate to which storm water service has been furnished prior to October 1 and pay-

ment for which is owing and in arrears at the time of giving such notice. Such notice shall be in writing and shall state the amount of such arrears, including any penalty assessed pursuant to the rules of the Utility District; that unless the delinquent account is paid by November 1 thereafter, a penalty of 10% of the amount of such arrears will be added thereto; and that unless arrears, with any such added penalty, shall be paid by November 15 thereafter, the same will be levied as a tax against the lot or property of real estate to which storm water service was furnished and for which payment is delinquent. Such notice may be served by delivery to either such owner or occupant personally or by letter addressed to such owner or occupant at the post office addresses of such lot or property of real estate. On November 16 the Village Treasurer shall certify and file with the Clerk a list of all lots or properties of real estate, giving the legal descriptions thereof, to the owners or occupants of which notice of arrears in payment were given as above specified and which arrears still remain unpaid, and stating the amount of such arrears together with the added penalty thereon as herein provided.
3. *Lien for delinquent charges.* Each delinquent amount for storm water service, including penalty, shall thereupon become a lien upon the lot or property of real estate to which the storm water service was furnished and payment for which is delinquent, and the Village Clerk shall insert the same as a tax against such lot or property of real estate. All proceedings in relation to the collection of general property taxes and to the return and sale of property for delinquent taxes shall apply to said delinquent tax if the same is not paid within the time required by law for payment of taxes upon real estate.

WHEREAS, the Developer of Woodland Creek has installed, at his own cost, the storm water management facilities as required by the approved storm water management plans; and

WHEREAS, said structures are not used elsewhere in the Village and are more costly to maintain than storm water management facilities located elsewhere in the Village; and

WHEREAS, it is the intent of the Village that the cost of providing and maintaining said structures should be charged to properties within the Woodland Creek subdivision in the form of annual service charges pursuant to Wisconsin Statutes 66.0821; and

WHEREAS, the Village caused a report to be prepared which included plans and specifications for the storm water management facilities; an estimate of the entire cost of the proposed operation and maintenance of the storm water management facilities; a statement that the properties against which the storm water service charges are proposed are benefited; and a schedule of the proposed charges; and

WHEREAS, pursuant to the provisions of Wisconsin Statutes 66.0703(7) and 66.0827, a public hearing regarding the proposed establishment and creation of a utility district in the Village of Kewaskum to wit: Village of Kewaskum Utility District No. 1 ("Woodland Creek Storm Water Utility District") was duly held before the Village Board on February 20, 2006, at the Village Hall located at 204 First Street, Village of Kewaskum, Washington County, Wisconsin, and all interested persons or their agents or attorneys, desiring to be heard were heard; and

WHEREAS, the Village Board has duly considered the testimony given at said hearing and hereby finds and determines that it is the best interest of the residents of the proposed district that Village of Kewaskum Utility District No. 1 be established to facilitate providing storm water management services to said area.

NOW THEREFORE BE IT RESOLVED, by the Village Board of the Village of Kewaskum, Washington County, Wisconsin, that:

Section 1. Pursuant to Wisconsin Statutes Section 66.0827 and 66.0821, Village of Kewaskum Utility District No. 1 is hereby established and created in the Village of Kewaskum, Washington County, Wisconsin, for a public municipal purpose to wit: to provide storm water management services to said utility district, and the Village Clerk shall establish and maintain a separate account in which

all utility district funds shall be kept and accounted for.

Section 2. The limits and boundaries of Village of Kewaskum Utility District No. 1 are set forth on the map and legal description attached hereto and incorporated herein and made part hereof by reference as Exhibit A.

Section 3. The rates for storm water service charges shall be as per Table 3 of the Report of Engineer On The Establishment Of Utility District No. 1 (Woodland Creek Storm Water Utility District) and Storm Water Charges Village of Kewaskum, Washington County, Wisconsin. The effective date of the charges will be April 1, 2006 and to be collected on a quarterly basis with the normal Water and Sanitary Sewer quarterly bill.

Section 4. The properties which comprise said district are benefited by the provision of storm water management services within the proposed district, and said actions by the Village Board constitute an exercise of the police power of the governing body of the Village of Kewaskum, Washington County, Wisconsin.

Section 5. Each paragraph of the Preamble of this Resolution shall be and is hereby incorporated in its entirety into the substance of this Resolution and made a part of this Resolution by reference as though fully restated.

the win "a great way to go into the WIAA Tournament," which opens Tuesday night.

The victory gave Kewaskum a 3-11 record in the EWC, a game behind the Raiders, who ended up at 4-10. Roncalli claimed the title after defeating Campbellsport 77-35 for a perfect 14-0 season.

True to form, the Indians started out slowly, scoring just eight points in the first quarter, but the hosts also struggled a bit offensively and were only ahead by one.

The KHS coach said when Parrent became a problem for the Raiders inside, they started paying more attention to him, which then "opened up the perimeter for Cain and Austin Flanders," who contributed 10 points to the effort.

Speaking of free throws, they played a key role in the win. Kewaskum was good on 17 of 19 tries at the line, an impressive 89 percent.

"We played solid defense, except early in the fourth period when we led 42-28, and Kiel ran off 10 straight to make it a

game until we pulled away at the free throw line," Eichstedt said. "The only missed tosses were when Eric Cain was fouled on a 3-point attempt and proceeded to miss his first two (of three) free throws."

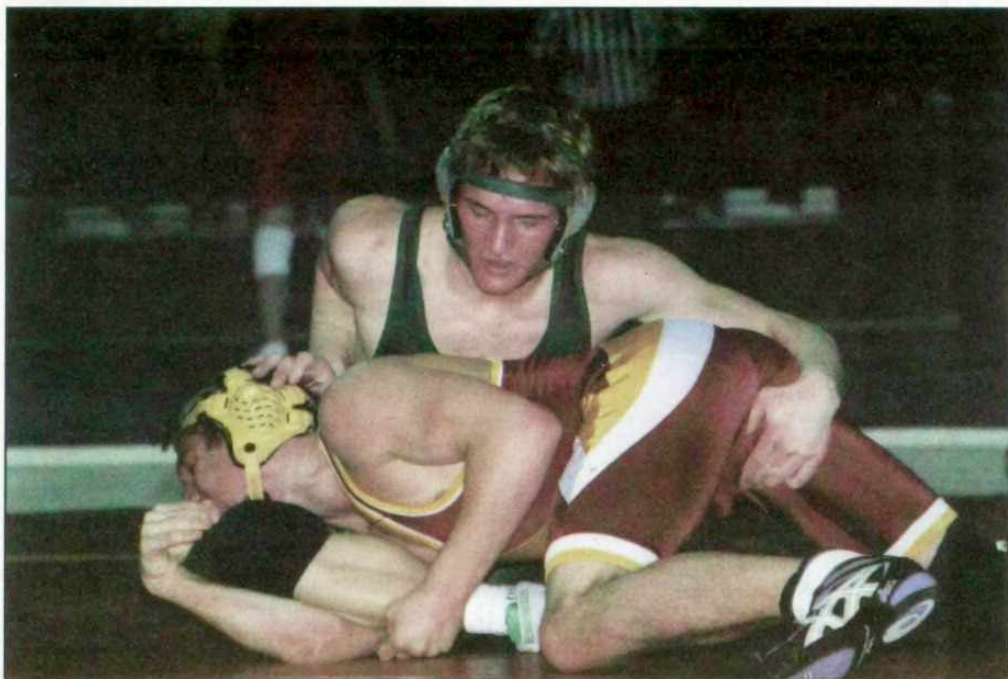

KHS senior wins 2nd straight title; Ogi is 4th again

Rhoads stands tall on state mat victory stand



A lot of people who watched Friday's semifinal match between Kewaskum High junior Eric Ogi and Zac Cibula of Luxemburg-Casco really determined the champion at 140 pounds. Unfortunately, Ogi gave up a four-point move after taking a 2-0 lead in the first period, and he lost to the defending state champion by a score of 7-5. Ogi eventually placed fourth, duplicating his effort from the 2005 tournament.

MADISON — By today's standards, Scott Rhoads is kind of small, but after winning his second straight WIAA Division 2 state wrestling title Saturday night, he is standing nearly 10 feet tall, at least in the eyes of the state wrestling circles, his coaches, teammates and his classmates at Kewaskum High School.

By defeating Kendall Vogel of Pioneer Westfield 8-4, Rhoads made history, becoming the first Kewaskum High athlete to win back-to-back championships.

Eric Ogi also made the victory stand, finishing in fourth place for the second year in a row after losing a battle royal with a defending champion, Zac Cibula of Luxemburg-Casco, in the semis.

"He wrestled well ... did a nice job," KHS coach Dennis Aupperle said about Rhoads, reporting the title match at 145 pounds was his right from the start. "Yeah, he got a takedown ... actually lateraled him (Vogel) right to his back" but part of Vogel's body was off the mat, thus he only got the takedown.

"He was in control all the time," Aupperle went on. "He stayed in good position, and put pressure on him the whole match. He just kept being aggressive ... there was no holding back. I think winning the second one (title) was harder than the first" because the pressure was on him.

Aupperle said after his man got the takedown, Vogel got a reversal to tie the match, but Rhoads came right back with an escape for a 3-2 lead after the

first period.

Vogel had the choice for the second period and deferred to Rhoads, who took the down position and quickly escaped again, using a sit out to start the escape move.

Aupperle wasn't certain what happened in the next few minutes but said Rhoads "sealed the deal" with a takedown near the end of the third period.

"He's very deserving. He's worked very hard for this," Aupperle said, adding, "He's put in a lot of extra time on his own."

Rhoads finished the season at 40-1 and takes over the No. 1

spot in history with a 134 career wins. He finished with a glossy 134-20 record.

In the quarterfinals, Rhoads wrestled smart in posting an 11-7 win over Jon Friar of Lancaster.

Thanks to a couple beautiful takedowns, Rhoads took a 6-1 lead after the first period, and rode Friar right down to the end of the second when there was a questionable reversal call, making the score 6-3.

Plenty of fireworks were on the horizon. In the third period, Rhoads reversed Friar and put him on his back for an 11-3 advantage but gave up four points

near the end.

In the semis, it was Rhoads scoring five points to three for Trevin Hines of Ellsworth. With 19 seconds left in the first period, Rhoads used a double leg takedown for a 2-0 lead and stayed out front for a 5-3 decision.

After his two matches on Friday, Rhoads said being in good shape helped him a great deal. "That's a big thing ... working harder during the season so that when you're in a close match, you can pull ahead," he said.

Rhoads was strong on his feet and riding, but he did have a little difficulty getting away from Hines. "He was a hard rider," especially using his legs, Rhoads said. "He was really pressing on my back. That hurt a little bit."

When asked if he felt he was ever in trouble, Rhoads said, "I panicked for a second once, then I got out of it."

As far as making history at KHS, Rhoads said, "I'd love to be the first one to make history at Kewaskum ... just the honor of it has been pushing me this season."

Ogi got past his first opponent, Jon Ames of Viroqua by a score of 3-0 in what was a very defensive battle. He took Ames down in the first period and got the other point, an escape, in the third.

The style wasn't one he favored, still Ogi advanced and was definitely fired up for his match against Cibula. A lot of people said this looked like the championship match at 140.

"He got caught in that 'cement mixer' ... take that away and he wins," Aupperle said about Ogi, who lost 7-5 after Cibula scored four points on

the move with about 15 seconds to go in the first period.

Ogi drew within two points with a reversal in the second but he got too high riding in the third period, allowing Cibula to gain a reversal.

"I knew I had to be aggressive to beat him," Ogi said. "It was that one move that killed me. He was waiting for me to shoot in on him so he could get the underhook."

The near-fall Ogi gave up to Cibula might have been only the second he gave up all year, according to Aupperle, who said, "He might have given up one at Oshkosh, if he did give up any."

"There are a lot of tough guys here," the KHS junior went on, indicating he would be striving for third place on Saturday because it would still be an improvement over his sophomore finish.

It wasn't to be, however, as Ogi was defeated 14-11 by Blaze Stephens of Barron to finish the year at 32-6.

"Eric got some nice takedowns," Aupperle said, indicating on one, he took Stephens to his back but off the mat, and on the second, in the middle of the mat, "He just couldn't pin him."

Aupperle also said the officiating in the match was certainly not state caliber, noting Ogi got called twice for illegal scissors moves when, in fact, "He (Ogi) didn't make it a penalty. The other kid did."

"His goal was to get to the finals," Aupperle said about Ogi, who will be aiming for a third trip next February, and since Cibula is only a sophomore, they could meet again.

"You'll see them again next year," Aupperle predicted.

All in all, it was a great weekend for KHS wrestling!
