New homebuilders face almost \$3,000 fee

Impact fee approved for water utility

KEWASKUM- Following in line with many of the growing communities in Washington and Fond du Lac Counties, the Village of Kewaskum has approved adding impact fees to the development of residential lots.

After a comprehensive report of what will need to be done to the village's water utility, village trustees were quick to approve the extra revenue source. When to start collecting the fees, however, was another story.

John Camron of Ruekert and Mielke, addressed the trustees regarding a study conducted by the village's engineering firm, regarding the need for implementing impact fees for the water utility. He stated that before the village can start collecting impact fees, state statute mandates that a 20-year assessment of the utility in question, needs to occur.

Camron told the trustees that during the assessment, his firm could not

identify any current deficiencies inside the water and sewer utility. However, over a 20-year period, the village is facing spending approximately \$5 million in upgrades to the water utility. This includes the cost of erecting a water tower to be built in the Kettle Country Estates subdivision on the eastern village limits.

Interim Village Administrator, Janet Knops stated, that while doing the survey, Ruekert and Mielke looked at the current vacant lots and the potential number of lots available for future growth in the village. They then divided the cost of improvements to the water utility and what it would take to service those vacant lots.

Ultimately, the study revealed that if each person with a buildable lot was charged \$2,986, the needed improvements could be made without forcing taxpayers to pay for the recent growth spurt the village is experiencing.

In 2004 the village board approved an ordinance setting impact fees for park and sewer. Knops stated that the amount charged for sewer

impact fees depends on the size of the meter installed. The standard size for a normal residential home costs the purchaser of a lot \$1,857. The park impact fee is \$1,087. Impact fees are usually paid at the time the lot owner applies for a building permit although some developers bear the cost. It depends how the developer's agreement is written, she said.

According to new impact fee legislation passed in March of this year, the village is forced to spend the funds collected by impact fees within seven years. However, if the village passes a resolution, stating a hardship, spending of the money could be pushed out to 10 years.

Local developer Gary Gavin stated his displeasure with the idea of the state telling the village when to spend the impact fees. "What you are telling me is that the village pools this fee money and then in seven years if

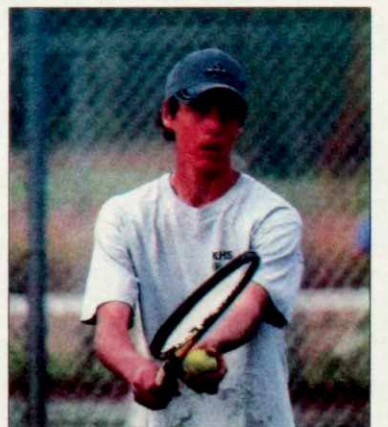

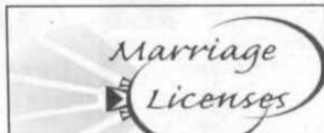

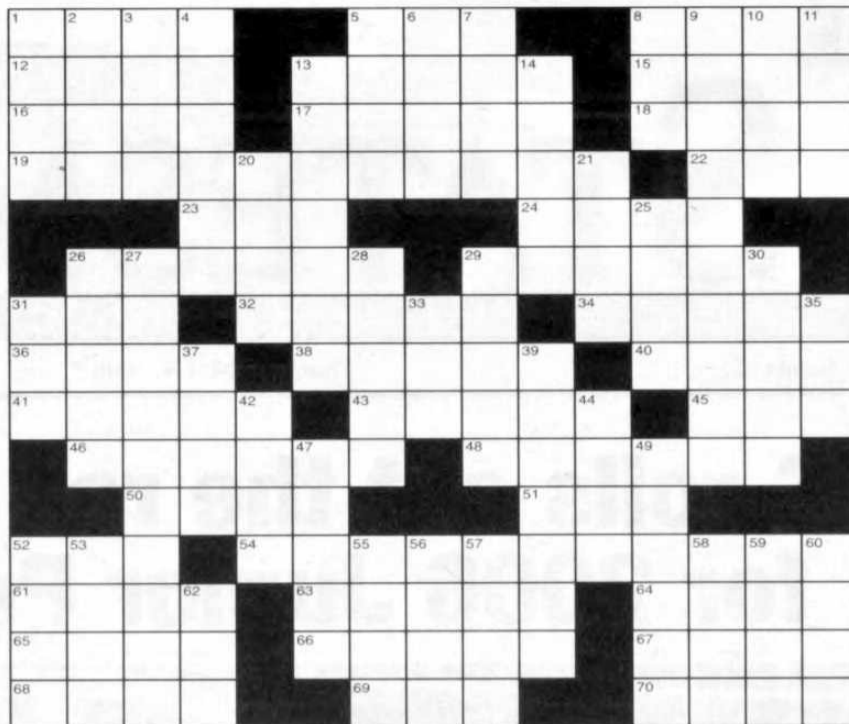

Once popular railroad line resurrects into Eisenbahn Trail

KEWASKUM— A once thriving railroad line that brought thousands of visitors to the Village of Kewaskum, the gateway to the Northern Unit of the Kettle Moraine State Forest in the 1920's 30's, 40's and 50's has been resurrected.

In 2006 it comes back to life as a hiking, biking and snowmobile recreational trail. Village businessmen are hopeful the Eisenbahn State Trail will once again bring visitors into the community as the old railway did. Washington County Park dignitaries officially opened their almost 12-mile portion of the Eisenbahn State Trail on Friday, Arbor Day, April 28, 2006.

At the special opening ceremony, on Friday, Washington County Board Chairman, Tom Sackett was joined by members of the Kewaskum Area Chamber of Commerce and the Washington County Parks and Highway Department. Sackett unveiled a memorial wooden bench for Mary Sauer and Paul Beistle, deceased members of the county board, who were instrumental in the trail's progression.

Sackett stated, "I took my first trip on the Eisenbahn Trail last week. What a delightful experience. A railroad bed has been turned into another opportunity to commune with nature. It was great," he stated.

According to Sam Tobias, of Fond du Lac County Parks and Planning, bridges on their section of the trail are complete. They were funded through the Wisconsin Snowmobile Grant Program. Surfacing is taking place right now with assistance from the

Valley and Western Ltd. abandoned a portion of the rail line running from Eden to Rusco Drive in West Bend.

Shortly, after its abandonment, the state of Wisconsin became the owner of the railroad corridor under a program, which "banks" or preserves the corridor for potential future railroad use. During the preservation phase, the state of Wisconsin Department of Natural Resources who oversees the rails-to-trails program, permits recreational use on abandoned railroad lines.

After the rails were removed on April 26, 2000 The Statesman printed a history of the railroad penned by local railroad historian Jim Yanke. In his history, Yanke stated that in the railroad's infancy, Kewaskum was a destination place for many of the Brotherhood of Locomotive Firemen and Engineer's Union. Members and their families came to Kewaskum from Chicago and Milwaukee for picnics in what was then Northside Park. Northside Park was located where Regal Ware is currently situated.

Yanke continued by saying that from 1920 until 1950, the line was mostly used for passenger trains. Starting in the 1950's the line started carrying more freight than passengers. Local businesses such as Regal Ware (The Kewaskum Aluminum Company), HJ Lay Lumber, Rosenheimer Malt and Grain and the Kewaskum Creamery were serviced by the railroad.

Looking towards the future while remembering the past

The Village of Kewaskum, located in the center of the trail, is rolling out the welcome mat for trail-users. In April, the Kewaskum Area Chamber of Commerce announced they would be build-

ing a 10' x 20' kiosk for those taking a scenic hike or bike ride. It will be located adjacent to the downtown parking lot on Main Street in Kewaskum.

Chamber Board of Directors member, Aaron Laatsch, stated the goal in erecting the structure is to promote business along the bike trail. The kiosk will also display Kewaskum area events and advertising from Kewaskum Chamber of Commerce members. Additionally it will have a pictorial history of the railroad line as well as trail maps.

"The chamber has been receiving numerous calls and online requests regarding information about the bike trail and the Kewaskum area. We have even had a few requests from out of state residents who will be vacationing here this year. Our kiosk will provide maps, visitors guides, and brochures, which will be helpful to residents and visitors to the Village of Kewaskum and the Kettle Moraine."

The total funding for the

Washington County trail construction cost \$709,092 that came from federal and state grants. The federal government awarded Washington County three grants; they were the Acquisition and Development of Local Parks grant for \$240,000; the National Recreational Trails Act fund for \$99,227, and the Snowmobile Grant program amounting to \$19,845 that covers trail relocation.

Wisconsin Stewardship fund. Surfacing should be completed in the next week.

"Opening of our portion of the trail should occur by about May 12," Tobias said. Fond du Lac County's portion of the trail will be open for bicycling, running and walking during spring, summer and fall. Winter uses will include snowmobiles and ATVs.

Trail has over 100 years of history.

The Eisenbahn (State Trail), which in German translates to iron road, runs a 20-mile stretch from West Bend to Eden. The history of railroad began with its construction by the Chicago and North Western Co. in 1872-1973. The line originally ran from Chicago to Green Bay. It was later purchased by the Fox Valley and Western Ltd. in 1988. Nearly ten years later, the Fox

there isn't a current project, we come up with a project to throw the money away?"

Gavin said he thought it was very unfair to people who may have bought a lot today in a current subdivisions, who already have home plans and budgets, to place this additional financial burden on them without any notice. He asked the trustees to consider implementing the water impact fee with the start of a new residential development, not in the middle of one that is being developed.

Village engineer Ken Ward stated most of the communities he works in do not give a grace period before the fees are mandated.

When taking a vote on the proposal, the board decided to give a three-month cushion and approved having the fees start on July 1, 2006.

Schmidt will challenge Rahn for Sheriff's seat in November

WEST BEND- A 17-year veteran of the Washington County Sheriff's Department has announced his candidacy to become Washington County's next Sheriff. Current Sheriff Brian Rahn has already submitted papers and said he intends to try and keep his sheriff's badge.

Dale Schmidt, the current Captain of Operations for the Washington County Sheriff's Department, will run under the Republican ticket in November's fall election. He is the first to announce candidacy in the November race.

Rahn has been serving since he was appointed by Governor Jim Doyle in July of 2003. "For the last three years

I've enjoyed providing leadership for the department and service to the community, and I

want to assure the public that this campaign will not impact the professionalism of the Sheriff's Department," he said Wednesday after Schmidt's announcement.

Schmidt has been a member of the Sheriff's Department since 1989, holding the positions of Special Deputy, Patrolman, Detective, and Lieutenant, and is in his sixth year as the Captain of Operations.

He has also served as a DARE Officer, Drug Unit Investigator, and a SWAT Team member since 1994. He served as the Acting Sheriff in 2003 after the death of Sheriff Jack Theusch.

Rock, Paper, Scissors is fun for everyone

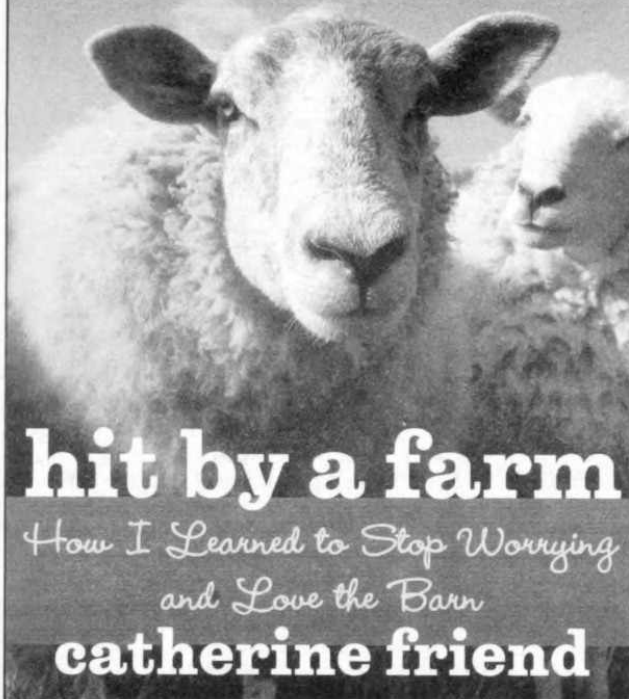
Hit by a Farm

It has dogs, sheep, a pickup truck, women's underwear, electric fences, the works."

People in love do pretty strange things.

Case in point: the fictional Cyrano de Bergerac, who helped another man win the heart of the lovely Roxane.

Case in point: Vincent Van Gogh, who snipped off his ear and sent it to the woman he admired.

Case in point: author Catherine Friend, who (temporarily) gave up her writing career and followed the dream of her partner, Melissa. In the new book "Hit by a Farm", you'll see that for Friend, following love was (temporarily) a bad idea.

For most of her childhood, Catherine Friend was happy being a bookworm. She was perfectly content to spend her summers inside reading, instead of outside doing anything else. Friend had a successful career as a writer and a writing teacher, and she loved her work. So when she fell in love with Melissa, who was the active, outdoorsy type, Friend should've seen trouble coming.

Years into their relationship, wistfully and out of the blue, Melissa told Friend that she wanted to buy a farm. A farm with a real barn.

And a few sheep. Maybe a cow or two, a couple of chickens.

And a tractor.

Not much. Just a little spread of land where they could watch the animals graze. A place to relax, quietly watching the sunset. It would be a haven of peace.

It would almost mean the end of their relationship.

The two found a 53-acre plot near a small town in Minnesota, where they built a house for themselves and

their three dogs. They built a barn. They added 50 ewe-lambs and two ram-lambs. A hundred chickens soon lived in portable pens, and a few laying hens and two roosters roamed the grounds. Two goats moved in, followed by a Mama Goat, a llama, ducks, and geese. To make the farm sustainable, the two women planned a grape arbor and tried their hand at organic gardening.

But the farm was hardly peaceful. Friend says that she and Melissa fought nearly constantly. Beloved animals died, nature was violent and unforgiving, crops didn't grow as expected, and it was easy to blame one another for everything that went wrong. Melissa seemed angry all the time. And the former bookworm who loved to write and teach had lost herself somewhere in the feathers, the wool, the manure, and the barn out back.

Alternating between humor and sad befuddlement, "Hit by a Farm" is going to make city folks chuckle and seasoned farmers laugh out loud. Author Catherine Friend isn't afraid to poke fun at herself and her bookishness, and she's perfectly willing to let readers peek into her personal life a bit. Despite the sub-title of the book ("How I Learned to Stop Worrying and Love the Barn"), I was afraid there wouldn't be a happy ending. Sheepishly, I admit my fears were unfounded.

If you've ever lived on a farm or wondered if genteel country life was possible for you, pick up a copy of "Hit by a Farm". For dyed-in-the-wool farmers or farmer-wanna-be's, it's a great book.

ORDINANCE NO. 2006-05 AN ORDINANCE CREATING STORM WATER UTILITY DISTRICT NO. 2 VILLAGE OF KEWASKUM, WASHINGTON COUNTY, WISCONSIN

The Village Board of the Village of Kewaskum, Wisconsin, do ordain as follows:

SECTION 01 CREATION AND PURPOSE

The Village of Kewaskum Utility District No. 2 (Utility) was created pursuant to Section 66.0827 of the Wisconsin Statutes and is hereinafter referred to as the "Utility District". The Utility District was created for the purpose of providing facilities for the drainage and control of storm and surface waters so as to insure that the health, property, safety and welfare of the District and its inhabitants are safeguarded and protected. The District includes all of the territory shown on Exhibit 1 and described in the legal description, which are incorporated herein by reference. The Village, through the Utility District may acquire, construct, lease, own, operate, maintain, extend, replace, clean, dredge, repair, conduct, manage and finance such facilities as are deemed by the Village to be reasonably necessary for a system of storm and surface water management within the Utility District.

SECTION 02 DEFINITIONS

The meaning of terms used in this chapter shall be as follows:

- 1) **Administrative Costs.** The cost of general management and oversight of the Utility District, development plan and erosion control plan review, and compliance with the requirements of Wisconsin Administrative Code Chapter NR 216, including, but not limited to, the following:
 - (a) Wages, salaries and employee's related expenses together with fringe benefits and premiums paid on such wages and salaries for the State Worker's Compensation Coverage.
 - (b) Utility billing and accounting expenses.
 - (c) Office supplies.
 - (d) Permit fees.
 - (e) Consultant and legal fees.
- 2) **Board.** The Village Board of the Village of Kewaskum.
- 3) **Capital Cost.** The cost of acquiring, purchasing, leasing, planning, designing, constructing, extending and improving all or any part of the Storm Water Sewerage System that benefits properties within the Utility District and any principal, interest or premiums on any indebtedness incurred for these purposes.
- 4) **Debt Retirement.** All annual principal and interest requirements and obligations of the Village that relate to storm water sewerage system improvements that benefit properties within the District.
- 5) **Equivalent Impervious Area.** The amount of impervious area on a lot or property plus the amount of pervious area times a factor of 0.10.
- 6) **Equivalent Runoff Unit (ERU).** The amount of equivalent impervious area on a typical single-family residential lot within the District.
- 7) **Operation and Maintenance Costs (O&M).** All direct and indirect costs, excluding debt service and other capital costs, necessary to ensure adequate drainage and control of storm and surface waters on a continuing basis and assure optimal long term function of storm water sewerage system facilities. O&M costs for the Utility District shall include expenses incurred by the Village of Kewaskum for activities that benefit properties within the District. O&M cost may include expenses for, but not limited to, the following purposes:
 - (a) Wages and salaries and employee's related expenses for operating and maintenance of the Storm Water Sewerage System, and supervisory personnel, together with fringe ben-

efits and premiums paid on such wages and salaries for the State Worker's Compensation coverage.

- (b) Electrical
- (c) Fuel and other operating supplies.
- (d) Repairs to and maintenance of the equipment associated therewith.
- (e) Premiums for hazard insurance.
- (f) Premiums for insurance providing coverage against liability for the injury to persons and/or property.
- (g) Rents and leasing costs.
- (h) Operation, licensing and maintenance costs for trucks and heavy equipment.
- (i) Consultant and legal fees.
- (j) Replacement costs.
- 8) **Pervious Area or Pervious Surface.** Any permeable surface that allows water to pass through.
- 9) **Replacement Fund.** Expenditures for obtaining and installing equipment, accessories and appurtenances which are necessary during the useful life of the storm water sewerage system to maintain performance for which such system was designed and constructed.
- 10) **Service Charge.** A charge levied on users to recover the component of total operation, maintenance and capital costs of the sewerage system that relates to storm and surface water runoff generated by users of the system. The Storm Water Service charge shall consist of a charge in terms of dollars per Equivalent Runoff Unit.
- 11) **Storm Sewer.** A sewer that carries storm and surface drainage but excludes domestic wastewater and industrial wastes.
- 12) **Storm Water Management Program.** Any activities undertaken by the Village of Kewaskum for the collection, transportation, storage, treatment, and disposal of storm and surface water and for the reduction or elimination of pollutants in storm and surface water, including, but not limited to administration, operation and maintenance of the Storm Water Sewerage System, constructing storm water sewerage facilities, and complying with the requirements of Wisconsin Administrative Code NR 216.
- 13) **Storm Water Sewerage System.** Any plant, facilities or equipment owned or leased by the Village for the collection, transportation, storage, treatment, and disposal of storm water and surface water, including but not limited to storm sewers, stormceptors, retention/detention basins and storm water drainageways.
- 14) **Storm Water Charges.** Charges to properties in the Utility District to recover the administrative, operating, maintenance and capital costs relating to storm water management facilities benefiting properties in the District. Storm Water Utility Charges may include service charges or any other special fees and charges that may be required to provide for an equitable sharing of Utility District costs by properties in the District.
- 15) **Utility District (District).** The Utility District No. 2 of the Village of Kewaskum.
- 16) **Village.** The Village of Kewaskum.

SECTION 03 APPLICATION

The application of this subchapter, its rules, regulations and rates shall apply to all individuals, firms, corporations and institutions owning property within the Utility District.

SECTION 04 MANAGEMENT

(1) The operation, management and control of the Storm Water Management Program of the Utility District is vested in the Village Board. The Village Clerk/Treasurer shall keep all records of the Utility District in the Municipal Building or other officially designated place.

(2) The Village Board shall establish a Utility District Fund, which shall be used for collection of revenues and payment of expenses relating to the Utility District. A separate

accounting shall be maintained for the Utility District Fund by the Village Treasurer.

(3) The Village Board shall cause an annual audit of the books of the Utility District to be made and shall make the books and records relating to the Utility District available for inspection during regular business hours.

(4) The Village may utilize the full authority provided in §66.0821, Wis. Stats, with respect to financing methods, service charges, and other matters therein dealt with and shall have all legal authority permitted for municipal utilities to impose reasonable charges for services.

(5) Storm Water Utility charges imposed on properties in the Utility District shall provide for a proportionate distribution of administration, operation, maintenance, capital and replacement costs among user classes.

SECTION 05 STORM WATER CHARGES

(1) **Purpose.** There is hereby established a uniform system of Storm Water charges that shall apply to each and every lot or property within the Utility District. It shall be the policy to establish storm water charges in such amount in order to pay the following costs relating to the Utility District: 1) operation and maintenance (O & M); 2) administrative; 3) contributions to a replacement and capital improvement fund; and 4) debt service, including debt retirement, debt service reserves and coverage requirements. The Board may establish and modify storm water utility charges as necessary so as to assure that the charges generate adequate revenues to pay the costs of the storm water management program and that costs are allocated fairly and proportionately to all properties in the Utility District.

(2) **Rates Set by Resolution.** All storm water service charge rates shall be established from time to time by resolution of the Village Board and set forth in a Storm Water Service Charge Rate Table.

(3) **Determination of Charges.** (a) The Storm Water Charges shall consist of a service charge. The Village may establish special fees, charges or credits as deemed necessary to assure uniform and proportionate allocation of costs to all users.

(b) **Service Charge.** Each lot or property that is within the Utility District shall be subject to a storm water service charge. This charge shall recover operation, maintenance and capital costs of the Utility District. The charge to each property shall be based upon an assignment to the property of a number of Equivalent Runoff Units (ERU). The service charge for each property shall be equal to the product of the service charge rate in terms of dollars per ERU, and the assigned number of ERUs for the property.

(c) **Determination of ERUs.** For purposes of imposing service charges, all properties within the District shall be classified into the following three customer classifications: 1) Single-Family Residential; 2) Duplex Residential; 3) Other. The number of ERUs for each customer class shall be assigned as follows:

1. **Single-Family Residential:** All single-family residential properties shall be assigned 1.00 ERU per dwelling unit.

2. **Duplex Residential:** All duplex residential properties shall be assigned 0.75 ERU per dwelling unit.

3. **Other:** The Village shall determine the Impervious Area and Pervious Area of each multi-family residential, nonresidential or vacant property based on the best available information, including, but not limited to data supplied by the Village Assessor or Building Inspector, aerial photography, the property owner, tenant or developer, or actual

on-site measurements. The total Pervious Area of the property shall be multiplied by 0.10 and added to the Impervious Area of the property to determine the Equivalent Impervious Area. The Equivalent Impervious Area shall be divided by the number of square feet per ERU as established by the Village Board and set forth in a Storm Water Service Charge Rate Table determine the number of ERUs to assign to the property. The number of ERUs per property shall be rounded to the nearest 0.50 ERUs.

(d) **New Construction.** The construction of new buildings will result in an increase in the number of ERUs for a property. For all properties subject to the service charge, the Village shall recalculate the ERUs upon completion of new construction.

(4) **Method of Payment of Charges.**

(a) **Stormwater Service Charges.** Storm water service charges shall be billed on quarterly basis and shall be payable to the Village Clerk/Treasurer. Statements for such charges shall become due and payable within 20 days after the end of each period. A penalty of 1.5% per month shall be added to all bills not paid by the date fixed for final payment.

(b) **Billing.** The property owner is held responsible for all storm water charges on premises that he or she owns. All storm water bills and notices of any nature relative to the storm water management service will be addressed to the owner and/or occupant and delivered to the addressee by bulk mail.

(c) **Failure to Receive Bill, No Penalty Exemption.** Every reasonable care will be exercised in the proper delivery of storm water bills. Failure to receive a storm water bill, however, shall not relieve any person of the responsibility for payment of storm water charges within the prescribed period nor exempt any person from any penalty imposed for delinquency in the payment thereof.

(d) **Delinquent Accounts.** 1. **Authority.** The Village Board of the Village of Kewaskum adopts §66.0821(4)(d), Wis. Stats., by reference.

2. **Procedure.** a. The Utility Director shall inform the Village Treasurer before October 15 of each year of all lots or properties for which storm water charges are still owed for service supplied in the year preceding October 1.

b. On October 15 in each year, notice shall be given by the Village Treasurer to the owner or occupant of all lots or properties of real estate to which storm water service has been furnished prior to October 1 and payment for which is owing and in arrears at the time of giving such notice. Such notice shall be in writing and shall state the amount of such arrears, including any penalty assessed pursuant to the rules of the Utility District; that unless the delinquent account is paid by November 1 thereafter, a

penalty of 10% of the amount of such arrears will be added thereto; and that unless arrears, with any such added penalty, shall be paid by November 15 thereafter, the same will be levied as a tax against the lot or property of real estate to which storm water service was furnished and for which payment is delinquent. Such notice may be served by delivery to either such owner or occupant personally or by letter addressed to such owner or occupant at the post office addresses of such lot or property of real estate. On November 16 the Village Treasurer shall certify and file with the Clerk a list of all lots or properties of real estate, giving the legal descriptions thereof, to the owners or occupants of which notice of arrears in payment were given as above specified and which arrears still remain unpaid, and stating the amount of such arrears together with the added penalty thereon as herein provided.

3. **Lien for delinquent charges.**

Each delinquent amount for storm water service, including penalty, shall thereupon become a lien upon the lot or property of real estate to which the storm water service was furnished and payment for which is delinquent, and the Village Clerk shall insert the same as a tax against such lot or property of real estate. All proceedings in relation to the collection of general property taxes and to the return and sale of property for delinquent taxes shall apply to said delinquent tax if the same is not paid within the time required by law for payment of taxes upon real estate.

This ordinance shall take effect upon passage the 1st day of July 2006 and publication as provided by law.

A RESOLUTION OF THE VILLAGE OF KEWASKUM, WASHINGTON COUNTY, WISCONSIN ESTABLISHING BY ORDER OF THE VILLAGE BOARD A UTILITY DISTRICT IN THE VILLAGE OF KEWASKUM TO WIT: VILLAGE OF KEWASKUM UTILITY DISTRICT NO. 2

WHEREAS, the Village Board of the Village of Kewaskum, Washington County, Wisconsin, has approved the storm water management plans for the Tax Incremental District No. 2 ("TID 2"); and

WHEREAS, the storm water management plans for TID 2 include the use of regional storm water detention ponds for the control of storm water runoff quantity and pollutants in storm water runoff; and

WHEREAS, the Wisconsin Department of Natural Resources has approved the storm water management plans for the TID 2, subject to the Village agreeing to take responsibility for the long-term maintenance of the storm water detention ponds and other facilities; and

WHEREAS, the Village installed the storm water management facilities as required by the approved storm water management plans and funded the installation of the improvements through the creation of Tax Incremental District No. 2; and

WHEREAS, it is the intent of the Village that the cost of perpetually maintaining said structures should be charged to certain properties within the TID 2 and the adjacent Nature Haven Estates Subdivision ("Nature Haven") that will derive a benefit from the facilities in the form of annual service charges pursuant to Wisconsin Statutes §66.0821; and

WHEREAS, the Village caused a report to be prepared which included plans and specifications for the storm water management facilities; an estimate of the entire annual cost of the proposed maintenance of the storm water management facilities; a statement that the properties against which the storm water service charges are proposed are benefited; and a schedule of the proposed annual charges for each of the affected properties; and

WHEREAS, pursuant to the provisions of Wisconsin Statutes §66.0703(7) and §66.0827, a public hearing regarding the proposed establishment and creation of a utility district in the Village of Kewaskum to wit: Village of Kewaskum Utility District No. 2 ("TID 2 Storm Water Utility District") was duly held before the Village Board on May 1, 2006, at the Village Hall located at 204 Main Street, Village of Kewaskum, Washington County, Wisconsin, and all interested persons or their agents or attorneys, desiring to be heard were heard; and

WHEREAS, the Village Board has duly considered the testimony given at said hearing and hereby finds and determines that it is the best interest of the properties within the proposed district that Village of Kewaskum Utility District No. 2 be established to facilitate providing storm water management services to said area.

NOW THEREFORE BE IT RESOLVED, by the Village Board of the Village of Kewaskum, Washington County, Wisconsin, that:

Section 1. Pursuant to Wisconsin Statutes Section §66.0827 and §66.0821, Village of Kewaskum Utility District No. 2 is hereby established and created in the Village of Kewaskum, Washington County, Wisconsin, for a public municipal purpose to wit: to provide storm water management services to said utility district, and the Village Clerk shall establish and maintain a separate ac-

count in which all utility district funds shall be kept and accounted for.

Section 2. The limits and boundaries of Village of Kewaskum Utility District No. 2 are set forth on the map and legal description attached hereto and incorporated herein and made part hereof by reference as Exhibit 1.

Section 3. The rates for storm water service charges shall be as per Table 3 of the Report of the Engineer on the Establishment of Utility District No. 2 and Storm Water Service Charges, Village of Kewaskum, Washington County, Wisconsin. The effective date of the charges will be July 1, 2006, with charges to be collected with the normal Water and Sanitary Sewer quarterly bill.

Section 4. The properties which comprise said district are benefited by the provision of storm water management services within the proposed district, and said actions by the Village Board constitute an exercise of the police power of the governing body of the Village of Kewaskum, Washington County, Wisconsin.

Section 5. Each paragraph of the Preamble of this Resolution shall be and is hereby incorporated in its entirety into the substance of this Resolution and made a part of this Resolution by reference as though fully restated.

Section 6. If any provision of this Resolution is determined to be invalid or unconstitutional, or if the application of this Resolution to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality will not affect other provision of applications of this Resolution that can be given effect aside from the invalid or unconstitutional provision or application.

The Plan Commission of the Village of Kewaskum, Washington County, Wisconsin, held their regular meeting in the Council Room of the Municipal Building, 204 First Street.

Chairperson Mathew Heiser, called the meeting to order at 7:00 p.m. The following Commissioners were present: Commissioners Frank Beesten, Theodore Meilahn, Chad Cook, Jim Wright and Andy Pesch; a quorum was present. Also in attendance was Mr. Gary Gavin.

The meeting was opened with a Moment of Silence and Pledge of Allegiance.

On a motion made by Andy Pesch, seconded by Theodore Meilahn and carried unanimously by voice vote the Plan Commission approved the minutes as printed for February 28, 2006.

The Plan Commission reviewed the revised concept plan for the proposed parkland donation from the Regal land from Gary Gavin. It was noted the land area would be ap-

proximately 10 acres and that the primary use of said land would be a soccer field, parking and natural area. The placement of one retention pond would be located in the SE corner of the park addition, which would divert storm water from Old Glory. The proposed bathroom facilities for the west side of KKCP would more than likely be located on the park addition. Mr. Gavin informed the Plan Commission that rather than sell the Village or donate in lieu of park impact fees, his wife and he would donate the parkland. The timing would be after the completion of his development's infrastructure. It was noted that the Village should locate the proposed bathroom, soccer field and proposed parking lot so preliminary clearing could proceed and the driveway located. Work may proceed later this summer or fall with no final construction of any of the park facilities installed until plans and budgeting are completed. It is possible that the water and sanitary sewer laterals for the bathroom may be installed this year by the developer. It was further noted that the Regal and Volm project are tied together with shared retention facilities even though the timing is totally independent. On a motion by Andy Pesch and unanimously carried by voice vote, the Plan Commission recommended moving the concept plan forward to the Village Board with a favorable recommendation.

The Plan Commission members and Mr. Gary Gavin thanked Administrator Daniel Schmidt for his years of service and dedication to the Plan Commission and the citizens of the Village of Kewaskum. Administrator graciously accepted their compliments and thanked them for their community mindedness.

Chairperson Mathew Heiser entertained the motion for adjournment. On a motion made by Frank Beesten, seconded by Andy Pesch for adjournment. By a roll call vote 6 "Aye", 0 "Nay", 0 "Absent". Motion passed. Meeting was adjourned.

Indian boys track team brings home a trophy

Buoyed by five first places and another five seconds, the Kewaskum High boys track team soared to the top of the charts in last Friday's annual Altheimer Invitational hosted by Pewaukee High School.

The Indians have consistently done well in this meet, and Friday was no exception. They scored 126 points to outdistance themselves from the rest of the field. Host Pewaukee finished second among the 10 other teams, coming in with 96 points.

The three major highlights were provided by senior Zach VanWormer and junior Logan Staeger, along with the reliable Garrett Donath, who is always good for at least a couple of first places.

Donath also came in first in the 200-meter dash, posting a time of 23.30, and added a third place in the 100 (11.7) for what could be described as an MVP kind of performance from one athlete.

Old dependables lead Indian boys to fourth place

Kewaskum High coach Jerry Gosa is well aware of the male athletes he can count on to score points in the major track meets this spring.

Bob Gibson, Luke Herriges, Garrett Donath, Zach VanWormer, Ross Stockhausen, Logan Staeger ... they all have been around long enough to know that hard work equals success, and they joined forces last Tuesday to finish a respectable fourth in the annual Washington County Track and Field Meet held on the Slinger track.

The Indians scored 87.50 points. As expected, powerful Germantown captured the team trophy. The Warhawks amassed 177 points and in the process completed the indoor/outdoor sweep in county action.

The host Owls were a distant second with a good effort, equaling 114 points, then came Hartford at 109.50 and the Indians. The two West Bend schools, East and West, were fifth and sixth, respectively, with 86 and 63 points. Kettle Moraine Lutheran brought up the rear with 56.

Kewaskum had one first place, by Donath in the pole vault. He cleared 13 feet even (13-0) to finish a foot and a half ahead of the next best vaulter in the competition.

"This equals his personal best he did at sectionals and state last year," Gosa said, indicating after reaching 13, Donath tried his new pole at 14-0, and "He had some good jumps at 14."

The KHS coach was delighted with the efforts turned in by junior distance ace Bob Gibson. First Gibson took a third in the 1,600 with a good time of 4 minutes, 45.4 seconds (4:45.4), and, "He came back and took second in the 3,200," Gosa said. In that event Gibson had a 10:24.2 clocking.

About the longer of the two runs, Gosa said, "He (Gibson) fell back into fourth place, then the last two laps, he got his focus and intensity back ... It was his fastest two-mile of the year ... a very good day for Bob" who had been struggling to try to do well in both events in previous meets.

Donath and VanWormer sparkled in the open 400 where they placed third and fourth, respectively, with times of 52.4 and 53.0. "Zach and Garrett did real nice jobs with good times," the coach said.

Unfortunately the 4x400 relay did not go as well as expected, mainly because Jake Sabel had a slight hamstring problem and was unable to run and because the relays were split into two heats (because Slinger has just a six-lane track), and Kewaskum always seemed to be in the

slower heat.

The Indians' time of 3:39.4, was .7 out of third and 1.4 seconds out of second. "VanWormer had an excellent split of 50.4. He was behind the guy from KML, caught him and passed him" by quite a good margin.

Others on the quarter were Dan Dymond, Gibson, and Matt Donath.

Gosa was hoping Herriges would claim the high jump title that was his since the indoor meet in mid-March but that did not happen only because of misses.

"Three jumpers cleared 6-2. Based on misses, Luke was third," Gosa said, confident, "It (a jump higher than 6-4) will come."

Herriges also placed fifth in the triple jump, going 36-8.25.

Ross Stockhausen had another good outing, not at 50 feet but close to that mark with a 49-6.50, which gave him, fourth place.

"Ross threw well. He was disappointed. He would have liked to have been more competitive," Gosa said.

Staeger finished fourth in the discus (138-5) and Sabel placed fifth in the long jump, going 17-4.75.

The Indians did not do well in the sprint relays, but Donath managed a fifth in the 100 (11.5) and a fifth in the 200 (23.3).

Indians lose two more games; pick up first win in EWC

The hitting is starting to come around a little bit, but the pitching and defense by the Kewaskum High girls fast-pitch team was far from stellar in three Eastern Wisconsin Conference games played last week.

The Indians started off with a 16-0 defeat at the hands of powerful Plymouth, then managed a split against host Two Rivers on Thursday, falling in the opener by a score of 17-7 before posting a 13-6 win.

Corin Groth, the winning

pitcher, helped her own cause by piling up five RBIs. Groth was 2x5, according to Gosse, who said, "She had a double, a sacrifice and a walk."

Heberer had just one hit, but her bases-loaded single drove in two runs.

Groth walked six, struck out three and gave up only five hits.

The lead seasawed back and forth, according to Gosse, who said, "We led 1-0, then 2-1 ... then we gave them a five-run inning in the fifth to fall behind 7-6. In the fourth and fifth, we took over."

"Every phase of the game we played poorly," Gosse said about the effort vs. the Plymouth squad. "April (Lettow) pitched. I gave her a start coming off her win (over Elkhart Lake). She gave up 17 hits, walked four and struck out two. We had four errors behind her."

Lindsey Grahn, the top pitcher in the conference, got the win. She struck out eight and walked none in the five-inning game via the 10-run rule. The shutout was Grahn's eighth of the year and helped the Panthers improve to 8-0 in the EWC and 10-1 overall.

When asked how many hits his team had, Gosse said, "We got two," reporting Heberer and Caytlyn Sprinkman each singled in the top of the fourth."

Kewaskum is at Campbellsport this afternoon (Thursday). They Indians also will play in a twilight double-header tomorrow at Kiel in a four-game week.

Also praised was senior midfielder, Danielle Yanke. "I thought Danielle played well. She continues to progress" after last year's injury," he said.

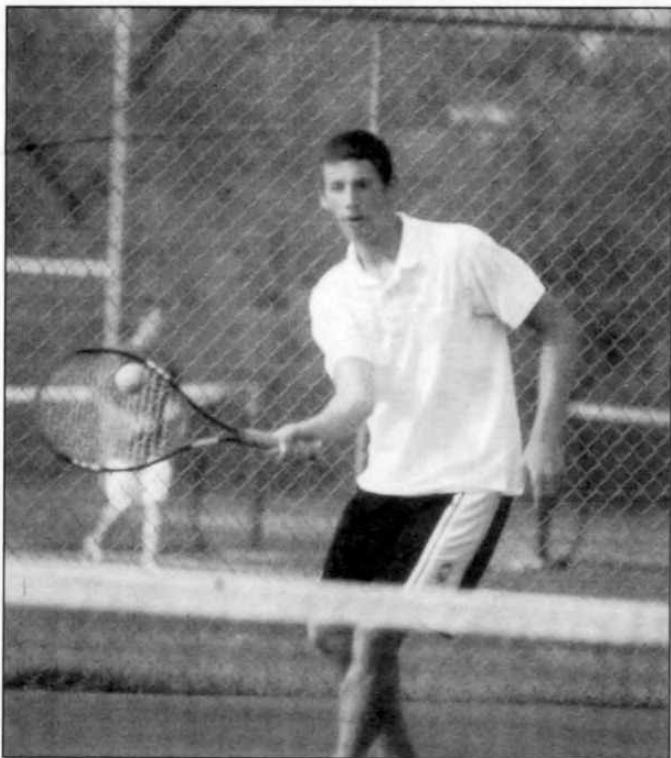

Brock, Liniewski provide highlights in County test

Erika Brock continues to be a leading lady for the Kewaskum High girls track team, and now freshman Jessie Liniewski is starting to star in a supporting role.

The two posted the Indians' only wins in the annual Washington County Track and Field Meet hosted by Slinger last Tuesday.

Kettle Moraine Lutheran, which easily is the smallest of the schools in the county but also fields a talented group of sprinters and relay runners, won the competition, mounting up 137 points, 15 in front of West Bend East (122).

The host Lady Owls placed third with 110.5 points, followed by Germantown, 98; Hartford, 90.5; Kewaskum, 69.5; and West Bend West, 58.50.

Brock won the shot put with a toss of 34 feet, 11.50 inches (34-11.50).

"She's very consistent," coach Jerry Gosa said about the lone senior on the girls' squad, pointing out Brock was within less a half of an inch of her best toss.

Liniewski cleared 4-8 to

take the high jump. There were three girls tied at 4-8, according to Gosa, who said, "She had no misses" to break the tie and take first.

"We ended up winning the County indoor and outdoor (high jump titles) with two different people," Gosa went on, referring to the fact Sam Droese won the indoor title. (Droese is no longer on the girls team.)

Liniewski's night wasn't finished with the high jump. "She leads off the 4x200 relay," Gosa said. "They finished third."

The Indians' time was 1 minute, 53.6 seconds, and helping to that end were Jenny Wicklund, Nichole Kison and Kelly Uelmen.

"It wasn't a night for sprinters," Gosa said, indicating one thing that kept the relay times from dipping down was splitting up with seven teams into two heats. Kewaskum was not in the fast heat with Germantown (1:49.1) and KML (1:51.7).

Liniewski also placed fourth in a swift field of 200 runners. Her time in the event was 28.7.

Once again, Kison, another freshman on the KHS team, contributed points in the

long jump and open 400. She jumped 14-6.25 to take third in the long jump and covered the one lap in the 400 in a time of 1:056.1, which earned her a fourth spot.

Other top-six efforts by Lady Indians included: a fourth by Crystal Treptow in the pole vault, 8-6; fourth by Uelmen in the 100, 13.7; sixth by Catherine Stoffel in the

discus, 90-09; and sixth by Liz Potter in the 300 hurdles, 55.5.

Both the KHS boys and girls track teams are at the annual Vanderpan Relays in Sheboygan Falls on Friday.
