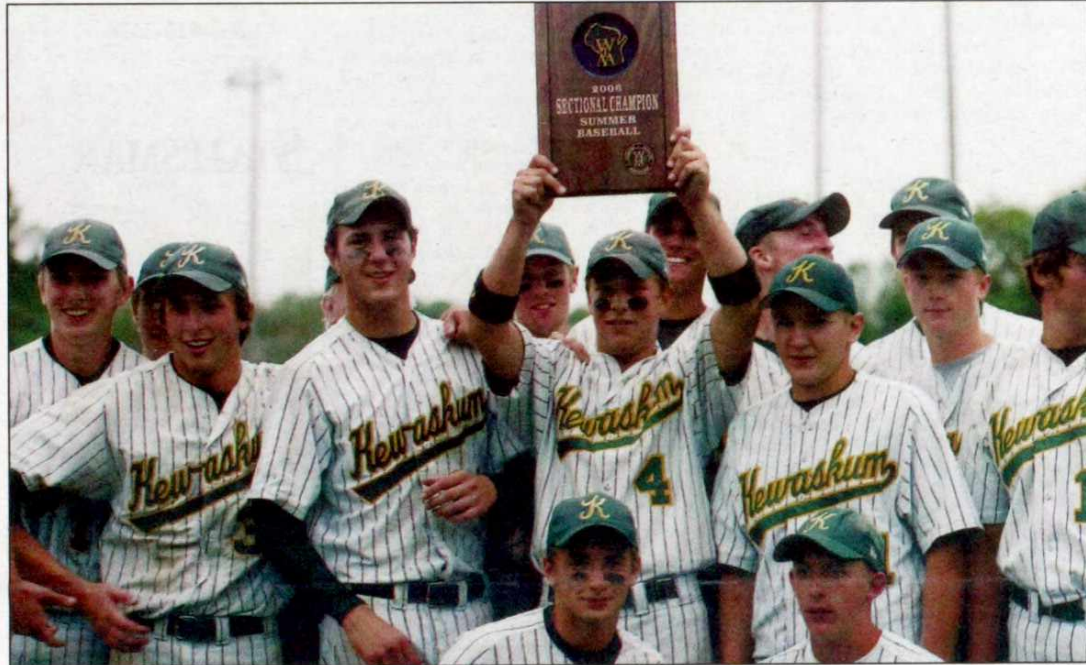

Lightning cause of Elmore house fire

TOWN OF ASHFORD- Lightning is believed to be the cause of a house fire in the rural hamlet of Elmore outside of the village of Campbellsport Thursday, July 20. The Campbellsport Fire Department was dispatched shortly after 8 a.m. to the home at 3079 Spring Street which is a complete loss and has displaced the family who lived there.

Campbellsport Fire Chief Jeff Lindsley indicated that lightning from an early morning storm is thought to have struck the home and started the fire that fully engulfed the front of the structure when firefighters arrived on scene.

Steve and Jolyn Kyler and their family live at the residence. Family pets, a cat and hamster perished in the fire. The family's dog survived. There were no injuries at the scene.

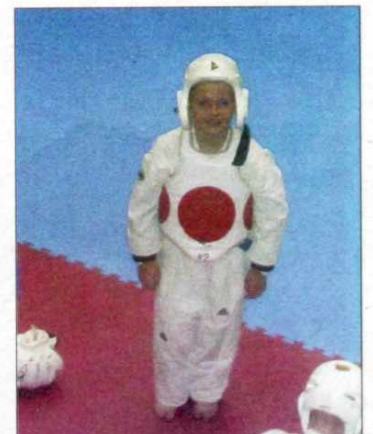
The fire remains under investigation by the Fond du Lac County Sheriff's Department and Campbellsport Fire Department.

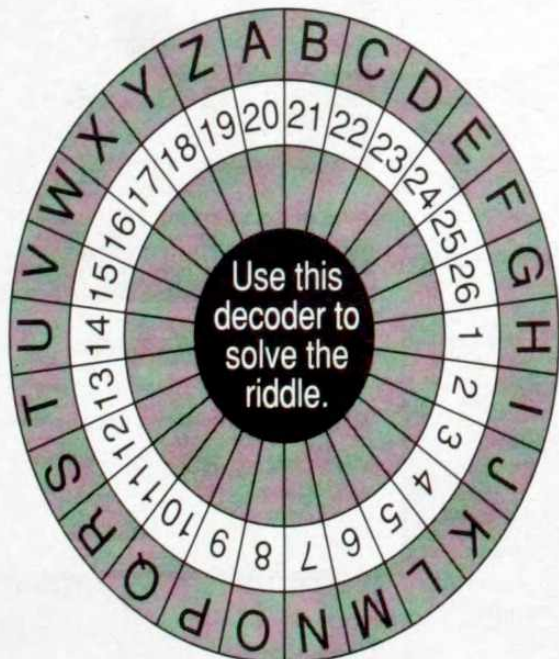

Tax levy of \$9,145,882 to be collected by school district

KEWASKUM- Taxpayers in the Kewaskum School District approved a \$8.55 tax rate for the 2006-2007. However, they will save \$15,000 by not having to pay out board salaries for yet another year thanks to 12 of the electorate in the district who voted to suspend the salaries another year.

District business manager, Paul Reichert presented the balanced, 2006-07 budget and gave the un-audited actual numbers from the 2005-06 budget. He noted the district saw a \$33,666 shortfall on the revenue side of the budget. However, on the expenditure side the district over compensated and had a surplus of \$576,513. This added \$542,847 to the fund balance for the district.

Reichert stated a number of expenditure items came in under budget. One of them being board members' compensation. At last year's meeting members were stripped of their salaries, which removed a \$15,000 expenditure. On the same note, the early retirement of the superintendent saved the district \$85,000. Utilities, open enrollment tuition, pupil transportation, legal fees and election expenses also came in under budget.

The fund balance now has \$3,101,148 in it. It is used for emergencies, budget shortfalls, special projects, and to reduce the cash flow loan that is borrowed annually and improves bond rating that lowers interest expense when borrowing becomes necessary. Board policy also says that 15% of the operating budget must remain in the fund balance.

Reichert articulated that the district would spend 1.4 percent (\$252) more per pupil than that of the previous school year. He anticipated \$8,715 to be spent per pupil for the 2006-07 year. Last year's increase was a 3.4 percent (\$7.47).

The district's revenue limit rose slightly by four percent (\$663,030) with a grand total of \$17,132,675. Last year's budget showed a 3.3 percent increase (\$527,511).

The 2006-07 budget is set at \$18,039,439, an increase of 3.7 percent (\$639,254).

The budget reflects \$212,829 in increased teaching staff that will be primarily at the high school. The budget also adds \$28,129 in support staff increases. The budget also has a new line item of \$50,000 for adding instructional equipment to classrooms at all district schools.

Reichert reported that the district could expect to receive

\$9.5 million in equalization aid. This source of revenue makes up 49 percent of the budget. The tax levy will bring in 41 percent. State and Federal aid will bring in three and four percent respectively. Miscellaneous sources account for two percent and open enrollment tuition received from other school districts account for one percent.

On the expenditures side of the budget, 75% will be paid out for salaries and benefits of district employees. Seven percent will go for supplies and equipment; five percent each will go for pupil transportation, open enrollment and purchased services. Utilities account for two percent and debt and insurance one percent.

Tax rate is estimated to be \$8.55. Total tax levy is projected to be \$9,145,882.

Kim Kauth motioned to have the school board member salary set at zero. She received a second from Robin Albert. Board member Bruce Braidigan asked for a ballot vote. The motion passed 12-9.

Neal Weare motioned to change the way board members are paid for their travel expenses while they attend meetings and conferences, on behalf of the district. Jean Goeden seconded his motion and it passed. Braidigan was the lone no vote.

CESA 6 and WASB delegates and Board Members will receive payment of \$125 per day for their attendance at the CESA 6 and WASB meetings and workshops. They will also receive mileage and other travel expenses.

"I believe the School District is moving in the right direction and is very excited about the positive actions we are taking to that end. In that vein, I think it illustrative to note that while we spent nearly 45 minutes debating two resolutions amounting to about 15 thousand dollars for Board salary and Board expenses, we spent less than 45 seconds discussing the overall budget of nearly 18 million dollars. We spent even less time discussing the provision of textbooks, school lunch and transportation to our students. Those measures all were passed with little or no debate and with an overwhelming majority vote.

And that is what truly matters, not the non-instructive squabbling of personalities in conflict. That is merely distraction from our greater mission. In the long run, paid or unpaid, the Board of Education is but a small component of an overall community effort to educate our children, and I am very excited in our ability to do just that," stated Board of Education President, John Kenworthy.

Director of Elementary Education, Kieth Kriewaldt, made a presentation of the year's activities. He also highlighted on some of the accomplishments the district achieved since the last annual meeting, such as the hiring of a new superintendent, settling two union contracts, instituting 30 new policies and an increase of 17 students in the district.

Koser confirmation comes just short of a year after 2005 condo arson blaze

Results from DNA testing confirm murder victim's death

KEWASKUM- Kewaskum's Chief of Police Richard Knoebel confirmed that Elizabeth Koser, 7, of Kewaskum was positively identified as the murder victim of the June 5 murder-suicide that took place in the Village. Other tests revealed gasoline was used as an accelerant in the home.

Knoebel stated Monday afternoon, July 24, that he received the confirmation from the Wisconsin Department of Justice Crime Lab. Other tests also conducted on materials from the incident, showed that there was the presence of gasoline found in several areas inside the residence.

Kewaskum Police Department responded to 211 Bonnie Lane in the village around 4:58 a.m. to find a fully engulfed house fire. Kewaskum Fire Department also responded and quickly extinguished the flames. They later discovered the remains of one adult and one juvenile inside the home.

The Koser confirmation comes just shy of a year after Kewaskum's first arson fire that

took place in the early morning hours of Monday, July 25, 2005 at the Prairie Gardens Condominium complex. Knoebel revealed that while his department continues to field calls on that arson, they have yet been able to receive enough information to make an arrest.

The original reward of up

to \$10,000 is still available for anyone who can give information that leads to an arrest in the 2005 arson case. Information can be given by contacting the Kewaskum Police Department at 262-626-2323 or the Arson Hotline at 1-800-363-3005.

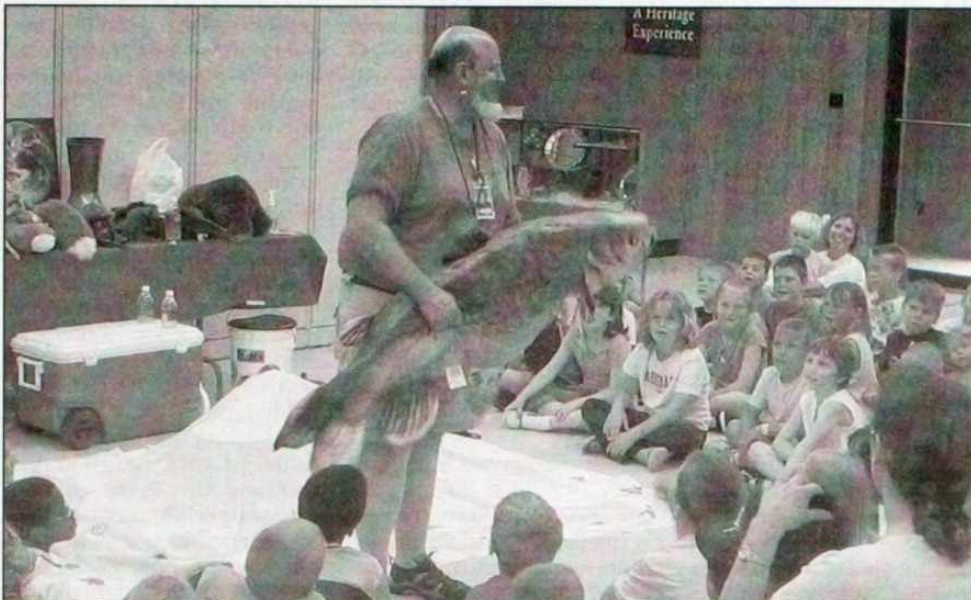

great food and homemade desserts, good music, a variety show, crafts, games for the kids, a bucket raffle, a quilt raffle and more. Everyone is invited!

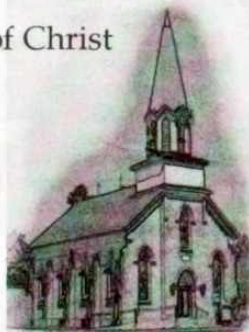

New village administrator getting acquainted with Kewaskum

Kewaskum's new village administrator has begun settling into his new position. Jay Shambeau, 35, has officially moved into his office, a week early. He recently left his job as Clark County's administrator of zoning, planning and land information.

Monday, July 24, was Shambeau's first day in the village hall. He indicated that so far things have been great. His primary tasks have been learning a lot of the day-to-day operations of the office. "Janet (Knops) has been a big help getting me on my feet," he professed.

He stated his first priority was meeting with all the department heads and touring the different facilities they were responsible for. "I wanted to get a feel for what the people here needed to do to work in their jobs effectively," he stated.

Shambeau stated he was pleased to meet Superintendent of Kewaskum Schools, Mike Krumm. "I'm excited about his views of intergovernmental cooperation. We're all in this together, with one common goal," he stated.

The change from county

government to village government has been a welcome change for Shambeau. He ensured that structurally it is a big difference. "I am used to dealing with 29 county board supervisors. I am excited to be moving down to seven folks who will run the show," he indicated.

"After 13 years in a position you feel you know everything. The first day here was much more of learning the organization, the goals and what direction the village wants to go. As a department head for Clark County my level of focus was narrow. As village administrator, I will have a much more broad perspective of everything. I look very forward to that and the challenges that will be afforded here," described Shambeau.

In his short time in the village, Shambeau says he sees things he would like to modernize, mostly from a technology standpoint. He stated that what is here currently is working fine. He feels that some modernization can improve how many village employees do their jobs.

Shambeau states that in his visits to the village before and after receiving the job, he contemplated whether or not he made the right move. In his time here since Sunday, he

"I would like to let the people of Kewaskum know that I am open-minded, I have a very open-door policy. I would be excited to meet many folks in the coming months. I would

like to hear their goals, so we can implement them the best we can. I like to think of myself as a unitary, not a divider," he concluded.

Shambeau is currently staying in a hotel, anxious to bring his family to their new home. He indicated that his

wife Sandy was finishing the last two weeks at her job in Neillsville. They will then rent while they look at permanent housing. The Shambeaus have four children, Elliot, 8, Mason, 7, and twins Abby and Lilly, 3.

KCK to offer workshop on raising healthy children and building healthy communities

Countywide Smart Growth Survey Results

The Washington County Planning and Parks Department, in partnership with SEWRPC, UW-Extension, the village of Kewaskum and towns of Addison, Barton, Erin, Farmington, German-town, Hartford, Kewaskum, Polk, Trenton and Wayne, conducted a survey gathering opinions on various issues regarding the nine elements and fourteen goals of comprehensive planning relating to housing, transportation, land use, economic development, agriculture, natural resources, cultural resources, utilities, and community facilities.

This survey was conducted by telephone in February and March of 2006 using a random digit dialing system that sampled a portion of Washington County residents. Results from the survey will be used to guide the committees in the development of the Comprehensive Smart Growth Plan and is available on the internet at www.co.washington.wi.us/smartgrowth in the public comment information section.

The random sample telephone survey was developed by the Comprehensive Plan Advisory Committee with the assistance of the University of Wisconsin - Oshkosh and University of Wisconsin - Milwaukee which surveyed 1,205 county residents. The random sample constitutes a sample population of all county residents with the results being considered statistically significant, meaning that the results are very likely to represent the views of the entire county's population.

Sample survey results include:

63% of residents believe the county is growing too fast, 31% at the right pace, 3% growing too slow and 3% not reported.

86% of respondents, either strongly agreed (46%) or agreed (40%) with the need to preserve farmland in Washington County. Only 2% strongly disagreed and 6% disagreed with the need to preserve farmland.

Preserving a community's small town character: Low priority 7%, Medium priority, 23%, High priority, 69%, not reported, 1%.

As Washington County grows, 53% of residents see new developments being concentrated in existing population centers, 38% stated scattered, 5% stated depends/both, 3% stated no growth and 3% did not report.

This survey is part of the joint planning process that will allow, for the first time, the development of an overall vision for the county and

provide an opportunity for neighboring municipalities to work through tough issues to ensure the future success, economic vitality, and quality of life in Washington County.

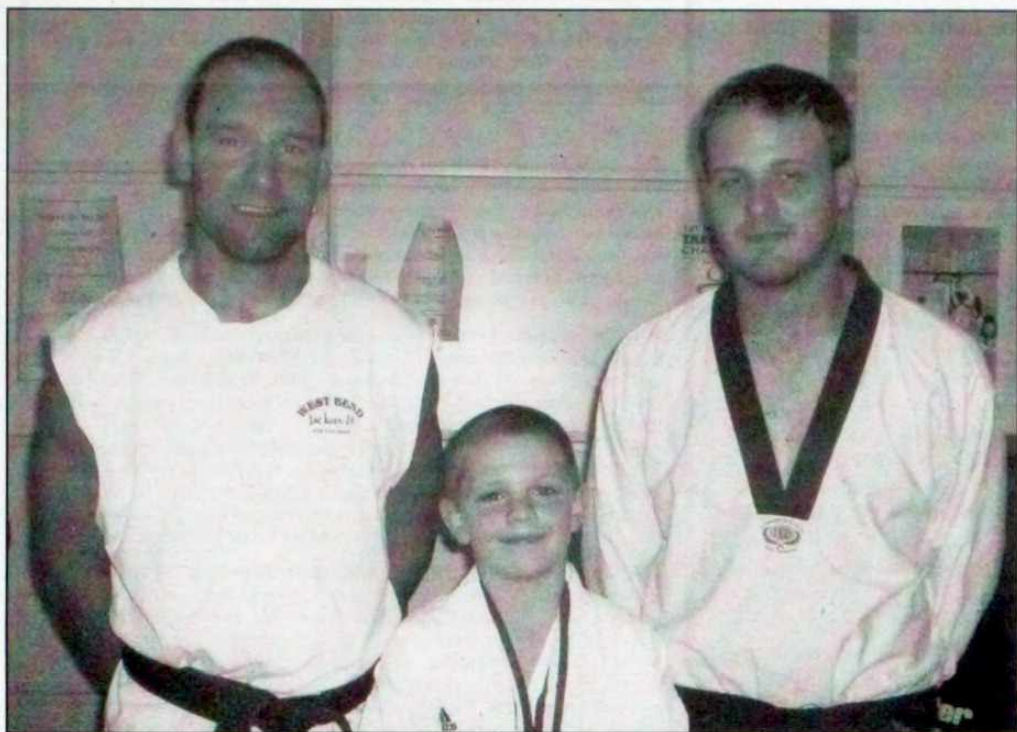

Young Lawrenz is quickly moving up tae kwon do ladder

When school starts again in early September, young Dakota Lawrenz will have plenty to tell his classmates at the Farmington Elementary School.

It's amazing that after only two and a half years in the sport of tae kwon do, Lawrenz has advanced to high red belt level, but even more exciting is the fact this third grader finished second in his class in the AAU National Tae Kwon Do Championships held recently in Knoxville, Tenn.

Lawrenz got interested in the sport after going to watch a practice at the West Bend Taekwondo School. "We went to watch ... I thought it was cool," Lawrenz said. Now he goes to classes five times a week, and

he still hasn't reached his eighth birthday, which is coming up this Sunday, on July 30th.

Lawrenz, who weighs 80 pounds, was involved in three bouts — there are two rounds in tae kwon do competition and they run two minutes in length — in the national competition.

"I had to fight 86-pound boys who were eight and nine," he said, reporting he beat his first opponent 7-0 and the next by a score of 7-2, advancing him to the finals where he lost a very close match to a boy from Florida.

"It was tied up for the first round, 2-2," Lawrenz said. "Then it was 2-3."

And was he nervous before the matches? "Yes, a lot," Lawrenz said, recalling his emotions rose when he finished in second place. "I was happy because this was my first time."

Accompanying Lawrenz on his trip to Tennessee were his mother, Tracy, and his two instructors, Bill Schellinger, the owner of the West Bend Taekwon do School, and Andy Ruckinski.

No one else in Lawrenz's immediate family is involved in taek won do. "My brother is too

young. He's four," Lawrenz said, reporting one of his uncles, Scott Peohnet is involved in the sport, and, "He's good."

And even though the national competition only concluded a couple weeks ago, Lawrenz is already looking forward to the meet in 2007.

"Next year, I get to go to (Fort Lauderdale) Florida," he said, indicating he also plans to compete in the state taek won do meet next March, "and I do to other little ones around here."

Participants in tae kwon do also are tested periodically in techniques and breaking boards, and Lawrenz took his tests last Friday, passing from brown belt right into the high red.

And what is his favorite move in the sport? "The spin kick," was Lawrenz's quick response. "It's like a horse kick," he said.

Lawrenz plans to continue to work out twice weekly in an effort to perfect the spin kick and other moves because he has two new goals set for himself, winning the 2007 nationals, and says, "By October, I want to be a black belt."

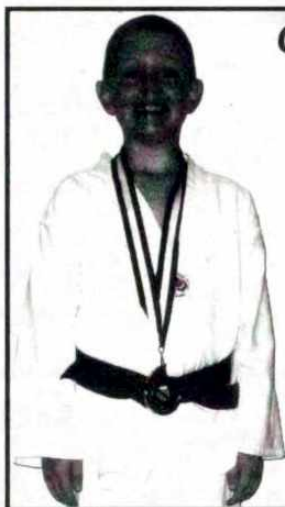

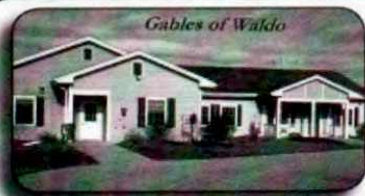

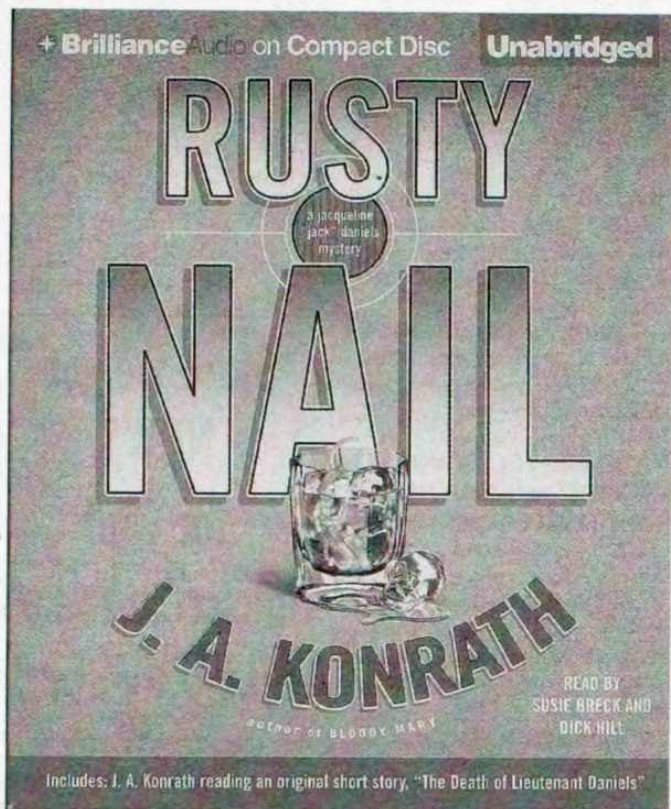

Trouble, as they say, comes in threes.

If you have one bit of bad luck, you can bet you're facing two more annoyances before you've gotten through the triad of turmoil. Even Hollywood knows that; everybody says that when one star dies, two more will follow soon.

In "Rusty Nail", the third book in the Jacqueline "Jack" Daniels mystery series by J.A. Konrath, there's one more killer loose in Chicago. At least one more.

The videotape was delivered to the Chicago PD by a young man with a blonde beard. It had Detective Jacqueline Daniels' name on it, and when Jack popped the tape in the machine, it felt like déjà vu. Jack and her partner, Herb Benedict, watched for as long as they were able, but the video was stomach-churning. This tape, this method, the struggling girl's murder... everything was eerily reminiscent of the Gingerbread Man case, a bloody, terrible series of crimes that were solved two years ago.

But Charles Kork, the Gingerbread Man, was dead. Was this the work of a copycat or was this a video of a Kork killing that the CPD didn't know about?

Then people start disappearing. The handwriting specialist that Jack used on the Gingerbread Man case vanishes. The home of a major Gingerbread Man witness is torched. The FBI's computer thinks it's the work of two killers, but Jack thinks the Feebies are weird. One copycat, yes, but three different murderers committing identical crimes? Highly unlikely.

And then the second tape arrives. The second tape shows a torture more disturbing than anything Jack has ever seen. Worse, the tape showed up at Jack's apartment, which means that the killer knows where Jack lives.

In another area of Chicago, a psychiatrist has an appointment with his patient, Alex. Alex is obviously troubled, and admits to killing cats as a stress-reliever. When the doctor instructs Alex to try avoiding cat-killing for just one week, Alex thinks that might be do-able. That's because Alex is planning on killing a far, far larger animal.

At some point or other in the near future, you might see a review of this audio book that says it's a "roller-coaster ride".

That would be wrong. "Rusty Nail" is a screaming hundred-mile-an-hour detour down a winding mountain road in a sports car, standing on the seat with the top down.

Author J.A. Konrath is known for some gruesomely bloody details in his books and this one won't disappoint his fans one bit. Readers of Konrath's first two novels will also be happy to see that Jack hasn't lost her bite. Narrators Dick Hill and Susie Breck do an incredible job with voices of various characters, including a dead-on Chicago accent for Herb Benedict and an uber-creepy voice for Alex.

Be aware that "Rusty Nail" is positively not for kids and will certainly mean nightmares for them if they listen along. But if you're ready for a triple shot of crime, murder, and mystery, then be sure to nail a copy of this audio book for yourself.

He encouraged the Village to explore enacting a room tax, since 70% of the proceeds are to be used by the Visitor's Bureau promoting the area. Trustee Kevin Scheunemann questioned the need for a room tax versus motel proprietors making direct payment or donations to the Bureau.

Ms. Anne Martin was not in attendance to present her request for placement of a stop sign at the intersection of Memorial & Timblin Drive. On a motion by Trustee Kevin Scheunemann, seconded by Trustee Thomas Piwoni and unanimously carried, the Board tabled action on the request.

Fire Chief Mark Groeschel reported that he would be bringing to the Board in the near future a Resolution addressing mutual aid throughout the area.

Director of Public Works, Jerry Gilles reported to the Board that the annual CCR had been filed with the WI DNR and is available on their website. He also presented a quote from Bruce Municipal Equipment Inc. for a 14 cubic yard 2006 Giant Vac Leaf Loader at \$26,185, indicating \$28,000 was included in the 2006 budget for this purpose. On a motion by Trustee Derek Peterson, seconded by Trustee Andy Pesch and unanimously carried, the Board approved the purchase.

Interim Administrator Janet L. Knops reported that building per-

mits issued in May of 2006 were half of what had been issued in May of 2005.

Residents were in attendance from the Old Glory Heights subdivision and voiced concerns regarding the status of the Regal Ware land abutting their properties. Mr. Gary Gavin informed them that he planned to develop the land in two phases containing PUDS retaining as many trees as possible. He plans to run the sewer and water to the property this fall but estimates development would not begin until fall of 2007.

Mr. Gary Gavin requested that the Board revise his Developers Agreement for Nature Haven Estates by allowing the blacktop to be placed in October 2007 versus October 2006 and that the lot corners not be placed until sidewalk is installed. On a motion by Trustee Kevin Scheunemann, seconded by Trustee Steve Scheunemann, and carried by voice vote, the Board approved his request.

On a motion by Trustee Kevin Scheunemann, seconded by Trustee Thomas Piwoni and unanimously carried, the Board approved the issuance of renewal and new Operators Licenses for 2006/2007 upon proper payment of fees and documentation for the following as recommended by the Police Department.

Interim Administrator Janet Knops announced the scheduled Special Village Board meetings for June 23 & 24, 2006.

Trustee Steve Scheunemann reviewed with the Board the poor condition of the trees on the 10-acre addition to the Kiwanis Park donated by Gary and Linda Gavin. On a motion by Trustee Kevin Scheunemann, seconded by Trustee Steve Scheunemann and unanimously carried, the Board approved the razing of the trees and permission to burn the refuse, provided the Fire Chief is advised. Mr. Gavin stated he would remove the trees this fall and probably do no burning until after it had snowed.

Trustee Andy Pesch the Board Representative for the Plan Commission announced a scheduled meeting for June 27, 2006 at 7:00 p.m.

President Mathew Heiser the Board Representative on the Library Board reported the Summer Reading Program is off to a healthy start and that usage is up 23% over last May and 17% year to date.

On a motion by Trustee Kevin Scheunemann, seconded by Trustee Steven Scheunemann and unanimously carried by voice vote, the Board approved granting permission to Mr. Gary Gavin to use Ruckert & Mielke, Inc. to engineer the TID No. 2 provided that all Village standards are abided and adhered to and that the prior permission granted to United Construction for this project be formally revoked by the Village Board.

Village Engineer Ken Ward presented four options to the Board ranging from a high of \$21,000 to doing nothing to correct Mr. Jeff Schicker's storm sewer on his property at 510 Jefferson Drive. On a motion by Trustee Kevin Scheunemann, seconded by Trustee Steve Scheunemann and unanimously carried the Board offered to complete option #1 for \$7,900 with the stipulation Mr. Schicker and his neighbor complete a Consent and Waiver whereby the Village would special assess the cost of the work to their properties.

A letter from Ruckert & Mielke, Inc. to Heartland Construction was reviewed proposing to revise the grading behind the back of the curb on Prospect Drive along the Kurt and Debbie Schmidt parcel with the additional cost of \$2,200 to be absorbed by the TID. The Schmidts had now requested the change because the current slope was too steep to mow. On a motion by Trustee Andy Pesch, seconded by Trustee Thomas Piwoni, with Trustee Harry Roecker and Trustee Kevin Scheunemann voting

Nay, the Board agreed to have the work performed by majority voice vote.

Mr. Ken Ward reported that the record drawings of the Nature Haven Estates were substantially completed. On a motion by Trustee Kevin Scheunemann, seconded by Trustee Steve Scheunemann and unanimously carried, the Board approved the issuance of 1 (one) occupancy permit.

A letter from Ruckert & Mielke, Inc. was reviewed regarding the sanitary sewer defects in the Kewaskum Potawatomi Prairie Subdivision. Mr. Ken Ward advised they were requested by Heartland Construction to provide them additional time to present their case to the Board. No action was taken at this time.

President Mathew Heiser informed the Board that he was attending the Kewaskum School District's board meetings as part of Inter-Governmental Cooperation and School Board President John Kenworthy was in attendance to reciprocate. He stated that the current relationship between the Village and School was an improvement over what it was in the past, citing the School Liaison Officer and sharing the baseball diamonds as examples. The possibility of broadcasting the Village and School Boards meetings was discussed and research will be done with Charter Cable to check that feasibility.

On a motion by Trustee Thomas Piwoni, seconded by Trustee Kevin Scheunemann and carried by the majority roll call vote, to adjourn. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent".

Chief of Police Richard Knoebel was sworn in by Attorney Phillip Eckert and testified to the accuracy of his June 15, 2006 statement regarding his recommendation to deny the renewal of Alcohol Beverage License Applications for Bullseye Construction, LLC for the period July 1, 2006 through June 30, 2007 for the locations previously noted.

Chief Knoebel testified that he inspected the premises applied for by Bullseye Construction LLC and 357 Main Street and 1235 Fond du Lac Avenue failed to meet the requirements of Wisconsin Statute 125.32(3)(m). While 355 Main Street would comply with Wisconsin Statute 125.32(3)(m), the Village should be provided proof of control of the premises by the applicant before any license is granted.

He further testified that in his review of the Renewal Alcohol Beverage License applications for Bullseye Construction LLC at these locations, the agent for all three is William Melchiori whose address is listed as 120 Medocino Place, Ukiah, California 95482 and the person listed as "President/Member" is Gregory Chmielewski whose address is listed as 16003 Healdsburg Avenue, Healdsburg, California 95448. Wisconsin Statute 125.04(5)(c) and 125.04(5)(a)(2) require that the Agent be a resident of Wisconsin continuously for at least ninety (90) days prior to the date of application.

He noted that all three (3) Renewal Applications list a different address for the premises than was listed on the licenses granted to the applicant for the prior year. Two (2) of these applications were for "reserve licenses". The transfer of a Reserve License to another location is prohibited by Wisconsin Statute 125.04(12)(a).

Attorney Charles Benner representing Bullseye Construction, LLC acknowledged that he did not know why the Agent and Director/Manager were listed as such when they did not reside in the State of Wisconsin. He asked Chief Knoebel why the Original Class B Liquor License applications were not scrutinized in such detail last year and he stated he was not asked to do so by former Clerk Daniel S. Schmidt. On behalf of Bullseye Construction LLC he stressed the importance of his client obtaining assurance of a Class B Liquor license was instrumental to them in developing the TID area of the Village and often was a condition of securing financing.

On a motion by Trustee Thomas Piwoni, seconded by Trustee Kevin Scheunemann and carried by majority roll call vote, the Board closed the Public Hearing. Roll call vote was 7 "Aye" 0 "Nay" 0 "Absent".



The term "game, set and match" is one that is used in the sport of tennis.

Stockhausen had to wait a few minutes as Random's Nic Weyker (the third pitcher used by Ram coach Mark Heise) warmed up to face him with Nic Olla (walk), Jon Olla (hit by a pitch) and Dan Shea (hit by a pitch) on third, second and first bases, respectively.

Stockhausen watched the first pitch go by for a ball, then it was Weyker's turn to watch as the Indian first baseman ripped the ball high and deep over the fence in left field.

"With the bases loaded, I knew he wouldn't take a chance on throwing me a curve ball," Stockhausen said later, indicating he was waiting for the fast-ball and was really excited when he saw it coming.

"He (Stockhausen) got a good pitch, and he knew what to do when he got it," KHS coach Dave Donath said afterward, breathing a sigh of relief the win was in the book after his own pitcher, Jon Roskopf, was a bit shaky in the beginning of the game, then settled down and did not allow a run from the third inning on.

"He got his pitches up," Donath said, indicating he had a couple of 1 and 2 counts on Ram hitters when he gave them pitches they were able to hit. "He's got to be a little smarter ... Later, he got smarter. He got in a real good rhythm."

Random Lake, which finished the season one game above the .500 mark, took a 1-0 lead in the first inning when its leadoff man, Brian Knight tagged Roskopf's second pitch and sent it over the fence in left field.

After a ground out, Brian Miller hit a two-bagger but died on second after Roskopf got the next two Rams on a pop out and a liner caught by Matt Parrent in left field.

"That one run doesn't mean anything," Parrent said as he raced to the dugout for the Indians' first at-bat, and how right he was.

By the time the inning was over, Kewaskum was up 4-1. Casey Scheel, who has just been playing as the designated hitter the past several weeks because of a torn labrum in his throwing arm, started off with a double

past third base. After Jon Olla was nailed by a pitch thrown by Ram starter, Andy Schwan, both base runners stole a base, and Scheel scampered home on Dan Shea's ground out.

Stockhausen followed with a double to left-center, scoring Olla, and then after Parrent was hit by a pitch, Stockhausen scored on a squeeze bunt.

Catcher Logan Staeger looked at just one pitch before he smacked a single to left, scoring Parrent, and the inning ended when Schwann got the third out when Random's center fielder, Weyker, made a nice running catch on Jake Junk's fly ball.

The Rams came flying back with three runs in the top of the second as Spencer Plier doubled home Andy Huebner, then Roskopf walked the next two batters to force in a run, and Brian Miller's single was good for an RBI.

The rally could have been even bigger had it not been for Junk's throw to the plate as Knight tried to score from second. Logan Staeger put on the tag for the second out, then Tim Schwan hit a grounder to second to end the inning.

Kewaskum sent seven batters to their plate in their half of the second, scoring three runs to surge to a 7-4 advantage.

After a strikeout, Scheel stroked his second double of the game, just inside the bag at third. Jon Olla struck out, but when Knight dropped the third strike, he threw to third base after Scheel broke for home. It looked like Scheel was a dead duck, but the ball got away from one of the Rams, and he scored.

Olla scampered to second on the play and went to third on a passed ball and scored on Shea's timely single.

Parrent picked up an RBI when he hit a bullet up the middle for a single, and the Indians were starting to breathe a little easier.

Kewaskum added a pair of runs in the fourth, and one of them is likely to go down as one of the most exciting runs of the 2006 season.

After singling to left, moving to second on a walk to Shea and stealing third, Jon Olla stole

home, nearly beating the pitch by Schwan to the plate.

Donath said he had never seen a guy have to wait for the pitch while he was stealing home, but that was definitely the case, and once again it showed the Indians have excellent speed on the base paths. For the game, they had ten stolen bases.

And while Kewaskum used big hits to score the majority of its runs, Donath liked the fact they scored several with singles and a bunt. "I think we proved we can do a little bit of the other, too," he said. "If we have to, we can."

Indians' talents are rewarded in EWC balloting

It had all the earmarks of a monopoly, and it was perfectly legal.

The Kewaskum High baseball team dominated the Eastern Wisconsin all-conference balloting, with four players selected to the first team and another four on the second.

That's right. Eight of the nine Indian starters received post season acclaim, and how could anyone argue with the outcome, considering how they won the EWC title with a 19-2 mark, far ahead of the other conference teams.

Pitcher Jon Roskopf, first baseman Ross Stockhausen, third baseman Dan Shea and outfielder Jon Olla all were selected to the first team. All but Shea are seniors.

On the second unit were catcher Logan Staeger, second baseman Garrett Donath, outfielder/pitcher Matt Parrent and utility player Corey Torrison. Donath is the lone senior in this group.

During the regular season, Shea batted an impressive team-leading .494, with six home runs, 32 runs batted in and 43 runs scored.

Olla's batting average was .460, and his stats included three home runs, 22 RBI and 19 stolen bases, while Stockhausen hit a hefty .474, with four homers, 42 RBI and seven doubles.

Roskopf finished the regular season at 9-1, with 40 strikeouts and just 18 walks. His ERA (earned run average) was 3.067.

KHS coach Dave Donath was an easy choice as the coach of the year after directing the Indians to their most successful season in the history of the school and the first EWC title since 1992.

As expected, Donath was delighted with the outcome of the voting ... except for the fact John Holt was somehow overlooked when it came to determining the first and second team pitchers.

"He was pretty good, and he couldn't even get a vote,"

Donath said, indicating this was totally unfair since he had more wins and better ERAs than the two pitchers, Mike Brazzale of Manitowoc Roncalli and Plymouth's Dean Sanders, named to the second team.

Holt sported a 6-1 record in the regular season with a 2.185 ERA.

Olla, the team's spark plug, was a unanimous selection, and this was the third year in a row he has won all-conference honors. Shea, who had an excellent season offensively and defensively, moved up from the second team. He also was one of the unanimous picks.

Nick Whitty of Campbellsport was a repeat honoree as a first team pitcher, and other unanimous picks included Cameron Salter of Campbellsport (who won all-EWC honors in 2004 and 2005), Tony Tollefson, a senior from Kiel, Matt Rodenwald of Manitowoc Roncalli, Matt Guelig and Matt Stephanie of New Holstein, and Plymouth's Tyler Niedfeldt.

Torrison's selection may have been a bit surprising, since he didn't share the right field spot with Jake Junk. "He was hitting .420," Donath said in explaining how the junior was noticed by the coaches, who normally looked at offensive stats as a determining factor in their picks.

The entire vote put the finishing touches on a memorable conference season for the Indians.

If Friday's baseball sectional would have been a music concert, the fans supporting Kewaskum would have definitely cheered until they got an encore.

Their beloved Indians put on quite a show, trouncing Campbellsport and West Bend West by respective scores of 13-1 and 8-1 in a definite statement they were the champions and indeed worthy of moving on to the WIAA Summer Baseball Tournament in Stevens Point.

"It feels outstanding! It's something great for the kids ... something they will never forget," coach Dave Donath said after his team notched its 26th and most important win of the season, behind an outstanding pitching effort by Matt Parrent.

During the bottom of the fifth inning in the Indians' opening game, Parrent dove for a ball hit by Campbellsport's Cameron Salter and injured his thumb (on his glove hand) when he landed. Instead of resting between games, Parrent made a trip to have the thumb X-rayed, but that didn't stop him from tossing a 7-hitter at the Spartans, who had beaten Kewaskum 8-3 a week ago.

"Matt threw great ... What a gutsy performance by a guy who has a broken thumb," Donath said about the 6-foot-4 junior who stopped West cold in its tracks.

The Spartans didn't score a run until the top of the seventh, and it came off two of the few mistakes the Indians made in the finals.

After Parrent got the first two outs on a ground out and a strikeout, Ryan Schilter reached on an error, moved to third on Adam Martz's single and scored on a passed ball.

The run was really of no consequence since the Indians scored a pair of runs off Jake

Lathers in the first inning, four more in the second and two in the third when they forced West coach Bill Albrecht to make a pitching change in favor of Matt Meisenheimer.

The first runs came via a single by Logan Staeger, a bunt by Garrett Donath, which was mishandled by Lathers, allowing both runners to safely reach base.

Corey Torrison, playing outfield because of the injury to Parrent, stepped to the plate and smacked a single to center, scoring Staeger, and after Jake Junk successfully sacrificed the runners ahead to second and third, Donath scored when Jon Olla grounded out to short.

The big rally in the second started with a walk and stolen base by Jon Olla, who scored on Ross Stockhausen's single. Stockhausen took second on the late throw home, then Staeger followed with his second hit of the game, putting runners at the corners.

Garrett Donath followed with an RBI single over third base, then everyone was safe when West's second baseman dropped the ball (hit by Torrison) attempting to tag Donath.

With the bases loaded, Junk was hit by Meisenheimer, forcing in another run and the West pitcher also walked Nic Olla to force in run No. 6.

Kewaskum still wasn't finished. In the top of the fourth, Jon Olla, singled, stole second and got an extra base on a bad throw by the catcher. With Stockhausen up, Meisenheimer was guilty of a wild pitch, and Olla easily sprinted home, and the final run came via a Staeger single, followed by Donath's three-base rip to deep center field.

Now the Indians' confidence level was soaring. The dream of reaching state was becoming a clear reality.

"The kids really stepped up. With him (Parrent) out (of the

batting order), they had to," Donath said, referring to Torrison, and Staeger, who produced four hits in his four trips to the plate.

Another key, according to Donath, was keeping West from getting its leadoff men (each inning) on base. In six of the seven innings, Parrent got an out on the first man he faced. The lone exception was the first inning when he walked shortstop Matt Schilter on five pitchers.

Schilter stole second base but was erased when Donath grabbed a line drive off the bat of Matt Meisenheimer and tossed to Nic Olla to double him

off.

"On the other hand, we got our leadoff guys on and put pressure on them," Donath said.

Parrent wound up striking out five while walking just two. Other than in the seventh inning, he was only in trouble in the fifth when the Spartans loaded the bases (on a single, walk and error) before he got Martz to hit in a comebacker that wound up as a 1 to 2 to 3 double play.

Garrett Donath was the only Indian, besides Staeger, with two hits, but seven of the nine starters came up with hits.

Matt Schilter, Martz and Tyler Kunick all had two hits for West, which only got one hit from the bottom of its order.

Donath said he had planned to pitch Parrent if the opponent was West, and Jon Roskopf if East had won in the semis. When the doctor said he could still play, Donath said, "I figured he was going on a lot of adrenalin ... he's one of those very competitive kids. He hates losing."

"I landed on it funny. My thumb was up in the air," Parrent said, indicating a bone may have been chipped off the thumb in the process. His catcher (Staeger) helped him out (when there were no runners on base) "by lobbing the ball back so I could catch it in the basket of the glove."

Parrent did wave off some of Staeger's called pitches, however. "I just wanted to come

with the fastball because my cutter wasn't working," Parrent said, and when asked if he will be ready to play Wednesday and Thursday at state, he said, "I hope so."

Kewaskum's (26-4) first opponent will be Hartland Arrowhead (27-9-1) in the final game Wednesday at Bukolt Park. Game time is approximately 7 p.m. If the Indians win that game, they advance to the semifinals at approximately 1 p.m. on Thursday. The championship game is set for 4:30 p.m.

To reach the finals, the Indians buried Campbellsport behind 13 hits and a solid pitching effort by sophomore John Holt, who limited the Cougars to three hits in six innings. Nic Ebert finished up the final inning for the Indians.

Kewaskum scored in every inning but the sixth off Nick Whitty, one of the top pitchers in the area.

Shea contributed a single in the first inning and a towering grand slam in the top of the seventh when 10 KHS hitters went to the plate. Shea's blast cleared the fence in left field, traveling an estimated 355 feet.

Everyone in the Indians' starting lineup except for Parrent had a hit.

Holt gave up a double to Austin Sarauer and an RBI single to Whitty in the first inning, then only gave up one more hit, an infield single to Austin Backhaus in the bottom of the fourth.
