Fire Department receives new 2006 ambulance



Kewaskum Fire Chief Mark Groeschel accepts keys for the department's new ambulance from Bill Rockafellow, vice president of Foster Coach Sales in Sterling, Illinois. Rescue squad captain Sandy Hahn is also shown to the left. The new ambulance is a 2006 MedTec on a Ford E-450 chassis. The new rig replaces a 1993 Ford that was traded in on the new model. Groeschel states that the Emergency Medical Technicians (EMT) were so impressed and enjoy using the 1999 MedTech the department owns, that they ordered a newer model of that exact ambulance. The color scheme also matches the 1999 rig. The new model has a 168" box with 72" of headroom and is 96" wide. The new ambulance cost \$104,306. The only difference between the 1999 and 2006 is that the new model has LED lights, more storage and some other modern upgrades. As in the past, the department will alternate ambulances between runs so both rigs get equal use. MedTec is based in Goshen, Indiana and is a division of Oshkosh Truck and Pierce who manufacture many of the the department's fire trucks. (See related photo on page 3)

Stolen vehicle discovered in Barton crash Tuesday

The Washington County Sheriff's Department may have killed two birds with one stone Tuesday evening, August 8. After being called to the scene of a one-vehicle crash at approximately 10 p.m. they discovered the vehicle in the crash was that of a vehicle reported stolen three days ago.

Authorities are not releasing the name of the 22 year-old West Bend man who was critically injured in the one-vehicle roll-over accident. The mishap occurred on Lighthouse Lane near County Highway D in the Town of Barton.

The Sheriff's Department was notified by a passing motorist of

the crash and a victim lying in the westbound lane of travel on Highway D. The victim appeared to be the only occupant of an SUV that was traveling westbound on Lighthouse Lane.

Deputies believe the driver of the vehicle failed to negotiate a curve in the roadway, traveled off the road into the ditch, down and embankment and overturned numerous times. The driver was ejected and ended up in the westbound lane of traffic on Highway D. He was not wearing a safety belt.

West Bend Rescue responded and treated the injured party, prior to transporting him to St. Joseph's Hospital. He was immediately transferred by Flight For Life he-

licopter to Froedtert Hospital in Milwaukee.

Westbound traffic on Highway D was rerouted around the accident scene for about one hour as rescue and clean-up efforts took place.

Alcohol use is not believed to have been a contributing factor, however, speed is. The crash and the possibility of the vehicle theft remain under investigation by the Sheriff's Department.

The vehicle is believed to be owned by a Jackson resident.

The driver's condition was unknown at press time according to Captain Dale Schmidt of the Sheriff's Department. (See related photo on page 3).

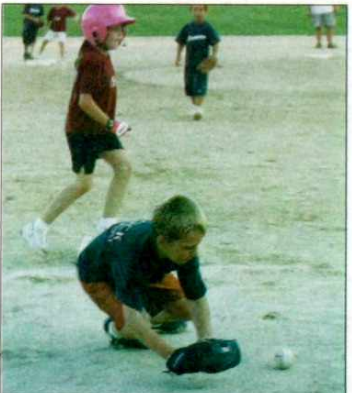

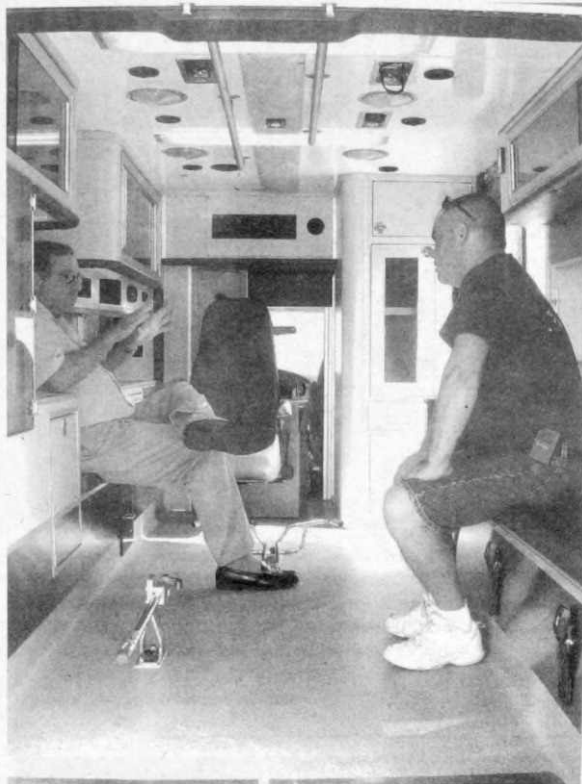

Kohlsville Fire Dept. handles silo fire

TOWN OF WAYNE—Kohlsville fire fighters responded to a possible silo fire on Sunday, August 6 shortly before 11 p.m. Firefighters remained on the scene for around an hour and a half and extinguished a small fire inside the silo.

Washington County Sheriff's deputies arrived at the Jerome R. Herman farm located on Sunset Drive in the town of Wayne after being notified at 10:41 p.m. Upon arrival, firefighters entered the silo and quickly extinguished a small fire inside located near a mechanical silage unloader.

An investigation revealed that an electric cord attached to the mechanical silage unloader shorted out, ultimately causing some silage in the area to catch fire. There were no reports of injury to any firefighters or animals; however, there was approximately \$250 in damage to the mechanical unloader.

POLICE REPORTS

On June 27, 2006, a Kewaskum Police Officer was advised of juveniles spray-painting the north side of St. Lucas church on Parkview Drive. The officer was advised that the three suspects were on bikes southbound in the alley towards First Street.

The officer, with the help of another Kewaskum officer, was able to apprehend the suspects. The group later admitted to spray painting the school in the alley. One of the three also later admitted to spray painting on the backside of the U.S. Post Office building on Main Street, and the backside of Holy Trinity Church, on the door going to a lower level.

Citations were issued to all three for disorderly conduct. They were also referred to juvenile intake on charges of criminal damage to religious property.

A Kewaskum Police Officer responded to a fight in progress in an alley behind St. Lucas

Church on June 27, at 2:02 p.m. Upon arrival the officer came across a vehicle occupied by an adult male and female, and two younger females along with a juvenile male. It appeared that the adults were fighting with the juvenile male.

The juvenile male had been arrested earlier in the day for spray painting three village properties. While driving in Kewaskum the adult male, father of the juvenile, wanted to see the spray painting. They went to St. Lucas Church and found the spray painting being removed by an adult and juvenile.

The juvenile's father wanted to have his son assist in the clean up but the son refused. The father then pulled his son out of the vehicle as he continued to refuse clean up. Finally the father pulled the son into the vehicle with the help of the adult female. In the scuffle the two males allegedly hit each other and their clothes became torn and the juvenile male ended up being struck in the eye as he was pushed back into the ve-

hicle.

The juvenile male told officers that his father hit him in the face and kicked him in the back.

A witness at the scene stated that she did observe the father push the son into the van and at the same time saw the son hit the female in the face. The witness further stated that she did not see the adult male hit his son, but saw him kick him twice.

The father was arrested for physical abuse of a child while his son was referred to juvenile authorities for battery and disorderly conduct. Washington County District Attorney dismissed the adult father's child abuse charge. He now faces a disorderly conduct charge.

On July 2, 2006, a Kewaskum Police Officer received information about someone damaging the complainant's vehicle.

The complainant stated someone dumped sugar into her car's gas tank. She left an apartment building and got to West Bend when her vehicle stopped running. Upon further inspection, she found sugar spilled in the gas tank area and down the gas spout. When she came back to the apartment, she also found sugar on the ground.

The complaint remains active.

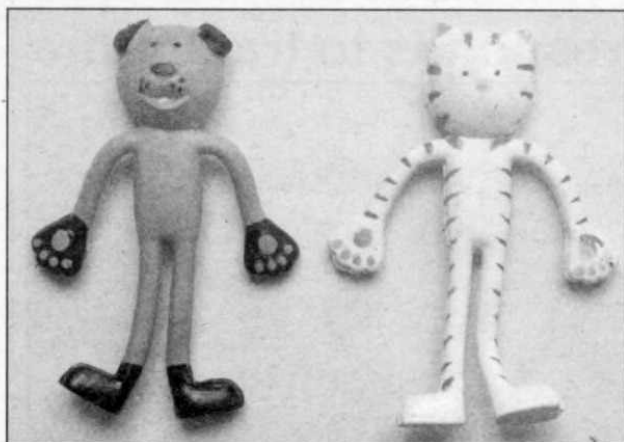

Destroy these toys immediately



Libraries were notified last week that some of the toys given out as summer reading program incentives were coated with a lead-based paint.

The toys in question--small, bendable cats and dogs--should be thrown away immediately or returned to the library for proper disposal. The amount of lead in the toys ranged from 0.24 to 0.4 percent; the maximum safety limit is 0.04 percent. According to the National Institutes of Health, lead is an extremely toxic substance which, if ingested in large enough quantities, can lead to serious health issues. Children in particular

are susceptible to the dangers of lead poisoning because lead can affect developing nerves and brains.

These toys were purchased by a national consortium of public libraries as incentives for the Paws, Claws, Scales and Tales program and were offered for sale by Highsmith, Inc. of Fort Atkinson. The Kewaskum Public Library purchased 24 of these items and offered them for sale in their summer reading prize store.

"Obviously these are not edible items," remarked Steev Baker, director of the library,

"But they are of the right size, shape, and texture that young children might be tempted to suck or chew on them."

The library requests that anyone with any of these toys destroy them immediately. For more information about lead poisoning in children, please contact the Wisconsin Childhood Lead Poisoning Prevention Program at (608) 266-5817.

Iraq Marines thank local parishes Kohl accepting military academy applications

Up North: Imaging Northwoods Culture and Mythology Exhibit at West Bend Art Museum

Ever since the 1920s when tourism really began to take off in Wisconsin's North Woods, the area of the state above Highway 64, has attracted generations of tourists, visitors and artists seeking a respite from their everyday lives, a source of rest and relaxation and an inspirational environment unlike anything they may be used to in their home town.

Even though development continues to change the area, the North Woods environment still offers a sense of serenity, peace, and a reconnection with nature that each artist and regular visitors alike appreciate.

Why are the North Woods such an inspiration for artists? For many artists, it is the different pace of life, the huge, primeval landscape, the almost spiritual feeling of creating a connection with a different time and place that draws them northwards.

John Miller, participating

artist from Madison, articulates this from his point of view of being an avid canoeist, as well as an artist. "I must read the sky, water, winds and every movement as if they were tea leaves in the bottom of a cup forecasting my future. The culture of the North Woods is steeped in a tradition of reading the world for signs and meaning. This tradition calls forth a heightened awareness that can easily awaken the mystical in a person since so much of comfort and fortune depends upon chance and intuition inseparable from skill."

Up North: Imaging North Woods Culture and Mythology features the work of ten Wisconsin artists: Randall Berndt (Madison), Barry Roal Carlsen (Madison), Gary John Gresl (Brown Deer), John S. Miller (Madison), Charles Munch (Lone Rock), David Peacock (Rhineland), Vicki Reed (Cedarburg), Mai Wyn Schantz (Grafton/Houston, TX), Jim Stewart (Hazelhurst)

and Tom Uttech (Saukville).

As evidenced by their place of residence, most live in southern Wisconsin; however, their art testifies to the imaginative and creative spell that the upper part of the state has on them. For the artists located in the North Woods, their inspiration is derived not so much by a spiritual separation from their subject but an immersion in it.

This special exhibit began on August 2 and will run through September 24. The West Bend Art Museum is located in downtown West Bend at 300 South Sixth Avenue. cluster. The folks of the Northern Cross Science Foundation are always eager to share their hobby and help folks who are just getting started in astronomy. The program will be held only if the skies are clear, and is best for adults and youth over the age of 8 years.

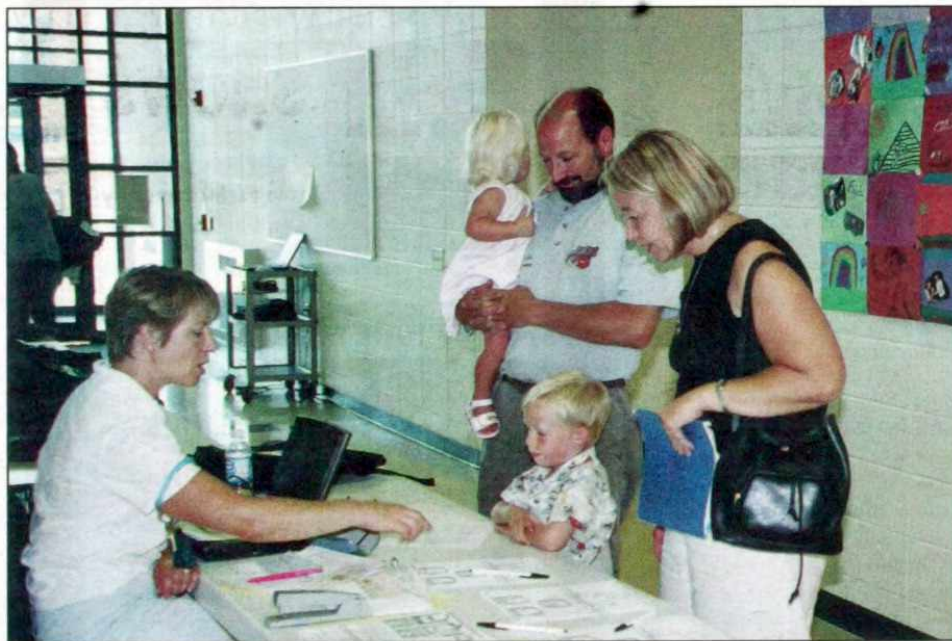

A DIARY OF LOVE, SECRETS AND
GROWING UP IN THE '70S

MISS AMERICAN PIE

MARGARET SARTOR

If you could take a giant Mother-May-I step back to your teenage years and watch yourself, what do you suppose you'd see?

A bit of a mischief-maker, maybe? Or someone who took on too much responsibility too early? Or would you see a confused teen, filled with angst and confusion, trying to make a way in the world?

Or maybe all three.

Author Margaret Sartor found her old diaries in a box in an attic, and in the new book "Miss American Pie," she lets you have a peek into the life of a teen in the mid-to-late-1970s.

On a hot October Louisiana afternoon, as she was going through some old pictures for an article she was writing, Margaret Sartor realized that the photos weren't enough. She searched in the attic of the home she was raised in, and she found just what she needed: six diaries from her teenaged years.

Sartor says the first two - from her ages twelve and thirteen - were typical stuff, but the diaries from her fourteenth through eighteenth years brought back particularly vivid memories.

In the earlier diaries, Sartor wrote about boys, and how they were a mystery to her. She wanted to date but "all the boys ask all the same girls." Later, young Sartor wrote about many boys and the many times she fell in and out of love with them.

She wrote about her cousin and her friends; her best pal and neighbor, Tommy; her brother who was one year younger; and a surprising baby sister who was

born when Sartor was 16. In many entries, Sartor laid bare anguished relationships with her parents and how they never gave her credit for her good deeds, later learning in a letter that her parents were enormously proud of her.


Is this all sounding familiar?

Most late-Boomer-Era girls grew up believing that our diaries were near-sacrosanct, so it's a little unsettling to peek into someone else's. Still, there are funny parts in this book ("October 24: Tried to smoke one of Daddy's El Trelles cigars but after two puffs I was ready to El Puke."), some parts that will sound all too familiar ("June 3: How do I explain to my parents that there is so much I want to do in my life and this is a really awkward time for me to put my life on hold?") and some parts that will break your heart with remembering ("August 27: Trying not to think about the dance but it's the idea of no one wanting me that hurts").

Now it definitely sounds familiar, doesn't it? That's because you probably lived these sentiments if you were a teen girl during the "Me Decade." Author Margaret Sartor's experiences growing up in Montgomery, Louisiana are, I would guess, much the same as those of a girl growing up in Kewaskum, Wisconsin or Turlock, California or Levittown, Pennsylvania.

If you were a late-Boomer and want to revisit some memories, don't miss "Miss American Pie." Drive your Chevy to the le-vee and read it.

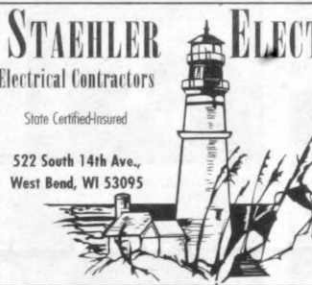

Any qualified elector who is unable or unwilling to appear at the polling place on election day may request to vote an absentee ballot. A qualified elector is any U.S. citizen, who will be 18 years of age or older on election day, who has resided in the ward or municipality where he or she wishes to vote for at least 10 days before the election. The elector must also be registered in order to receive an absentee ballot.

On a motion by Andy Pesch, seconded by Frank Beesten and unanimously carried by voice vote, the Plan Commission approved the minutes as printed for May 23, 2006.

Chairperson Mathew Heiser informed the Commission that Washington County Comprehensive Planning was in the process of reviewing and compiling a summary of the existing land use plans adopted by the local governments of the county and that they would be reviewing Chapter 6 at their next meeting.

The Plan Commission reviewed the revised concept plan submitted by Tom Timblin for Cherokee Lakes Condominiums. He requested that the remaining 71 buildings he had proposed with 4 units be changed to 64 buildings consisting of 2 units each. Besides reducing the density of the complex, he felt this change would make the units very saleable, as some would have basements and all would have three car garages and be approximately 1,600 s.f.

Andy Petersen pointed out that the change would revise the building count from 58 on the existing plan to 52 on the revised plan. The change would also raise the Village's ratio of duplex units to 22% from the existing 20%. There are also water and sewer lateral issues to address and an existing storm sewer may be in conflict with the revised plan. Mr. Timblin proposed a branching of the sewer laterals and was told a clean out needed to be placed at both services. Also the size of the water lateral will be based on the plumbing fixture count per building.

On a motion by Andy Pesch, seconded by Jim Wright and carried by voice vote, the Commission approved the revised concept plan for Cherokee Lakes provided all utility concerns are satisfactorily addressed. It was the consensus of the Commission that this did not need to go before the Village Board for approval.

Representatives of M Squared Engineering presented the concept plan for Mediterra Subdivision on 130 acres located at 9376 Old Fond du Lac Road known as the Diana Stephan Property. The site is currently in the Town of Kewaskum and zoned Agricultural containing wetlands, environmental corridor and floodplain adjacent to the Milwaukee River as well as a 100' bluff and many large trees. Their proposed 132-lot subdivision would contain all RS-1 single-family lots of 14,500 - 15,000 s.f. and is designed to preserve the large trees and pristine nature of the site. They stated that the annexation of the land to the Village of Kewaskum was in progress.

The Commission questioned the situation with Lots 116 through 132 which are proposed for the bluff and were informed the street to the area would have a slope of 15% while the Village Standard was 10%. They were also informed that water booster stations would need to be utilized to service that area and maintain proper

water pressure.

Tom Timblin stated that he would prefer to install a sewage lift station to service the subdivision versus individual grinder pumps and the Village Engineer conceded he was not aware that 88 lots would need to be serviced and in that case, a lift station would be called for.

The Commission discussed the location of the dedicated right of way for a future Milwaukee River bridge crossing and if it was intended to have the developers bear the cost of its installation. Tom Timblin stated that if that were the case, this development would not be financially feasible.

Commissioner Frank Beesten questioned the proximity of the easterly lots to the Milwaukee River meeting the proper setback conditions. The developer's engineer stated that the West Branch of the Milwaukee River is a Class 1 water body, the rest being classified as Class 3.

Referencing the Land Use Plan, it was noted that the approximately 17 lots to the north of the subdivision are classified as park in the study. Tom Timblin stated that in the early development of this project, he was told the Village didn't want that land for a park.

Commissioner Andy Pesch voiced his concerns regarding the length of the cul-de-sac road exceeding the recommended 500 foot Village Standard and the long dead end road posing problems in a fire and rescue situation. The developer felt that until land to the north or east of the proposed Mediterra were improved there was no immediate solution to this problem but to propose a cul-de-sac at the dead end.

Jerry Gilles asked who would have ownership of the land designated C-2 and Tom Timblin stated that would be public land. The consensus of the Commission was not favorable to this and suggested that when the subdivision is platted, each lot share a portion of the ownership, eliminating the need for any Village maintenance.

On a motion by Jim Wright, seconded by Andy Pesch and unanimously carried by voice vote, the Commission tabled action on a recommendation for Mediterra Subdivi-

sion until the developer could bring back a revised plan for the street slope of the bluff area closer to the Village Standard of 10% and cost estimates and sizing of the water booster pumps and size of the lift station in question, as well as the definite location of the dedicated right of way for the bridge crossing.

Chairperson Mathew Heiser entertained the motion for adjournment. On a motion made by Andy Pesch, seconded by Jim Wright for adjournment. By a roll call vote of 5 "Aye" 0 "Nay" 1 "Absent" the motion passed and the meeting was adjourned.

Strobel was not able to be at that game, but Doyle reported "In the first inning, we scored eight. That was pretty much it!"

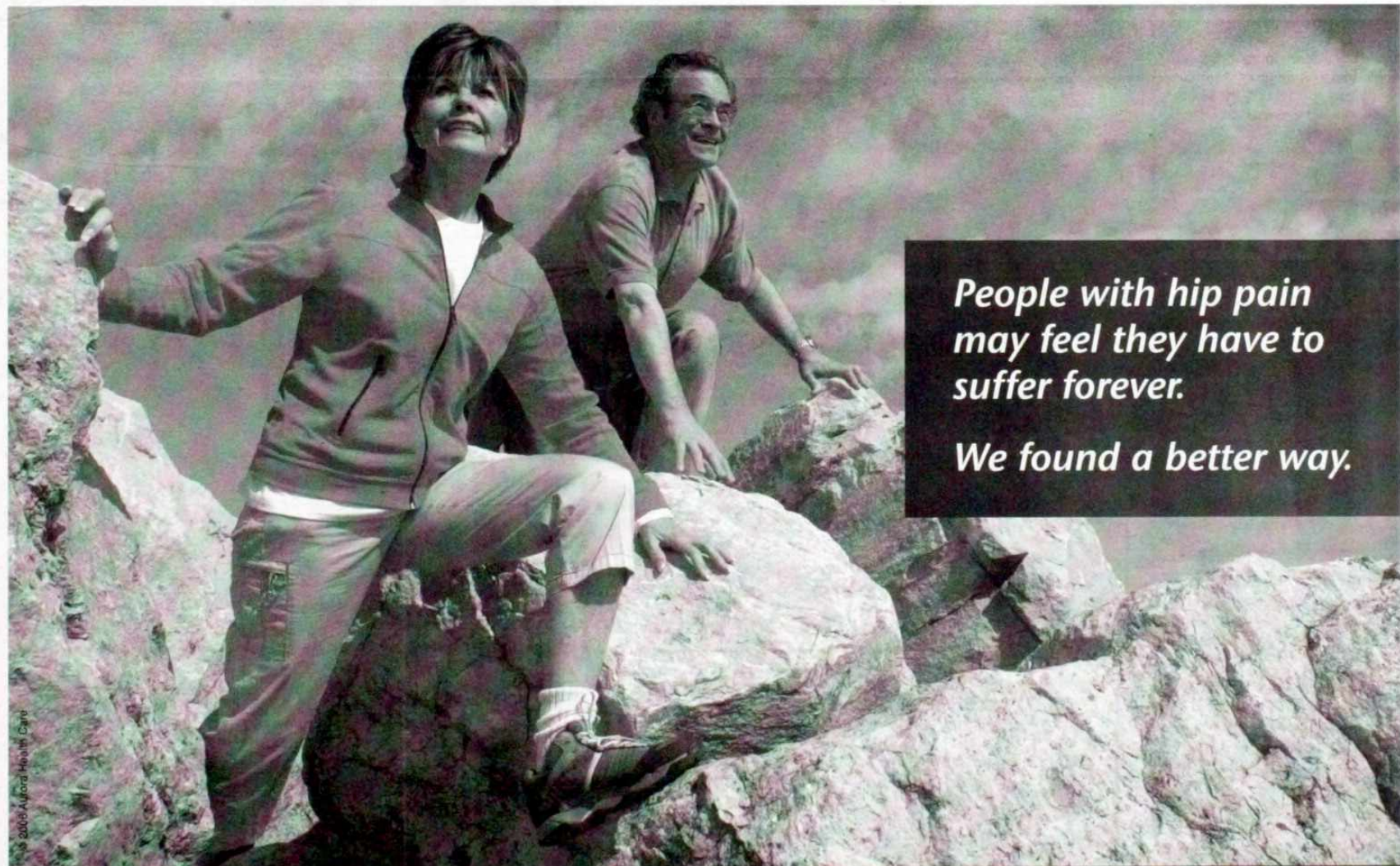
The big blast in the opening inning was Corey Immel's 3-run home run, his first of the season.

That pretty well describes the games the Kewaskum Athletics home talent baseball team was involved in last weekend.

On Friday night in a Tri-County Nite League game, the A's defeated host Johnson Creek 6-3 behind the 16-strikeout effort of Jim Ziegler.

"He had a good day," player/manager Jason Strobel said about his No. 1 pitcher, who has suffered some tough defeats this season. Ziegler scattered seven hits and walked just one of the hosts, who took a 1-0 lead in the first inning after scoring an unearned run on an overthrow.

"We tied it up in the second," Ziegler said about the game, reporting his infield single put the A's first run on

the board.

Kewaskum surged into the lead in the third when they scored two runs, including one on Adam Sarauer's sacrifice fly.

In the eighth, Jon Olla, who has moved up from the Kewaskum High School team, tripped in a run, then "Jason suicided him home," Ziegler said.

Ziegler got in a jam in the ninth when Johnson Creek loaded the bases, but he got out of it in a hurry with three straight strikeouts.

And what was working for Ziegler as he recorded a personal high 16 K's? The fastball. "That's all it was. I think 15 of the 16 struck out on fastballs," Ziegler said.

Kewaskum had 10 hits in the win, including three by Ziegler, two by Jake Panzer and two by Jake Junk, another player who completed his high school career at the WIAA Summer Baseball Tournament earlier in the week.

The win gave the A's a 7-2 mark in the Tri-County.

The heartbreaker came on Saturday when the A's lost a 1-0 decision in 11 innings to host Clyman.

Panzer started and pitched five innings for the A's, and Adam Sarauer went the next five. Corey Immel came in to pitch part of the 11th inning, but it was Sarauer who got the loss because he allowed the winning run to reach base.

Clyman filled the bases, then Tim Landram singled between third and short for the only run of the game, according to Strobel, who said, "We had 10 hits, but we did not come through with the big hit."

Jake Spaeth went 4x5, while Panzer was 2x4 with a pair of doubles.

The loss gave the A's a final mark of 7-3 (tied for second place with four teams) in the Tri-County League, meaning they will compete in the playoffs but Strobel has not been informed just when that will be.

Had the A's won, "We could have won the title or tied for it," he said.

On Sunday at Rubicon, the roof caved in on the A's who lost 1-0 to drop their Rock River League record to 5-8 with five games left.

"We didn't have many hits," Strobel said, reporting Dan Shea, who was recently selected to the all-state team, singled; Austin Sarauer singled; and Adam Sarauer hit a solo homer in the seventh to breakup the shutout bid.

Fresh off a great career for Campbellsport High, Nick Whitty started for the A's and pitched pretty well until the sixth when he gave up nine runs. "He pitched well, but one inning they had a lot of hits," Strobel said, referring to the sixth.

Geidel is making his mark in state golf circles

Soon-to-be Kewaskum High sophomore Ethan Geidel is certainly partial to the color green.

The reason is simple — Geidel spends a great deal of his time at Hon-E-Kor Country Club and other golf courses in the state, and his goal is to stay in the green fairways and to reach the putting greens just as quickly as he can.

Geidel, who is 15, certainly was successful at moving the ball around the Drugan's Castle Mound at Holmen last Monday, Tuesday and Wednesday.

Playing in the Wisconsin State Junior Boys Tournament, Geidel, who won all-Eastern Wisconsin Conference honors this past spring, posted a 54-hole score of 230, giving him a spot in the top 30.

"I was tied for 29th overall," Geidel said Saturday, explaining he toured the par 72 course in 79 the first day, then bettered his score the next day with a 76 and chipped another stroke off in the third round with his 75.

"It was playing between 6,500 and 6,700 (yards)," Geidel said about Castle

Mound, and he was quick to add his chipping and putting helped him score well.

"My short game was very good," Geidel said. "I didn't have a lot of birdies ... I just got up and down a lot for par."

Considering this was his first time in the event, Geidel, who was tied for 12th among the 15 and 16-year-olds in the competition, said, "I was actually pretty satisfied."

There were 190 golfers who started in the event, including two others from the area. Jason Jahnke, a recent KHS graduate, did not make it to the third round, while West Bend West's Jeff Anderson, who plays out of Hon-E-Kor and is one of Geidel's best friends, finished about 70th overall.

Geidel said Jahnke, who was one of his high school teammates, got off to a shaky start with his 83 and fired an 81 the second day. "He didn't make the cut," Geidel said.

After three days of golfing in scorching 90-degree conditions, Geidel took Thursday off from competition and then headed to Rolling Meadows in Fond du Lac Friday for a PGA Junior Tour event.

This time he finished as the runner-up in his age group

with an even par 72, prompting him to admit this was definitely his best competitive week of the summer, which has already included a dozen tournaments.

"I'm starting to play better now. I didn't start out too well," Geidel said, explaining his season will slow down a bit at this point with tournaments remaining at Portage Country Club and Rock River Hills in Horicon.

Geidel hopes to do well in these events in an effort to finish high in the Player of the Year standings for junior boys.

Right now he has 106 points when, "Last year, I only got 20," he said.

Geidel figures he plays about 90 practice holes per week but rarely hits balls except to warm up before a tournament.

As far as goals for next year, he said, "I hope to make it to state. Hopefully our team will make it to state," he said, adding he also has his sights on a top-10 finish in the Player of the Year standings.

To get to the tournaments, Geidel has three pretty fine chaperones, including his grandma and grandpa, Judy and Bill Geidel. "They probably take me the most ... and my mom," Geidel said. "My dad (Mike Geidel) has to work."

"I started playing golf when I was eight," he said, indicating his first rounds at Hon-E-Kor came when he was 10 and was coaxed into the game by his dad and grandpa. "They are really the only teachers I've ever had."

Eichstedt reaches goal, will be in '06 Wisconsin Open

Along with practicing, Clark Eichstedt did a little bit of homework before his qualifying at the Fire Ridge Golf Course on August 1st.

Noting that it took a score of 76 to qualify for the Bank One Championships professional golf tournament on the same course a couple weeks ago, Eichstedt set his sights on that score.

Mission accomplished: Eichstedt fired an even par 37-35—72 to finish second among the 49 hopefuls and secured a spot in the annual Wisconsin Open Golf Tournament.

"That was one of the goals of my golf summer ... to qualify and see how I stand up against the other golfers in the state," Eichstedt said.

Tim O'Brien of Mequon captured the medal in the qualifying tournament with an impressive 33-34—67.

Eichstedt wasn't sure what length the course was set at for the event, saying, "On some of the par fives, the tees weren't all the way back, but on one of the par fours, it was way back."

The veteran Kewaskum golfer, once a four-sport standout at Kewaskum High School, said the pin placements weren't overly challenging but battling the sweltering heat was.

"By the end, we were

shot," he said about the heat, but the results quickly erased thoughts about having the sun beat down on him for over four hours.

"I wanted to stay away from mistakes and stay under 76," Eichstedt said. The 72 meant he has several strokes to spare. "That was it, and I'm in."

The Wisconsin Open, which includes professional and amateur golfers, will be held Aug. 21-22-23 at the Bog near Saukville.

When asked how many Opens he has qualified for, Eichstedt said, "This will be the third." He made the cut in the tournament at Kohler (the Meadows) but didn't make the final round when he played at Westmoor CC two years ago.

The field will start with 144 players and will be trimmed to 60 and tied after the second day.

Eichstedt works as a jailer at the Washington County Jail.
