Foreign exchange student treated and released from local hospital

Farmington reviewing request to allow for sludge storage on farm in Fillmore

TOWN of FARMINGTON- Residents will have a chance to speak their minds regarding a change in the town's commercial zoning land uses. A proposal by Arnold's Environmental to store septic waste on the James Degnitz farm is the reason for the change.

At an informational meeting held for town residents on January 16, Pat Oreskovic of Arnold's announced the company wished to use a sludge storage facility situated on the James Degnitz farm located on Fillmore Road.

Degnitz previously used the storage tank for animal waste associated with his dairy farm, but he no longer needs the tank. He announced the 435,000-gallon storage facility that was built in 1976.

Oreskovic explained that his company would be spreading the stored

waste on Degnitz's fields and also in other communities when weather permits. In the past, Diamond F Corporation spread municipal sludge on the fields. He further explained the waste matter will be injected into the field, so it's not laying on the topsoil. Arnold's will also be required to aerate the tank to address any odor problem that may arise.

Ken Nienow from the DNR explained the approval process. He advised that in order for the DNR to approve the tank, Arnold's would be required to meet three different codes.

Arnold's must first hire an engineer who will provide evidence to the DNR that the tank would not leak. A site investigation then must be conducted to reveal distance from homes, wells and groundwater. Another investigation looks at how the waste material is placed in the tank, what it is mixed with and how it's removed.

County Board Supervisor Brian Bausch, asked who would monitor the septic hauler from mixing holding tank and septic waste. He also inquired about industry septic waste containing metals. Nienow stated the hauler must keep a log of the hauled waste. "We do everything we can to make sure it's done right," he added. Oreskovic asserted that Washington County is one of four counties that requires holding tank waste to be disposed of at a treatment plant.

The Degnitz Farm is zoned commercial, however, town officials would like to regulate the use of the storage tank through a conditional use permit. Currently, the township's zoning code does not state that.

Town officials reviewed an opinion from their attorney Phil Eckert at their meeting on Tuesday, February 6 regarding the matter. Eckert advised

Spring primary election here Tuesday

Next Tuesday, voters will judge which two of the three candidates will face off in the spring election for a seat on the state's top court. Washington County Circuit Court Judge Annette Ziegler is one of those three.

The three candidates have jumped in the race that will replace retiring justice Jon Wilcox who has served since being appointed in 1992 by then-governor Tommy Thompson. He successfully attained a 10-year term in 1997.

Joining Ziegler for the non-partisan seat on the high court is Madison civil attorney Linda Clifford and Oregon defense attorney Joseph Sommers. The two highest vote getters on February 20, will be placed on the ballot for Tuesday, April 3.

Linda Clifford

Clifford's website (www.lindacliffordforjustice.org) says she grew up in North Chicago, Illinois. She moved to Wisconsin in 1966, and attended Beloit College. She graduated from Beloit in 1970 Phi Beta Kappa cum laude with a major in International Relations. She went on to the University of Wisconsin Law School, where she was a member of the Board of Editors of the Wisconsin Law Review. She graduated in 1974.

After graduation Clifford worked as Assistant Attorney General at the Department of Justice.

KHS foreign exchange student injured in Tuesday crash

TOWN OF FARMINGTON-

Two Kewaskum High School students were injured Tuesday, February 13 after a single-vehicle accident. One of the students, a foreign exchange student was treated and released from St. Joseph's Hospital.

The crash happened shortly after 4 p.m.. The Washington County Sheriff's Department was called to the scene and later joined by Boltonville First Responders and Fire Department and Kewaskum Fire Department and EMS. West Bend Rescue Intercept also responded to the scene and assisted Kewaskum Rescue Squad.

The teens are believed to have been heading home from Kewaskum High School when the 17-year-old driver

lost control of his Dodge Dakota truck traveling southbound on Highway XX, a half mile south of Jay Road. After losing control, the truck went into the east ditch-line, impacting a WE Energies utility pole, on the passenger side of the truck. The impact cracked the top of the pole.

Both teens required extrication with the Jaws of Life and were transported to St. Joseph's Hospital in West Bend.

The 17-year-old passenger, is a foreign exchange student from Columbia.

WE Energies responded to the scene to repair the cracked utility pole.

Spicy California Raisin-Wine Sauced New York Strip With Warm Green Bean-USA-Grown Peanut Salad

Serves: 6

New York Strip

- 2 tablespoons chopped garlic
- 2 tablespoons cumin
- 2 tablespoons ground coriander
- 1 1/2 tablespoons salt
- 1/4 cup olive oil
- 6 New York strip steaks (about 12 ounces each)

Spicy Raisin-Wine Sauce

- 1/2 cup red wine
- 1/4 cup California raisins
- 1 tablespoon honey
- 2 tablespoons Dijon mustard
- 1 teaspoon chopped fresh oregano
- 1/2 teaspoon chopped cilantro
- 1 teaspoon chipotle peppers canned in adobo sauce
- 1/2 teaspoon chopped shallot
- Salt and pepper to taste

Warm Green Bean Salad

- 2 tablespoons olive oil
- 1 1/2 pounds fresh green beans, trimmed and blanched
- 2 tablespoons chopped shallot
- 1/2 cup roasted red peppers, cut into matchstick-size pieces (julienne)
- 1 cup roasted USA-grown peanuts
- 2 tablespoons chopped fresh parsley
- 1/4 cup balsamic vinegar
- Salt and pepper to taste

Combine garlic, cumin, coriander, salt and olive oil in small bowl and mix together. Rub onto steaks and arrange in shallow dish; refrigerate 1 to 2 hours.

In small saucepan, heat wine just to boiling for sauce. Measure raisins into small bowl and pour wine over; let stand 10 to 15 minutes until raisins are soft. Add remaining ingredients and puree in food processor or blender; set aside.

For salad, heat oil in large skillet and sauté shallot over medium-high heat 2 to 3 minutes. Add remaining ingredients; cook until heated through and beans are tender-crisp.

To serve, remove steak from refrigerator; drain and grill over high heat for 4 minutes per side until preferred doneness (145°F for medium rare). Remove from grill and drizzle with raisin wine sauce. Serve with green bean-peanut salad.

Grilled Veal Chop With California Raisin Pilaf and Toasted USA-Grown Peanuts

Serves: 6

Veal

- 6 veal chops (about 10 ounces each)
- 1 12-ounce bottle garlic-olive oil marinade
- Salt and pepper, to taste

Rice Pilaf

- 1 5.9-ounce package rice pilaf mix
- 1/2 cup California raisins
- 1 cup USA-grown peanuts, toasted
- 1/4 cup chopped parsley

Combine chops and marinade in shallow pan; let stand 1 to 2 hours in refrigerator, turning occasionally.

Cook pilaf according to package directions. Add remaining ingredients to hot pilaf and mix together. Keep hot.

Remove chops from marinade. Discard used marinade and grill chops over high heat 5 to 6 minutes per side until done (145°F for medium rare). Spoon 1/4 cup pilaf onto each serving plate; arrange grilled veal chop on top. Serve immediately.

Grilled Filet Mignon With California Raisin-Onion Jam and USA-Grown Peanut Garden Sauté

Raisin-Onion Jam

- 1/2 tablespoon olive oil
- 1/4 medium yellow onion, thinly sliced (julienne)
- 1 tablespoon balsamic vinegar
- 1/2 tablespoon honey

- 1 small sprig fresh thyme
- 1/2 teaspoon fresh lemon zest
- Salt and pepper to taste

- 1/2 tablespoon chopped chives

- 6 cups fresh chopped Swiss chard leaves or beet greens, stems and ribs removed

- 6 filet mignon (about 6 ounces each)
- Olive oil
- Salt and pepper, to taste

For jam, heat oil in 12-inch skillet over medium heat. Add onions and cook until soft. Stir in vinegar and honey; cook 1 minute. Add raisins, thyme and lemon zest; cook over medium heat until reduced. Remove thyme sprig and divide mixture in half. Add half to food processor or blender and pulse until smooth. Combine with remaining mixture in skillet and mix well. Season to taste and set aside.

In a small bowl, combine ingredients for blue cheese glaze; mix well and set aside.

Cook bacon in large saucepan over medium-high heat for 6 to 7 minutes, until almost crispy. Add garlic and shallot; cook 2 to 3 minutes more until soft. Stir in Swiss chard; cook and toss until wilted, 3 to 4 minutes. Stir in peanuts and season to taste.

To serve, brush steaks with oil and season with salt and pepper. Spoon 1 to 2 tablespoons of glaze onto each steak. Grill steaks over high heat for 4 to 5 minutes per side until they reach preferred doneness (145°F for medium rare) and glaze is golden brown. Remove from grill and add a heaping dollop of jam. Serve with garden sauté.

that the use, if granted, should be through a conditional use permit.

A public hearing will be held on Tuesday, February 27 at 6:30 p.m. to update the zoning to allow this type of use with a conditional use permit in the commercial zone. The plan commission will make their recommendation to the town board at their meeting scheduled to begin 30 minutes later.

If the town board grants the conditional use permit, Arnold's will take their second step and work on getting the tank approved by the Department of Natural Resources (DNR) for human waste. Once

approved, Oreskovic receives a five-year permit. After that expires, the tank receives another inspection.


According to Nienow, the townships of Kewaskum, Richfield and Scott all have similar situations. He advised he has 12,000 waste storage sites in his region. The DNR performs spot checks once every year or two, unless complaints are received.

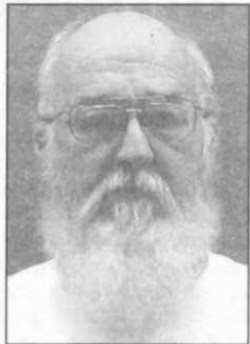

Former Farmington resident found guilty of failure to support children

WEST BEND- A Washington County jury convicted one of the state's worst offenders of failing to pay child support. The former town of Farmington resident owes his ex-wife over \$260,000 in child support for his two children from the last 10 years.

The jury announced their decision on Wednesday evening, February 7. John Brayshaw, 58, was found guilty of 18 counts of failure to support a child. He will be sentenced on April 19. He faces more

than 60 years in prison.

Instead of paying child support Brayshaw is believed to have borrowed money, purchased a sailboat and headed

south, eventually floating down the Mississippi River and ending up in Key West Florida. In Florida he took up residency on the boat for about six years.

While living on the boat his former wife, Diane Brayshaw, was forced to sell their home to pay off the boat loan. Because of Wisconsin's marital property law, Diane Brayshaw was responsible for the loan on the boat.

Diane Brayshaw divorced John Brayshaw in April of 1997. He was ordered to pay \$1,293.75 per month to support their two children starting March 1, 1997.

Child Passenger Safety Week Feb. 11-17

According to the National Highway Traffic Safety Administration (NHTSA), approximately 7,500 lives have been saved by the proper use of child restraints during the past 20 years. Yet, motor vehicle crashes still remain the number one killer of children ages four to 14 in America. Child Passenger Safety Week is February 11-17.

While 98 percent of America's infants and 93 percent of children ages one to three are regularly restrained, not enough children ages four through seven are restrained properly for their size and age.

Children ages four to eight who are placed in booster seats are 59 percent less likely to be injured in a car crash than children who are restrained only by a seat belt, according to a study by Children's Hospital of Philadelphia (CHOP).

For maximum child passenger safety, parents and caregivers simply need to remember and follow the four Steps for Kids:

1) For the best possible protection keep infants in the back seat, in rear-facing child safety seats, as long as possible up to the height or weight limit of the particular seat. At a minimum, keep infants rear-facing until a minimum of age 1 and at least 20 pounds;

2) When children outgrow their rear-facing seats (at a minimum age 1 and at least 20 pounds) they should ride in forward-facing child safety seats, in the back seat, until they reach the upper weight or height limit of the particular seat (usually around age four and 40 pounds);

3) Once children outgrow their forward-facing seat (usu-

ally around age four and 40 pounds), they should ride in booster seats, in the back seat, until the vehicle seat belts fit properly. Seat belts fit properly when the lap belt lays across the upper thighs and the shoulder belt fits across the chest (usually at age eight or when they are 4'9" tall);

4) When children outgrow their booster seats, (usually at age eight or when they are 4'9" tall) they can use the adult seat belt in the back seat, if it fits properly (lap belt lays across the upper thighs and the shoulder belt across the chest).

TAX INFORMATION

Taxpayers have until April 17 to file and pay

WASHINGTON — Taxpayers across the nation will have until Tuesday, April 17, 2007, to file their 2006 returns and pay any taxes due, the Internal Revenue Service announced today.

Taxpayers will have extra time to file and pay because April 15 falls on a Sunday in 2007, and the following day, Monday, April 16, is Emancipation Day, a legal holiday in the District of Columbia.

"This year, taxpayers have additional time to file and pay beyond the traditional April 15 deadline," said IRS Commissioner Mark W. Everson. "As we always do, we encourage taxpayers to get an early start on their taxes to make sure they have plenty of time to accurately prepare their return."

This means the entire country has an April 17 deadline. Previously, the April 17 deadline applied just to individuals in the District of Columbia and six eastern states who are served by an IRS processing facility in Massachusetts, where Patriots Day will be observed on April 16.

The April 17, 2007 deadline will apply to any of the following:

- 2006 federal individual income tax returns, whether filed electronically or on paper.
- 2006 state individual income tax returns, whether filed electronically or by paper (Forms 1, 1A, WI-Z, 1NPR).

- Requests for an automatic six-month tax-filing extension, whether submitted electronically or on Form 4868.

- Tax year 2006 balance due payments, whether made electronically (direct debit or credit card) or by check.

- Tax-year 2006 contributions to a Roth or traditional IRA.

- Individual estimated tax payments for the first quarter of 2007, whether made electronically or by check.

- Individual refund claims for tax year 2003, where the regular three-year statute of limitations is expiring.

Other tax-filing and payment requirements affected by this change are described in IRS Publication 509, Tax Calendars for 2007, available at the IRS web site at <http://www.irs.gov/pub/irs-pdf/p509.pdf>.

Most taxpayers will not have to change their plans in response to this announcement. Three out of four individual filers get refunds. Typically, returns claiming refunds are filed early in the tax season.

By law, filing and payment deadlines that fall on a Saturday, Sunday or legal holiday are timely satisfied if met on the next business day. Under a federal statute enacted decades ago, holidays observed in the District of Columbia have impact nationwide on tax issues,

not just in D.C. Under recently-enacted city legislation, April 16 is a holiday in the District of Columbia. Officials recently became aware of the intersection of the national filing day and the local observance of the new Emancipation Day holiday after most forms and publications for the current tax filing season went to print.

Even with the extra time, taxpayers can skip the last-minute rush and avoid needless mistakes by filing early, taking advantage of the speed and convenience of electronic filing, choosing direct deposit for any refunds and paying any taxes due by direct debit or credit card. IRS.gov has further details on electronic filing and payment options and links to companies providing these services.

Free volunteer tax assistance available

Taxpayers who qualify can combine the advantages of e-file with free face-to-face tax help from the IRS Volunteer Income Tax Assistance (VITA) Program and the Tax Counseling for the Elderly (TCE) Program.

Trained community volunteers can help with special credits, such as Earned Income Tax Credit (EITC), Child Tax Credit, and Credit for the Elderly for which taxpayers may qualify. In addition to free tax return preparation assistance, most sites also offer free electronic filing (e-filing).

"By offering free tax preparation services, MABC partners are seeking to get all of the tax refunds and credits that working families have earned back into their pockets so they can begin to build financial assets and an independent life-style," says Deborah Blanks, head of the Milwaukee Asset Building Coalition (MABC). The MABC is a group of community organizations that partner with the IRS to offer the VITA/TCE program. Other VITA/TCE partners include AARP, faith-based organizations, the Veterans Ad-

ministration and the Wisconsin Department of Revenue.

"These community partnerships are vital in helping the IRS bring free tax preparation to many taxpayers throughout the state. Last year, VITA/TCE sites helped more than 43,000 taxpayers across Wisconsin," according to Julie Nunlist, IRS manager of the division that coordinates the VITA/TCE program.

The VITA Program offers free tax help to low- to moderate-income (generally, \$39,000 and below) people who cannot prepare their own tax returns. Certified volunteers sponsored by various organizations receive training to help prepare basic tax returns in communities across the country.

The Tax Counseling for the Elderly (TCE) Program provides free tax help to people age 60 and older, generally without regard to income.

Across Wisconsin, there are more than 300 VITA/TCE sites. There are more than 24 VITA sites in the Metro Milwaukee area alone.

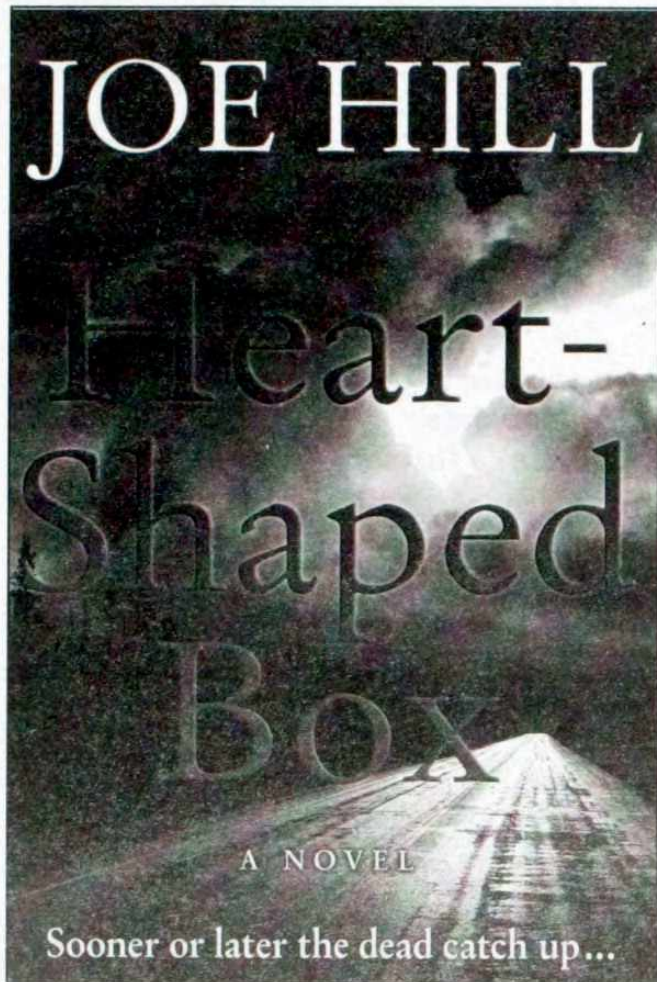

Heart-Shaped Box

Every collector knows what must be done when one acquires a prized item for the collection.

You display it.

Maybe the new Crown Jewel goes in a glass case with a special light box, or perhaps it just goes on a shelf somewhere for everyone to admire.

So what do you collect?

Judas Coyne collects macabre things: death masks, real skulls, a witch's confession, a noose that a man died wearing. Jude's latest acquisition, though, is quite interesting. In the new novel "Heart-Shaped Box" by Joe Hill, it might also be the most deadly thing Jude owns.

Just one thousand dollars, the online ad read. Buy it now and don't be outbid. A thousand bucks and you could own a ghost. How could a man like Judas - a man who lives his life catering to Goths, vampire wanna-be's, and heavy-metal music fans - pass on a chance like that?

With the click of a mouse, Jude had himself a ghost.

Or he had a suit, anyhow. When the black heart-shaped box arrived, it held a moldering Johnny-Cash-type suit that, coincidentally, looked as if it might have been made to fit Jude. The thing smelled terrible.

And on the first night with the new suit, the ghost of an old man appeared on the landing outside Jude's bedroom.

It wasn't a cute and cuddly cartoon-Casper kind of

ghost. This one had black scribbles for eyes and he carried a shiny razor blade on a chain. He was tall and gaunt and made it very, very clear that he and Jude needed to go down a long highway together one nightfall. Jude would die. Georgia, Jude's latest Goth girlfriend, would die. Jude's dogs would die. Anyone who

gave aid to Jude would die.

How does one get rid of a very unwanted ghost? When Jude calls the woman in Florida who sold him the spectre, he learns that his ownership was planned. Now Jude and Georgia must leave Louisiana to find the woman because Jude has a dead man on his tail and the past is coming back to haunt him.

Wow.

Do you know who Joe Hill is? Probably not, and I'm not going to reveal his secret. I can tell you that he's the son of a famous gazillion-selling writer father and a famous-writer mother. And he's better than both of them.

I took "Heart-Shaped Box" to bed with me the first night I got it and I had to force myself to stop reading and turn the light off.

That was a mistake because I was too creeped to sleep.

This novel sinks its claws into you on the first page and makes your skin crawl through to the deliciously malevolent end. Author Joe Hill's use of phrases is first-class, he gives his characters good senses of the absurd, and his plot is I-can-barely-stand-to-imagine-it-believable.

Pick up a copy of "Heart-Shaped Box" and be ready for some heart-stopping horror. This is the first novel from this soon-to-be-as-famous-as-his-parents author and the first don't-miss book of the year.

How do I qualify for an IRA?

An IRA is a vehicle for accumulating money for retirement.

If you are not covered by an employer-sponsored pension plan at work, the amount of your IRA contribution can be deducted from your taxable income. The IRA contribution limit is \$4,000 for 2006 and 2007. A special catch-up contribution is available if you will be age 50 or greater during 2006 tax year. The catch-up contribution is \$1,000 for the 2006 tax year.

If you are a nonworking spouse, you may be eligible to contribute to an IRA and deduct the contribution from your taxable income. The spousal contribution limit is \$4,000 for 2006 and 2007. A catch-up contribution is available if you will be age 50 or greater during 2006 tax year. A catch-up contribution is \$1,000 for the 2006 tax year.

Even if you participate in an employer-sponsored pension plan, you may still make contributions to an IRA. The amount you can deduct from your taxable income depends on your adjusted gross income.

The IRA deduction phase-out for married couples filing a joint return ranges from \$75,000 to \$85,000 AGI for the 2006 tax year. For the 2007 tax year, the AGI ranges from \$80,000 to \$100,000.

For singles the IRA phase-out ranges from \$50,000 to \$60,000 AGI for the 2006 and 2007 tax years.

Remember, the interest earned on money placed in an IRA grows tax-deferred under current tax laws. You do not pay taxes on the funds until

you withdraw them, usually at retirement when you are in a lower tax bracket. However, because an IRA is intended for retirement, you may incur tax penalties if you withdraw the money before age 59 1/2, except in special circumstances.

You can withdraw funds from your IRA and not incur a federal penalty if you are a first-time home buyer (\$10,000 limit) or you are using the money to pay for a college education. Any withdrawals will be subject to income taxes. It's important to check with your tax advisor first before withdrawing funds from your IRA.

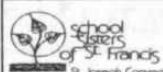

Notice is hereby given of a spring primary election to be held in Washington County on the 20th day of February 2007, at which the officers named below shall be nominated. The names of the candidates for each office, whose nominations have been certified to or filed in this office, are given under the title of the office, each in its proper column, in the sample ballot below.

INFORMATION TO ELECTORS

Upon entering the polling place, an elector shall give his or her name and address before being permitted to vote. Where ballots are distributed to electors, the initials of two inspectors must appear on the ballot. Upon being permitted to vote, the elector shall retire alone to a voting booth and cast his or her ballot except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

At the spring primary election where marksense voting is used, the elector shall fill in the oval next to the name of the candidate of his or her choice for each office for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the person of his or her choice in the space provided and fill in the oval on the write-in line.

The vote should not be cast in any other manner. If the elector spoils a marksense ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initiated by two inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth. Sample ballots or other materials to assist the elector in casting his or her vote may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official marksense ballot is marked, it shall be inserted in the security sleeve so the marks do not show. After casting his or her vote, the elector shall leave the booth, insert the ballot in the voting device and discard the sleeve, or deliver the ballot to an inspector for deposit. The elector shall leave the polling place promptly.

At the spring primary election, where touch screen voting systems are used, the elector shall depress the button next to the name of the candidate for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall type in the name of the person of his or her choice in the space provided for a write-in vote.

The vote should not be cast in any other manner. The elector may spoil a touch screen ballot at the voting station, but not more than three ballots shall be issued to any one elector. Not more than five minutes' time shall be allowed inside a touch screen voting booth. Sample ballots or other materials to assist the elector in casting his or her vote may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official touch screen ballot is marked, the elector shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization which represents the elector.

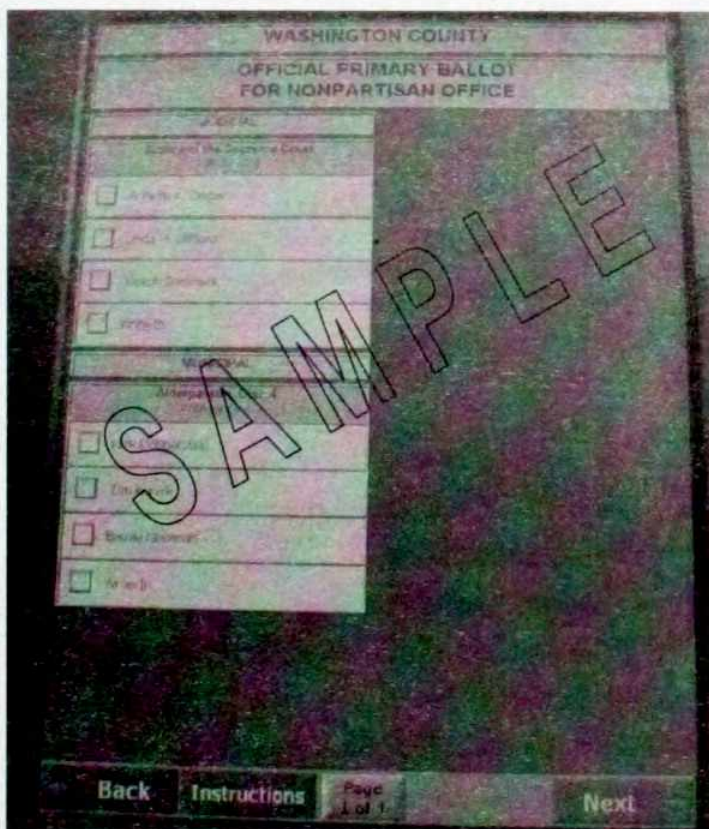

Determined bunch of Indians top Kiel, end losing streak

It was a determined bunch of Kewaskum High basketball players who turned their game into high gear in the fourth quarter Friday night, and the late push helped propel the Indians to a hard-fought 49-41 Eastern Wisconsin Conference victory over host Kiel.

The Indians outscored Kiel 18-12 in the closing eight minutes to seal the win.

The win gave Kewaskum (3-8 in EWC play and 3-12 overall) a sweep over the Raiders this year and even more important helped them break a 6-game losing streak.

Hopefully, it will also serve a momentum build for the Indians, who have a tough week ahead, with a game Monday (Feb. 12) at unbeaten Roncalli, a home game Tuesday against Grafton (Feb. 13), tonight (Thursday) against Sheboygan Falls and another trip north on Friday night when they take on Two Rivers.

"The boys played very well. It was good. We got our first sweep of the season," KHS coach Bobby Bannasch said.

About the strong fourth quarter, Bannasch said, "We talked about basically how we

had to hold the lead (31-29), and we did that."

Kewaskum came up with three good quarters of play Friday night, scoring 12 or more points in the first, third and fourth quarters.

The second quarter wasn't as productive, but while they struggled offensively, they scoring six points, they were sparkling on defense, holding the Raiders to just two.

"We talked about that at the beginning of the season, how we were going to stress defense," Bannasch said. "We did a nice job holding them to two points."

Senior post player Matt Parrent paced the Indian attack with 13 points, which brings his career total to 968, just 32 shy of becoming Kewaskum's first 1,000-point scorer in boys basketball.

"That moved him up," Bannasch said of his top scorer, Parrent.

Help came once again from junior John Holt, who chipped in with 11 points, and two others, Casey Scheel and Dan Shea, were next with eight apiece. For Shea, more or less a defensive specialist, this was his highest output of the season. Shea also came up with six rebounds.

"He played his best game of the year," the coach said about Shea, who made four of six free throws to help the Indians keep Kiel at bay in the fourth quarter. Holt was instrumental with his five points down the stretch.

Jack Breeze, another solid defender, contributed six points to the effort.

Kewaskum took 32 shots on the night, hitting 17 of them for a 53 percent shooting clip. From beyond the arc, the Indians struggled, with Scheel making the lone trey in six Indian tries.

The Indians came up with seven steals, and Parrent led in that category with two, while five others had one.

Kiel was led by Evan Walsh, who popped in 16 points, and Ben Miller, who added eight.

About playing four games in five days this week, Bannasch said, "We're putting some miles on the bus this week," and about facing Roncalli, the No. 2 team in Division 3 in the state, added, "Hopefully we can play to their level."

First youth turkey hunt to be held in state

MADISON -- 2007 marks the first year Wisconsin youth will be able to participate in an annual youth turkey hunt in state. The hunt is designed to give youth hunters, ages 12 through 15 that have successfully completed a hunter education program, an opportunity to hunt turkeys and gain valuable hunting experiences.

The new special youth hunt is for both residents and nonresidents who have a spring turkey hunting license and carcass tag. Youth hunters will be allowed to hunt on Saturday and Sunday April 7 and 8, regardless of what time period their permit is issued for. They may only hunt in the Turkey Management Zone for which their permit was issued, and may only harvest one turkey total, during this two-day youth hunt. If they have more than one tag, it does not matter which tag they use, as long as it is for the zone in which they will be hunting. If the participants do not fill their tags, or have extra tags purchased over-the-counter, they may still use any remaining tags not filled during the special youth hunt during the time period and in the zone for which the tags were issued.

Turkey regulations correction:

Hunters should note that the spring turkey regulations incorrectly state the bag limit during the youth hunt is one turkey per permit. The law that creates this season states only one male or bearded turkey total may be harvested during the two-day youth hunt. Hunters should note this important change when accompanying a youth hunter during April 7 and 8.

A full set of regulations for the youth hunt will be available in the 2007 Spring Turkey Hunting Regulations. More information can be found on the DNR Web site.

The start of the "second season" will dawn next week for the girls basketball teams in the state, followed a week later by the boys.

The Kewaskum High girls team has been assigned to the Division 2 Hartford Regional. The others in the seven-team field include Campbellsport, Grafton, Kettle Moraine Lutheran, Mayville, Plymouth and Port Washington.

Unofficially, five of these teams have winning records, led by Grafton (16-2), which is currently ranked among the top 10 Division 2 schools in Wisconsin. Dwyer, young snowboarder with big future

Cayden Dwyer can hardly wait to get home from school every day but not to watch Sponge Bob or any other cartoons.

As soon as the second grader's classes are finished at Kewaskum Elementary School, young Dwyer wants to head for Sunburst either to work on his snow boarding techniques or compete for the Midwest Best Snow boarding team.

Cayden started snow boarding at age five, and he was hooked. At first, he would just practice behind schools and then a year later, he moved on to Sunburst where he has been helped by three different teachers, Brandon Bennett, Jordan Wheeler, and Matt Doman.

Within two years, he has perfected tricks like the 360 and worked hard on other moves to a point where he has qualified for the USASA Nationals, which will be held in Lake Tahoe in April.

"I'm the youngest one (on the Midwest team)," Dwyer

said last week, explaining 14 different snow boarders of all ages make up a snow boarding team.

In snow boarding, there are slope style events (trick and jumps), boarder cross when three or four snow boarders race on a rugged course and slalom races, regular slalom and giant slalom, where the first one down the course wins.

Normally style points and difficulty of the tricks are combined to determine the final scores of the snow boarders. "There are three or four judges ... they write down your scores. If you do real good, you get first place. I have about 12 (firsts) of them this year," Cayden said.

As far as his best score of the year, Cayden said 39.9 is "the most points I have gotten."

Concerning how many events he has competed in this year, Cayden said "I think like about 20," and they are mainly at Sunburst, Nordic Mountain near Wautoma and at the hill near Lake Geneva. Some of the competitions are on the weekends and others are scheduled

for the evenings.

"I'm sponsored by Mountain Outfitters of West Bend," he said.

What makes Cayden's story so interesting is that he started while sledding down the hill behind the McLane School in West Bend. His mom, Krista, said one day Cayden just stood up on the plastic sled, held onto the rope and went down the hill. The next day the family purchased an inexpensive snow board for him, and last year, his grandparents bought him a good one.

Cayden is so small, the first time he did the slalom, he didn't even trigger off the timing machine, so he had to go again. He didn't mind because he loves the sport so much.

There is an element of danger in snow boarding, but he doesn't worry. "I get hurt on a lot of things, but I get up and keep going," Cayden said. "If I fall on one (move), I just get up and do it again."

With that kind of a positive attitude, Cayden can go the front flip, an 180, "nose grabs," where the boarder grabs the nose of the board and pulls it up in the air until they hit the snow.

Cayden also enjoys skate boarding, biking, basketball, baseball and football, but for now snow boarding tops his list and for that reason, he is a regular at Sunburst.

"I go there about every day, but my mom wouldn't let me go today because of the cold," Cayden said, indicating when he does get a bit cold practicing, he calls home and someone comes the three blocks to get him. "That's why I have a cell phone," he said.

Boys and girls from Phelps, Green Bay, West Bend, Cedarburg, Hartland, Adell, Lomira, Menomonee Falls, Kiel and Whitefish Bay come to Kewaskum to compete with the Midwest Best team. Dana Wilson is the series director for the team, and Brian Wilson is the technical director.

Droese, Miller have big games but it's not enough

The senior-freshman duo of Sam Droese and Elissa Miller put on quite a show for the annual Parents Night celebration Thursday evening, still their Kewaskum High basketball team was ten points short of the victory the Indians desired.

Droese scored a team-high and season-high 14 points, while Miller, who was recently moved up to the varsity team on a permanent basis, added 11 in the Indians' 49-37 loss to visiting Kiel in the Eastern Wisconsin Conference game.

"She had a real nice game last night. It was Parents Night," coach Jeff Gosse said, indicating Droese's points came "on a couple of steals ... penetrations and a couple of free throws."

Droese is the only senior on this year's team, meaning next year the Indians could be stronger, but Gosse warns, "They've got to work hard in the off-season ... It's not going to happen like a miracle."

The coach lauded the effort of the 5-foot-9 Miller, who has brought enthusiasm and a little more scoring punch to the team.

"It was a good game," Gosse said, praising his two leading scorers, along with Megan Rinzel, who added six points.

All the girls who played helped to spark a strong defensive effort, according to Gosse, who said, "Our press bothered them. We gave them a couple different looks."

While defense was a strong point, Gosse said the Indians struggled to score and were below par with their rebounding.

"We just could not score. We missed a lot of open shots," Gosse said, noting, "The girls are just too anxious. They hurry

their shots."

And if Gosse would have been grading the rebounding effort, Kewaskum would have probably received a "D" from the coach. "We did a terrible job of rebounding. That killed us," he said. "We had no weakside help, and four times, we fouled a girl who scored and ended up getting the free throw. So four times, they (Raiders) scored old-fashioned three-pointers."

Genke led the Raiders with 14 points. "She's a sophomore. She's a pretty good post player," Gosse said.

With the loss, Kewaskum fell to 0-12 in the EWC and 0-18 overall.

After this game, only two remain in the Eastern Wisconsin Conference for the Indians. After Monday's (Feb. 12) makeup game against Campbellsport, the Indians finish the regular season when they entertain Two Rivers Friday night.

Gosse said he and six other coaches were to meet Sunday (Feb. 11) night to determine the seeding for the WIAA Division 2 Hartford regional. Gosse figured Grafton would be selected as the No. 1 seed, and "probably it's a tossup between Campbellsport and Kettle Moraine Lutheran for the second spot." Kewaskum will probably play the No. 2 team. First-round regional games will be played Tuesday, Feb. 20, with the winner moving on to the semifinals on Feb. 22.

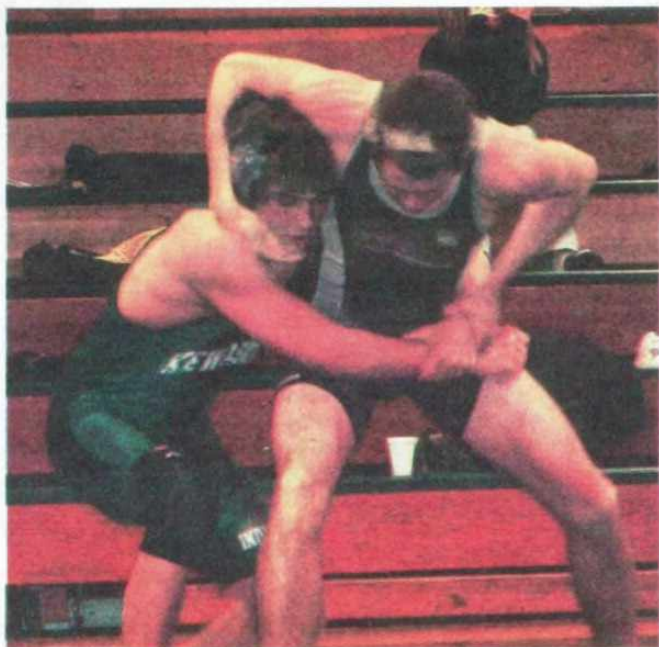

Both teams have nine men advancing to the sectionals, but Pewaukee High's wrestlers claimed seven titles to three for the Kewaskum team, and that was the major factor in determining the team champion Saturday at the Division 2 regional tournament hosted by Kewaskum.

The Pirates piled up plenty of pins and 262.5 points, earning themselves a spot in the Division 2 Team Sectionals.

Kewaskum was 40 points back, at 222.5, in its bid to make the team sectional field. Finish-

ing third with 169.5 points and just three sectional qualifiers was Campbellsport, followed in order by: Milwaukee Lutheran, 169.5; Grafton, 117.5; St. John's/Northwestern Military Academy, 66.0; and Brown Deer, 31.0.

"Pewaukee has a nice team. They're honorable mention in the rankings," KHS coach Dennis Aupperle said. "I thought we hung in there with them."

Taking first for Kewaskum were Stephan "Bud" Kattar at 119, Mason Smith at 140, and Eric Ogi at 145. All three are seniors. Kattar and Smith have never been to state, but Ogi

has placed fourth the past two years.

The second-place finishers from Kewaskum include: Andrew Haugen at 103, Calob Olla at 112, Nathan Seitz at 125, Cody Seibel at 152, Mike Pfothhauer at 160 and Jacob Turowski at 189.

Once again, Ogi, the MVP of the Eastern Wisconsin Conference this year, breezed through the competition at his weight class. After receiving a bye, the talented senior pinned Josh Hass of Milwaukee Lutheran in a brief 1:43, and then in the finals, he took care of Time Zeimet of Pewaukee, pinning him in 5:21.

Ogi pushed his record to an impressive 31-2. Zeimet is also over the 30-win mark, with a record of 33-10.

Ogi now has a run of seven pins and nine of his last 10 tech falls going.

Kattar (21-11) also drew a bye in the first round, then he manhandled Travis Decker of Pewaukee, pinning him in 2:39 to earn a berth in the finals, against Tommy Beck of Campbellsport.

The sophomore Beck battled hard, but Kattar pinning him in 5:40.

"He wasn't in trouble the whole tournament. He wrestled solid," Aupperle said of Kattar, who was wrestling Beck for the fourth or fifth time.

The loss forced Beck to wrestle back for the No. 2 spot at 119. Decker was the better wrestler this time, gaining the pin in 5:23.

Smith (24-10) continues his solid year with two good victories. As the No. 2 seed, he faced Pewaukee's Jon Singer in the semifinals and dominated the Pirate opponent, 11-2.

"The guy from Pewaukee is ranked honorable mention in state," Aupperle said.

In the finals, Smith had little trouble with Justin Peterson of Grafton, pinning the Blackhaws in 1:20.

Peterson pinned the No. 1 seed from Wisconsin Lutheran in the semis.

"Mason's wrestling excellent," Aupperle said. "One of his goals is to get 25 wins. He's at 24 right now. He's got to have a good day next week."

As far as the runners-up go, Haugen (22-9) ran into a buzz saw in the finals, losing an 18-8 decision to Praveen Dhat of Pewaukee in the finals.

In the wrestler back, he pinned Brian Dilley of Milwaukee Lutheran in 1:23.

At 112, Olla was the top seed but could not match T.J. Stolp-Apel's strength and experience, losing to him 6-0 in the finals after beating Kyle Holtz of Milwaukee Lutheran 7-2.

Holtz won the first wrestle back, meaning Olla (20-12) did not have to go up against him again because he had already beaten him.

Seitz, who has been hovering around the .500 mark most of the year, got a bye in the first round, then beat Mitch Teeters of Pewaukee 5-2 in the second but he was pinned by Codi Wilch of Campbellsport in the finals.

Seitz (15-16) also did not need to wrestle back to prove his second place because he had already defeated Teeters.

"He's been doing a tremendous job," Aupperle said. "He's just a second-year wrestler. He worked hard in the off-season," going to camps. "It's nice to see that hard work pays off."

One of the big stories at Kewaskum this winter has been the impressive wrestling of freshman Cody Seibel. Last week, he captured the EWC title at 152, and Saturday qualified for the sectional.

After a bye, Seibel pinned Chris Ponder of St. John's in the first period, but he fell short in his bid to upset John Hrabik of Pewaukee, who was 35-8 going

into the match.

Hrabik won 8-4, but Seibel (22-9) got second because Ponder took third place.

Mike Pfothhauer's coming out for wrestling in mid-December certainly helped Kewaskum, and he had a good day Saturday, defeating Wes Bengel of Campbellsport 10-4 to reach the finals. There T.J. Decker was a bit better, beating Pfothhauer 11-3.

"He beat the No. 1 seed (Bengel), and he beat him handily," Aupperle said.

The 160-pound KHS senior, now 8-7, did not have to prove his second because he had beaten Bengel.

Once again, Billy Mayer of Campbellsport got the best of Turowski in the finals at 189. The meeting was their third this season, Mayer has won all three, and this time he had the upper hand 7-4.

"With a minute left, he was down 4-3," Aupperle said. "He's actually got to be more offensive and make things happen."

In the first round, Turowski (29-6) won by tech fall over Austin Gomez of Brown Deer, 16-zip, then he pinned Pewaukee's Josh Mohr in 1:54.

He also did not have to prove the second place.

The big disappointment of the day was P.J. Krueger's loss in the semifinals. Krueger was pinned by Matt Benoit of Pewaukee in 3:09 of the semifinals. Benoit entered the competition with a 16-20 mark, while Krueger was 29-5.

"P.J. was sick all week, and he just did not wrestle well at all. He didn't look like himself," Aupperle said. "He was the No. 1 seed, and he just didn't have any gas... this is a tough time to get sick."

On Saturday, Milwaukee Lutheran will host the Division 2 sectional. The top three survivors in each weight class advance to the WIAA State Tournament on Feb. 22-24 at the Kohl Center in Madison.
