## KES student killed in FDL crash



Campbellsport paramedics work on extricating victims from a Ford Explorer that became involved in a motor vehicle accident on Friday, March 2 near Waucosta in Fond du Lac County. Firefighters and paramedics from Campbellsport, Kewaskum and the city of Fond du Lac worked in the midst of blowing and drifting snow on State Highway 45. The accident left a nine-year-old KES student dead and his father facing possible drunk driving charges. A total of five people were injured in the two-vehicle crash. ## Krautkramer, Heberer awarded prestigious Regal scholarship

**KEWASKUM-** Regal Ware has announced the recipients of their annual \$18,000 scholarship award. This year's recipients are Bekki Heberer and Lindsay Krautkramer.

The scholarship was established in 1963 in honor of the housewares firm's founder, the late J.O. Reigle. The award recognizes the outstand-

ing scholastic achievements of one or more graduating seniors at Kewaskum High School, and is designed to assist the recipients in their pursuit of a college education.

To be eligible for the scholarship a student must have attended Kewaskum High School for at least the previous two years, and maintained

at least a "B" average for the first 31/2 years of high school. Each student will receive \$4,500 per year for each of their four-year college programs.

Bekki Heberer is the daughter of Randy and Janet Heberer of Kewaskum. She plans to attend Marquette University this fall to study in the Physician's Assistant field. Her high school activities include National Honor Society, student council, yearbook, volleyball, and fastpitch. Bekki is also involved in club volleyball and medical explorers; she has participated in youth outreach activities, and serves as a volunteer at Kathy Hospice.

Lindsay Krautkramer is the daughter of Ross and Sandra Krautkramer of Kewaskum. Her activities at Kewaskum High School include serving as secretary of the National Honor Society, captain of the dance team, and drum major of the marching band. She is a member of the Key club, Spanish club, swing choir, and the varsity soccer team. Out-of-school activities include singing and playing piano. Lindsay plans to study music at Lawrence University, Viterbo, UW-Steven's Point, or Carthage College, with her goal being a teaching degree.

## Wastewater plan given thumbs up

**KEWASKUM-** The public, village trustees, DNR and two engineering firms gave a thumbs up to an updated plan to renovate the village's outdated wastewater treatment facility. The village is set to make an official vote on the project at their Monday, March 19 meeting.

The revised plan will cost taxpayers \$3.44 million. The first plan presented by the village's engineering firm, Ruckert-Mielke was estimated to cost \$10.9 million.

Revised population estimates were a factor in bringing the price down for the facility upgrades.

Judith Gottlieb of the Wisconsin Department of Natural Resources (DNR) gave vocal approval of the plan. Originally the DNR wanted a plan in place by 2006. Because the village was making an honest attempt at rectifying the situation, she became more lenient on dates.

At their meeting on March 19, trustees will discuss a possible timeline and may take action on implementing the plan.

Village residents left the meeting feeling easier about paying for the facility, however the exact method of payment is still to be determined.

In May of 2004 flooding in the village saw wastewater bypassing the plant and being disposed of in the Milwaukee River prompting action by the DNR. The village has already made significant improvements to infrastructure to the sewer and water utility because of mandates from the DNR.

## KES dad facing drunk driving charges after crash kills son

**OSCEOLA TOWNSHIP-** A nine-year-old town of Farmington boy was fatally injured on Friday, March 2, after a two-vehicle crash on U.S. Highway 45, just north of County Road F. The boy's father, the driver of one vehicle was later arrested on drunken driving charges. A Kewaskum couple was also involved in the crash and received non-life threatening injuries.

Fond du Lac County Sheriff's Deputies responded to the crash at 4:31 p.m. and were joined by Campbellsport Fire and EMS. Kewaskum EMS and City of Fond du Lac paramedics also responded and provided mutual aid.

According to Sergeant Mike Nolan of the Fond du Lac County Sheriff's Department, John Ibeme Sr., 55, of the town of West Bend, was traveling southbound with his three children on U.S. Highway 45, when he lost control of his Lincoln Town Car. Ibeme's car struck a Ford Explorer that was traveling northbound on U.S. Highway 45.

John Ibeme was sitting in the right rear passenger seat of the car and was not wearing a seat belt. Unconfirmed reports say paramedics were unable to save his life at the scene.

His seven-year-old brother, Kent, and six-year-old sister, Olivia, were also passengers in the car. Nolan stated that both were taken to St.

Agnes Hospital in Fond du Lac with serious injuries and later transferred to Children's Hospital in Milwaukee. Information on both was not being released.

The driver of the Ford Explorer, Larry Morenzen, 48, of Kewaskum, was traveling with his wife, Kristine, 46. Both were transported to St. Agnes Hospital in Fond du Lac by ambulance with non-life threatening injuries. They were treated and released.

Law enforcement officers say they believe speed and alcohol are believed to be a factor in the accident. After being treated and released from St. Agnes Hospital, the driver was arrested on suspicion of operating a vehicle while intoxicated. He is expected to be formally charged in Fond du Lac County Circuit Court on Wednesday, March 7.

### School Reacts

Students at Kewaskum Elementary School were dealt another blow after the death of the second student in less than a year. Only a few months shy of the one-year anniversary of the death of student Elizabeth Koser, students returned to school Monday to learn of John "Ike" Ibeme's death.

Director of Elementary Education, Kieth Kriewaldt stated that after assembling the district's crisis team on Saturday. On Monday, students were made aware of the tragic death of their classmate. Counselors were brought in and spoke to Ibeme's classmates. A letter from Kriewaldt went home with students on Monday.

"The staff and students at KES are very saddened by the loss of our friend John "Ike" Ibeme. The students will miss Ike's smile and willingness to share his toys," stated Kriewaldt.

"At this time the students are handling the situation as best to be expected. Some children are talking with parents, teachers, counselors, and even the principal. We are doing what ever the children need to help them deal with this loss," he concluded.

The officer met with the manager, who advised there was an older white male in the store for over an hour. He appeared to be very incoherent.

While walking through the aisles, the male knocked items over and appeared to either be on drugs or was intoxicated. The male was currently using the men's room.

Inside, the officer observed the subject was sitting in a stall. The officer asked the male to identify himself. He replied, "yes, yup, yup" numerous times and could not recall his name or phone number.

The officer attempted to get information from him for several minutes without success. He then advised the subject he would have to leave the restroom and be seated in the officer's patrol car. The subject advised again, yup, but could not get up.

The officer then went to collect the subject's belongings outside of the store. He found a bottle of Coke that smelled like it contained an intoxicant inside, a pint of vodka that was nearly empty along with a large bottle of Coke and three empty beer cans.

The officer later identified the subject and attempted to locate the man's girlfriend but was unsuccessful.

A PBT test indicated a blood-alcohol level of 0.200 and was slowly rising. The officer then transported the man to St. Joseph's Hospital's detox ward.

### Nurse makes initial appearance

Barbara Hansen, 45, of Random Lake, faces six counts of obtaining a controlled substance. She is accused of ingesting morphine taken while on the job at St. Joseph's Hospital in West Bend.

Washington County District Attorney Todd Martens stated that Hansen signed a \$3,000 signature bond with a condition stating she be in no contact with any controlled substances without a valid prescription.

### Farmington teen facing felonies

**WEST BEND-** Judge David Resheske has set a local teen's bond in connection with a head-on collision last July on State Highway 33 east. Nineteen-year-old Jordan Pehowski of Farmington is charged with two felony counts of causing injury by intoxicated use of a vehicle. He also has a misdemeanor count of causing injury while driving under the influence and has citations for operating left of center and first offense drunk-en driving.

Police say Pehowski was headed east on Highway 33 under the influence of sleeping pills when his pickup truck crossed into the wrong lane and collided with a car. All three of the occupants were injured, two of them seriously. Pehowski is free on a \$7,500 signature bond and will return to court on March 26.

### Mound to be removed in downtown W.B.

**WEST BEND-** Bids will be opened in about two weeks for a small, but somewhat contentious project in downtown West Bend. City Engineer Judy Neu says the project would involve removing the mound and curb at the most southerly end of Main Street in the downtown area.

Neu estimated the entire project to cost around \$35,000. The contract is expected to be awarded in early April of this year. While originally it was thought to add more parking stalls, that idea will not proceed.

## Ziegler making headlines for alleged conflict of interest

The Wisconsin State Journal is reporting that state supreme court candidate Annette Ziegler failed to disclose a conflict of interest in at least four cases she presided over as a Washington County Circuit Court judge last year.

The Madison newspaper says all of the cases involved people sued by West Bend Savings Bank. J.J. Ziegler is a paid member of the board of directors of the bank.

The defendants said Judge Ziegler did not withdraw from the cases or disclose her conflict as required by law.

In other campaign news, Judge Ziegler also states that she is returning \$500 in a campaign contribution from her uncle, Doug Ziegler.

In reviewing donation records, the Wisconsin Democracy Campaign found Ziegler donated \$10,500 to the judge's campaign.

State law requires donations not to exceed \$10,000. Ziegler's campaign spokesperson, Mark Graul, stated accepting the money was an oversight and a \$500 check would be sent to Doug Ziegler to correct the error.

Judge Ziegler will face Madison attorney Linda Clifford in the April election. Ziegler received over 50 percent of the vote in the February primary.

### Woman dies after jump from overpass

**GERMANTOWN**- A Menomonee Falls woman who jumped off a highway overpass in the town of Polk on February 19 has died. The Washington County Sheriff's Department states the woman was pronounced dead at Froedtert Hospital in Milwaukee at 2 p.m. on Wednesday, February 28.

The woman was transported to Froedtert Hospital following the jump. The sheriff's department ruled the mishap a suicide attempt shortly after. With the investigation complete, the cause of death is ruled suicide.

## IRS has \$20.6 million for Wisconsin residents who failed to file in 2003

**MILWAUKEE**-Unclaimed refunds totaling more than \$20.6 million are awaiting about 20,000 people in Wisconsin who failed to file a federal income tax return for 2003, the Internal Revenue Service announced recently. However, in order to collect the money, a return for 2003 must be filed no later than Tuesday, April 17, 2007.

The IRS estimates that half of those who could claim refunds in Wisconsin would receive more than \$563.

Across the country, unclaimed refunds totaling more than \$2.2 billion are awaiting about 1.8 million people who failed to file a federal income tax return for 2003, with an estimated median refund of \$611.

In some cases, individuals had taxes withheld from their wages, or made payments against their taxes out of self-employed earnings, but had too little income to require filing a tax return. Some taxpay-

ers may also be eligible for the refundable Earned Income Tax Credit.

In cases where a return was not filed, the law provides most taxpayers with a three-year window of opportunity for claiming a refund. If no return is filed to claim the refund within three years, the money becomes property of the U.S. Treasury. For 2003 returns, the window closes on April 17, 2007. The law requires that the return be properly addressed, postmarked and mailed by that date. There is no penalty assessed by the IRS for filing a late return qualifying for a refund.

The IRS reminds taxpayers seeking a 2003 refund that their checks will be held if they have not filed tax returns for 2004 or 2005. In addition, the refund will be applied to any amounts still owed to the IRS and may be used to satisfy unpaid child support or past due federal debts such as student loans.

By failing to file a return, individuals stand to lose more than refunds of taxes withheld or paid during 2003. Many low-income workers may not have claimed the Earned Income Tax Credit (EITC). Generally, unmarried individuals qualified for the EITC if in 2003 they earned less than \$33,692 and had more than one qualifying child living with them, earned less than \$29,666 with one qualifying child, or earned less than \$11,230 and had no qualifying child. Limits are slightly higher for married individuals filing jointly.

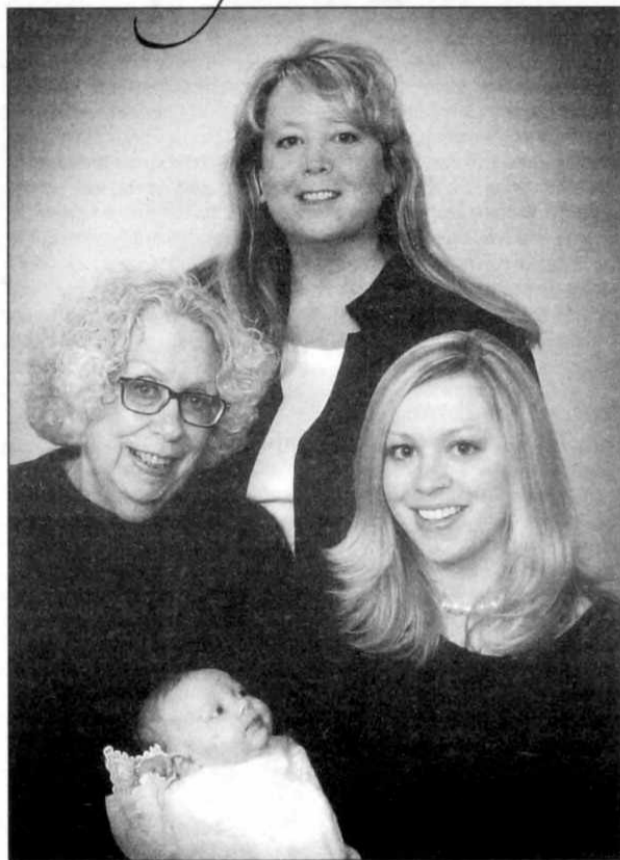

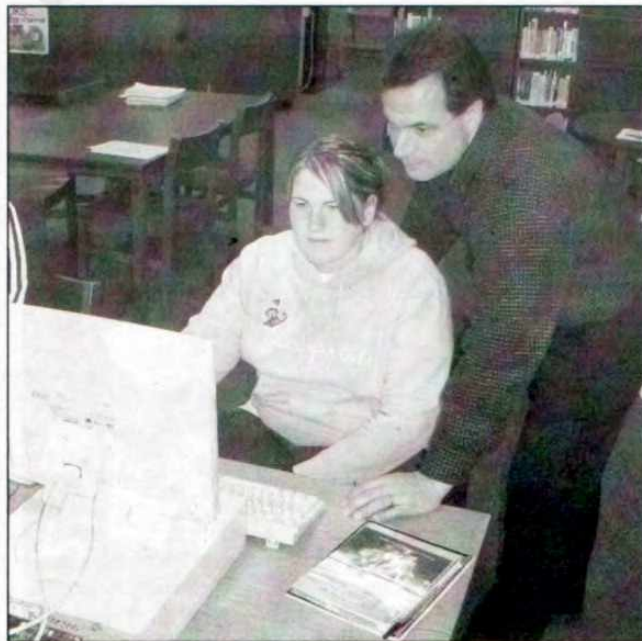

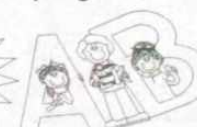

Four Moraine Park Technical College District high school teams took part in the inaugural Bots IQ competition on Feb. 2, 2007, at the Oak Creek campus of Milwaukee Area Technical College.

The competition hosted 15 middle school, high school, and technical college teams in the double elimination tournament. Kewaskum High School placed second and Slinger High School placed fourth.

Bots IQ - Robotics Education exposes students to the math, science, engineering and manufacturing skills needed to build competitive robots. As the students worked on their robots they learned about electronics, teamwork, problem solving and how to manage time and money. While the teams spent countless hours on their projects over the last four to five months, many teams were working on their bots until midnight prior to the competition.

Moraine Park district teams and mentors/sponsors participating included Kettle Moraine Lutheran High School, sponsored by Mahuta Tool Corp of Germantown; Kewaskum High School, sponsored by Toolcraft, Inc. of Germantown and Regal Ware of Kewaskum; Slinger High School, sponsored by CDM Tool of Hartford; and West Bend East High School, sponsored by Strohwig In-

dustries of Richfield.

The Kettle Moraine Lutheran team had Moraine Park tool and die making apprenticeship alumnus Mike Koepfel as their mentor. Koepfel helped the team members with the design and fabrication while his employer, Mahuta Tool Corp., provided financial support and use of their facilities to work on the robot.

The Bots IQ competition was sponsored by members of the Wisconsin Precision Metalworking Council (WPMC) who provided \$10,000 for teacher training in June 2006 and paid for the transport of the competition arena from Florida.

The association is backing the highly popular competition to get young people in Wisconsin interested in math, science, engineering and manufacturing.

While the WPMC membership has sponsored a majority of teams for the 2007 competition, the group would like to broaden the competition and is seeking other companies to be mentors/sponsors for additional schools to get involved for next year's competition. 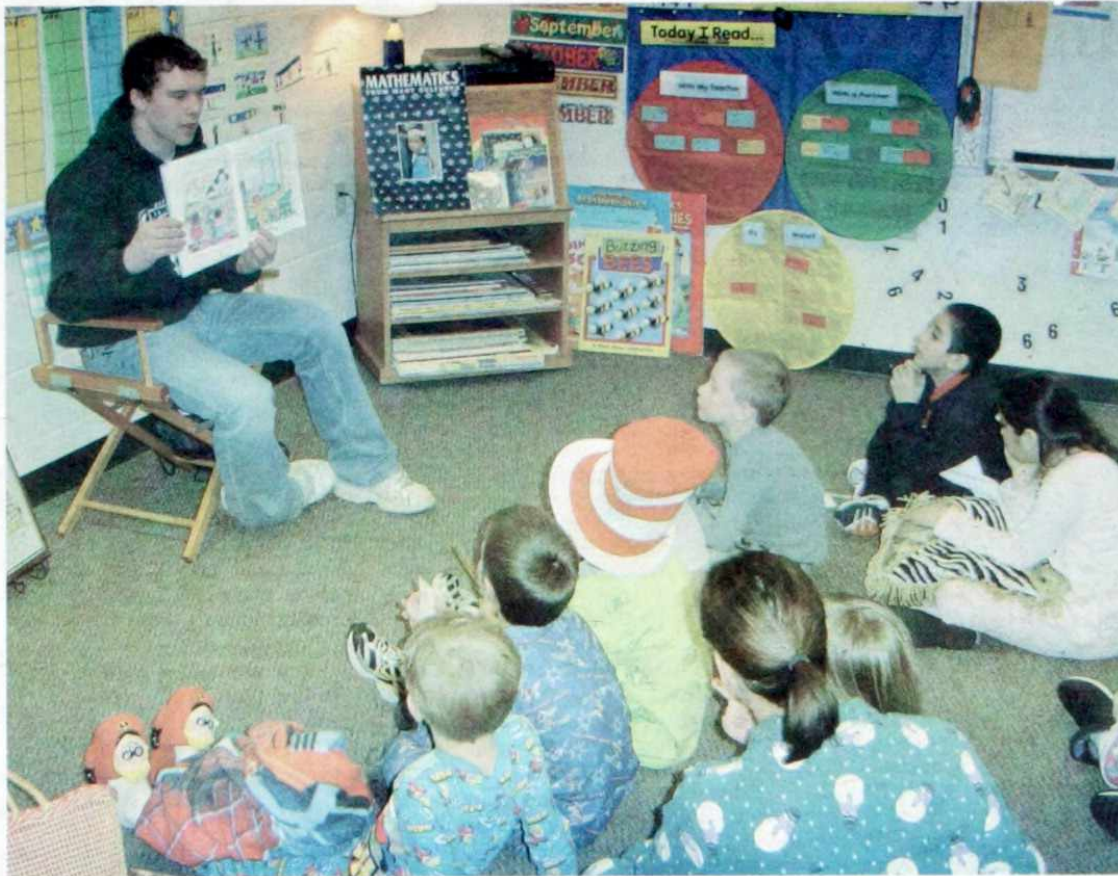

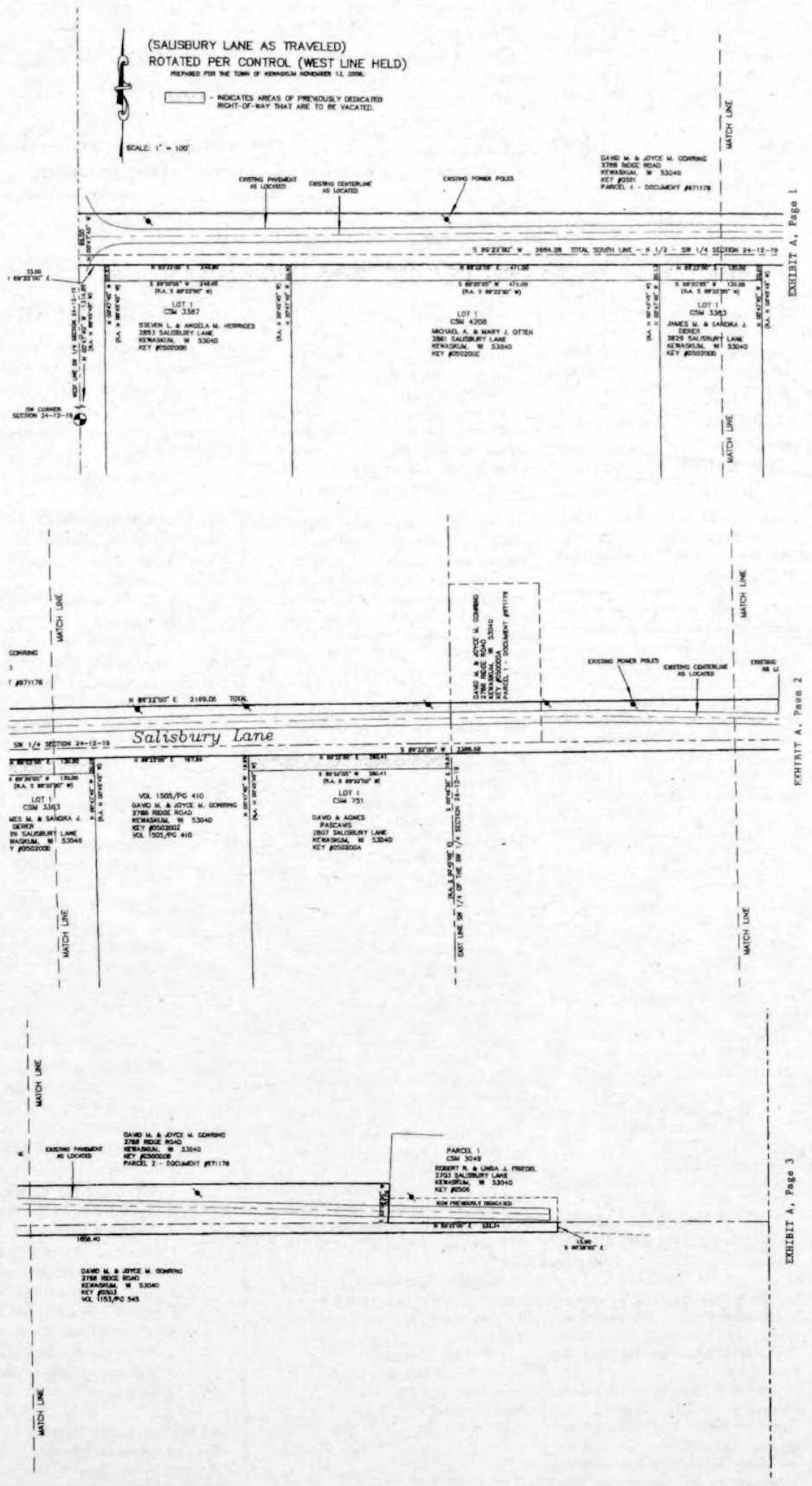

## Kewaskum boys ruin Lancers' playoff party in low-scoring game

It isn't certain just when the Kewaskum High boys basketball team won its last WIAA playoff game, but it's safe to say it's been a long time.

The Indians changed all that last Tuesday night, pulling off a big upset in their 29-28 victory over St. John's Academy/Northwestern Prep team in a game played in Delafield. That is no typo, the final score was 29-28, and the slower-paced game suited the Indians, seeded seventh in the eight-team regional, just fine because it seemed to negate the height the second-seeded Knights featured.

"We knew they had a size advantage on us. We knew we had to play a zone and pack it in on them ... we had to be patient on offense, and we played very aggressively defensively," KHS coach Bobby Bannasch said, just thrilled with the way his team carried out the game plan.

The Indians just smothered the Lancers' 6-foot-5 Martin Esters, holding him to just four points before they got him to foul out of the game.

The score was close throughout the first half, with the hosts holding a one-point advantage at the break.

Then the Indians surged into the lead, 27 to 24, thanks to a 12-point third quarter, and it was the only time either team was able to climb into double figures in an eight-minute segment of the game.

In the third quarter, Matt Parrent was the spark plug, scoring five points and Dan Parker added a 3-point bucket.

Bannasch said his Indians only managed to score

two points in the final period, but those two points, on a medium-range jumper by Casey Scheel put the Indians up by two, and with 45 seconds left on the clock, they had possession of the ball.

"We set up a play for Casey. It was basically an isolation call. It was a nice move, but they called him for an offensive foul," Bannasch said, reporting the Lancers decided to hold the ball and go for the win.

"They ran the clock down ... It was (Marco) Piemonte. He missed it, and Jack Breese got the rebound, and it saved the victory for us," Bannasch said about the Knight's last second 3-point try from the left wing.

Concerning the rebounding in the contest, Bannasch said, "It was even," and he thought it was John Holt who led the Indians in that department.

Parrent had a team-high and game-high nine points for KHS, while Holt added eight and Scheel and Parker both scored five.

With the win, the team's sixth in a row, Kewaskum im-

proved to 9-12 and more important, earned the right to move to the semifinal game against Port Washington.

St. John's/Northwestern ended its year at 16-5.

## Indians' bid for seven comes up short

Kewaskum High's win streak stood at six going into the second round of the WIAA Division 2 regional Thursday night at Port Washington, and unfortunately for the Indians it ended there, thanks to the efforts of the Pirates' two big guns, Chris Prom and Mike Burmesch.

Burmesch and Prom combined for 29 points to turn back the Indians 49-38 in a game that was closer than the final score indicates.

"With 1:55 left, Port, the No. 3 seed in the regional, had a four-point lead, and we had to come out of our zone," KHS coach Bobby Bannasch said. With only three fouls and still four to five, the Indians had to gamble, and, "They got a couple nice back door cuts. They got some easy lay-ups."

Still, the first-year coach was really proud of the run his players compiled at the end of the season, giving the team a 9-13 mark.

"I'm definitely happy for the kids ... It was a good end to these guys' careers," Bannasch said. He was referring to Matt Parrent, who started all four years at KHS, Casey Scheel, who started since midway through his freshman season, Dan Shea, who finished the season with several good scoring games, and Jack Breese, a defensive specialist and Mr. Hustle as far as the coach was concerned.

The game didn't start out very well for the Indians, who had lost to the Pirates by ten points back on January 30 (at home). Kewaskum managed just five points the first eight minutes while the Pirates were

running their offense very efficiently to the tune of 16 points and an 11-point lead.

"We just came out flat," Bannasch said. "They (Pirates) did a nice job of being aggressive."

"Again we were undersized," Bannasch went on in explaining why he went with a 2-3 zone in the first quarter when Prom and Burmesch combined for 14 of their team's 16 points.

Near the end of the quarter, Bannasch was ready to come out of the zone, but then, he said, Shea hit a 3-point goal, and he decided to stay with it. Bannasch was happy he did, because in the second quarter, the Indians came alive and pulled to within two points at intermission.

"We felt we dug ourselves out of the hole we were in. The kids had a little more confidence," the coach said.

"(John) Holt went crazy," Bannasch said, reporting he had eight points in the second quarter, with Parker and Shea adding six apiece.

Kewaskum took the lead in the third quarter on a basket by the junior Holt, who led the Indians in scoring with 17 points. Port came right back to take the lead, then Kewaskum went ahead, but the Pirates regained the lead with a basket.

When they went back on top, it was a two-point lead most of the remainder of the game until those closing minutes, Bannasch said.

Concerning Holt's efforts, Bannasch said, "He just used his body so well. Our guys did a good job getting the ball to him ... and he had some excellent moves."

Holt is expected to take

over the role as team leader next year, with help from Dan Parker, who scored four points in the contest.

For Parrent and Scheel, their finals games were not quite up to par. The 6-foot-4 Parrent, who became the school's all-time leading scorer midway in the season and the first KHS boy to score 1,000 points on Feb. 6, was held to six points. Scheel only managed five.

"They did a nice job shutting them down," Bannasch said, indicating the 6-5 John DeBoer was on Parrent most of the game. With his six points, Parrent wound up with 1,075 points for his career, while Scheel scored approximately 500 for his career.

Scheel missed 10 games his sophomore year with a partial tear of his MCL (knee),

and he broke his wrist in the second to the last game his junior year. Had he been able to play in all those games, he probably would have hit the 600-point mark.

Bannasch thanked the parents and fans for great support at the end of the season. "It (the six-game run) did put some excitement back in boys' basketball," he said.

When asked how he would grade himself in his first year as a head coach, Bannasch grinned, then said, "To be honest, it was a learning experience for me, but all the coaches worked extremely hard and we gained some knowledge."

"It takes kids a while to buy into a system," he went on. Next year, "The kids will now have a year with it ... it's going to help."

Five of the Eastern Wisconsin Conference teams lost in the first round of the tournament. Kewaskum reached the second game, and Plymouth went to the regional finals before losing to Port Washington. Roncalli, the EWC champion for the third year in a row, advanced to regional final (Monday, March 5th) after whipping Kewaunee, 78-28.
