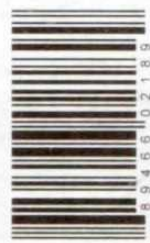

# State bound and determined

*Kewaskum has a good contingency heading for La Crosse*

**KEWASKUM-** Elevating their efforts to new highs, three members of the Kewaskum High School boys track team and six from the school's girls track team are packing their bags for the WIAA Division 2 State Track and Field Meet in La Crosse Friday and Saturday.

The talented crew of Indians earned berths in the state competition by placing among the top four in their specialties in the sectional meet hosted by Kewaskum last Thursday.

"I think things went very well. The kids who we thought had a good chance to make it... they all made it!" exclaimed KHS coach Jerry Gosa about the efforts of his athletes, who broke two school records and set several personal bests to successfully reach their goals. "And we had a nice little surprise about Tyler Swanson," he added.

In the team competitions, it was East Troy winning the girls team title with 67 points. In the runner-up spot was Whitewater with 57, followed by Lakeside Lutheran, 55; and Milwaukee Lutheran 52. The KHS girls finished seventh with 46 points.

A spirited race developed between Milwaukee Lutheran and Brown Deer for the boys title, with Lutheran coming out ahead 82 to 79 points. In the third and fourth spots were Whitewater, 59.5; and Shorewood, 46. The Indian boys scored 24.5 points, which was good enough for the ninth spot.

If there was one race that stood out in the meet for the Indians, it had to be the girls 4x200-meter relay. Kewaskum came into the event with the third best time from the regional and left the track with the title.

Carrying the green and white colors for the Indians were Haley Gregoriou, Jessie Liniewski, Nichole Kison and Kelly Uelmen. They combined for an excellent time of 1 minute, 45.65 seconds (1:45.65), a school record. The old record stood at 1:47.01 "I would like to have a video of that race," Gosa boasted.

Good passes and excellent legs by Liniewski and Kison helped to give Uelmen the lead, and the senior sprinter turned into overdrive to hold off the teams from East Troy (1:45.85), Whitewater (1:45.95) and Brown Deer (1:46.15).

The same Indian quartet was also facing an uphill climb in the 4x100 where they had the fifth best time. Again, thanks to some good passes, they were in position to win, and Uelmen made sure of it with a strong anchor leg for a 50.54, good for fourth and much better than their seed time of 51.22.

Individually, high jumper Candace Beine and pole vaulter Alissa Clapper move on to state. Clapper won the pole vault by clearing 9-feet, 6 inches (9-6), and Beine topped out at 5-0 in the high-

jump.

"The high jump is an interesting event, so many times this is decided by misses," Gosa said. "You have to have a good day," and Beine had one.

Relays will be running in preliminaries on Friday, Clapper will be vaulting on Saturday and Beine is in the high jump on Friday.

Uelmen just missed qualifying for the 100, running a 13.13.10 for fifth place, while Liniewski finished seventh in the 200 (27.19), missing by three places.

Even though she finished eighth, Gregoriou had an excellent time of 49.89 in the 300 hurdles.

The senior duo of Ben Boettcher and Tyler Swanson had another banner

day in the discus. Ditto for junior Jake Dickmann, who went over 13 feet for the first time in the pole vault.

"I think Jake did a really nice job vaulting; he did exactly what he had to do," Gosa said. "13 feet is good for a junior, and he did have some nice attempts at 13-3."

In the prelims, Boettcher let loose with a winning toss of 178 feet, 7 inches, breaking Charlie Sparks' school record by just under six feet. With the effort, Boettcher was able to defeat Lomira's fine weightman, Nick Baatz, by nearly three feet.

Swanson also had a big day, throwing the silver platter 149-07 for a new personal best, a third place and place in the state competition.

While he was happy with Boettcher's effort, weight coach Matt Gundrum was even more excited Swanson qualified. He worked so hard," the coach said.

Dickmann was fourth in a strong vaulting field.

"I made it on the third try," Dickmann said, adding, "I was clean until 13 feet," meaning he had no misses until then.

Boettcher and Swanson will throw on Friday afternoon, while Dickmann will vault on Friday.



## Bike ride was tops on Drexler's list

Former Kewaskum Middle School technology education teacher Dave Drexler calls his upcoming 3,000-mile cross country bike ride "something I put on my bucket list."

Similar to the recent Jack Nicholson movie where Jack and Morgan Freeman decided to list some of the things they wanted to do before they died, Drexler has included put the Bike Across America event on his. He and his team, that includes two other retired teachers, a nurse and a former West Bend CEO, call themselves Team Badger Bikers. They are ready to take off next week.

"We fly out on June 8th. We start biking on June 11th," Drexler, 60, said, indicating he is using these final days in Wisconsin working on "some sprints and long distance" rides which are totaling up to "between 200 and 300 miles a week."

Last week, for example, Drexler biked from his home in Horicon to Kewaskum and back again. "By the time I got back, it was 47 miles," he said, and there was an obvious eagerness in his voice that the date of the race's start is drawing near.

"I have been focusing more on my biking right now and not on my running," Drexler said, but he doesn't care about not running as much as he usually does, especially since the event will help children in the Make-A-Wish of Wisconsin program and since this is a major challenge.

And how did Drexler find out about this event, which extends from Oceanside, California to Annapolis, Maryland? Two years ago, I crewed for a friend who did it," Drex-

ler, who still coaches cross country at KHS, said, indicating he started thinking during the trip, "I'm in the wrong seat. I should be on the bike."

At first, Drexler said he wanted to be in a four-person event, but then after some discussion, it was decided the group would include eight cyclists and their support crew.

"Four will be on, and the other four will be resting," Drexler said, reporting a team of four will ride about 120 miles before trading off. "We're doing it as a sprint," Drexler said. "We'll be on the bike for anywhere from six to 10 miles," before resting a while, then riding again.

There will be a couple vans with the team, plus an RV, so the riders will be able to sleep and eat as the other four riders are taking their turns on the bike.

For now, Drexler said he has been following his regular healthy diet, but once the ride begins, "We'll be eating a lot of pastas and energy bars,

The group will need plen-

ty of energy to cover states that are flat and more when they are involved in uphill climbs.

And is the course going to go through the mountains? "Oh yes, we touch the southern part of Colorado," Drexler said, indicating they also travel through parts of Arizona and straight through Utah, then on to Kansas and the midwest.

Drexler said the team is hoping to reach Annapolis by June 18th, "so in six or seven days, we hope to make it across (the United States)."

So what happens if one of the riders takes ill or gets injured? "The rest of us will pull it out," Drexler said. "We're all committed," but should that happen, the rotation of riders will change.

Almost equally as important as the riders are those in the support team, which include four drivers for the two vans and the three people in the RV, including two drivers and an extra navigator.

Drexler is seeking pledges for the Make-A-Wish group and said he already has \$6,000

pledge, and the team has \$35,000.

Bringing in funds for terminally ill children is a major reason Drexler decided to make the ride. He said he and at least three others on the team spent their lives working with children, and this will be another way to help young people, ones who are facing serious physical difficulties.

Should anyone want to contribute, they can send a

tax deductible check to the Statesman in Drexler's name or directly to Make-A-Wish of Wisconsin.

The others on the trip include Jim Reiher, Paula Larsen, Phil Nelson, Nancy Sellars, John Torinus, Eileen Sherburne and Tom Brown.

And is Drexler excited about making the trip? "Oh yes, it's the experience of a lifetime," he said.

"Susan and her husband, Russ Broussard are members of our Board of Directors and have an innate, almost visceral understanding of the needs of the children of Africa and our role in helping them. Their efforts with us will assure that the Malaika School will be finished as scheduled in August of 2008."

Susan Cowsill made her initial mark on popular culture at the tender age of eight with The Cowsills, the 60s family pop group that not only scored Top Ten singles "The Rain the Park and Other Things", "Hair", and "We Can Fly" but also served as the real-life inspiration for TV's fictional Partridge Family. During Susan's decade with New Orleans' roots-pop supergroup The Continental Drifters, she won the hearts of discerning listeners with her impassioned vocals and personally charged songwriting, gracing three widely-acclaimed albums and a decade's worth of riveting performances.

According to family lore, Susan's husband and bandmate, Broussard was so mesmerized

by National Geographic photos of the Ituri drummers in Central Africa as a child that he would cry himself to sleep because he was not a part of the drum ceremony.

His dreams held firm and Russ graduated from the North Carolina School of the Arts in classical percussion, which led to the beginning of his professional career at the age of fifteen. # DAYS GONE BY

## 25 Years Ago

May 20, 1983

The Fond du Lac County Sheriff's Department and volunteers are continuing their search for five-year-old Bobbi Joe Fritz, Campbellsport, missing since late Saturday afternoon from his home. 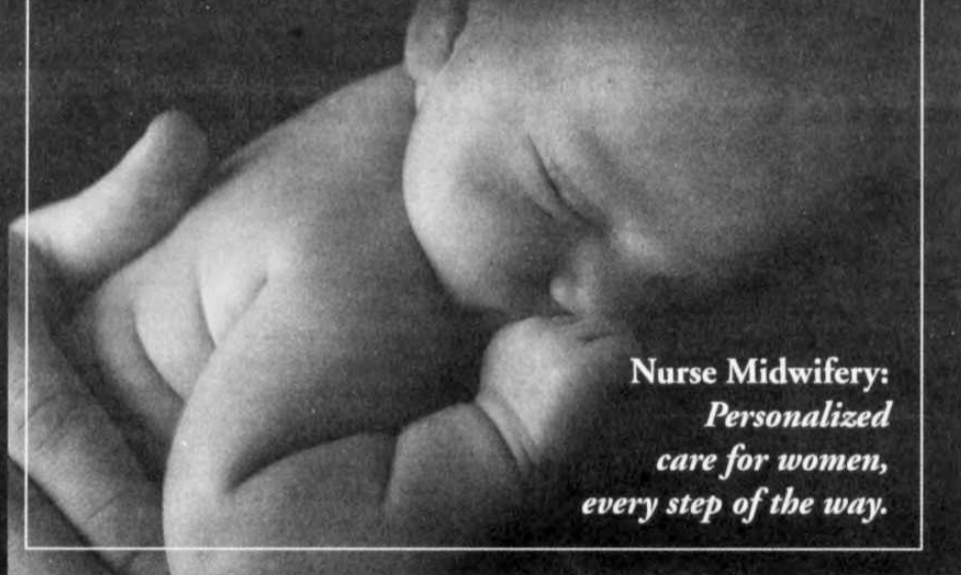
May 16, 1908

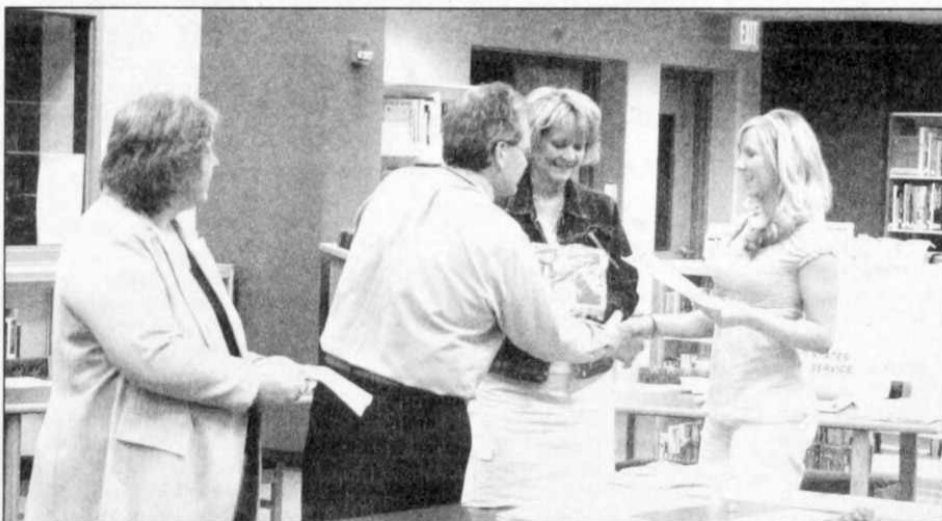

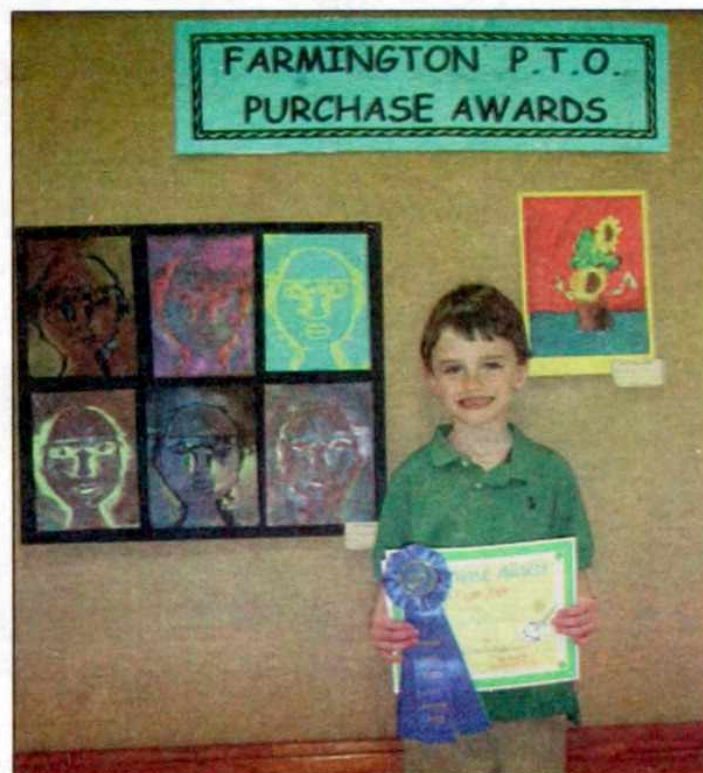

## The Bookworm Sez

### The Brothers' War: Civil War Voices in Verse

By J. Patrick Lewis

National Geographic \$17.95 32 pages



How well do you get along with your brother or sister?

I'll bet sometimes he really bugs you. She might touch your stuff or "borrow" things without your permission. You two might even argue sometimes until Mom or Dad steps in to stop the fight.

But even so, down deep, you love your brother or sister and you would do anything to protect him or her.

About a hundred fifty years ago, during the Civil War, protecting your brother sometimes wasn't possible. In the new book "The Brothers' War: Civil War Voices in Verse" by J. Patrick Lewis, you'll see that back then, brothers sometimes were on opposite sides of an issue and sometimes that meant death.

If you've studied history in school or if you've listened to Dad or Grandpa's stories, you might know about the Civil War. Author J. Patrick Lewis explains that the War Between the States started because Southern states were angry at Northern states, particularly over the issue of slavery. The South talked about withdrawing from the Union. In April of 1861, an attack was made on Fort Sumter in South Carolina. The War was on.

Of course, there was already a United States Army, but it was commanded by the North. Southern soldiers resigned their posts in the federal army and returned to their home states to fight for the South, or the Confederacy. This meant they were fighting - and killing - the people they had been friends with. It also meant they might be killing their own brothers.

In this book, you'll read poetry that will give you an idea of what people were thinking while they were fighting in the Civil War, while they were slaves, and while they fought for slaves' freedom. You'll find out more about the war, and you'll see some real, actual pictures that were

taken during the War Between the States.

I liked this book, but I have one strong caveat for parents and grandparents: if your child - no matter what age - is prone to nightmares or has a loved one at war now, be absolutely sure that you give this book with caution.

Although the poetry is well-written and can bring up some powerful feelings, that's not the issue. The historical facts that march along the bottom of each page are great, but they're not going to disturb a sensitive kid.

What could upset a child are the photographs of dead soldiers, battle scenes, and the aftermath of war. True, it's not much worse than what you'd see on TV, but it's not something you normally see in a children's book, either: because Civil War attitudes were different then, the pictures are unapologetic and blunt. That's okay for a grown-up, but parents need to know about them before giving this book to a child.

With that in mind, if you've got a young Civil War buff in your household or an adult collector, "The Brothers' War" is a must-have for their bookshelf. For them, it's a book they'll fight to own.

## Samuelson Sez

### Get Involved, for Safety's Sake

There are times when I feel I perhaps over-do the "farm safety" sermons in my column. Then I will receive a letter from a town in rural America with a newspaper clipping detailing the story of another tragic accident and the loss of life, and I realize we can't talk enough about being careful on farms and ranches, because accidents don't always happen to somebody else.

This week I share with you from the Spring edition of "4-H, The Power of Youth" the story of Carrie Nolan, a mother with a mission, who wants to make other families aware of the need for all-terrain vehicle safety after losing her two sons, seven-year old Justin and nine-year old Austin in an ATV accident on their farm in 2005. Note the ages, seven and nine.

This is not an attack on the all-terrain vehicle. The ATV is a necessary and valuable tool

on farms and ranches across the country and it is a great recreational vehicle if you are old enough to operate it safely and properly. Every time I say a seven-year old or eight-year old is not old enough, I'll hear from parents saying "my kids are old enough to drive an ATV" at that age. I just hope and pray they don't lose their kids in an accident because they lacked judgment and experience.

Carrie Nolan has worked hard to promote the 4-H ATV Safety Program, a collaboration among local 4-H groups, National 4-H Council and the Specialty Vehicle Institute of America's ATV Safety Institute. The whole idea is to build awareness for safe riding practices as we continue to see more and more all-terrain vehicles purchased and enjoyed as a tool or recreational vehicle across the country. Carrie states it this way..."Our sons are what give

me the drive to get the word out to other families about the dangers of ATV's."

This program gets kids and their parents thinking about the risks of riding ATV's and how to avoid them by wearing proper safety gear, determining safe places to ride and making sure the ATV is the proper size for its rider.

Much like Marilyn Adams who formed "Farm Safety4 Just Kids" after losing her son in a grain wagon accident, Carrie Nolan is turning her grief into something positive to save lives on all-terrain vehicles. She can't do it alone, so I strongly suggest that you as responsible parents get involved with your children in the 4-H program. 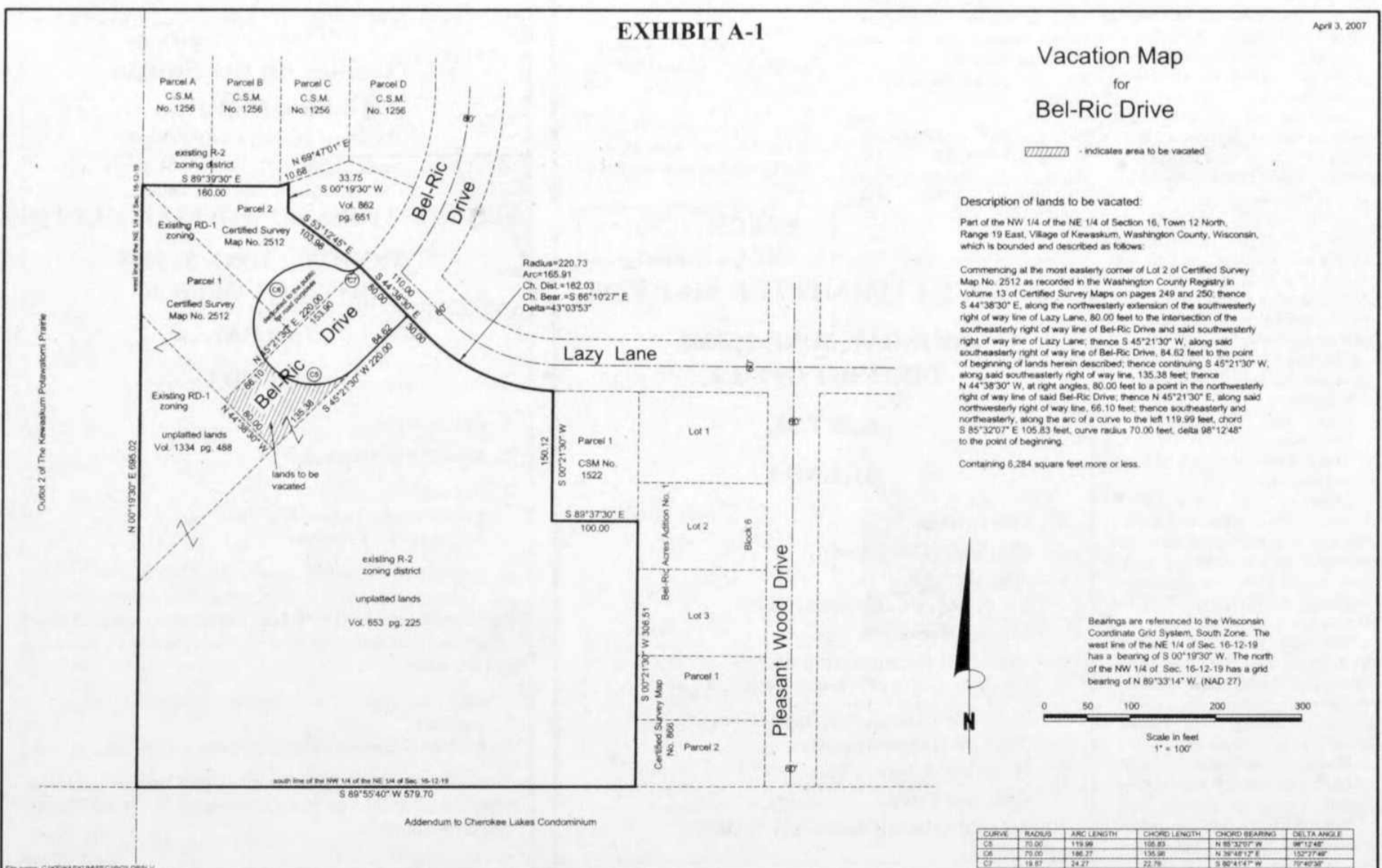

ball past short to bring Shea home, and Austin Sarauer's single was good for two more runs. This made the score 4-0, and Kewaskum still wasn't finished as Ketter knocked in another two runs, his second and third RBIs of the contest, with his single.

The game was put on ice in the top of the fifth, thanks to Ketter's leadoff double, his seventh one of the season, followed by an RBI double by Jon Olla.

Shea also doubled, and the bases were loaded once again after Sarauer drew a walk. Tjader, cracking the starting lineup for the first time this year, wasn't about to let the scoring opportunity get by. His single brought in one run, the fourth scored via a bases-loaded walk, and then Austin Sarauer hit a sacrifice fly to bring in run No. 5.

Austin Sarauer and Ketter both had 3 RBIs, while Schill and Nick Whitty had two each.

Ziegler started the game and turned in four solid innings. He scattered three hits and struck out three to pick up his third win of '08.

Tjader looked "very sharp," according to Ziegler, the club's spokesperson. He struck out six in the final three innings and only gave up one hit to the Roosters.

"The first two innings were a struggle," Holt said about his performance on the hill. "I hit my rhythm in the third and fourth innings."

Kewaskum's offense picked up in the fourth. Siebel led off the inning with a single to right center. Nuernberg walked to put runners on first and second. Menomonee Falls pitcher Jack Larsen balked, advancing the runners a base. The next two batters, Brian Backhaus and Justin Krueger, both struck out. Butler this time drove in the two base runners with a two-out double. Kewaskum took the lead 2-1.

Kewaskum lost the lead just as quickly as they got it in the fifth. Olla came in to relieve Holt on the hill. The first five batters for Menomonee Falls all reached home before an out was recorded. Falls batted through the order in the fifth.

The Indians showed perseverance in the bottom half of the fifth. Nick Ebert, Olla and Siebel all walked to have the bases loaded for Nuernberg. With one out, Nuernberg delivered with a double, scoring Ebert and Olla. Mike Herriges pinch hit for Backhaus and drove in Siebel with a fielders' choice. Bo Seibel pinch-hit for Krueger to end the inning with a ground out to first. Kewaskum was down after five, 6-5.

Ebert came in to pitch the sixth,

but he could not cool off Falls' hot bats. Falls scored four runs off of four hits in the sixth.

Butler started the sixth with a single to right. However, Holt hit into a double play and Ebert flied out to right. The game ended after the sixth because of time constraints.

"If I would have kept Johnny in the game he probably wins the ball game, but I was playing to hopefully get in three games," said Gonring.

With the loss, the Indians were right back on the diamond to play SWCHA. This game was a pitcher's dual between Ebert and SWCHA's Joel Bergmann. Ebert went five innings giving up one run off of four hits, one walk and struck out two with the loss. Bergmann went the distance giving up no runs, surrendering two hits and struck out 10.

Bergmann had a no hitter going into the fourth inning. With one out, Mike Gutjahr broke the no-hitter with a triple to right center. Ebert then came to the plate and hit the ball sky high to shallow center field. SWCHA centerfielder Travis Keyes took the ball off his chest and Ebert reached on the error. Gutjahr could not score on the error. Seibel and Nuernberg both got out stranding the two runners.

In the bottom of the fourth, SWCHA's Tyler Koepke reached on an in-

field single. Koepke stole second and the next batter Bergmann doubled, to help his cause, and bring in the only run of the game.

In the seventh Kewaskum almost broke through to score. Ebert led off the seventh by reaching on an error by new centerfielder Tyler Dykma. Seibel bunted Ebert over to second. Nuernberg then singled to left. SWCHA left fielder Keyes bobbled the ball, which created confusion on the base path between Ebert and Gonring, and Ebert stayed at third. Herriges and Bo Seibel both struck out to end the game.

Gonring said the team played better in the second game. He said a one to nothing ball game is a pretty good ball game. He said he is glad to see Ebert challenge the batter with a guy on second, and it was just unfortunate the guy hit a double to score the only run of the game.

"All of the pitchers did well," said Gonring. "They threw strikes for the most part."

Holt said the team needs to put the ball into play. He said the lack of hitting led to them having both of the games slip away.

Gonring said the focus going into the next practice is to stay consistent. He wants the team to improve every day and not to become over anxious or jump to conclusions.

## KHS girls wrap up another track title

Competing against the tougher teams in the Eastern Wisconsin Conference and some of the Division 1 schools in Washington County more than prepared the Kewaskum High track teams for Division 2 regional action.

The Lady Indians cleaned house at Lomira Monday, May 19, winning the regional title with a whopping 140 points. Mayville came in second with 122.

As far as the KHS boys were concerned, those in the field events helped propel the team to a third place with 89 points. Mayville topped the field with 131.5 points, followed by Lomira, which piled up 109.

The KHS girls were first, second or third in 10 event, posting wins in the two sprint relays, the 100-meter dash, 200, pole vault and high jump.

"The girls had a nice meet. They ran like they were highly motivated," KHS coach Jerry Gosa said, adding he is always concerned with having a meet on Monday, so the teams gathered Sunday afternoon to loosen up and talk about what they wanted to accomplish.

Senior sprinter Kelly Uelmen had an excellent day, winning the 100 in 13 and .11 seconds (13.11) and anchoring the 4x200 to a win in 1:47.44 and

the 4x100 with a 51.28 clocking.

The trio of Haley Gregoriou, Jessie Liniewski and Nichole Kison were involved with both relay wins, and they did well in their individual events as well. Liniewski won the 200 (26.83) and placed second in the high jump by going 5 feet, 1 inch (5-1), while Kison wound up second in the long jump (15-10) and fourth in the 200 (27.67).

Gregoriou finished third in the 300 hurdles with a good time of 50.74.

Gosa was thrilled with the way the 4x200 relay runners competed. "It was real interesting. Before the race, they got together and said they wanted to get under 1:50 again. They definitely did that," Gosa said, noting his foursome was four seconds ahead of the runner-up team. "It was a real credit to them, running very well without somebody right on their shoulder."

Kewaskum's others first were provided by Alissa Clapper (9-0) in the pole vault and Candace Beine in the high jump (5-1).

Senior Liz Potter was third in the 100 hurdles (17.49) and added a fourth in the 300s (51.42).

The fourth-place qualifiers included Kison in the 200 and the 4x400 relay with Heather Schmitt, Megan Thornton, Ashley Roeske and Rachel Yocum turning in a 4:26.

As far as the boys concerned, they were unable to pick up any wins, but did get a second from Ben Boettcher in the discus (157-04) and lots of thirds,

including one by Jake Dickmann in the high jump (18-10) and others by Eric Turowski in the long jump (18-10), Tyler Swanson in the shot (46-8) and Kevin Schellinger in the pole vault. Schellinger cleared a personal best 12-3.

The third by Schellinger was a bit of a surprise, and a pleasant one as far as the head coach was concerned. "I was happy for Kevin," Gosa said. "He's gone 11-6 so many times I couldn't count ... he just had a really good day."

Dickmann qualified for the pole vault by clearing 12-0. "Jake didn't have a particularly good day. He's capable of better," Gosa said, stressing the sectional would be starting with a clean slate.

The foursome of Jon Komp, Zack Amerling, Dylan Kenworthy and Matt Donath placed third in the 4x200 (1:39.33), while Dan Dymond finished third in the 400 (53.97) and Dymond, Dickman, Brandon Zolp and Scott Steldt, placed third in the 4x400 (3:39.56.)

Gosa was especially happy to see Tyler McElhatton place 4th and qualify in the 1,600 with a time of 4:52.37. "His goal was to run under five minutes. He dropped 12 seconds and qualified," the coach said. "I was happy for him. He's such a good kid."

The team's other fourth came from Swanson in the discus (137-02).

## KHS golf season comes to a close except for Geidel

In competitive golf at any level, every stroke counts, and that was exactly the case for the Kewaskum High golf team last Wednesday at a Division 2 regional held at the Rolling Meadows Golf Course in Fond du Lac.

The Indians lost fourth place and an opportunity to advance to the sectional by a single shot. Kewaskum came in at 348, while Random Lake earned the final sectional qualifying spot with a 347.

"At the turn we were in second place with a 172," coach Glenn Eichstedt said. "I figured we had to play better to guarantee our spot, but actually we played worse."

The Indians will, however, be represented at the Milwaukee Thomas Moore sectional (Oakwood Golf Course) as junior Ethan Geidel was the top individual from the on-qualifying teams. Geidel fired a 78 and will advance along with Kyle Witte of Kettle Moraine Lutheran (80) and Hayden Serwe of Campbellsport (82).

"He played solid," KHS coach Glenn Eichstedt said after the 18-hole competition at Rolling Meadows where Geidel had identical scores of 39 to arrive at his 78.

Eichstedt went on that his No. 1 man had two double bogeys on the front nine, "but came back both times with birdies on the next holes."

Concerning the back nine, the coach said, "He was pretty much par or bogey all the way ... pretty steady."

University School was far and away the top team in the tournament, posting a sizzling 309 behind scores of 75, 76, 79 and 79. Even the Wildcats' non-counting score was a 79.

Dan Simonsen of University School captured the medal with his 37-38-75.

Finishing a distance second was Kiel at 337, and then came Grafton at 338. Sophomore Brandon Gries led the Kiel Raiders with a 79.

Inconsistency was a problem for the Indians all season long, and it was again the case on

Wednesday. Junior Nick Gutbrod rebounded from his disappointing effort in the Eastern Wisconsin Conference tournament to post a 41-45-86, and senior John Holt battled to card an 89, starting with a 47 and then scoring a 42 on the back nine.

Jeremy Neuenfeld was Kewaskum's other counter. He started off with a 45 but struggled on a couple holes on the back nine for a 45-51-96.

Geidel played Tuesday in the sectional, and Eichstedt said, "Basically I think Ethan has to shoot something in the mid-70s to qualify for state."

"The top two teams and three individuals in the four Division 2 sectionals advance to the WIAA State Tournament on Monday and Tuesday, June 2-3 at University Ridge Golf Course in Verona.
