Wayne resident injured after fleeing burning home



A Town of Wayne man suffered only minor injuries after escaping his fully engulfed two-story home on Sunday, March 29. The home at 8665 Midland Drive was reported in flames at 9:48 p.m. Kohlsville Fire Department initially responded to the scene and later requested assistance from Kewaskum and Allenton Fire Departments. Lt. Bruce Theusch of The Washington County Sheriff's Department reported the homeowner Michael S Van Ourkerk, was home at the time and needed to jump from a second story window to escape the fire. He was later able to evacuate several family pets by forcing a rear door from a second story. He was transported to St. Joseph's Hospital by Kewaskum Rescue for smoke inhalation and a cut to his hand. "The fire appears to have started in the basement of the residence. The homeowner noticed smoke coming from the heat registers and then tried to evacuate to the first floor, but was not able to do so after he was met by intense smoke," Theusch said in a press release. The residence and its contents were a total loss. There is no dollar estimate available at this time. The origin of the fire remains under investigation however, it does not appear to be suspicious in nature. Kohlsville firefighters were called back to the scene at 1:47 a.m. Monday morning after flames became visible on the second floor. They were then extinguished.

Electors in The Statesman coverage area have contested races in just about each election with the exception of the Kewaskum Board of Education. Electors will head to the polls on Tuesday starting at 7 a.m.

On a state level electors will choose a new state superintendent of schools between Rose Ferdinand and Tony Evers. State Supreme Court Justice Shirley S. Abrahamson is receiving a challenge from Jefferson County Circuit Judge Randy R. Koschnick.

Another judgeship will be decided for those served by the Mid-Moraine Municipal Court. Two-time incumbent John A. Grundahl is receiving a challenge from Ozaukee County attorney Steve Cain.

Due to the number of races in local townships and the village, profiles for these races could not be published. Information about each candidate can be found online.

Kewaskum Board of Education members Bruce W. Braidigan and Stephen Jensen, both incumbents will seek their second terms. This is an uncontested race.

Buth, Smith capture 2009 State Folkstyle Wrestling crowns in Madison

It was a great weekend for the Kewaskum Indians Wrestling Club, two state champions, one fourth place and seven of the nine representatives winning at least one match against the tough competition in the 2009 Kids Folkstyle Championships held at the Alliance Energy Center in Madison.

Kewaskum had the honor of taking the first title of the tournament when sixth grader Garrett Buth won his two

matches by pin Friday night at 235 pounds (1996-97). The first pin over Samuel Truhler of Hudson came in 2 minutes and 40 seconds (2:40) after taking a 9-2 lead.

Since there were just two boys in this weight class, Buth and Truhler met an hour later, with Buth recording the pin in the first period.

Zach Smith was dynamite in the two days of wrestling, winning the 105-pound weight class for those athletes born in 1996-1997. He had no competition in his first three rounds, winning by pin in 2:50, by a 12-1 ma-

ior decision and then scored another pin in 2:12 in the semis, sending him into the finals against Wausau West's Travis Hettinga.

Hettinga led in the match going into the third period and was up by one point with 20 second left when he tried a head throw, which was quickly countered by Smith, who scored the reversal for the 4-3 victory.

Smith, a seventh grader, had finished fifth in his weight class a year

Bullying expert, Bonds provides road map for schools, community

KEWASKUM- The school district received an in-depth look at bullying from someone who saw firsthand its most severe consequences.

Bill Bond was principal of Heath High School in Kentucky in 1997 when a shooting occurred. Three years later, Bond spoke about the incident and what caused it, and it turned into his life's work. Since 2000, Bond has spoken in every state in the country on defining, preventing and punishing bullying.

At Monday night's presentation to about 65 community members, Bond said bullying "joking around."

"There's nothing wrong with joking around. It's part of being a human," he said. "But there's a fine line."

Bullying behavior must include four elements, he said: an imbalance of power, often repeated, the victim is humiliated and the perpetrator enjoys the humiliation.

While hurtful words are sometimes shared even among friends, Bond pointed out a difference.

"Friends don't go there again," he said.

Bullying happens when someone goes after the tender spot again and again, he said. When investigating cases of bullying, Bond said the two subjects should be interviewed separately in different rooms. Whether or not it's decided bullying took place, "you can always support the target or victim," he said. That is more important than consequences for the perpetrator, he said.

Bond advises to focus on the behavior of students and to be careful not to call them bullies.

"If you are constantly labeling a kid, that kid is going to live up to your expectations," he said. "The power of expectation is stronger than the deterrent of consequences."

When punishing bullying behavior, the "certainty of consequences" carries more weight than the severity, he said.

Techniques differ between boys and girls, he said. Boys tend to hit, kick, spit, taunt, use racial slurs, threaten and use obscene gestures.

Girls will get someone else to do the bullying, spread rumors or deliberately hurt someone by excluding her.

While boys make up about 70 percent of all bullying, the girls' tactics create twice as many problems for administrators, teachers and students, he said.

At least those problems adults can point out and address. A new type of bullying

allows for constant harassment that adults may not hear about until it's too late, and it's happening in their own homes.

Cyberbullying provides a new and different opportunity for children. Power over someone is unnecessary, it takes no fortitude - just typing - and it has no negative peer reaction. Two more key elements set it apart, Bond said. Teens see it as anonymous when it really isn't, and the bully doesn't know when "enough is enough."

Nothing on the Internet is anonymous to someone who wants to find where an e-mail came from badly enough, Bond said. Children don't understand that.

Beyond that, bullies don't know when to stop because "he's never seen you, never seen the pain he's causing."

Victims cannot escape cyberbullying as easily, either. Students used to go home to a safe haven of their families. With computers, children can be bullied right under their parents' noses.

Children, however, won't tell their parents they're being bullied for fear of losing computer or cell phone privileges - their social life.

"That's where I encourage you to have a talk with your kids," Bond said.

The relatively new hot-button technique, "sexting" - sending lewd photos of themselves or others to classmates and friends - is a new way of bullying. Bond said a girl in Missouri sent a topless photo of herself to her boyfriend. Once they broke up, he sent it to six of his friends and she was picked on at school.

It came so bad the girl committed suicide.

All but eight states have state bullying laws, Bond said.

Wisconsin does not, but the Kewaskum School District has a bullying policy so it's ahead of the game.

Superintendent Michael Krumm worked with Bond in Iowa and had what Bond called one of the best anti-bullying programs in the state. Krumm was happy to bring Bond to Kewaskum for \$1,500.

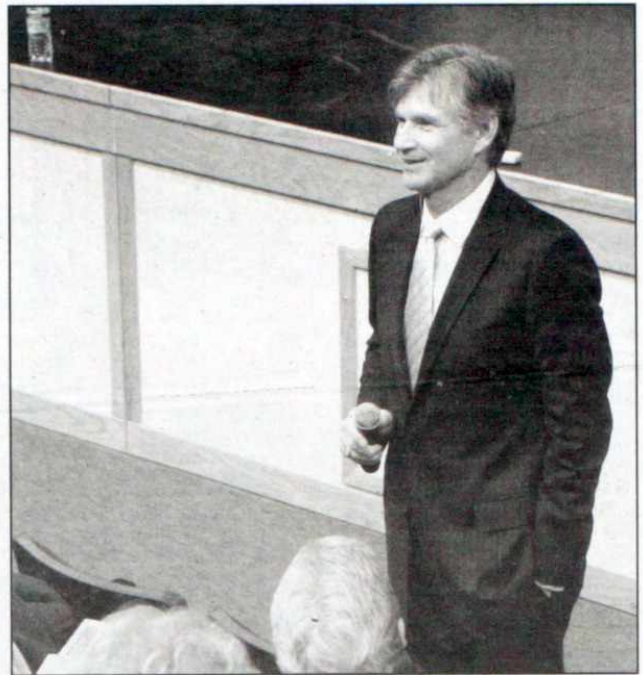
Krumm said the district has been working on bullying. "It's bullying prevention rather than reaction," he said.

On Monday, Bond met with school administrators and staff, and community emergency workers before talking to the public at night. For staff, he discussed in detail the shooting incident.

"You should hear a pin drop," Krumm said.

Tuesday, Bond met with student council members from the high school and middle school.

Bond said speaking on bullying is his way of "trying to get something positive out of a negative situation."

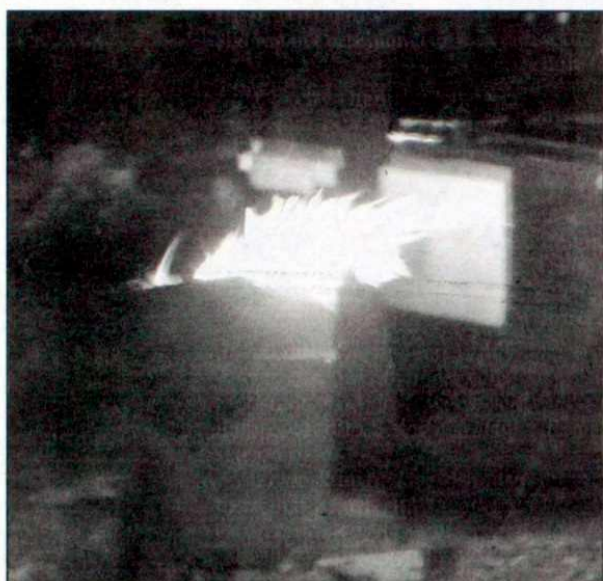

TOWN of KEWASKUM- The supervisor's position is a three-man race, while Chairman Ellis Kahn, Treasurer Daniel Stoffel and Clerk Nancy Boden, are all running opposed for their respective positions.

Allen Hron has been on the town board for three years, and seeks another term. Hron owned and operated Allen Hron Jewelers in West Bend for 35 years and is now retired.

"We are not interested in growth for growth sake. We would like to maintain our rural environment and encourage farming," Hron said. "Our new zoning will encourage those who want to develop in the future to do limited development in the Town. That would increase our tax base and prevent annexation to the Village."

Hron also stated that his action plans for the next two years include: restoring and resurfacing a number of town roads and shoulders however, that may take more than two years. Road projects for him mean performing some ditching and removing large rocks along some roads due to snowplows hitting them and causing damage.

Hron also wants to continue working in the road right-of-way.

The restoration and clean up of some town cemeteries is also on the to-do list for Hron.

"The number one issue as a supervisor is to protect the health and welfare of the people in the town," Hron concluded.

Daniel H. Schmidt was appointed to fill a seat vacated by William Butzlaff Sr. on September 12.

Wayne Township election full of challengers

TOWN of WAYNE- Just about every office is contested with the exception of town treasurer in Wayne. After long-serving supervisor Keith Kriewaldt filed for non-candidacy in December, a number of challengers stepped forward to challenge appointed supervisor Michael Samann.

In his first election, Michael Samann reported he would have the following issues on his mind if given the opportunity to serve a full-term: Spending "it's important to maintain what is in town." He reported that while serving as supervisor the town was able to cut and lower taxes.

Samann wants to finish the smart growth program and address concerns with development. He felt as supervisor he would keep town running effi-

ciently and keep taxes in order.

A resident of the town for over 50 years, Art Filber doesn't forsee changing a lot with the town. He is against taxpayers paying for repairs in subdivisions because of a developer's poor engineering.

"I would like to preserve this township in the way of agriculture, wildlife habitation, wetlands and our glacierized drumlins, kames and eskers," Filber stated.

Kriewaldt stated she wanted to

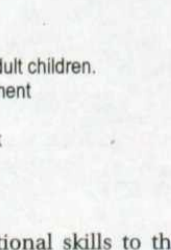

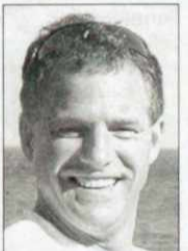

Even though I am unopposed this year, I would like to take this opportunity to let people know what I have worked on for the past two years.

One of the biggest projects is the Batavia Sanitary District. I met with the citizens advisory members and together we regrouped and got the project going again. We hired an engineering firm who is doing positive things for us and has a good working relationship with the DNR, unlike the last one. We have gotten all the repairs done downtown, and everything has been gone through with the camera.

We are now to the point of picking the new system for the drain fields. The warranty was never honored on the old system so I got a contact with Petri's office who has really gone to bat for us. He had us submit for keynote money last year using the warranty as leverage. We were put on the list, but at the end of the year the government threw out all the keynote money. We have resubmitted for this year and are again on the list. If we are lucky, it will pay for the new system.

I am also in the process of applying for stimulus grants for "shovel ready projects." I got the emergency government plans going again, which is required by the government, and had sat idle for two years. I have an election day plan in place and have now been joined by another board mem-

ber, and we are in the process of finishing the rest of them.

I am on the committee for the re-codification of our town ordinances to clean them up and make and keep us state compliant with new ordinances. Money has been budgeted for this but nothing had been done yet. This committee includes a town citizen, and we are now waiting for paperwork to come back so we can move on to the next step.

I have been actively involved in the smart growth plans, and have gone to several seminars for farmland/open space preservation and land use. This will help me to incorporate this into the smart growth plans with the rest of the board. I also joined the county smart growth agriculture committee, which will help me tie the two together, and to learn about the new programs that are coming for our area farmers.

One year into my term I was assigned to supervisor of roads. The previous supervisor left us with no salt contract and no trip money. I now have us back on the state list for salt, and am in the process to apply for trip money again.

I am also looking to see if we can obtain any stimulus money for road projects. I feel the road crew and I have developed a good working relationship and improved communication to create a more positive working atmosphere, and an improved course of action toward our road maintenance.

On three instances I have gotten together with citizens to help settle minor disputes without dragging it through a town meeting. I have also prided myself in receiving and returning phone calls from citizens, good or bad, and have attended all planning commission meeting for the last 3 1/2 years.

I am looking forward to finishing projects I have started, and taking any other problems and projects that may arise in the next two years. As always I will take and return all phone calls from citizens to address their concerns.

I would like to thank everyone's support of my first term and hope I can have your support again this time, even though I am not contested.

I would also like to mention that I will be supporting Steve Jung for chairman. The reasons being that in the last eight years of his term he has paid off a huge debt from the previous chairman and gotten equity back into the town finances without raising taxes. I feel this is a great track record. I have also gotten good support from him on sanitary district issues, farmland preservation, and on the roads department.

We need people to get out and vote to preserve the positive things in our township.

Again I thank you all for your support.

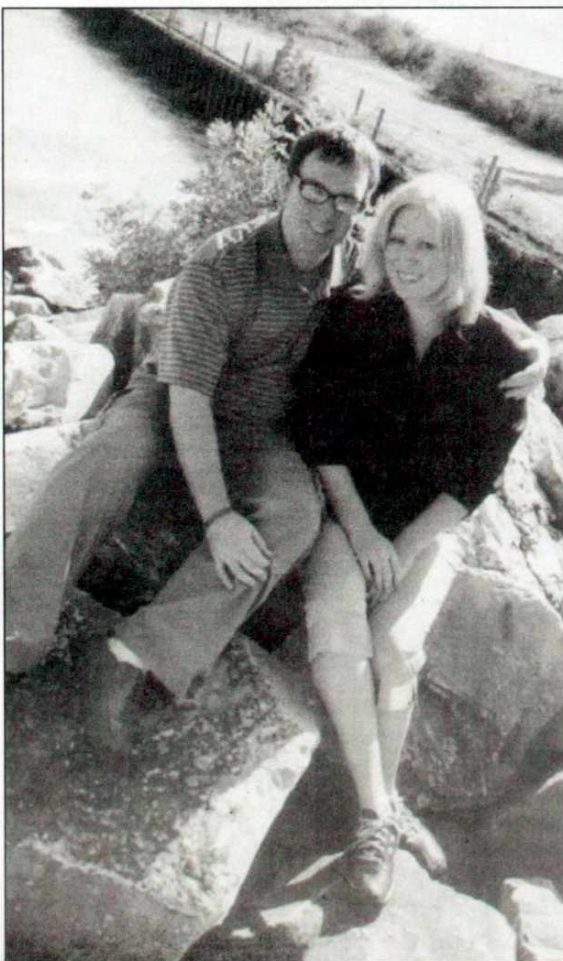

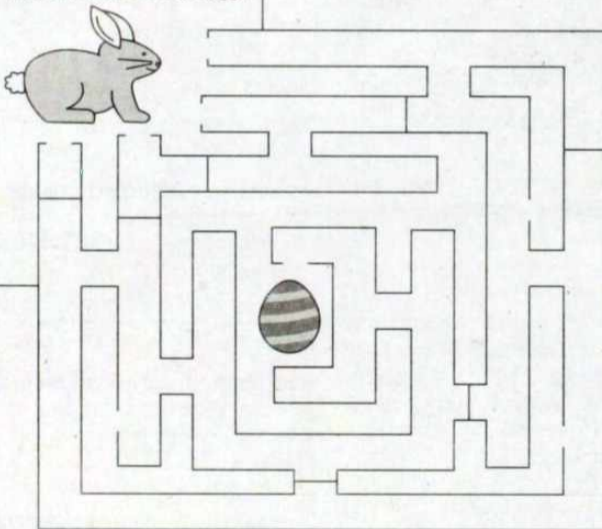

Upon being permitted to vote, the elector shall retire alone to a voting booth and cast his or her ballot except that an elector who is a parent or guardian may be accompanied by the elector's minor child or minor ward. An election official may inform the elector of the proper manner for casting a vote, but the official may not in any manner advise or indicate a particular voting choice.

At the spring election, where optical scan voting systems are used, the elector shall fill in the oval or connect the arrow next to the name of the candidate of his or her choice for each office for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall write in the name of the person of his or her choice in the space provided for a write-in vote and fill in the oval or connect the arrow on the write-in line. On referendum questions, the elector shall fill in the oval or connect the arrow next to "yes" if in favor of the question, or the elector shall fill in the oval or connect the arrow next to "no" if opposed to the question.

Where touch screen voting systems are used, the elector shall depress the button next to the name of the candidate of his or her choice for each office for whom he or she intends to vote. To vote for a person whose name does not appear on the ballot, the elector shall type in the name of the person of his or her choice in the space provided for a write-in vote. On referendum questions, the elector shall depress the button next to "yes" if in favor of the question, or the elector shall depress the button next to "no" if opposed to the question.

The vote should not be cast in any other manner. If the elector spoils an optical scan ballot, he or she shall return it to an election official who shall issue another ballot in its place, but not more than three ballots shall be issued to any one elector. If the ballot has not been initialed by two inspectors or is defective in any other way, the elector shall return it to the election official, who shall issue a proper ballot in its place. Not more than five minutes' time shall be allowed inside a voting booth or machine. Sample ballots or other materials to assist the elector in casting his or her vote may be taken into the booth and copied. The sample ballot shall not be shown to anyone so as to reveal how the ballot is marked.

After an official mark sense optical scan ballot is marked, it shall be inserted in the security sleeve so the marks do not show. After casting his or her vote, the elector shall leave the booth, insert the ballot in the voting device and discard the sleeve, or deliver the ballot to an inspector for deposit. If a central count system is used, the elector shall insert the ballot in the ballot box and discard the sleeve, or deliver the ballot to an inspector for deposit. The elector shall leave the polling place promptly.

After an official Touch Screen ballot is marked, the elector shall leave the polling place promptly.

An elector may select an individual to assist in casting his or her vote if the elector declares to the presiding official that he or she is unable to read, has difficulty reading, writing or understanding English or that due to disability is unable to cast his or her ballot. The selected individual rendering assistance may not be the elector's employer or an agent of that employer or an officer or agent of a labor organization, which represents the elector.

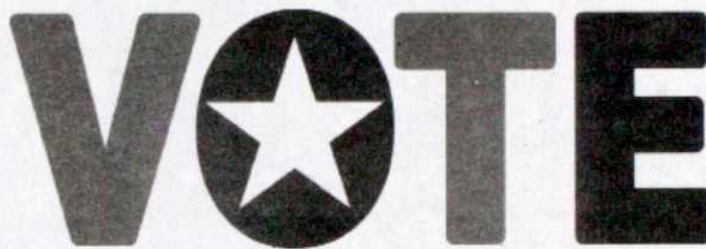

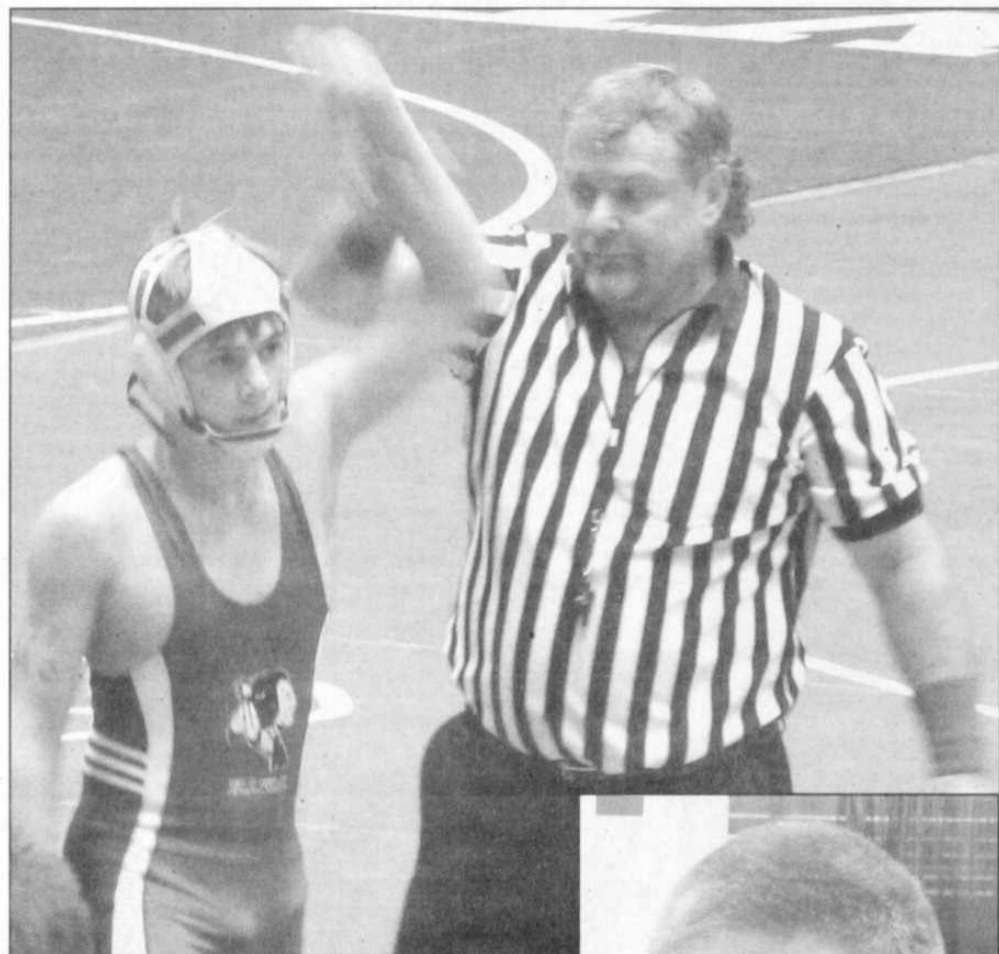

Spring turkey season opens April 15

MADISON - With the April 15 opening of the 2009 Spring Wild Turkey Hunting Season just around the corner, state wildlife officials say hunters should be able to look forward to a good season, and they are encouraging experienced hunters to consider taking a youth out during the April 11-12 statewide Turkey Youth Hunt.

"From the information we've gathered during annual surveys, the wild turkey population generally continues to be healthy and in good numbers despite the harsh winter and spring conditions of 2007-2008," said Scott Hull, Department of Natural Resources Upland Wildlife Ecologist. "The preliminary results of the 10-week brood survey does indicate a decrease of 12 percent in the number of broods observed compared to 2007, but the 2008 average is still well above the long-term mean."

More than 154,000 spring turkey permits were issued in the preference drawing for the spring 2009 Wisconsin wild turkey season. Approximately 70,900 leftover tags were available for sale on a zone-per-day basis beginning this March 23. In total, more than 225,000 permits were made available for this spring's hunt, a modest increase from the 2008 season

where nearly 213,000 permits were offered.

This will also mark the first spring turkey season under the new seven zone structure. The zone consolidation was rolled out during last fall's turkey season. Fewer, larger management zones will ultimately give hunters more flexibility to move about in search of wild turkey. Hull also noted that while the overall turkey population is generally very healthy, within the larger zones, hunters may see areas where populations increased and others that will be down a little from last season.

There were more than 208,500 permits issued for the 2008 spring season and hunters harvested a record 52,880 turkeys with a success rate of about 25 percent. Spring season success rates over the past few years have been in the 23-25 percent range.

"With a little cooperation from Mother Nature, we can expect to see the hunter success rate remain relatively stable," Hull said.

The 2009 spring turkey season starts on April 15 and consists of six, five-day time periods that end on May 24.

**YOUTH TURKEY HUNT
APRIL 11-12
The 2009 Turkey Youth**

Hunt occurs April 11-12 statewide. The two-day spring youth hunt, successfully initiated in 2007, occurs each year during the weekend preceding the opening of the regular season. The Youth Hunt allows opportunity for close one-on-one mentoring of future hunters in a relaxed atmosphere without competition for hunting spots from regular season hunters.

"Study after study has shown that it takes a hunter to make a hunter," said Hull. "With all the activities available today, spending time with a youth, passing on your skills and passion for your sport can be a big step toward nurturing a lifelong commitment to conservation of our wildlife resources."

There is no special application procedure for the youth hunt, and young hunters must either apply through the lottery drawing for a tag or purchase a left over tag. During the two-day bearded hunt, only one male or bearded turkey may be harvested per hunter regardless of the number of permits issued. Anyone interested in the youth hunt can find additional details in the spring turkey hunting regulations or on the DNR Web site.

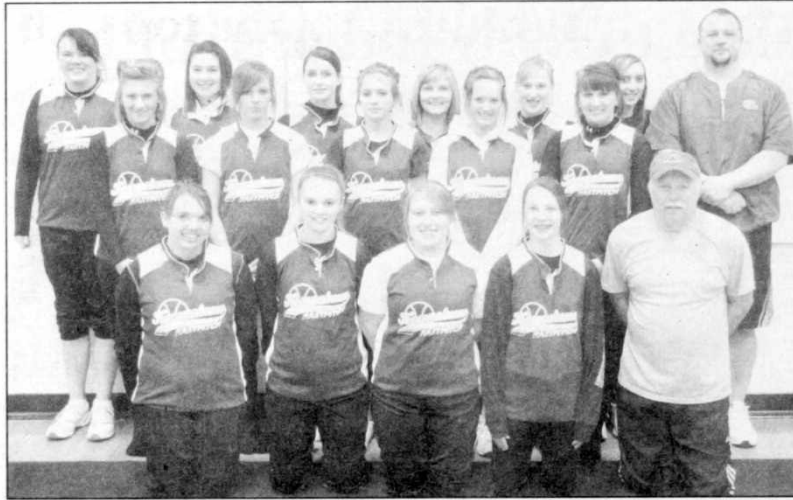

If you could only use one word to describe this year's girls track team at Kewaskum High School, potential would be that word.

That being said, hard work and a winning attitude will still be needed for the Lady Indians to challenge for the Eastern Wisconsin Conference (EWC) title, which defending champion Plymouth also undoubtedly has on its list of 2009 goals.

"Some of the girls were lamenting ... they thought last year was our year to make a run at the title, but I'm trying to convince them they have a good chance this year," coach Jerry Gosa said. Gosa has a good number of seasoned veterans returning, including 15 letter winners and three of the girls who won the WIAA Division 2 4x200 relay title last June in La Crosse.

Back are Hailey Gregoriou, Jessie Liniewski and Nichole Kison from the foursome that carried the baton to a time of 1 minute, 45 and 62 seconds (1:45.62) for a state title. In the trials, they were even faster, running a 1:45.25.

"They smashed the school record in the process," Gosa said, reporting the lone graduate on the foursome, anchor Kelly Uelmen is participating in track at UW-La Crosse.

Gregoriou, Liniewski and Kison are all multiple-event

track athletes. Gregoriou began hurdling the middle of last season and became very proficient in a short period of time.

"We need her to score points in that event," Gosa said, "her and Alissa Clapper," who is also the team's top pole vaulter, advancing to the state meet. The state competition produced disappointment after Clapper's pole broke and she was unable to clear 9-0 with another pole.

Liniewski can run relays, the open 200-meter dash where she is the defending EWC champion, and she is a fine high jumper, while Kison can run a strong 400 and does well in the long jump, along with being on the relay.

Gosa is convinced the high jump will be one of the Indians' strengths, especially in big meets when teams are allowed to have three competitors in several events.

Candace Beine is back as a jumper — she advanced to the state meet and has cleared 5 feet (5-0) and "I think Amanda Witek will do well in the high jump" after missing last season because of a residency issue.

Other returning letter winners among the 43 candidates on the team include: senior Lacy Taylor; juniors Steph Abramovich, Jessica Beaupre, Heather Schmitt, Megan Thornton, Karla Stoffel and Brooke Waala; and sopho-

mores Bryana Keller and Ashley Roeske.

It was hoped senior letter winner Jessie Forbes, a sprinter, would recover from a leg injury, but she is still not 100 percent, according to Gosa, who said her status is unknown at this time.

Waala, Thornton and Schmitt run the middle distances, and Gosa said, they were involved in spinning classes in the off season. "They did their winter workouts, and it shows."

Disappointing is the fact some of the distance runners, regulars on the team last season, did not come out this season. The good news, however, is there are some newcomers who look very promising, starting with junior Anna Butler.

"She was out for softball the last two years," Gosa said, indicating some of the other girls on the track team talked her into coming out for track, and, "She shows she has what it takes to be on the relay. She runs well and could be in the hundred (meter dash)," Gosa said.

Sophomore Sarah McWilliams is out for the first time after running in middle school. She could help in the 400, according to Gosa, who said, freshman Megan Ringwell "is running very well," and Sabrina Boehlke, another freshman, is showing promise in the middle distances.

Taylor is one of the few girls returning in the weight events, so help might be needed there. This is a concern like the two long distance events.

"Last year we were second in the Eastern Wisconsin behind Plymouth. Really our sprinters handled everyone in the conference, but Plymouth was tougher in the distance events," Gosa said. To overtake the Lady Panthers, the Indians

will have to dominate the relays and score double points in events such as the 400, high jump, hurdles and long jump.

After running in the annual Titan Invitational on March 31 in the Kolf Field House on the UW-Oshkosh campus, the Indians head to Plymouth for their first outdoor competition, a quadrangular event, on April 14th.

Like a large family trying to budget in these tough economic times, the Kewaskum High School boys track team will be stretched a little thin this spring. There just aren't enough boys out for the sport to go around for all the events.

"There are just gaps all over the place," Coach Jerry Gosa said in previewing his squad.

Gosa has plenty of quality in events like the pole vault, high jump, open 400-meter run and relays, then there's the fact the team has no hurdlers, few distance runners and not much depth in the weight events where he lost state qualifiers, Ben Boettcher and Tyler Swanson, who both graduated.

Starting with the bright spots, the Indians return nine lettermen, including seniors Jake Dickmann, Nick Olla and Eric Turowski, juniors Josh Boettcher, Tim Hall, Zach Herriges, Scott Steldt, Danny Treptow and Brandon Zolp.

The veteran Gosa is eager to see what Dickmann can do this year after he cleared 13 feet (13-0) in the pole vault and advanced to the WIAA Division 2 State meet a year ago.

Gosa is betting Dickmann has his sights set on 14-feet, the current school record which is currently held by Garrett Donath and Josh Parrent, who is now the pole vaulting coach at KHS.

"Josh is coaching again," Gosa said, pleased Parrent is currently working on constructing a new hospital in Grafton, so he will have a

shorter commute from work to practice each day.

Dickmann also will compete in the high jump, but in both events, there are very few backups.

"We better find some new people," Gosa said about vaulting and high jumping.

Add the weights in that mix also, although Josh Boettcher, Ben's younger brother, has some potential.

A year ago, there were plenty of 1-2 finishes by Ben Boettcher and Swanson in the discus and the two often added places in the shot.

Boettcher had a great year until he got to state and had trouble getting in a legal throw and failed to place among the top six. "He had one good throw that might have won it, but he had a little bit of a toe scratch," Gosa said, adding Swanson was "at or near his best and finished 13th in La Crosse. Ben Boettcher did set a new school record at Sectionals with a toss of 178-7.

Turowski, a rare three-sport athlete at KHS, will try almost any event if it will help the team. He works in the long

and triple jump and also can help in the 4x200 relay.

Olla, who first came out for track as a junior, is also an asset. He is expected to run the 4x200 relay, the 4x400 relay and perhaps the open sprints.

"Track helped him a lot in football. Coach Piittmann couldn't believe how much faster he was last fall," Gosa said, happy to see Olla out for his senior season.

As far as the top juniors, Steldt and Zolp head the list. Both are excellent 400 runners, and their goal is to find two others who want to qualify for state as much as they do.

"Newcomers Mat Toles (junior), Lucas Kopeschka (sophomore) and even Bo Seibel (sophomore) ... all three of these guys have the potential to make the four by 400 relay and give it a state shot. There's some pretty keen competition there," Gosa said, also looking at Collyn Sprinkmann as a possibility.

The junior Herriges can be counted on to score some big points in the 800, 1,600 or 3,200, according to Gosa, who said, "He's the best (distance)

athlete we've had in a long time."

The trouble is he is one of only a few distance runners as there is little help from any of the cross country runners.

"We have no hurdlers," Gosa said, adding, "We're going to be hurting in sprinting, but maybe they will come along."

As far as who will be strong in the Eastern Wisconsin Conference, Gosa said, "I've heard the numbers at Two Rivers are way down. New Holstein is down ... Kiel is where they usually are," Gosa said. "It looks

like the conference could be a little more wide open, but I wouldn't doubt Plymouth will be the team to beat."

Gosa, who handles the sprints and relays, will again be assisted by Jason Meinen (jumps), LuAnn Potter (hurdles), Randy Backhaus (distance events) and Matt Gundrum (weight events).

Kewaskum will host its annual Indian Invitational on Friday, April 24.

Piwoni thinks the team's biggest challenges will be from state runner-up New Holstein, Sheboygan Falls and Plymouth.

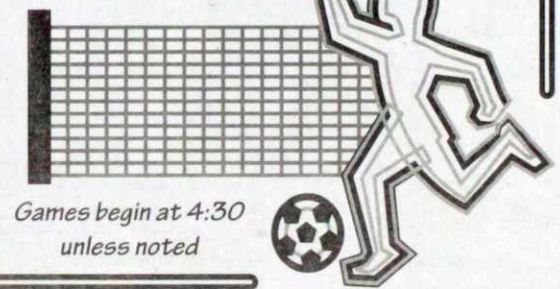

Coach Glenn Eichstedt may wear out an eraser penciling in his starters for the last three spots on this year's Kewaskum High School boys varsity golf team, but seniors Ethan Geidel and Nick Gutbrod are pretty indelibly set at Nos. 1 and 2.

"Last year, we didn't have the depth (we needed.) This year it's an unknown as well," Eichstedt said last week as he prepared to begin his 11th season here.

Kewaskum had to settle for third in the Eastern Wisconsin Conference (EWC) standings (after taking sixth in the EWC Tournament), and the Indians failed in their bid to advance as a team to a WIAA Division 2 regional. These are the only two returning letter winners, as Jon Holt, Paul Marchant and John Beisinger have all graduated. Possible replacements could include Jeremy Neuenfelt, who played some varsity golf after Beisinger was injured

his rounds and forced him to settle for 38th place with a 36-hole total of 172 (82-90).

"He had not been hitting his driver very well," the coach said, then in an attempt to compensate for the hooking, he hit a late drive on the first day which sailed far right, and he needed several more shots to get back in the fairway.

Concerning the top contenders in the EWC, very quickly Eichstedt said, Yeah, well the Plymouth Panthers are. They are and always will be (contenders)" after winning titles 22 out of the past 23 years.

"They (Panthers) have three regulars back," he said, also noting Kiel could be good if they find players to back up

junior Brandon Gries, who is "a very good athlete."

Waupun and Two Rivers could be considered dark horses, according to Eichstedt, who will again be assisted by Scott Rohlinger, starting his 12th season as JV coach.

depends on the third, fourth and fifth players," Eichstedt said.

The Indians linksmen opened practice on March 30th. Their first meet is the Washington County Meet on Saturday, April 11 at the Washington County Course near Hartford.

Dickmann, 400 runners are crisp in Oshkosh's Titan Invitational test

OSHKOSH- Plagued once again by a lack of depth, the Kewaskum High School boys had little chance challenging for the title at the annual Titan Invitational, but one individual sparkled and others showed encouraging signs in the smaller school competition.

Senior Jake Dickmann cleared 12 feet, 6 inches (12-6) to place second in the competition held recently at the Kolf Field House on the UW-Oshkosh Campus.

Luxemburg-Casco was the easy team winner, amassing 67 points, nearly 20 ahead of runner-up Little Chute, which finished with 47.50.

"It's a nice accomplishment (for both of them)," the coach said.

Other KHS points were scored in a relay race. In the 4x400 relay, it was Dickmann,

Sheboygan suits Indians fine, boys 4th, girls 7th at invite

When the annual Washington County Indoor Track Meet was canceled, Kewaskum Indians coach Jerry Gosa was looking to fill the early-season hole in the schedule and came up with a good replacement - the Sheboygan North Invitational.

The Indian boys finished third in the 12-team competition held on March 21, scoring 74 points behind only Little Chute (83 points) and Oak Creek (83.5).

A day earlier, the Lady Indians came in seventh with 49.7. The host Golden Raiders piled up 103 points to win top honors, while Little Chute was next with 96.5.

"We were a little surprised by that, considering there were only a dozen boys there," Gosa said about the boys' finish. Obviously he meant pleasantly surprised because his team came away with two firsts, and four second places.

Senior Dickmann went 5-feet, 8 inches (5-8) to win the high jump and cleared 12-0 to take second in the pole

looked to earn 18 of the Indians' points.

The other KHS winner was junior Scott Steldt, who raced to a 55 and .59 second (55.59) clocking in the open 400-meter run. This was a very good event for the Indians, who also got a fifth place from Brandon Zolp (57.95).

Junior Zach Herriges looked very good in the 1,600-meter run, taking second with a fine time of 4:58.57, while the foursome of Nick Olla, Eric Turowski, Eric Perkins and Jordan Blank combined for a 1:23.31, good for runner-up honors in the 4x160-meter relay. (A lap in the Sheboygan North track is 160 meters.)

Gosa was pleased with the efforts of Steldt, Dickmann, Tim Hall and Zolp in the 4x400 relay. Their time of 3:56.87 was also good for a second place, and the quartet of Olla, Turowski, Mat Toles and Collyn Sprinkman had a clocking of 2:11.15 in the 4x200 relay, good for third place.

Other top-eight finishes included: 200- Steldt, 7th, 26.08; Zolp, 8th in 26.33; long

jump- Turowski, 6th, 18-04; and Steldt, 6th, 18-03; and shot put- Josh Boettcher, 6th, 39-1.5.

The girls ran into some competition, but once again, Alissa Clapper did well. She posted the best jump in the pole vault, clearing 9-0. She tried for the school record at 9-9 but was not close on her three attempts, according to Gosa, who said 9-0 was good, considering the few days the girls have had to practice.

There was one second, coming from the foursome of Hailey Gregoriou, Jessie Liniewski, Nichole Kison and Clapper in the 4x160 relay. Their time was 1:38.37.

In the 4x400, it was Heather Schmitt, Megan Thornton, Rachel Yocum and freshman Megan Ringwell notching a third place in 4:47.05.

Liniewski cleared 4-8 in the high jump, putting her in the fourth spot, while Lacy Taylor tossed the shot 30-01, good for fifth.

Gosa was delighted with the fifth by the 4x800 relay unit of Brooke Waala, Jessica Beaupre, Steph Abramovich

and Sarah McWilliams. They had a time of 11:36.77.

Waala also ran in the open 800, taking a sixth behind a time of 2:52.63.

Triple jumper senior Candace Beine placed fifth on a jump of 30-7.50.


Big points were expected from the 4x200, but on one of the exchanges, "We ran smack

into the back of somebody," Gosa said, and that pushed the team (Gregoriou, Liniewski, Kison and Butler) back to eighth place in 2:38.93.

Other top-eight places came in the following: long jump- Schmitt, 6th, 14-5.25 and Kison, 8th, 13-07.25; and 400- Schmitt, 8th, 1:09.61.

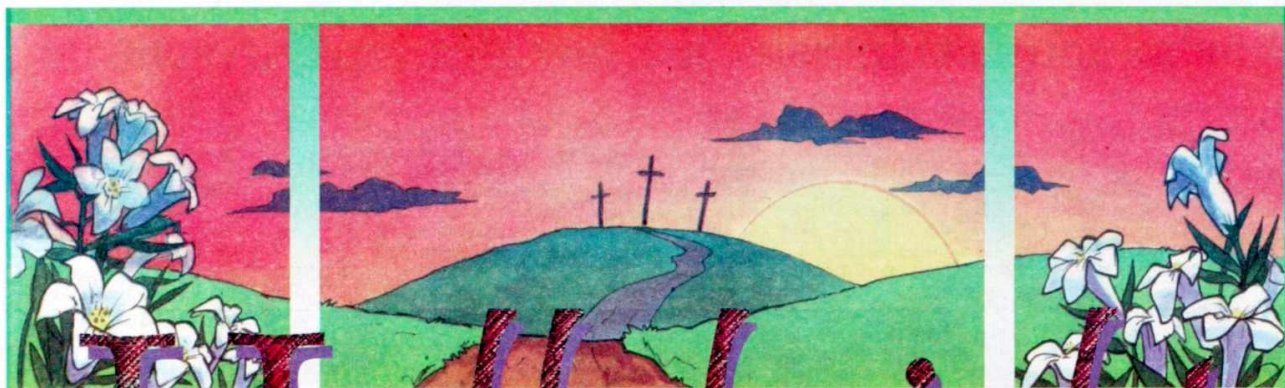
