County radio system upgrade ready in March

WEST BEND- The Washington County Sheriff's Department radio system is in testing stages with plans to be fully implemented and working next March.

The \$14.6 million system is coming in \$3.2 million under budget so far, said County Sheriff Dale Schmidt.

The system replaces the present county system covering the sheriff's and highway departments, which is past its lifespan and is having operational issues, including breakdowns, Schmidt said.

The new system will cover the same two departments and municipalities in the county, replacing their individual systems as well.

"The idea is just to replace all of those systems with one system," Schmidt said.

The county is paying for the entire system.

The system is now in testing stages covering the entire county.

A glitch was found last week on a tower in the town of Erin. The county's line interfered with a private Internet provider's line because the private company's line was unshielded.

"This blindsided us," said Project Manager Joe Caruso of Harris Corp., the company installing the radio system.

The county's Radio Communications Systems Committee was none too pleased to hear of the glitch at its August 6 meeting, and was concerned with what it would cost to fix the problem.

Since then, in order to keep the project moving, Schmidt gave Harris the go-ahead to replace the cable with a shielded cable for \$8,800.

The county originally contracted with Tyco Electronics for the job. A few months ago, Tyco was bought out by Harris Corp. of Melbourne, Fla.

While the project is a "tremendous amount of work" for the Sheriff's Department, county attorney and others, Schmidt said the new system will provide new capabilities and improve communication.

Parents prevail in grading grapple

Procedures will remain unchanged this year

KEWASKUM- After parents in the School District took umbrage over the fact students' grades would no longer be affected by cheating and late work, the district stated Friday the current grading procedures would remain in place. How long that policy will remain is unclear as the district will continue meeting with education consultants, first in November.

The reversal came after three listening sessions the night before where parents voiced their disgust in the idea. Approximately 50 parents and community members attended the listening sessions moderated by district principals on Thursday, August 6.

The community became incensed last month after High School principal Christine Horbas authored an article regarding changes in the grading procedures for the new school year. Within a week the district had a new piece ready to put in front of the community.

"That article was inappropriate, it was not informative enough and the way it was stated led to some misconceptions. I apologize for causing so much ruckus in the community,

that was not my intent," Horbas began.

School district administrators are looking to join many school districts across the state by implementing Standards Based Grading. The district got on the Standards Based Grading bandwagon after Superintendent of Schools Michael Krumm brought Canadian Education Consultant, Ken O'Connor, a.k.a. The Grade Doctor, who presented a seminar for teachers in April. The district also referred to Tom Guskey, another education consultant.

The district's leadership team had eight of O'Connor's 15 guiding principles they wished to implement. 1- Don't include behaviors in grades (effort, adherence to classroom rules, etc.). 2- Don't reduce marks on "work" submitted late. 3- Don't give extra credit or bonus points. 4- Don't punish academic dishonesty with reduced grades; re-access and use an alternative consequence. 5- Don't consider attendance in grade calculation; allow for make-up of work. 6- Don't include group work in scores. Assess students using individual achievement even in a group project situation. 7- Don't assign grades

based on a student's achievement compared to another student. Always grade based on pre-determined performance standards. 8- Don't average grades with zeros for missing work. Use in-completes and allow extra time or alternative evidences to determine a student's achievement.

In a prepared statement released Friday, Krumm and Board of Education President John Kenworthy certified that feedback from the listening sessions pointed the Board of Education and himself to concentrate on six points, removing the points regarding cheating and late work.

During the listening session, Horbas pointed out that in her estimation half of the school districts in the state are moving to standards based grading. She attributed this shift because legally teachers must separate behaviors from academics.

In checking with the Wisconsin Department of Public Instruction, late work and cheating are not measures of academic performance. Thus, to be in accordance with state law, they would need to be removed from the grading process. However,

Kewaskum grading grapple

er, there is not a general law on 'grading,' it is a local decision generally guided or set by school district policies.

"As far as I am aware, there is no state law that specifically references cheating in schools," stated DPI Communications Officer Patrick Gasper.

At the 8 p.m. meeting, parents were most concerned with the removal of downgrading for cheating and late work. Parents also asked the administrators for consequences to cheating and late work if grading was not affected but administrators failed to give a clear answer.

Lori Olla stated that it was her understanding that if students are caught cheating in college, they are walked off campus. She questioned that if cheating is not punished, "Is that real life for these kids?"

Maggie Buck agreed, "I'm sorry, but by high school, if my student is caught cheating he should get a zero."

Middle School principal Ken Soerens stated, "I wish that giving F's would force change, in my 35-years (as an educator) it just doesn't happen."

Parents Doug and Karen Gonring and Jon and Lori Olla said talk had already started among students who were thinking how to make the most of the new procedures/policies.

"If a student gets caught cheating they know they can re-take it," Lori Olla added.

Horbis reasserted the consequences for cheating will be severe. She explained that since attendance could not be attributed to a grade, they put the consequence of a municipal truancy citation to students who skip or do not attend school. "Other consequences do work, you don't need to have that embedded in the grade," she ensured.

Kewaskum Elementary School Principal Tom Fischer stated after the meeting that cheating at KES would land a student with recess detentions and informing parent/s and another assessment (of the student's knowledge).

Horbis added, "We're going to be making them retest and show us what they know instead of just giving them the zero."

Irritated that teachers

would give more opportunities to students who didn't study or meet certain requirements than those who did the required work and showed up for class, Doug Gonring stated, "What about all the other kids that met the requirement within the timeframe you required, why aren't those kids looked upon better than a kid that comes in and can do something else, you're giving a bunch of kids an opportunity to be a success that have not done the requirements in a timely fashion. Don't give him the same grade as somebody who busted his butt all year long."

Parents were told that make-up and re-tests were endless. When asked how many times a student could retest, Horbas replied, "How many times do you need to prove you are proficient?" When prompted if that meant endless, Fischer said, "That could be a possibility." He went on to say the reality of that happening was unlikely.

KMS principal Ken Soerens stated he was offering re-takes 15 years ago as a history teacher at KHS. The amount of students taking advantage of the opportunity was "minimal" he explained.

Jon Olla stated he thought instead of changing things for the students, principals should be working with the teachers to somehow develop a grading standard.

"You're throwing the kids in this thing when it should be the teachers," he stated.

Kewaskum is not the first district to receive disapproval for the items O'Connor advises against. The Hernando County School District in Florida put the brakes on implementation of O'Connor's practices much like Kewaskum after a flurry of

residents in that district adamantly opposed the change in grading there.

The leadership team will now continue their investigations and attempt to create a grading standard for students in the district. Curriculum Coordinator Anne Ignatowski stated Tuesday a representative from Marzano and Associates will speak to district staff on November 6.

According to their website, Marzano Research Laboratory associates are individuals trained by Dr. Robert J. Marzano who specialize in long-term school reform efforts with K-12 public and private school districts and individual schools for the purpose of enhancing student academic achievement.

"The person we have secured specializes in working with school staff to assist in the development of standards by which to grade," Ignatowski explained. "This presenter will be helping the teaching staff understand what quality standards are and to assist in the process of developing these standards," she concluded.

Also being worked on in the coming school year is a new report card for the high and middle school. Horbas explained, "It will separate work/character traits from academic achievement. Teachers will give the student a grade in the subject matter and also a grade in four work/character traits. A, B, C, D, and F will still be used for academic achievement. Additionally, each academic area may break out the separate learning standards and the student's progress in each. I am not sure if the same code will be used for the work/character traits."

Hillside Drive project complete in village

MILWAUKEE- Capitol Drive Lutheran Church (CDLC) of Milwaukee has partnered with Brick by Brick for Tanzania!, Inc. on a mission to build pre-schools in that region. The church recently presented a check for \$6,500 for a preschool in the King'ori region of Tanzania.

Through an innovative on-line website auction, Project 12 Baskets, members of the congregation auctioned off personal goods and unique items to raise money for the cause. Supplementing this on-line effort was an ongoing Sunday morning bake-sale.

Enthusied by the success of these projects, Linda Jaeger of CDLC took the project to Principal Dwayne Jobst at Milwaukee Lutheran School which also became actively involved by offering all of its April offerings to the King'ori School. \$1,000 of the \$6,500 raised came from donations from Milwaukee Lutheran's high school students.

Manure handling systems report offers safety ideas

MADISON-- A report recently prepared by agricultural engineers and farm safety experts examines different manure handling systems in Wisconsin, the dangers presented by manure gas and offers safety recommendations to keep farmers and their employees alive.

The 18-page report, Manure Gas Safety: Review of Practices and Recommendations for Wisconsin Livestock Farms, looks at the potential hazards of different procedures to handle manure on farms. They range from drive-in covered storage tanks to open pits and reception tanks to processing rooms often used with manure separators and digesters.

The report was prepared by a manure safety review team staffed by experts from the state agriculture department, USDA Natural Resources Conservation Service, the Wisconsin Department of Health Services, the University of Wisconsin Madison Biological Systems

Engineering and the Waupaca County Land Conservation Department.

One key recommendation in the report is a plan to educate the farm community about the dangers of different manure handling systems and what can be done to limit the potential harm to farm workers or livestock from manure gas. Other recommendations include design modifications, and the addition of safety features to existing systems, and items to include in a safety plan.

One type of system in particular has drawn the most concern from the manure safety review team. The expanding use of drive-in, covered storage tanks and transfer channels place farm workers in dangerous environments with little opportunity for rescue.

County Board hears finance department reports

WEST BEND- During Tuesday's County Finance Department's annual report to the County Board, Susan Haag described how the economy is impacting property tax payments.

Delinquent taxes as of July totaled \$1.7 million, up \$500,000 from last year at the same time. Neither figure includes the city of West Bend.

From 2007 to 2008, Haag said delinquent tax payments were up \$800,000 to more than \$2.5 million.

While numbers are up again so far this year, Haag has her fingers crossed that figure won't be eclipsed this year.

"I'm hoping we took the hit last year," she said.

Large developers, she said, are the biggest culprits.

"They're using us kind of as their bank," she said.

Delinquent tax money gets covered by the county's undesignated fund balance at the end of each year.

The society's six staff members took a 20 percent pay cut, the society's executive director

said during his presentation of the society's annual report.

The pay cut was effective as of May. It staved off layoffs. "We are doing everything we can to cut expenses," he said.

EDWC continues search for executive director

Economic Development of Washington County is on the hunt for a new executive director.

Jack Caldwell resigned June 30, and the EDWC is looking for a replacement.


"We put together a search committee and they will proceed with going forward," said Doreen Buntrock, EDWC president. "The latest we'd like to have someone in place is Dec. 1."

This year was my second time, and my hardest, due to health problems. The young adults were there making sure I was ok. I told them I know what my struggles are and my cross to carry, go find theirs and then the answers from our Father. They all wanted to help me, but I am stubborn and told them that the trip was for them.

This story needs to come out because we hear so much of the negative and after what happened to me, love has been repeated. The story is not about me, but a little about myself will show you about them, the youth group from Holy Trinity/St. Michael's called R.I.O.T. (Righteous Investors of Truth) and Catholic Heart Work Camp.

The weekend before camp I had a patio and shed slab frame dug out. This means I had the topsoil removed, about 10 yards worth sitting in the middle of my backyard. During the camp, I had the concrete poured. I knew that hauling the 10 yard pile or dirt would take me the rest of the summer and into late fall, maybe more to move it and level my yard. I was not up to it, but I knew it had to be done.

I came back from Rockford and moved about 30 wheelbarrows full. This was not even a dent in the pile and I had to stop due to my health. I had planned our family vacation in January to go July 17 with my brothers and sister and their family. Maybe the rest will do me good. The pile of dirt would have to sit.

On July 18, some of the RIOT and Catholic Heart Work Campers went to my house, unknown by me, and had a day of work. Not everyone who wanted to help could come, but were

with them in spirit and prayer. At 10 a.m. they met at the Benzings house and were briefed on what to do - lots of shoveling, dumping of the wheelbarrow loads, dirt fights and even as far as smoothing the dirt. They took a break for lunch and a little frisbee, but then it was back to work. At around 4:30 it was just

about finished. They wanted to do more but then needed the boss (me) there. They thought of building a retaining wall, raising the flower beds and planting the grass seed.

While doing this all my neighbors witnessed their hard work and their faith. When my friend Mark Muckerheide

came to pick up his forms from the concrete pouring they even helped him pack up. Mark could not believe what was being done for me.

I came home on Friday, July 25, and was greeted by Pam Benzing and a huge card. I was not sure what was going on, but once I read the card and went out back I knew. They did all this work for me, why did I deserve this? I did not do any more than what each of them does. I am to this day still speechless on what the amazing young adults did for me. I cannot express to them what it means to me. I see God each time I see their faces and remember what they do out of

love. You have saved me from a lot of hard work.

So far RIOT and the Catholic Heart Work Campers from Holy Trinity/Saint Michaels have taken that love and shown it to all they have come in contact with. It truly has been something special. As they embark on the second half of the summer, I hope that the love that has happened already will not only serve as an example to those who follow, but continue to grow and spread in our community.

They have given me the strength to go on teaching CYE and being part of this great Catholic Faith at Holy Trinity/St. Michaels.

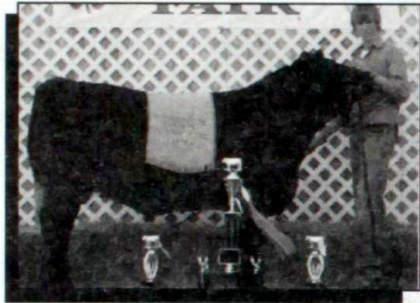

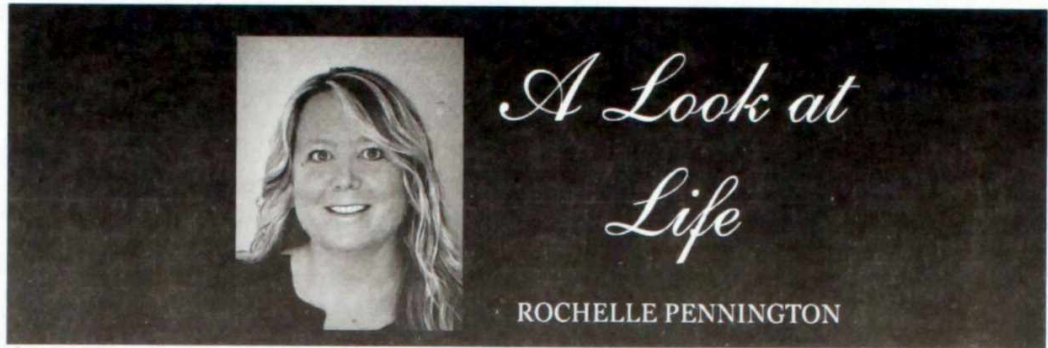

Star Light, Star Bright

"Who said that every wish would be heard and answered when wished on a falling star? Somebody thought of that, and someone believed it, and look what it's done so far."

So sings the Muppet character, Kermit the Frog, in "The Rainbow Connection," a song for "lovers and dreamers."

Kermit is joined on the subject of stargazing and wish making by another serenading childhood character, Jiminy Cricket, in Walt Disney's classic motion picture, "Pinocchio."

The bug promises hopeful listeners: "When you wish upon a star, makes no difference who you are, anything your heart desires will come to you. If your heart is in your dream, no request is too extreme, when you wish upon a star as dreamers do."

Well, we're all going to have an opportunity to put those words to the test this week when the annual Perseid meteor shower, the most spectacular and anticipated celestial light show of the entire calendar year, reaches its peak activity on August 12 and dominates the heavens. This yearly spectacle, a display of thousands of stars falling across the wide expanse of sky, and numbering as high as 100 per hour during optimal viewing, dates back to ancient times.

The performance has been underway for some time already (since July 17) and will continue until August 24, with the largest concentration of shooting stars overhead enhanced during the

shower's peak. The moon will pose a bit of a problem this year since it will be shining brightly, hindering ideal viewing of the fainter meteors with its interfering lunar glare.

Here are a few tips for those of you who would like to have yourself a look, whether you are a first-time attendee, or someone who has been making the annual pilgrimage out to the back lawn with an armful of blankets to watch the Perseid meteors every August:

Lie down, and look up. (This can best be accomplished in a reclining lawn chair or in a hammock, which is my personal preference for sprawling out and getting comfy.)

Focus your eyes on the Little Dipper to adjust your vision to the darkness.

Keep your gaze away from the moon.

Distance yourself from city lights, if possible. Expect premier viewing to be especially favored after midnight and in the wee hours before dawn when the activity will accelerate, gaining strength.

Binoculars and/or telescopes are not necessary, although some people prefer to have them on hand.

Prepare a wish because, after all, you just never know, right? It's why we keep blowing out birthday cake candles and throwing pennies into water fountains.

July was a good month on the track for Goeden

A lot of Wisconsinites were disappointed with the weather in July, but local race car driver Don Goeden wishes the month could have gone on for another 45 days.

Goeden, who pilots the black No. 11, had a red-hot month on various dirt tracks in Wisconsin, actually starting June 27th when he won the 25-lap feature at the Sheboygan County Fair Park in Plymouth.

"We had a good July, one win and four top-fives," Goeden said Sunday night, a day after he put on a good show for the fans at the Charter Track in Beaver Dam.

For the major portion of the race at Plymouth, it looked like he was going to have to settle for the runner-up spot behind fellow competitor and friend, Mike Kertscher, who is also from the Kewaskum area.

Then Kertscher made a slight miscue, opening the door for Goeden to take the checkered flag.

"On lap 21, I was second. The leader, Kertscher, ran off the track, and I took the lead under the yellow" and ended up winning the race, Goeden said, indicating he had never won a race before when he wasn't running first under the green flag.

This victory was especially satisfying for Goeden because his father, Willie, raced there for about 30 years and because it came on his sister-in-law's birthday.

Following his win, Goeden ran off the four top-fives, which included a third place at the Wilmot Raceway.

That streak ended Saturday when Goeden raced hard, fighting car problems, and just missed the mark at Charter. "I took sixth last night. I had

motor problems all night," Goeden said noting he was 17th in time and second in the heat racing before lining up 17th for the 30-lap feature event.

And what an effort Goeden put in to take sixth, passing 11 cars in the event and taking home the "Hard Charger" award for the night. Kertscher had a good night and ended up in the top spot.

"We'll get it figured out this week," Goeden said, noting he has a week off before heading for Wilmot, for a two-night event.

Goeden has pretty much owned the Wilmot Raceway in recent years and is hoping to continue that domination. "I won three of four features there last season," Goeden said. "This year we have a second and a third."

The shows on August 21st and 22nd are part of the an-

nual Kenosha County Fair, according to Goeden, who could perhaps move into the top five in IRA (Interstate Racing Association) point standings.

Goeden is more concerned, however, about taking one race at a time because he realizes he will have difficulty competing against those who race in all the IRA shows. "We're eighth right now, but we don't race for points," Goeden said, adding the same is true of Kertscher, "who picks and chooses (his shows) like I do."

For the record, defending champion Billy Balog is currently atop the standings with 2,720 points. Scott Bierterz of West Bend is among the leaders, sitting in fourth place at 2,409 points.

Goeden has 2,168 while Kertscher, currently the marketing director for Road America in Elkhart Lake, is in the 18th spot with 1,332.

Goeden and car owner Bob Walldan of Winthrop Harbor, Illinois are now in their fifth season together. Goeden's crew chief has been with him a lot longer. Twin brother, Dave "Dusty" Goeden is happy to be the setup man for the team, which has three local sponsors this season, including Valley Hydro-Excavation of Campbellsport, the

Grand Larsony in Kewaskum and Kettle Moraine Gardens in Kewaskum.

"Tina and Mark wanted to get involved with racing," Goeden said of the owners of Kettle Moraine Gardens, a senior residential facility. "Their kids are big fans of mine."

On the subject of fans, Goeden said crowds have been good at the IRA tracks despite the economy. "There have been good crowds. I think that's because people are staying closer to home."

Goeden, 45, has been involved in racing since he was a child, first washing his dad's race cars. He has raced since he was 21, and this is his 15th season in IRA.

"We're having fun," Goeden said. "The car has been good this year. We blew a motor the first night, but we have been good since then. We have about 11 shows to go. We'll be running Dodge County, Plymouth, Oshkosh and Wilmot."
